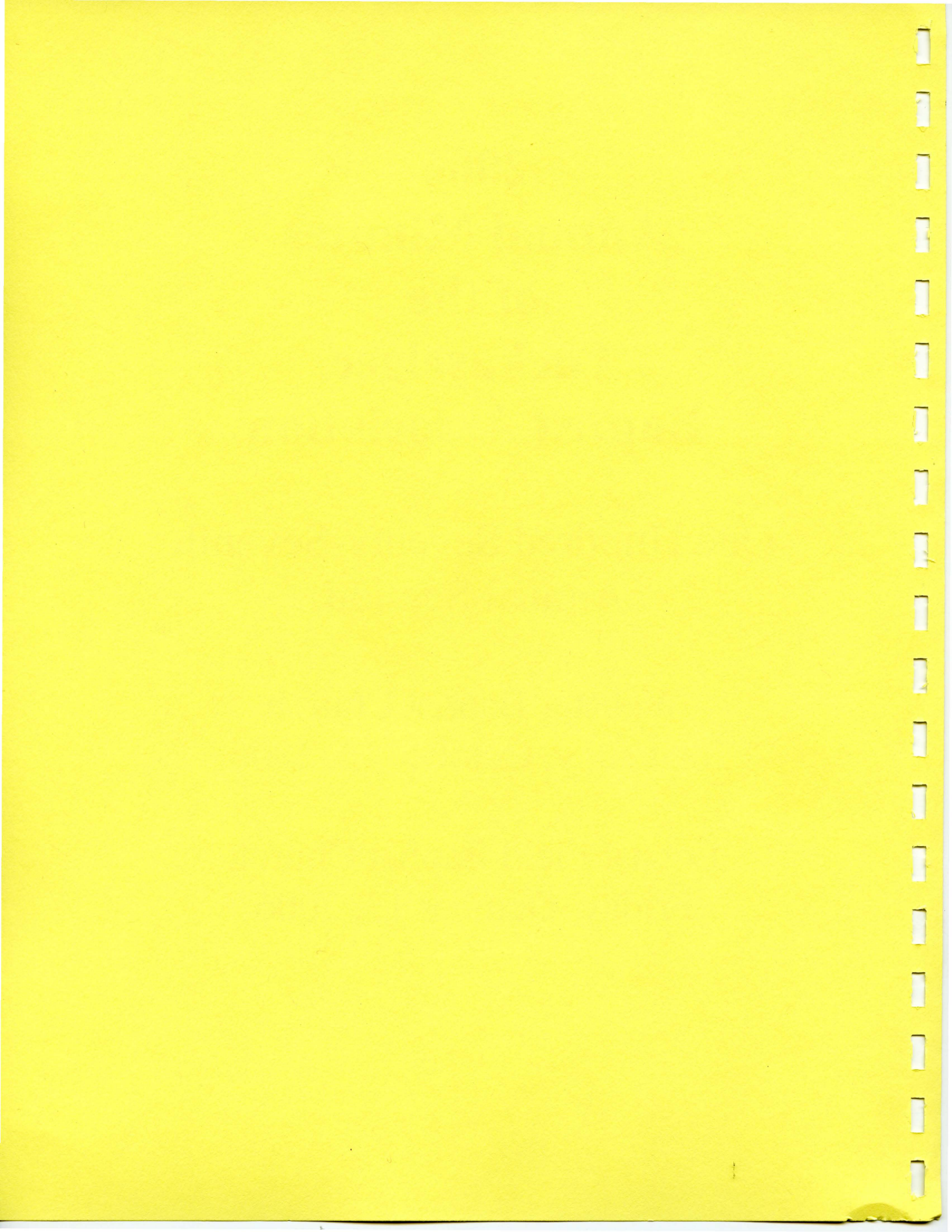

For many years she served as pastor's wife at Calvary Baptist Church.

Betty started teaching Vacation Bible School when her youngest daughter was only two years old. Since then, God has given her the opportunity to continue working with children every year. She has been a teacher and Vacation Bible School Director in her home church as well as serving as the Associational Vacation Bible School Director. She has lead many Bible School clinics including some for other associations. On a mission trip to Brazil in 1992, she had the privilege of working with kids. She is always looking for ways to tell children about Jesus' love.

In the association she has served as Vacation Bible School Director, Pianist, Assistant Clerk, and as a Member of the Credentials, Missions, Memorials, and Food Committees. She has also led the Associational WMU in a prayer retreat.

Betty is currently teaching Sunday School, sings in her church choir, participates in her church nursing home ministry, and is active in WMU. She teaches after school for Jackson County Bible Club at Fairview Elementary School and loves every minute. She is also a certified art instructor. She and Doris painted the baptistery mural at Black Mountain Baptist Church in Cullowhee, NC. In her spare time, she likes to quilt, basket weave, crochet, and garden.

PROCEEDINGS
177th ANNUAL MEETING
FIRST SESSION, THURSDAY, OCTOBER 12, 2006

1. Webster Baptist Church hosted the first session of the 177th Annual Meeting of the Tuckaseegee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 107 present: 75 Messengers and 32 visitors representing 21 churches.
2. Rev. Matthew Ledbetter, Moderator, welcomed everyone.
3. Rev. Emery Brooks led the congregation in singing "Blessed Assurance".
4. Rev. David Powell welcomed everyone to Webster Baptist Church. The Webster Baptist Church Choir sang special music.
5. Rev. David Powell, pastor of Webster Baptist Church, brought scripture and sermon from Ephesians 5:15-17. He also presented a CD presentation about the Youth Rally Ignite 2007 to be held on January 20th at the Ramsey Center. Rev. David Souderes was sick and could not preach.
6. The 177th Annual Meeting was called to order by Moderator Matthew Ledbetter after a time of fellowship.
7. Rev. Matthew Ledbetter asked for changes to the Agenda. A couple of changes were made to the timetable on the second day of business. He also recognized that Rev. David Powell, alternate speaker, filled in for Rev. David Souderes.
8. Rev. Matthew Ledbetter, recognized new pastors at the Associational Meeting. Rev. David Powell is serving as interim at Webster. Rev. Marlan Keener is the new pastor at Moses Creek. Rev. Gordon Vinton of Mars Hill, Rev. Bryan Smith of Mutual Insurance, and Rev. Lewis Smith of the Baptist Children's Homes of NC were recognized as visitors.
9. The Moderator announced appointment of Committee on Committees and Resolutions Committee on page 14 and it was approved.
10. Rev. Emory Brooks led the congregation in singing, "Standing on the Promises".

REPORTS

11. **Director of Missions** - Rev. Virgil Holloway gave his report as Director of Missions. It was located on page 4. It has been a joy to serve in the association.
12. Rev. Virgil Holloway recognized Cashiers Baptist Church for their achievement for the greatest per capita given to the Lottie Moon Christmas Offering and for the top giving church to this offering in the association. Several people were there from their church to receive it. Greens Creek Baptist also received a certificate for being the top giver to the Cooperative Program in the association.
13. Rev. Lewis Smith of the Baptist Children's Homes presented certificates to Cashiers Baptist, New Hope Baptist and Webster Baptist for being in the top 200 churches in 2006 to give to the BCH.
14. **Senior Adult** - Eloise Shuler gave the Senior Adult report listed on page 5. She is resigning as senior adult director after 14 years.
15. **Music** - Rev. Emery Brooks gave the Music report listed on page 6. He said 22 churches were represented at the association's annual singing. Hopefully more will participate next year.
16. **VBS** - Betty Greene gave the Vacation Bible School Report listed on page 7. At least 20 children made professions of faith. She is also giving up her job to work with the children on a weekly basis in the schools with the Jackson County Bible Club.

17. **WMU** - Janice Burnette reported they would be having an annual WMU training on October 23rd at the Baptist Center. Also on November 19th there would be an International Mission Study and World Crafts Fair. Report listed on page 8-9.
18. **Church Mutual Insurance Company** - Rev. Bryan Smith presented his report on page 21.
19. **Hispanic Church Planting** - Rev. Robert Fernandez presented his report on page 33 and read some scripture in English and Spanish. Their goal is to share Jesus Christ and make disciples and missionaries of their Hispanic church members.
20. Rev. Matthew Ledbetter then recognized Eloise Shuler and Betty Greene for their many years of faithful service to the association.

COMMITTEES

21. **Stewardship** - Rev. Mike Moore presented the proposed 2007 budget to be voted on during the second session. The budget is on page 11. He encouraged each church to consider giving more to the association.
22. **Committee on Committees** - Kenneth Miller presented their report on page 14 to be approved. No further nominations were made and it was approved.
23. **Nominating Committee** - Brad Stillwell presented their report on page 15 to be accepted for 2006-2007. No further nominations were made and the motion carried.
24. **Place and Preacher Committee** - Brad Stillwell presented their report on page 3. It was approved with no opposition. Next year's annual meetings will be at Pine Creek Baptist and Long Branch Baptist. Rev. Johnny Norris and Rev. Marlan Keener will be preaching.
25. **Memorials Committee** - Eloise Shuler and Alice Cabe read the names of members from each church that had passed away during the past year. Page 16. Eloise also read a poem and Rev. Virgil Holloway lead in prayer.

MISSIONS

26. **Scotts Creek Baptist** - Mark Rogers, the youth director, gave a report about their mission trips to Moldova and New York. Their youth did a week-long VBS in New York.
27. **Webster Baptist** - Rev. David Powell reported that several from their church have gone to the Southern states to help with Hurricane Relief and did Backyard Bible Clubs. They have also participated in local missions by building a dock for the Broyhill Baptist Children's Homes and having a Christmas party with them. They replaced the flooring for somebody locally also. Matt Bishop participated as resort missionary this past summer at the Yellowstone National Park.
28. The Covenants had special music at this time.
29. Rev. Lewis G. Smith of the Baptist Children's Homes of NC then brought a message of encouragement to everyone.
30. Rev. Rich Peoples of Scotts Creek Baptist Church led in the Benediction.

SECOND SESSION, FRIDAY, OCTOBER 13, 2006

1. Locust Field Baptist Church hosted the second session of the 177th Annual Meeting of the Tuckasegee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 79 present: 58 Messengers and 21 visitors representing 16 churches.
2. Rev. Matthew Ledbetter, Moderator, welcomed everyone and called the meeting to order.
3. Rev. Charles Carnes welcomed everyone to Locust Field Baptist Church and read Galatians 1:1-5.
4. The Locust Field Baptist Church Choir had special music.
5. Emery Brooks led the congregation in singing, "Revive Us Again".

REPORTS

6. **Historical** - Mildred Wilson presented the church historical events for the past year on page 32. She encouraged everyone to call her with news.
7. **SWARM** - Bob Tucker presented their annual report. The report that was in the book of reports was from the prior year. He gave Gracella this year's report to put in the annual minutes.
8. **Truett Baptist Camp** - Rev. Cecil Frady presented the annual report on page 23. Mrs. Robinson was hurt and Richard Robinson could not come.
9. **United Christian Ministries** - Kathy Cross reported they continue to assist with food, heating oil and gas, utilities, transportation, overnight lodging, past due rent, and medical/prescriptions. UCM also makes referrals to other agencies and hospitals. They continue to need volunteers and financial support. She reported they cannot get funding from federal or state funds due to being a Christian agency. They are also a host site for the Angel Food Ministry. She encouraged the churches to have UCM as a local mission such as Moses Creek does each month. Her report was on page 24.
10. **Baptist Hospital** - Rev. Paul Mullens said his report was on page 28. 11 churches in the Tuckaseegee Association gave to the Baptist Hospital last year. All this money goes to patients in need of hospital care, but can't quite cover their own bills.
11. Emery Brooks led the congregation in singing "Are You Washed in the Blood."
12. Gracella Morris reported that on Thursday 108 people were present and on Friday 77 people were present. (This is a little different after Gracella got back to the office and compared all the attendance sheets.
13. A mission report was presented by Art Keener for the Lighthouse Baptist Church. He presented some information about the NC Baptist Men's Disaster Relief work. Their church has volunteers who take part in this. Since Hurricane Katrina there has been over 134,000 volunteer days, 1,000,000 meals served, 4,000 recovery jobs, child care, and laundry services provided. There have been hundreds saved as a result of this work. The Baptist Men and Women are well respected and well loved. Volunteers are needed every day.
14. Rev. Matt Ledbetter spoke about Hamburg and Cashiers' mission trip to Honduras. They take Felix Villarreal with them as interpreter. They do street evangelism. This year they got to visit with the Mayor and gave him a Bible. He was saved. He encouraged everyone to go through ncomissions.org to set up a trip with the NC Partnerships.
15. **Executive Committee** The moderator pointed to the executive committee report beginning on page 17. It is a summary of the executive meetings held throughout the year. He pointed out that the attendance has been low at the meetings.
16. **Credentials Committee** - Rev. Cecil Frady said that the committee recommended that Lighthouse Baptist Church be accepted into the full fellowship of the Tuckaseegee Baptist Association. They were taken under the watchcare last year. 100% approval.
17. **Stewardship** - Rev. Mike Moore moved that the 2007 budget presented the previous session be approved. Page 11. No discussion followed and it passed.
18. **Personnel Committee** - Rev. Gene Hawkins, chairperson, said that Dr. Virgil Holloway was voted to be full-time director of missions at the last executive committee meeting.
19. **Resolutions Committee** - Rev. Gene Hawkins presented the following resolution.
Whereas Webster and Locust Field Baptist Churches have hosted meetings, provided abundant meals, and extraordinary hospitality to messengers of the Tuckaseegee Baptist Association, and
Whereas Rev. David Powell and Rev. Lewis Smith have presented (and we believe also Rev. Clemmey Queen will present) motivating, encouraging, and uplifting messages, and
Whereas associational and convention-wide representatives have given informative and challenging reports, and
Whereas Rev. Matt Ledbetter and Rev. Avery Brown have so capably presided over these sessions and other meetings, and

Whereas our Director of Missions, Dr. Virgil Holloway, has brought wise leadership that strongly promotes missions and unity, and

Whereas, our faithful and resourceful associational clerk, Gracella Morris, serves beyond her call of duty, and Whereas, our committee officers and members have given of time and energy to serve the association well. Be it therefore resolved that we extend sincere appreciation to all who have served to honor our wonderful Savior Jesus Christ. Bro. Moderator, I move that this well deserved resolution of appreciation be adopted. It was adopted.

20. Rev. Charles Robertson was recognized as the new pastor at East Fork Baptist Church.

21. Rev. Emery Brooks then led the congregation in singing "Nothing But the Blood".

22. A quartet from the New Hope Baptist Church had special singing.

23. Rev. Clemmey Queen, pastor from Speedwell Baptist, gave the Scripture and sermon. He spoke from I Chronicles 27.

24. Rev. Emery Brooks then led the congregation in singing Amazing Grace without music.

25. Rev. Josh Hyde closed with the Benediction.

Focus on WMU was celebrated on February 19, 2006, as Joyce Green and Janice Burnette led the North American Mission Study at the Baptist Center. The Women on Mission sponsored a prayer retreat at the Baptist Center on April 1, led by Betty Green. Our annual meeting was hosted by Locust Field Baptist Church on April 20, 2006. The program featured the Baptist Men Disaster Relief Team from Robbinsville, and several boxes of books were collected to send to Pass Road Elementary School in Gulfport, Mississippi.

WMU has been involved promoting the NC State Missions Offering in September, the Lottie Moon Christmas Offering in December, and the Annie Armstrong Easter Offering in the spring.

The WMU has been involved in several mission projects during the past year. The Girls in Action sponsored a missions fair in the fall of 2005. The fair was held at Faith Baptist Church, and missionaries from the Philippines, the Smiths, were guest speakers. GAs have been active also participating in Christmas in August, visiting nursing homes, baking cookies for public service employees (such as EMS and fire department workers), and preparing goodies for missionary kids. WMU has supported community ministries by helping with the After-School Bible Clubs, the Hispanic Mission, Lifeline for shut-ins, United Christian Ministries, REACH, and Relay for Life. We collected soup labels sent to purchase a van for missionary use. Over 1200 shoe boxes were filled for Operation Christmas Child, and food and supplies were collected for the Baptist Children's Homes. Other activities include disaster relief in the Ukraine, in Arkansas, and in the Gulf region; sending school supplies to Harlem; making hygiene kits for the disaster relief van; building ramps for the elderly; sewing for cancer patients; assisting with the dental clinic in Cashiers; preparing favors for the dialysis center; preparing Christmas boxes for the elderly in Jackson County; and planting flowers in the Mildred Cowan Prayer Garden at Truett Camp. Our associational WMU also gave \$50 through the NCWMU to help meet needs at Inlow Baptist Camp in New Mexico.

Our members have participated actively in both state and national WMU events during the year. Sandra James, of Whittier, served as the NCWMU President. Janice Burnette served on the NCWMU Executive Board. Several women were able to attend *Missions Extravaganza* at Ridgecrest, April 21-23. Others traveled to Greensboro for the national WMU meeting, held prior to the SBC Convention on June 11-12, 2006, focusing on the theme, *Live the Call*.

2006 has been an exciting year for Hispanic ministries in Jackson County and Western North Carolina. A discipleship retreat involving three Hispanic congregations was held in Canton. Hosted by High Street Baptist Church, this event included La Caridad (Glennville, Toxaway), Hay Esperanza (Haywood County), and El Centro del Señor (Cullowhee). Joint services involving the three Hispanic Churches currently in Jackson County (La Caridad, Primera Iglesia Bautista de Español, El Centro del Señor) are being held every other month. A concert featuring the group, Cansión de Amor, was held at a new church, Nueva Esperanza, in Robbinsville. Congregations from Asheville, Cashiers, Cullowhee, and Robbinsville took part in this event hosted by New Hope Baptist (Robbinsville). Later this month, a three day tent revival will take place in Cashiers. The fifth anniversary of El Centro del Señor will be celebrated with a special service in November.

God has richly blessed Hispanic ministries in our area. Many have come to Christ over the past year. For example, five were baptized from El Centro in a special service hosted by Hamburg Baptist. Please remember the pastors of Hispanic churches in Jackson County in your prayers: Jerry Hagen, Felix Villarreal, Rick Plotts, and Robert Fernandez.

The Regional Hispanic Ministry represents a partnership of several churches, including four associations. These associations are Cheoah, Tennessee River, Truett, and Tuckasegee. The Baptist State Convention of North Carolina is providing additional support. Our goal is to establish Hispanic churches in each of these associations throughout Western North Carolina. One new church has already been planted in Robbinsville: Neuva Esperanza. Another church will be planted in Andrews in January 2007. We are seeking to start new churches in Bryson City and Hayesville. Fruitland Baptist Bible Institute will be partnering with us by providing pastors for these churches. Samuel Rodriguez (church planter, evangelistic) is in charge of training Hispanic pastors at Fruitland. Funding for this important ministry is needed on an ongoing basis. Historical Report

CALVARY MISSIONARY BAPTIST: Established the Savannah Help Ministry in Nov. 2005. The purpose of this ministry is to help senior citizens age 65 and over and disabled citizens of the community who need help paying electrical, fuel, or medical bills: Firewood Ministry--volunteers bought, cut and delivered firewood. The Help Ministry assisted in need of fuel, money for hospital bills, etc. The Angel Food Ministry is a church-based food distribution organization headquartered in Monroe, GA. Groceries were sold by the box at \$25 per unit with additional specials available at an additional cost. One box of food assists in feeding a family of four for about one week or a single senior citizen for one month. This food is donated to someone in need.

EAST LAPORTE GRACE COMMUNITY CHURCH: THE TWO CHURCH CONGREGATIONS AT EAST LaPorte that have always been one in spirit have now become one in name. Since 1929 The East LaPorte United Methodist Church and the Lumberton Baptist Church have shared the same church building. Each church had its own identity and had its own pastor and church officers. The Baptist pastor preached the first, third and fifth Sundays and the Methodist pastor preached the second and fourth Sundays of each month. The new joint congregation extends an invitation to everyone to visit with us anytime.

HAMBURG BAPTIST CHURCH: Brad Hughes and Felix Villarreal were ordained into the ministry November, 2005. The church also participated in mission trips to Honduras and to Gulfport, MS; Eight people were trained in Disaster Relief; A Sunday School Class was started for Hispanics for English as a Second Language.

LONG BRANCH BAPTIST CHURCH: An individual donated a special gift of \$55,000 to the church for the specific use of a missionary (Trent Horton) who is departing for Honduras. This money is to be used to purchase land, materials, etc. for an orphanage in Honduras.

NEW SAVANNAH: A new well was drilled which will supply the necessary water. Also a fund raiser is being planned for October to raise money for the Building Fund.

SCOTTS CREEK BAPTIST: Mark Rogers was called as the Minister of Youth Program.

Many churches brought food, supplies and gift cards to the Baptist Center for the Baptist Children's Homes of NC: Bible Club, Buff Creek, Cashiers, Cullowhee, East Fork, East LaPorte, Faith, Little Savannah, Locust Field, Moses Creek, New Hope, New Savannah, Rockdale, Speedwell, Scotts Creek and Wilkesdale. The Buff Creek Baptist GA's and Virginia Pangle helped sort and box up the food supplies. Also Lewis Smith, Earl Hooper, Donal Shuler, Mike Moore, C. L. Proffitt, and Joe Rigdon helped load the furniture truck.

The following churches participated in the Greening Up of the Mountains Festival in April on Sylva's Main Street: Buff Creek, Cashiers, New Hope and Webster Baptist.

Many churches in Jackson County sent mission teams to assist in the hurricane relief efforts in Texas, Alabama, Mississippi and Louisiana. In addition to taking food, cleaning, staples, etc. the teams assisted in building, clean-up, or whatever was needed.

Many Voices, One Story. . . North Carolina Baptists attending the Baptist State Convention Tuesday evening, November 15, 2005, sat as the lights in the Joel Coliseum in Winston-Salem dimmed. Messengers and guests arrived anticipating the night's report from Baptist Children's Homes (BCH). Every five years, the Institution presents a 30-minute expanded report, which many people view as the highlight of the convention.

The crowd present this night leaned forward as the first child stepped to the microphone to tell her story. Children and residents representing BCH's four campuses, wilderness camping program, group homes and developmental disabilities ministry filled the stage area. The 2005 meeting was BCH's opportunity to share the ministry through children's testimonies and songs while highlighting the Institution's 120th anniversary.

BCH president Michael C. Blackwell enthusiastically addressed the group declaring, "We are uniquely, proudly, passionately, and incurably a part of the North Carolina Baptist family."

To close the presentation, Broyhill Home resident Jennifer and developmental disabilities resident Marcie sang "Jesus Loves Me."

"These are God's miracle children...", Blackwell said. "I want you to see in those eyes the eyes of our God who loves children."

But the true pinnacle of the evening for one special child occurred away from the eyes of messengers.

"We were all saying goodbye when I looked down and saw Jennifer crying," said Lou Arnsdorff, Jennifer's child care worker. (Jennifer had just sung on stage.)

A tearful Jennifer told Arnsdorff, "I just want to ask Jesus into my heart." In a crowded hallway outside the auditorium, Jennifer accepted Christ as her Savior.

Show you love. . . This year's Baptist Children's Homes' offering theme, "Show You Love," represents the pivotal role individuals and churches play in the lives of hurting children.

North Carolina Baptists show their love through their prayer and financial support. It is only through this commitment that BCH can continue to make a difference. This year's statewide offering goal is \$1,375,000. This represents a \$25,000 increase from last year. Challenge your church to participate in the 2006 Offering Campaign.

Biography Unveiled. . . The biography of BCH president Michael C. Blackwell was published and officially unveiled to the public in April. *Just Call Me Mickey: From Mill Village to Mills Home, The Journey of Michael C. Blackwell* was written by the late Wint Capel, former editor of the *Thomasville Times*. The book chronicles Blackwell's life from his humble beginnings as a boy living in the mill village town of Gastonia to

becoming president of one of the largest private children's homes in the southeast United States.

New PMG members named. . . Baptist Children's Homes president Michael C. Blackwell announced several key administrative appointments in June. Nancy McNeill was named BCH's Executive Vice President (EVP) of Operations overseeing the statewide Institution's day-to-day operations. Jim Edminson was appointed as BCH's Institutional Director for Communications directing the agency's statewide communications. Shane Nixon has been named BCH's Institutional Director of Information Services directing BCH's technology services and broadening his role of service. McNeill, Edminson and Nixon will serve on Blackwell's President's Management Group (PMG).

Former resident, BCH child care worker, and administrative office manager Jennifer Shore was appointed Executive Assistant to the President and longtime staff member Ron Richardson was named Manager, Institutional Support Services.

Dedicated to the Glory of God. . . Baptist Children's Homes set its sights towards the future expanding its services to children and families.

- The Alverta Bolick Home in Asheville was dedicated in May. The facility is home to developmentally disabled adults in the Asheville area.
- The campaign to build two similar facilities for special needs adults in the Sanford community began in August 2005.
- A state-of-the-art education center in Kinston was dedicated in July. The new Reverend Kenneth E. Haigler & William "Bill" Overcash Education Center offers an on-campus school to residents at BCH's Kennedy Home.
- The Winifred Lindsay and Three Forks Homes for developmentally disabled adults were dedicated August 27 in Boone.
- Groundbreaking for DDM homes in Sanford and Asheboro will take place September 10 and October 14 respectively.



THE NORTH CAROLINA BAPTIST FOUNDATION, INC.
2005 ANNUAL REPORT

The mission of the North Carolina Baptist Foundation since its inception in 1920 has been to assist the Convention and its institutions and agencies in increasing an awareness among North Carolina Baptists of Christian estate stewardship principles as a means of financially undergirding churches, institutions and mission endeavors on a permanent basis. The uniqueness of the ministries and services provided by the institutions and General Board staff merits increased financial support. The Foundation accomplishes these objectives by offering assistance in estate planning counsel, Will preparation, planned giving, charitable remainder trusts, endowment funds and church fund management.

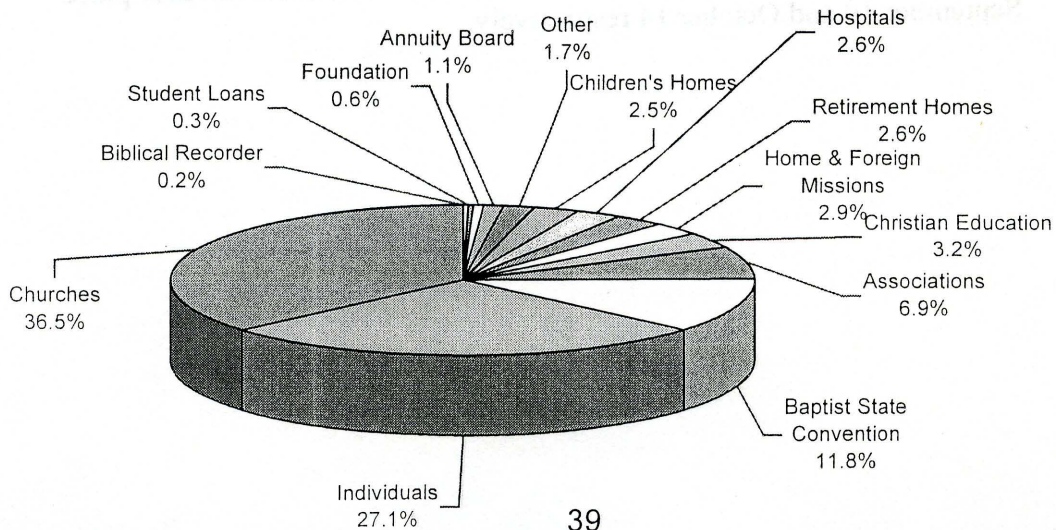
During 2005, the Foundation assisted individuals in establishing 49 endowment funds and 12 charitable remainder trusts totaling \$1.8 million and received \$7.1 million in contributions to existing endowments all of which will ultimately benefit countless Baptist causes on a permanent basis. Programs were provided for churches and associations during the year to promote Make Your Will Month, Christian estate stewardship, and church fund management. Over \$1.5 million from churches and institutions came under management to enhance numerous ministries including scholarships, building funds, cemetery funds, benevolence funds, general operating funds and other various mission causes. Overall, the Foundation received \$10.6 million in contributions during 2005 for Christian causes.

The Foundation employs professional money managers to invest these funds according to an investment policy adopted by its Board. Four investment pools are offered: a growth fund, a balanced fund, an income fund and a fixed income fund. The Foundation uses the services of Salomon Smith Barney to help select top money managers and evaluate performance. As of December 31, 2005, the Foundation held \$136.1 million under management.

During 2005, our distributions totaled \$7.8 million, with charity receiving \$5.7 million and individuals, through trusts, receiving \$2.1 million. During the 85-year history of The North Carolina Baptist Foundation, Inc., \$29.1 million has been distributed to individuals and \$53.3 million to Baptist churches, institutions and mission causes for a grand historical total of \$82.4 million.

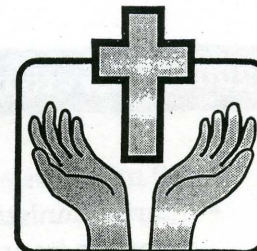



Report for 2006 Book of Reports

Office of GuideStone Financial Resources for the Baptist State Convention of NC, Inc.

During the past year significant strides have been made to provide the very best service to employees of our churches and agencies who are active participants in the retirement plan, jointly administered by GuideStone Financial Resources, SBC, and the Baptist Convention of NC, Inc., and to those who have purchased insurance products from GuideStone. Through a contractual agreement with Morningstar Associates, LLC, a registered investment advisor, retirement participants now have access online to a leading innovator in offering retirement advice. Specifically, Morningstar Retirement Manager offers objective, expert recommendations and resources to help participants make clear decisions about their retirement plans. Never before have we been able to offer this incredible service at no cost to our retirement participants.

In the life and health areas enhancements continue to be made to provide additional flexibility in plan options, deductibles and competitive rates. Taking advantage of significant discounts through Highmark Blue Cross Blue Shield, medical plan rates have been stabilized. While over 40% of personal plan participants received a decrease in rates in 2005, over 57% of personal plan medical participants received a decrease in rates for 2006. Additionally, the two Medicare supplement plans offered to retirees also received rate decreases in 2006. The 31 day open enrollment period for new students in our divinity schools, Bible institute, and seminary continues to be an attractive option for that target group.

During the past year the importance of the protection benefits (disability and survivor), which come free to those who are active participants in the Church Retirement Plan and who are serving an eligible church, was magnified with 100 participants receiving disability protection benefits and 40 families receiving survivor benefits because of that many deaths among our church employees. One widow, whose pastor/husband in his early 50's suffered a stroke and died within ten days, received a survivor benefit check in the amount of \$50,000 in addition to the money in his retirement account. The survivor check of \$50,000 came quickly (also tax free) and proved to be a "life saver" to this widow. As in previous years, the great challenge is to educate our church employees and key lay leaders in our churches about these great benefits **provided at no cost** to those church employees who meet the eligibility requirements.

Furthermore, we gladly cooperate with the Endowment ministry at GuideStone to provide ongoing and one-time financial assistance to retired ministers and widows of ministers who are living in poverty. As of June 30, we have 222 North Carolinians, who have met the very strict guidelines, receiving financial assistance from GuideStone Financial Resources. Unfortunately, others could be assisted if we only knew who they were.

In conclusion, it is our strong desire to increase the level of retirement participation and to serve all of our churches and their employees with the appropriate information/products to meet their needs. Report from the Baptist State Convention of North Carolina

For period July 1, 2005 to June 30, 2006

Executive leadership in the Baptist State Convention of North Carolina changed April 11, 2006 when Milton A. Hollifield, Jr. was elected executive director-treasurer. He was installed the same day during services at Calvary Baptist Church in Winston-Salem.

Hollifield declared that he intends to lead North Carolina Baptists "to become the strongest force in the history of this Convention for reaching people with the message of the Gospel."

Within months, Hollifield filled three executive leader positions. He eliminated the position of associate executive director-treasurer; and combined some of those duties with a newly named executive leader for administration and convention relations. Brian Davis, pastor of Beulah Baptist Church in Statesville, board member and Fruitland Baptist Bible Institute teacher, filled that position.

Hollifield called Don McCutcheon from the Florida Baptist Convention, to succeed him as executive leader for mission growth evangelism. He also brought on John Butler, pastor of First Baptist Church, Matthews and board chair in 2004-05 as executive leader for business services, replacing Glenn Harder who returned to corporate life.

Norman Jameson in public relations and resource development, and Lynn Sasser in congregational services, are the other executive leaders.

Cause for Rejoicing

BSC leadership rejoiced over many areas of progress that indicate God's blessing on the work. These include in part the 103 new churches started in 2005; thousands of volunteers participating in a national Crossover event in the Piedmont that sowed seeds for 27 new churches; continued strong support for Cooperative

Program Missions Giving in which 1,672 churches increased their giving to missions through CPMG; a growing awareness of Pursuing Vital Ministry and coaching ministry; campus ministries growing in strength; powerful student weeks at Fort Caswell; burgeoning interest in church renewal weekends; nationally televised disaster relief efforts in Gulfport with Baptist Men; programs and services provided by Convention staff that serve countless churches; increasing visibility for prayer evangelism and personal evangelism strategies; well attended programs and special events and a convention of churches facing the future with the courage of their convictions and faith in Jesus.

Significant resources were committed to strengthening information technology services, recognizing that the Convention must stay current with technology to readily serve churches' needs.

The Convention is increasing emphasis on multi-cultural ministries — reaching people from the many and varied cultures present in North Carolina. The face of the Convention staff reflects that commitment as Ken Tan and Ralph Garay from the Philippines, Tayo Jolaoso, from Nigeria and Maria Luoni from Puerto Rico have joined the staff.

Of the 103 churches started last year, 39 are Anglo. The rest are a variety including Hispanic, cowboy, and several Asian languages. North Carolina Baptists now worship weekly in at least 33 languages.

Changed lives are Certain Proof that missions giving through the Cooperative Program works. Each church received a Certain Proof DVD of 90 second video clips that feature lives changed through a ministry sponsored by North Carolina Baptists.

The 2006 and 2007 budgets each send an additional half percent for Baptist work in North America and beyond and North Carolina led all

state conventions in designated missions gifts to the SBC.

On Mission Celebrations is the new name for World Mission Conferences. Coordinate a conference in your association through Dan Euliss, 800-395-5102, ext. 121.

These missions awareness events provide missionary speakers from the association, state convention, North American Mission Board and the International Mission Board. In 2007 six associations will host OMCs.

Retirement Planning

The importance of the insurance and health benefits provided to participating church staff members was never more dramatically demonstrated than during one week this year when two young pastors died. One was covered and his widow and children received an immediate death benefit of \$50,000. The other was not a participant in the plan and his family faces a much more difficult struggle.

We cooperate with GuideStone to provide financial assistance to retired ministers and widows of ministers who are living in poverty. As of June 30, 222 North Carolinians receive financial assistance. We could help others if we knew who they are.

Don McCutcheon, new executive leader for Mission Growth Evangelism, brings a single goal to his task: To Win North Carolina to Christ – Acts 1:8

He will organize the work of his team around three priorities:

- Intentional, effective evangelism without apology

- Planting intentionally and effectively evangelistic churches
- Assisting existing churches in becoming intentionally and effectively evangelistic

In 2005 North Carolina Baptist churches reported 23,179 baptisms with only 75 percent of our churches reporting. If each of our churches will establish and reach a four-year goal to baptize just one more person than they did the previous year, we will surpass 43,000 baptisms in five years.

The *Biblical Recorder* is now in its 173rd year of service to Baptists in North Carolina, a ministry that now extends around the world. The *Recorder's* mission is "to further Christ's kingdom among North Carolina Baptists by providing relevant news, insightful opinions and supportive resources in a timely and accessible fashion."

The *Recorder* was founded in 1833 and has served since that time as the official news journal of the Baptist State Convention of North Carolina, even though it was privately owned and operated until 1939, when it became a convention agency. As it has from the beginning, the *Recorder* relates to the full spectrum of BSC churches, and reports on matters of interest to them.

In keeping with principles outlined in its charter and reflected in the Baptist State Convention Articles and Bylaws, the *Recorder* staff works "to maintain and safeguard the inalienable rights and privileges of a free press, these rights and privileges being consistent with the traditional Baptist emphasis upon the freedom, under Christ, of both the human spirit and Baptist churches."

The *Biblical Recorder* is widely acknowledged to be in the top echelon of state Baptist papers, winning national honors from the Baptist Communicator's Association every year since 2000, including the prestigious Burkhalter Award for news writing in 2001 and numerous first place awards for news and editorial writing.

As many readers now prefer electronic media to traditional print formats, the *Biblical Recorder* maintains a popular and rapidly growing presence on the World Wide Web. The Website, www.biblicalrecorder.org, provides much of each paper's content online, as well as access to classified ads, online Bible study resources, and a portal to other news services. The site is updated frequently with breaking news items and other articles of interest.

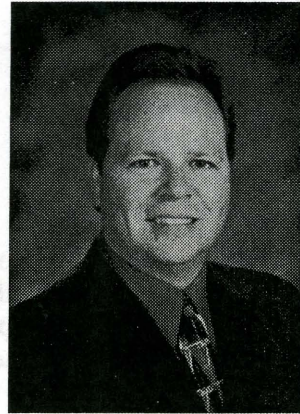

BY-LAWS OF THE TUCKASEIGEE BAPTIST ASSOCIATION, INC.

ARTICLE I. NAME

The name of the body shall be the Tuckaseigee Baptist Association, Incorporated.

ARTICLE II. OBJECTIVES

The purpose of the Association is to be a fellowship of churches on mission in our setting. The specific objectives of the Association are as follows:

1. To promote harmony, understanding and spiritual power between the churches.
2. To afford and promote a larger fellowship of Christians in the work of Christ.
3. To provide such programs, projects and organizations as will strengthen the churches and assist them in achieving their goals and objectives.
4. To discover needs which cannot be met effectively by churches individually and to coordinate the use of resources in meeting these needs.
5. To encourage support by every church for the mission causes of the Association, the North Carolina Baptist Convention, and the Southern Baptist Convention.

ARTICLE III. AUTHORITY

SECTION 1. The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient.

SECTION 2. The Association shall have power to recommend measures of usefulness and guidance to our churches in matters of organization, ordinations and questions of doctrines and discipline,

SECTION 3. The Association shall have no power to infringe upon the right of local churches as sovereign and independent bodies.

ARTICLE IV. MEMBERSHIP

SECTION 1. The Association shall be composed of regularly constituted Baptist churches in cooperating fellowship with the Southern Baptist Convention and following the teachings of the New Testament.

SECTION 2. The Association shall be the sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure. Churches applying for membership shall agree to come under the watchcare of the Association for one year. It is understood that during this period of watchcare the church shall be entitled to all rights and privileges of the Association except those of voting.

Applications for membership shall be presented to the Credentials Committee of the Association. The applications will consist of a letter from a constituted church stating their desire to affiliate with the Tuckaseigee Baptist Association. The Credentials Committee as a part of the review process may invite the requesting church to a conference to discuss its history, its mission strategy, and any other information that may be pertinent to the application. The Credentials Committee may then approve the application and recommend them to the Executive Committee. The Executive Committee may by a simple majority vote accept the requesting church to come under the watchcare of the Association for one year. It is suggested that any church under watchcare participate in the missions program of the Association. At the end of the year, the church may be voted in as a member of the Association with full privileges by a two-thirds vote of the messengers present and voting at the annual meeting of the Association, provided that the church submits an acceptable letter and at least one messenger be present at the meeting.

SECTION 3. Any church may withdraw from the Association at its pleasure and should notify the Association of this action in writing. Such action will be recognized by the Association at the next annual meeting.

SECTION 4. It shall be the duty of each church to furnish the Associational Clerk, before each annual session, an annual letter, the forms provided by the Associational Clerk, giving the information requested as is applicable to each church situation.

SECTION 5. The Association may withdraw from any church which has become unscriptural in its doctrine or practices by a two-thirds majority vote of the messengers present and voting at the annual meeting. Such vote is to be taken by written ballot.

ARTICLE V. MEETINGS

SECTION 1. The Association shall hold its annual meeting on Thursday and Friday preceding the third Sunday in October. Special meetings of the Association may be called by the Executive Committee provided two weeks written notice is given to the member churches.

SECTION 2. Each church shall be entitled to be represented at the annual meeting by the pastor and one additional messenger. Churches which give to the association more than .5% of their undesignated receipts shall be entitled to an

additional 2 messengers for every .5% of giving up to a total of 10 messengers for churches which give 2% of their undesignated giving."

SECTION 3. Churches are requested to elect their messengers and alternatives in conference to attend the annual meeting.

SECTION 4. In case of internal dissension in a church and two parties coming to the Association, each claiming to represent the church, neither party shall be seated until the question is decided as to which party is in union with the Association. The decision is to be made by a majority of the messengers present and voting.

ARTICLE VI. OFFICERS

SECTION 1. General officers of the Association shall be: Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Historian, Parliamentarian, and Assistant Parliamentarian. Program leaders shall be Sunday School Director, Church Training Director, Music Director, Chairman of Evangelism Committee, Seminary Extension Director, Chairman of Mission Committee, Director of Missions, Trustees, Pastor Conference President, Youth Director, Stewardship Director, Vacation Bible School Director, Woman's Missionary Union Director, Brotherhood Director, Deacons Chairmen, Senior Adult Director, Singles Ministry Director, and such other officers as the Association may desire to elect.

Associational representatives will be elected for the following institutions and agencies: (1) Truett Camp, (2) Baptist Children's Homes, (3) Baptist Hospital, (4) North Carolina Baptist Homes, Inc. (Homes for the Aging), (5) Biblical Recorder, (6) Christian Education, (7) Annuity Board and other representatives as may be deemed appropriate and elected in the Association.

SECTION 2. With the exception of the Director of Missions and Trustees, the terms of office for all officers of the Association shall be for one year with the privilege of continuing re-election. The Moderator and Vice Moderator shall not be eligible for re-election but one year in succession. (1) The number of Trustees shall be three. (2) The term of service should be for three years, with the term of only one expiring each year. In the first election of Trustees, the term of service for one should be three years, another two years, and the other one year. (3) Upon the expiration of term of service, the Trustee may or may not be re-elected for another term of three years.

Each term of office shall begin with the close of the annual session. The Associational financial year will run from January 1 through December 31.

ARTICLE VII. DUTIES OF OFFICERS

SECTION 1. The **Moderator** shall preside and maintain the order of all meetings of the Association and Executive Committee. He shall serve as ex officio member of all committees of the Association.

He shall appoint the Committee on Committees and all other committees pertinent to the operation of the body not named by the Committee on Committees in its regular report.

SECTION 2. The **Vice Moderator** shall assist the Moderator and preside in the absence of, or at the pleasure of the Moderator.

SECTION 3. The **Clerk** shall keep a complete and accurate record of all transactions; shall prepare a "Book of Reports" to be distributed to messengers at the beginning of each day's session of the annual meeting; and shall cause to be printed minutes concerning the records made.

The Clerk shall distribute to the clerk of each church in the Association blanks for the preparation of the church letter as soon as they are received from the State Convention. This form is to be returned to the Clerk of the Association not later than four weeks prior to the meeting of the body or by the deadline set by the Clerk and Director of Missions. All program reports should be returned by the same date.

An **Assistant Clerk** shall work with the Clerk in preparing the "Book of Reports," the annual minutes and the registration of messengers at the annual meeting.

SECTION 4. The **Treasurer** shall receive and dispense by order of the Executive Committee of the Association while in session, the money of the treasury and make a complete report at the Annual meeting and a current report at each Executive Committee meeting.

An **Assistant Treasurer** shall be elected to assist the Treasurer by request and to serve in the event the Treasurer resigns or is ill or unable to function.

SECTION 5. The **Historian** shall keep the records of the Association up-to-date.

SECTION 6. The **Parliamentarian** shall upon the request of the presiding officer of the body, advise and assist the Association with respect to all matters involving Parliamentary Procedure.

An **Assistant Parliamentarian** shall be elected. The Parliamentarian and Assistant should always communicate with each other to ensure that this office is filled at each Associational Annual or Executive Committee meeting.

SECTION 7. The **Program Leaders** and the **Institutional Agency Representatives** shall perform all duties customary to their titles and shall make a written report to the annual session of the Association.

SECTION 8. **Trustees** have no authority except by direction of the Association and are not personally bound by

signatures but are to be the legal signees for the Association. Trustees represent the Association in legal matters. Trustees act on behalf of the Association in acquisition and disposal of Associational property.

They sign all deeds of conveyance, execute all notes, bonds or mortgages, intervene in all suits, by authority of the Association.

All persons dealing with the Trustees, as Associational officers, may rely upon any written resolution duly adopted by the Association or Executive Committee, directing and authorizing the Trustees to act in its behalf and certified by the Association Moderator and Clerk.

ARTICLE VIII. RULES OF ORDER

The business of the Association shall be conducted according to Robert's Parliamentary Practice or in a manner not contrary thereto.

ARTICLE IX. QUORUM

The quorum for the Annual Associational meeting or any special called meeting of the Association shall not be less than 25 percent of the member churches.

ARTICLE X. THE EXECUTIVE COMMITTEE

SECTION 1. The Executive Committee shall be composed of the General Officers and Program Leaders elected by the Association and the Pastor and one member from each church in the Association. No Pastor, by virtue of his being an Associational Officer or Program Leader shall be disqualified as a member of the Executive Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

SECTION 2. It shall be the duty of the Executive Committee to act for the Association on matters arising when the Association is not in session and to make a report of all work to the next session of the Association. This body shall meet at a time and place designated by the Moderator on Monday following the first Sunday of each quarter except for the July quarter which shall meet on the second Monday of the month of July. Special meetings of the Executive Committee may be called by the Moderator with a one week notice to the churches.

SECTION 3. All vacancies occurring on committees or among elected officers shall be filled by the Executive Committee.

SECTION 4. In the event that a vacancy occurs with the Trustees, the Executive Committee should fill such vacancy for the remainder of the term.

ARTICLE XI. ASSOCIATIONAL STANDING COMMITTEES

SECTION 1. The Association shall have such standing committees as may be deemed necessary to promote efficiently the work of the Master in our midst. The terms of office for all committee members shall be for one year except where specifically stated otherwise.

SECTION 2. COMMITTEE ON COMMITTEES. It shall be the duty of this committee to nominate at the general meeting all standing committees as set forth under Article XI.

SECTION 3. THE NOMINATING COMMITTEE shall be composed of seven members. To this group the Directors of Sunday School, Discipleship Training, Woman's Missionary Union, Brotherhood and Music Ministry will be added.

It shall be the duty of this committee to nominate the Officers, Program Leaders and Institutional Agency Representatives. These nominees shall be notified in writing not less than one month prior to presenting of their names at annual session.

SECTION 4. THE ORDER OF BUSINESS COMMITTEE, composed of three members, shall plan the annual program of the Association and present it to the Executive Committee at its October meeting.

SECTION 5. THE CREDENTIALS COMMITTEE shall be composed of three pastors and two laymen. It shall examine applications of churches seeking admission into the Association in keeping with Article IV and make recommendation to the Association. It shall counsel with churches that are out of harmony of fellowship with the Association. It shall be responsible for registering messengers at the Annual Meetings."

SECTION 6. THE PLACE AND PREACHER COMMITTEE shall be composed of three members. The duties of this committee shall be to recommend the place or places for the following annual meeting and to recommend the preacher and alternate to deliver the annual sermon for the following year.

SECTION 7. THE RESOLUTIONS COMMITTEE shall be composed of three members. It is appointed by the Moderator at the October Executive Committee meeting. It shall be the duty of this committee to present suitable resolutions at the annual Associational meeting.

SECTION 8. THE MEMORIAL COMMITTEE shall be composed of three members. It shall be the duty of this committee to bring a report to the annual meeting of those listed by the member churches as deceased since the last annual meeting and shall lead a memorial service in their memory.

SECTION 9. THE STEWARDSHIP COMMITTEE shall be composed of six members including the Treasurer of the Association. This committee shall: (a) present a Budget to the Association for the following year; (b) devise plans for raising

the funds for the Associational Budget; (c) audit the finances and financial records of the Association annually and anytime there is a change of Treasurer or at the direction of the Association or the Executive Committee; (d) report all audits to the Annual Association Meeting.

SECTION 10. THE CONSTITUTION COMMITTEE shall be composed of three members and shall perform all duties specified in Article XV.

SECTION 11. THE ORDINATION COMMITTEE shall be composed of five designated Pastors and all other Pastors who desire to sit with the committee.

A. The committee serves on an advisory capacity only and serves at the request of the church from which the member is seeking ordination.

B. The committee should examine such candidates for the ministry as come before it as to their call and fitness for the gospel ministry and make such recommendations to the church as they feel led.

C. The committee should assist in arranging the proper service of ordination when such assistance is requested.

D. The Executive Committee should be informed regularly of the work of the committee.

E. Each church desiring to ordain a candidate is urged to consult with the committee, and shall give two weeks notice in which the committee is to do its work.

SECTION 12. THE EVANGELISM COMMITTEE. The duties of the committee shall be to direct and propose a perpetual program and spirit of evangelism in the Association. It shall arrange and direct all Associational-wide evangelistic activities.

SECTION 13. THE ASSOCIATIONAL MISSIONS DEVELOPMENT COUNCIL shall be composed of eight (8) members, nominated by the Associational Committee on Committees and elected by the Association at the annual meeting. The committee shall be: Missions Development Director, Promotion Director, Survey Director, Associational WMU Mission Action Director, Associational Brotherhood Director, Sunday School Outreach Director, Church Training Director, and Associational Deacons President. The Missions Development Director, Promotion Director, and Survey Director shall be elected for a three-year term, with one member named each year. The other five positions shall be filled by the person who is elected to fill those five Associational offices.

The duties of the AMDC are to lead the associational missions development in the five mission performance tasks: (1) call churches to be on missions; (2) train, develop, and encourage church and Associational workers; (3) provide resources and services to churches and leaders; (4) provide opportunities for working together in missions, ministry and growth; (5) establish and maintain appropriate communications and relationships with the community and the denomination.

SECTION 14. THE BUILDING AND GROUNDS COMMITTEE shall be comprised of three members. The committee shall be responsible for and in charge of the upkeep and repairs of the Associational building, grounds, and equipment.

SECTION 15. THE PERSONNEL COMMITTEE

A. The Committee shall be composed of 7 members of which 3 are pastors.

B. They shall recommend policies and procedures for the selection, supervision and termination of Associational staff personnel. Those policies and procedures shall be approved by the Association.

C. Prepare and maintain an organizational manual relation to the Association's staff personnel.

D. Develop and recommend to the association policies and procedures for paid and volunteer staff personnel.

E. Develop policies and procedures regarding continuing education and development for the Director of Missions and other Associational staff.

F. When a staff vacancy occurs, other than the DOM, they shall serve as the search committee. When a DOM vacancy occurs, they shall nominate a search committee and present it to the Executive Committee.

G. The Personnel Committee shall handle grievances as outlined in the grievance policy.

ARTICLE XII. THE ASSOCIATIONAL COUNCIL

The ASSOCIATIONAL COUNCIL shall be composed of the Director of Missions, the Moderator, the Vice Moderator, the Program Leaders: Sunday School, Discipleship Director, Woman's Missionary Union, Brotherhood Director, Chairman of Deacons, Missions Development Director, Chairman of Evangelism, Chairman of the Finance Committee, Vacation Bible School Director, Youth Director, Director of the Singles, Director of the Senior Adults, and Music Director. The Director of Missions is to serve as Chairman and a secretary shall be elected from the group.

The purpose of the council is to coordinate the planning of the various programs of the Association, to develop an Associational calendar, and to give mutual support to the various organization and program units in carrying out their assignments.

The council shall meet quarterly.

ARTICLE XIII. THE ASSOCIATIONAL PASTORS' CONFERENCE

The Associational Pastors' Conference provides regular meetings for the Baptist ministers of the Association. The purpose of the conference is for fellowship and mutual support, for doctrinal and professional discussion and for promotion of church, Associational and other denominational programs. The conference is not an administrative or executive body.

ARTICLE XIV. JOB DESCRIPTION, DIRECTOR OF MISSIONS

SECTION 1. Title and Functions.

A. Position Title. This position shall be known as the Director of Missions for the Tuckaseegee Baptist Association.

B. Basic Functions. The Director of Missions shall serve as minister to the churches and church leaders of the Tuckaseegee Baptist Association, as mission strategist for the Association, as chief administrative officer for the Association, and as a general leader of the Association.

SECTION 2. Responsibilities.

A. Minister to Churches and Church Leaders.

1. The Director of Missions shall serve as pastor to the pastors of the Association. Upon request, the Director of Missions shall provide counseling and consultation for pastors regarding spiritual, vocational, congregational, personal or family concerns. The Director of Missions shall be available to assist pastors considering a move, shall orient new pastors to the Association, shall develop systems of pastoral support and fellowship, and shall provide growth opportunities for pastors.

2. Upon request, the Director of Missions shall assist and counsel pastors and church leaders regarding ministries, programs and procedures within the churches, including but not limited to building planning, budget procedures, long range or strategy planning, curriculum evaluation or review, issues of church policy and organization, church-community surveys, outreach, and spiritual growth.

3. Upon request, the Director of Missions shall assist and counsel churches regarding the calling of pastors or church staff, conflicts between a pastor and church, or conflicts within a church's fellowship. The Director of Missions shall assist churches without a pastor in their ministries and programs at their request and shall provide advice for persons considering a Christian vocation.

4. The Director of Missions shall be available upon request to preach or teach in and for churches on such occasions as revivals, pulpit supply, study courses, stewardship or missions emphasis, promotion or recognition assemblies and services, special day addresses, Vacation Bible School, and similar events.

5. The Director of Missions shall take the initiative to regularly visit churches for worship and fellowship, taking care to treat all churches as equal partners in the Association.

6. The Director of Missions shall develop opportunities to foster fellowship and mutual commitment between and among the churches.

B. Mission Strategist.

1. The Director of Missions shall encourage churches to develop and maintain a missions perspective and to extend their ministries and outreach beyond the local church field and community through broader involvement and cooperation with other churches in missions activities.

2. The Director of Missions shall interpret to the churches the needs of persons and groups within the Association's area and shall lead the Association to start new churches or ministry activities appropriate to the needs.

3. The Director of Missions shall encourage and lead volunteer involvement in mission activities beyond the Association's boundaries, such as home and foreign missions partnerships and disaster relief.

4. The Director of Missions shall interpret to the Association the mission work of the churches and conventions of the denomination at the state and national levels and shall encourage churches to support such work with their prayers, finances and personal commitment.

C. Chief Administrative Officer.

1. The Director of Missions shall administer all policies and instructions committed to that office by the Association in annual session or by the Executive Committee.

2. The Director of Missions shall work with the Executive Committee to plan, organize, coordinate, communicate and evaluate the total work of the Association.

3. The Director of Missions shall work with and assist Associational officers, committees and program leaders to implement the specific objectives of the Association and to communicate these activities to the churches and encourage their involvement.

4. The Director of Missions shall serve as an ex officio member of all committees and program departments of the Association.

5. The Director of Missions shall publish a regular Associational news medium to promote the work and fellowship of the Association among the churches and shall otherwise communicate with the churches as required.

6. The Director of Missions shall supervise the Associational office staff and any volunteers or other paid employees, full or part time, who are directly involved in ministries or activities sponsored by the Association.

7. The Director of Missions shall act as office and property manager and purchasing agent for the Association in all matters not assigned to the Trustees of the Association.

D. General Leader of the Association.

1. The Director of Missions shall interpret the work of the Association in the churches.

2. The Director of Missions shall maintain relationships with pertinent Baptist conventions and bodies, and especially with those denominational offices charged with Associational development and support, informing those bodies of the needs and potentialities in the Association and interpreting the overall work of the denomination to the churches.

3. The Director of Missions shall relate to other Christian and service organizations, such as local relief and assistance groups, hospital chaplaincy programs, groups that minister to the homebound or terminally ill, ministerial conferences or support groups, and similar organizations, as appropriate.

4. The Director of Missions shall relate to and represent the work of the Association to various business, social, educational, governmental and civic groups.

5. The Director of Missions shall act as chief public relations and information officer for the Association, promoting its work to the general public through the various communications media and responding to inquiries and requests for information as required.

SECTION 3. Terms of Employment.

A. Employment. The Director of Missions is employed by the Tuckaseegee Baptist Association.

B. Call, Termination and Interim.

1. A person shall be called to the office of Director of Missions according to the following procedures:

a. When a vacancy occurs in the office of Director of Missions, the Personnel Committee shall nominate a search committee to be elected by the Executive Committee. Election of the search committee shall take place within 30 days of the occurrence of the vacancy. If a regular meeting of the Executive Committee is not scheduled within 30 days, a special meeting shall be called by the Moderator. Executive Committee members shall be given two weeks' written notice of the names of the nominees to serve on the search committee and the date, time and place of the meeting.

b. Once elected, the search committee shall solicit and screen candidates according to qualifications and procedures which the committee shall determine. The search committee shall recommend and present one candidate for election by the Association.

c. Election of the candidate by the Association shall take place within 30 days of the search committee's decision to recommend. If the annual session of the Association is not scheduled within 30 days, a special session of the Association shall be called by the Moderator. The Association shall be given two weeks' written notice of the name of the candidate and the date, time, and place of the meeting.

d. Election of the candidate shall be by majority vote. If the candidate fails to receive a majority vote, the search committee shall be immediately dissolved and the Personnel Committee shall begin the process over again.

2. The term of service of the Director of Missions shall be indefinite. Employment of the Director of Missions may be terminated according to the following procedures:

a. The Director of Missions may resign by giving written notice 60 days in advance. The resignation may be accepted on behalf of the Association by the Executive Committee in regular or called session. By mutual agreement of the Director of Missions and the Executive Committee, the period of 60 days' notice may be waived.

b. The Director of Missions may be involuntarily terminated by the Association in annual or called session.

(1) No final action to terminate the Director of Missions shall occur unless both the Director of Missions and the Association have endeavored to resolve any existing conflict by lesser means. In addition, no final action to terminate the Director of Missions shall occur without prior investigation by the Personnel Committee according to established grievance procedures. The Personnel Committee shall then make a report of its findings to the Association. The Association shall consider, but shall not be bound by or required to follow, the recommendations of the Personnel Committee. If such an investigation and report has not occurred, any action to terminate the Director of Missions shall be referred to the Personnel Committee for investigation before final action is taken.

(2) Action by the Association to terminate the Director of Missions, whether in annual or called session, shall require 30 days' written notice to the Association following completion of the Personnel Committee's investigation. Action to terminate shall be by majority vote.

(3) If the Association in session votes to terminate, the Director of Missions shall receive full pay and benefits for a period of 60 days following the effective date of the termination.

3. When a vacancy occurs in the office of Director of Missions, the Executive Committee may elect an Interim Director of Missions according to the following procedure:

a. The Personnel Committee shall recommend a candidate, negotiate terms of employment, and present the recommendations to the Executive Committee for approval. Such election may take place at the same time and in the same manner as election of the search committee, or at any other appropriate time.

b. The Personnel Committee shall supervise the work of the Interim Director of Missions. Authority to extend, terminate, or otherwise change the terms of employment of the Interim Director of Missions shall be retained by the Executive Committee.

C. Accountability.

1. The Director of Missions shall be supervised by the Personnel Committee acting on behalf of the Association.
2. The Personnel Committee shall arrange for an annual evaluation of the Director of Missions.
3. The Personnel Committee shall establish a grievance policy to provide an orderly and appropriate process to hear grievances and complaints against the Director of Missions by members or churches of the Association.

D. Pay and Benefits.

1. Salary, retirement, insurance and other financial benefits for the Director of Missions shall be proposed by the Budget and Finance Committee and established by the Association in the annual budget. The Budget and Finance Committee shall solicit recommendations concerning pay and benefits for the Director of Missions from the Personnel Committee, but shall not be bound to accept those recommendations.

2. Travel allowance for the Director of Missions shall be deemed by the Association to be a business expense and not a personal benefit for the Director of Missions.

3. The Director of Missions shall receive two weeks paid vacation annually. The period of two weeks shall incorporate ten working days, including two Sundays. Unused vacation shall not accrue to the following year.

4. The Director of Missions shall receive sick leave at the rate of one day per month, accruing on the first day of the month, not to exceed 120 working days. Additional sick leave may be credited against future months. If the Director of Missions is involuntarily terminated by the Association, any unused sick leave accrued shall be financially reimbursed to the Director of Missions in addition to the 60 days' pay and benefits required by the act of termination.

5. The Director of Missions shall be granted one day off each week in addition to Saturday.

6. The following holidays shall be observed: New Year's Day, Easter Monday, Memorial Day, July 4, Labor Day, Thanksgiving Thursday and Friday, and December 25 and 26 at Christmas.

7. The Association acknowledges the flexibility of schedule required by the Director of Missions. The Director of Missions' time shall be organized in a professional manner, with the work schedule devoted to activities that will benefit the work of the Association, whether in the office or on the field and whether during the normal work day or at night. The Director of Missions shall establish office hours for the office secretary and shall be available, either through personal office hours or some other established procedure, to any in the Association needing assistance.

8. The Director of Missions may attend denominational conventions and meetings, continuing education and professional development events, and other assemblies and conferences pertaining to the work of the office. The Association through its annual budget may reimburse the Director of Missions for expenses incurred while attending such meetings.

9. The Director of Missions may use up to three weeks of paid leave annually to lead or participate in revivals, world missions conferences, and similar meetings outside the Association, which result in an honorarium or other reimbursement above and beyond expenses. The Director of Missions may lead revivals and conferences within the Association as schedule permits, such activities being included in the job responsibility of minister to the churches of the Association.

10. The Director of Missions may serve as interim pastor of a church or churches in the Association. Such activity may not exceed three months in a given calendar year without prior approval of the Personnel Committee. The Director of Missions may engage in pulpit supply and similar activities as schedule permits, such activities being included in the job responsibility of minister to the churches of the Association.

11. The Director of Missions may lead or participate in mission trips, mission partnerships, disaster relief, and other direct mission opportunities outside the Association, such activities being included in the job responsibility of mission strategist for the Association. Such activities may not exceed three weeks in a given calendar year without prior approval of the Personnel Committee.

12. The Director of Missions shall keep a record of leave and time spent off the Associational field, including vacation, sick leave, conventions and conferences, continuing education events, revivals and similar meetings, and mission trips. The record shall be submitted to and maintained by the Treasurer of the Association.

13. The Director of Missions shall be free to use off duty time to engage in personal activities and pursuits. Such activities shall not interfere with the professional responsibilities or activities and meetings that require the presence of the Director of Missions. The Director of Missions shall be aware that all personal activities reflect on the office and the job responsibility of general leader of the Association.

14. No honorarium shall be expected or required for any service performed by the Director of Missions in conjunction with official duties. However, any individual, group or church is free to present an honorarium if they so desire, and such may be retained by the Director of Missions and not submitted to the Association.

SECTION 4. Adoption.

A. This job description supersedes, repeals and takes the place of any conflicting articles or statements in this Constitution or other documents of the Association.

B. The Personnel Committee shall be responsible to maintain, update and revise this job description as required, making recommendations to the Association for approval as they are needed.

ARTICLE XV. AMENDMENTS

The constitution may be amended at any annual meeting of the Association by a two-thirds majority of the messengers present and voting, provided the amendment has been presented to the Constitutional Committee at least 10 days prior to the annual meeting and presented to the Association in printed form on the first day of the annual meeting to be voted on the second day.

ARTICLE XVI. NON-PROFIT STATUS

The Tuckaseegee Baptist Association, Inc. is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the Tuckaseegee Baptist Association, Inc. shall inure to the benefit of its' members, directs, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

In the event of dissolution, the residual assets of the Tuckaseegee Baptist Association, Inc. will be turned over to one or more organizations with similar purposes which are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986.
