



Dedicated in Honor of Lloyd Vernon Fish, Jr.

The 2015 Annual Minutes are dedicated in honor of Lloyd Vernon Fish, Jr. Lloyd was born on September 18, 1943, at the Haywood County Hospital in Waynesville. He grew up in the Spring Creek Community of Madison County. Lloyd's life was one of a very humble beginning. The family – parents and 4 children – lived in a 2-room log house. In sharing his testimony about his growing up years, Lloyd has shared of a barrel for a heating stove and of his dad putting pieces of old tires on his shoes for soles.

Lloyd grew up in the Ball City Baptist Church on Spring Creek where he made his profession of faith and received Jesus Christ as his Lord and Savior at the age of 11. In 1960 at the age of 16, Lloyd rededicated his life to Jesus Christ. Out of that rededication he heard God's call to preach. He was licensed by the Ball City Baptist Church on July 23, 1961.

Lloyd graduated from high school in 1961. With no money for college, but with the certainty of God's call upon his life, Lloyd enrolled at Fruitland Baptist Bible College that year. In 1964, Lloyd graduated from

Fruitland in the top one-third of his class. While a student at Fruitland, Lloyd was ordained to the Gospel ministry by the Ball City Baptist Church on June 24, 1962.

Lloyd married Linda Rathbone of Haywood County on August 3, 1963. To their family two children, Angela Denise and Timothy Lane, were born.

Lloyd's ministry began with bi-vocational pastorates. In 1965, he was called to his first full-time pastorate at the Shoal Creek Baptist Church in Whittier. Later in the 1960's, Lloyd was called to his second full-time church – Buff Creek Baptist Church, also in Jackson County.

In his 43 years of full-time ministry from 1965-2008, Lloyd pastored churches in Jackson, Haywood and Macon Counties (37 years), served as a Director of Missions (1 year) and worked with the Baptist Children's Homes of North Carolina as Director of Planned Giving (2 years) and as the BCH Western Area Director (3 years). During his time of full-time ministry, Lloyd enrolled at Mars Hill College (now University) and graduated cum laude with a Bachelor's Degree in Religion in 1982. He also completed some graduate work toward a Master's Degree in Religion.

Following retirement as a full-time pastor in 2008, Lloyd has served as interim pastor in 8 churches. He currently serves as interim pastor of the Buff Creek Baptist Church, a position he has held since April of this year.


Lloyd has held places of leadership at the associational, regional and state levels throughout his ministry. Currently he serves on the Public Relations Board of Angel Community Hospital and on the Steering Committee for a new cancer treatment center in Franklin.

Throughout his ministry, Lloyd has been active in the community in various ways. Currently, he is on the Angel Medical Center Community Board.

In 2010, Lloyd published a book, ...And Then The Spirit Spoke!, a celebration of the joy, peace, warmth, victory and direction that comes when our life is as open to God as the beach is for whatever the tide brings in!

Lloyd and Linda currently reside at 324 Mashburn Street in Franklin. During his spare time, Lloyd's personal hobbies are fishing, fly-tying, gardening and woodcarving.

This humble servant of God who first said an "eternal yes" to Jesus more than 60 years ago has blessed countless lives with his ministry as he has called people to follow Jesus and be a "voice of hope, a face of grace and a sawdust servant" to a world that is lost and without hope aside from Jesus Christ.

PROCEEDINGS 186th ANNUAL MEETING FIRST SESSION, THURSDAY, OCTOBER 15, 2015

- 1. Webster Baptist Church hosted the first session of the 186th Annual Meeting of the Tuckaseigee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 101 present: 85 Messengers and 16 visitors representing 21 churches.
- 2. Rev. Mike Moore, Vice Moderator, welcomed everyone
- 3. Rev. Scott Carter welcomed everyone to Webster Baptist Church. He read scripture and opened with prayer. Rev. Jeff Pate and Matt Cowan of Webster Baptist Church provided special music.
- 4. Rev. Jason Buchanan brought the message from Ephesians 3:14-21. He then had the pastors and others gather around the altar to pray.
- 5. The 186th Annual Meeting was called to order by Rev. Mike Moore, Vice Moderator.
- 6. The agenda was approved after the Missions/Evangelism Committee was added and Unity's Mission Report was removed.
- 7. Rev. Brandon Lewis of Wilkesdale Baptist Church was recognized as a new pastor in the association.
- 8. Grace Morris, music director, led the congregation in singing, "Brethren We Have Met to Worship".

REPORTS

- 9. <u>Director of Missions</u> Rev. Gerald Morris gave his report as Director of Missions. It was located on page 3 and 4. He also added that the land inherited from the Wall Estate had been sold on October 14th.
- 10. <u>Music</u> Grace Morris gave the Music report listed on page 5.
- 11. <u>WMU</u> Lee Lillard presented the WMU report on page 6. She started by reminiscing about how just a couple of years before that she and Steve had sat there in only one of the pews with their youth at Webster Baptist Church at a youth rally. She got to know Gerald for the first time and it led to her going to Book Link and getting to know Ms. Virginia Pangle and leading to do missions. God is doing a lot through them.

COMMITTEES

12. Annual Meeting Committee

<u>Memorials</u> - Laura Brown and Virginia Pangle said the minutes will be dedicated this year in honor of Rev. Lloyd Fish and in memory of Bob Parker of Lovedale Baptist Church. Descriptions of these two people are at the front of this book. Laura and Virginia also read the names of members from each church that had passed away during the past year. Rev. Mike Moore led in prayer.

<u>Place and Preacher Committee</u> – Dennis Proffitt presented the Place and Preacher report for the 2016 meetings on page 13. It was voted on and approved.

- 13. <u>Stewardship</u> Rev. Mike Moore presented the proposed 2015-2016 budget to be voted on during the second session. The budget was on page 7.
- 14. <u>Nominating Committee</u> Arnold Brooks presented their report on page 11. No further nominations were made and the Nominating Committee List was approved.
- 15. <u>Doctrinal Committee</u> Rev. Clemmey Queen read a letter from Shoal Creek Baptist withdrawing from the Tuckaseigee Baptist Association. It is included in the Book of Reports. It was voted to accept this withdrawal. He also moved that Big Ridge Baptist Church no longer

be part of the association since they are no longer meeting and a Nondenominational Church is using their church building. This was also approved.

- 16. <u>Missions/Evangelism Committee</u> Rev. Jason Buchanan presented a motion from their committee to give Michael Farmer and Michelle Pippio \$500 each for a medical missionary trip in November 2015. Annie Hoyle Endowment Funds would be used. This was approved. Gerald also reported that the Missions/Evangelism committee is discussing guidelines and an application process for awarding mission trip funds.
- 17. <u>Miscellaneous Business</u> Mike reported there were 85 messengers and 17 visitors present representing 21 churches on Thursday. (This is a little different after Gracella got back to the office and compared more carefully all the attendance sheets.)
- 18. Grace Morris led the congregation in singing, "When We All Get to Heaven".

MISSIONS

- 19. <u>Scotts Creek</u> Frankie Harris spoke about their fourth annual OperationInAsMuch day they conducted on May 2, 2015. They did local missions within a five-mile radius of the church. Over half of the church participated in some way with the mission projects. 1) In Remembrance: They were able to visit and take the Lord's Supper to five of their homebound members. 2) Act of Reaching out to hurting People: They took big plastic tubs of snacks to the ICU, dialysis center and cancer center. 3) Showed appreciation to People who serve in our community: Took water and goodies to the EMS, Sheriff's Dept., Sylva Fire Dept., Balsam Fire Dept., and Sylva Police Dept. 4) Act of Brightening Someone's Day: Took 275 bright goodie bags Scotts Creek Elementary School, The HUB, Heritage Christian Academy, and Morning Star. 5) Took bird feeders and flower arrangements to some people also. It was a day given to the Lord to reach the community with God's love. In 2016 it will be on April 30 and May 7. It can make a big impact in your community.
- 20. <u>KY Raceway Ministry</u> Tuck Brown from Calvary Baptist Church spoke about the Associational mission trip to KY. He showed pictures and said the theme verse was Philippians 4:13. Rev. Avery, Laura and Tuck Brown from Calvary Baptist, Rev. Gerald, Gracella, Grace and Will Morris, Kim, Jacob, and Jared Fiskeaux and Callie Ledford from Ochre Hill Baptist Church went. They lodged at Gracella's sister's house. They spent two days at the track passing out Bibles and other materials. They worked in the KIDS Fun Zone where children could do games and other activities. Tuck encouraged kids to race hot wheel cars on a track.
- 21. <u>Jackson County Backyard Bible School</u> Lee Lillard spoke about the vision, prayer, plan, advertising and sponsors for the Jackson Co. Backyard Bible School. 25 churches and 200 participants worked together to share the Gospel to the unreached in our backyard. The Gideons presented each child a New Testament. There was Bible Study, games, music, crafts and food. She hopes to see you next year!
- 22. Dennis Proffitt did the benediction prayer.

SECOND SESSION, FRIDAY, OCTOBER 16, 2015

- 1. Buff Creek Baptist Church hosted the second session of the 186th Annual Meeting of the Tuckaseigee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 91 present: 69 Messengers and 22 visitors representing 17 churches. There was a total of 21 churches represented for both nights.
- 2. Chuck Norris, Moderator, welcomed everyone and called the meeting to order.
- 3. Rev. Keith Dean thanked everyone for their prayers and monetary help during his long stay in the hospital this past summer.

- 4. Rev. Lloyd Fish welcomed everyone to Buff Creek Baptist Church and quoted scripture and led a guided altar prayer.
- 5. One Accord sang several songs for special music.
- 6. Grace Morris lead the congregation in singing "Amazing Grace".

REPORTS

- 7. <u>Book Link WNC</u> Rev. Gerald Morris requested prayers, Christian literature, Bibles, volunteers, and money for shipping the Christian materials overseas.
- 8. The Gideon's International Were not able to present.
- 9. **Jackson County Bible Club** Rev. Steve Alexander presented the need for volunteers to work with Bible Club. It is being held at Cullowhee Valley Elementary, Smokey Mountain Elementary, Scotts Creek Elementary, and a helper was needed at Fairview so they could start again this year.
- 10. <u>NC Baptists on Mission</u> Gary Holland, Director of Missions of the Macon Baptist Association, said there is 17 different ministries to be involved in with the NC Baptist Men. He started out in the Disaster Relief in 1994. Currently volunteers are needed to do mud outs and feed people after Hurricane Joaquin caused so much flooding in much of Columbia, Charleston and scores of cities and towns across southeastern North Carolina and most of South Carolina. They will be helping to rebuild in the future also.
- 11. <u>Smoky Mountain Pregancy Care Center</u> Lynne Johnson said that it is a life affirming organization located close to WCU. She actually goes on campus 3 hours a week in front of the University Center to reach the students. The office is open 3 days a week from 10-4:00. They have an ultrasound machine on the premises. They need financial help to keep the office open and volunteers. Items can also be donated for the Earn While You Learn Program. Another way to help is do a Baby Bottle Campaign in the church. Collect change or other monies in a baby bottle and donate it to SMPCC.
- 12. <u>Southeastern Baptist Theological Seminary</u> —Chris Allen was scheduled to come and speak. However, due to a fatal wreck on I-26, he was stuck in traffic and unable to get there.
- 13. <u>Baptist Children's Homes of NC</u> –Rev. Lewis Smith encouraged the churches to show the Thanksgiving Offering video at their churches. There are currently 20 locations. He did a historical summary of how the Baptist Children's Homes was started 130 years ago.
- 14. Grace Morris led the congregation in singing, "Solid Rock".
- 15. Chuck reported that there were 69 messengers, 20 visitors and 18 churches represented on Friday. (This is a little different after Gracella got back to the office and compared more carefully all the attendance sheets.)

MISSIONS

- 16. <u>Vermont</u> Grace, Gracella, Will and Gerald Morris reported on the Associational Mission trip to St. Johnsbury, VT to work in the Mustard Seed Soup Kitchen and Thrift Store. It was from July 24- Aug. 1. They also asked everyone to pray for the church plant started in the Soup Kitchen. Joyce Green (Greens Creek), Dianne Cochran (Scotts Creek), Elizabeth Buchanan (Long Branch), Gerald, Gracella, Grace and Will Morris (Ochre Hill) participated.
- 17. <u>Deep Impact Missions (Ochre Hill and Buff Creek)</u> Jacob Fiskeaux presented pictures and spoke about their youth trip to Shelby, NC. They participated in a sports camp, VBS, and Life Enrichment Center. 6 people were saved. There were also wonderful times of worship in the evenings.
- 18. Larry Madden (NAMB) Was unable to speak because his mother was in the hospital.

COMMITTEES

- 19. <u>Stewardship Committee</u> Rev. Mike Moore moved that the 2015-2016 budget on page 7 presented the previous session be approved. It was approved. He pointed out that the association finished in the black for the past year.
- 20. **Resolutions Committee** David Dalton presented the following resolution:

Whereas Chuck Norris and Rev. Mike Moore have so capably presided over these sessions and other meetings, and

Whereas our Director of Missions, Rev. Gerald Morris, has brought wise leadership that strongly promotes missions and unity, and

Whereas, our committee officers and members have given of time and energy to serve the association well. Be it resolved that we extend sincere appreciation to all who have served to honor our wonderful Savior Jesus Christ. Bro. Executive Committee Report Gracella Morris, Clerk

October 6, 14, 2014 The quarterly meeting, of the Tuckaseigee Baptist Association was called to order by Chuck Norris, Moderator and was held at the Baptist Center. There were 15 executive committee members with eight churches represented. Rev. Jason Buchanan led the group in prayer after prayer requests. Grace Morris led the group in singing "Are You Washed in the Blood". Rev. Lloyd Fish of Lighthouse Baptist had the devotion. The July 14, 2014 executive committee minutes were presented in the Book of Reports and approved. The October through September 24, 2014 financial statement was presented in the Book of Reports and approved.

Rev. Gerald Morris presented his quarterly Director of Missions report. He had the privilege to teach at Rockdale Baptist's Vacation Bible School Adult class. They had a great attendance and a wonderful time learning about how God wants to use us to make disciples. Gerald also got to go on two mission trips. One was for a week to Wheeling, WV with Ochre Hill Baptist Church. While there they worked in two VBSs, a soup kitchen, did light construction and worked with the Salvation Army. 3 people came to know the Lord. He led a second mission trip to BookLink in Eubank, KY. They were able to pack and process over 100 boxes to be shipped overseas.

Gerald led a group of 8 people to the Creation Museum in Northern Kentucky. They spent two days touring a wonderful facility that teaches one message, God created everything in six literal days a few thousand years ago. He also reported that he was able to give the organ to the pastor of Lincoln Street Baptist Church in Greenville, SC. It will be returned to working order and used in the church. As a reminder that the world has come to our doorstep, he shared about the opportunities to witness to a Buddhist, a Wiccan, and four Muslim men here Jackson County. He encouraged everyone to keep their heart open to the opportunities that God is sending their way. The Baptist State Convention of NC has made available to all of the churches a new ministry tool called MissionInsite. It is a wonderful free demographic tool that can give your church detailed information about the people living near you.

The Annual Children's Rally was a great success. The "3Ms" performed Gospel Illusion and music and Pastor Lloyd Fish led the children in devotion about how we are all wonderfully made. We had several churches participate and about 50 children attended. The Migrant Ministry is off to a great start with two trips. The first one was at a packing house in Franklin, NC to reach the workers that live there and work in Jackson County. At least one man was saved. At least seven churches were represented that night with many more helping in other "behind the scenes" ways. The Hispanic churches of the Jackson and Macon Counties have begun to work out a plan to start Bible studies in these camps as follow up to the gatherings. The fourth annual Campus Prayer journey was a success even though turnout was down this year. Approximately 81 people gathered at all the schools to pray for faculty, staff and students.

He reported 14 visits to churches, 9 preaching and 17 meetings. The association received a grant for \$1,000 from the North Carolina Baptist Foundation to purchase a sno cone, popcorn, and cotton candy machines with supplies. This will be loaned to churches for outreach events.

Old Business:

- The Wall Estate Property is still not sold.
- It was approved to present the changed Proposed By Laws at the annual meeting on Thursday, Oct. 16, and be voted on the next day. The proposed By Laws have been mailed to each church and presented at this meeting and July's Executive Committee Meeting. There was no discussion.

New Business:

• It was approved to change the beginning time of the executive committee meeting to 7:00 p.m. each quarter instead of 7:30 p.m.

Rev. Mike Moore led the group in closing prayer.

January 5, 2015 The quarterly meeting, of the Tuckaseigee Baptist Association was called to order by Chuck Norris, Moderator and was held at the Baptist Center. There were 21 executive committee members with ten churches represented. Roy Young led the group in an opening prayer. Grace Morris led the group in singing "The Solid Rock". Rev. Tim Reeves of Hyatt's Chapel Baptist Church had the devotion. The October 6, 14, 2014 executive committee minutes were presented and approved. The October through November 30, 2014 financial statement was presented and approved.

Rev. Gerald Morris presented his quarterly Director of Missions report. The annual meetings in October were a great time of worship and fellowship. The messengers voted on two important votes: The first being a resolution to stand against homosexual marriage. The response he has personally had has been all positive. Several people have approached him in public and thanked the Association for their stand on the issue. The second vote was to change the By-laws of the Association to streamline the committee structure to better efficiency. The finances of the Association have improved some with churches increasing their giving and others taking up special offerings. He encourages everyone to pray that the Wall Property on NC 107 would sell. In October they reached out to the second Migrant Camp in Glenville with food, fellowship, and the Gospel. The Hispanic churches in the area are now formulating a plan to begin Bible studies with the migrants while they are in the area each year. A few men were saved.

The work to start a BookLink chapter here in Jackson County is progressing. We now have a small building to process the material and ready it for shipping. At this time, this ministry is a separate entity from the Association that Gracella and Gerald are working on. It will take about 50 cents per pound to process and ship the material. Help is needed to sort and pack the materials that are received.

Gerald reported 12 visits to churches, 14 times at 8 churches preaching and 10 meetings.

Betty Dean, WMU Director, reported that the "Now I Lay Me Down to Sleep" project to collect bedding materials for the North Carolina Baptist Children's Home was a success. They wanted to thank everyone for their help with their need. The following churches contributed: Locust Field, Scotts Creek, East Fork, Long Branch, New Hope, Greens Creek and other. The WMU is asking churches for a donation to go to the Heck Jones Offering.

New Business:

• It was approved to send \$1,000 Annie Hoyle Funds to the La Primera Iglesia Bautista de Amor for a mission trip to Mexico. Rev. Felix Villarreal from La Primera Iglesia Bautista de Amor and Karen Burnette from Faith Baptist Churches are participating in this mission trip from March 7-15, 2015.

A time of announcements and prayer requests was held. Rev. Mike Moore led the group in closing prayer.

April 6, 2015 The quarterly meeting, of the Tuckaseigee Baptist Association was called to order by Chuck Norris, Moderator and was held at the Baptist Center. There were 18 executive committee members and two visitors with nine churches represented. Rev. Clemmey Queen led the group in an opening prayer after taking prayer requests. Grace Morris led the group in singing "Leaning on the Everlasting Arms". Rev. Jason Buchanan of Locust Field Baptist Church had the devotion. Rev. Brandon Lewis, new pastor of Wilkesdale Baptist Church, was recognized as a new member. The January 5, 2015 executive committee minutes were presented and approved. The October 2014 through March 31, 2015 financial statement was presented and approved. Gracella reported that the Hispanic class that meets on Saturdays at the Baptist Center built the two handrails for the Baptist Center. They only charged for the materials (\$88.57).

Rev. Gerald Morris presented his quarterly Director of Missions report. He was able to briefly visit with two host churches during the spring singing. It was a great time of worship and fellowship. He reported that Cashiers had sponsored a Chili cook off between the pastors to benefit the Association. 10 pastors entered chili and 85-90 people came sampled the chili, donated money and had a great time visiting with each other. Over \$1900 was raised for the work of the Association (\$2,010.54 is total after check received that night). The response of the churches and people to help close the budget gap has been great. With the money from the chilli cookoff, love offerings and increases in regular contributions, the financial situation looks better than it has since I began serving. Hopefully, by the end of the May emphasis on the Alton Hooper memorial offering, the Association will be able to end the year in the black.

His quarter has been filled with several meetings to make plans for this summer and fall. The Mission/Evangelism committee met and discussed plans for mission opportunities this summer. This year they

will be offering three mission trips of varying lengths along with local missions opportunities. The first, and shortest, trip is to Book-Link Int. in Eubank, Ky. People will be gone June 19-20 to help them sort, pack and wrap boxes of literature for shipment overseas. The second trip will be to serve at the Kentucky Raceway July 9-11. People will be mainly working at the children's tent but may be asked to serve in other areas as needed. The third, and longest, trip planned will be to Vermont. People will be going to assist NAMB church planters in this very unchurched state. He also encouraged churches to participate in Operation Inasmuch to do local missions. This is a one day local missions' blitz into your church's community to share Christ through service. He has a list of ideas of how you can reach your neighbors with the Gospel.

Something new this year in the works is a Global Mission Conference coming in September. Expanding on the one night missions' conference that we have had in the past, multiple churches will host missionaries for services from Sunday morning to Wednesday night (five services). The format is similar to a revival with a different missionary speaker each night in the host church. Host churches are still needed. Ginger Patrick from Cashiers Baptist Church shared about her experiences of a Global Mission Conference when she was an International Missionary. It is a great way to hear about how our Lottie Moon Christmas Offering dollars are being spent to support the missionaries in the field.

In May the Association will have the annual National Day of Prayer at the Justice Center on May 7th. In preparation for this event, the State Convention is holding Prayer Walking Training at Lighthouse Baptist Church April 28th with Chris Schofield, prayer coordinator for the Baptist State Convention.

Gerald reported 15 visits to churches, preaching 6 times at 5 churches and 10 meetings.

Betty Dean, WMU Director, reported that their Annual Associational WMU meeting will be on April 9th hosted by Lovedale Baptist Church. It will start with a salad supper at 6:00 and the program will begin at 7:00 p.m. On April 12 Lovedale will also be hosting a retired missionary couple (The Hinsons) to speak about their missionary experiences.

Old Business: \$1,000 from Annie Hoyle Funds was sent to La Primera Iglesia Bautista de Amor for its combined mission trip to Mexico with Faith Baptist. Over 100 people were saved.

New Business:

- It was approved to spend up to \$350 of Annie Hoyle Funds on transportation costs for an Associational mission trip to Book Link International in Kentucky.
- It was approved to spend up to \$475 of Annie Hoyle Funds on transportation costs for an Associational mission trip to work with the Kentucky Raceway Ministries on July 9-11.
- It was approved to spend up to \$1,300 of Annie Hoyle Funds on transportation costs for an Associational mission trip to Vermont.
- It was approved to send \$1,000 of Annie Hoyle Funds to the Ochre Hill Baptist Church for a mission trip to Shelby, NC to do construction and/or sports camps. The youth from Ochre Hill Baptist and Buff Creek Baptist Churches are participating in this mission trip from July 20-24, 2015.

Rev. Brandon Lewis led the group in closing prayer.

July 13, 2015 The quarterly meeting, of the Tuckaseigee Baptist Association was called to order by Chuck Norris, Moderator and was held at the Baptist Center. There were 20 executive committee members and one visitor with eleven churches represented. Rev. Jason Buchanan led the group in an opening prayer after taking prayer requests. Chuck led the group in singing "Nothing But the Blood". Rev. Brandon Lewis of Wilkesdale Baptist Church had the devotion. No new members were present. The April 6, 2015 executive committee minutes were presented and approved. The October 2014 through June 30, 2015 financial statement was presented and approved.

Rev. Gerald Morris presented his quarterly Director of Missions report. In April we served as a collection point for the Broyhill Food Drive. He enjoyed watching as the food came in from many of our churches and several individuals. The youth from Scotts Creek and New Savannah came to help sort and pack the donated items. Volunteers hauled the collection to Broyhill. The National Day of Prayer event held each year in front of the Justice Center was attended by the "faithful few. The first week of May saw churches throughout the county participating in Operation Inasmuch. This one day missions blitz was designed to motivate people to move out of the pews and into their community. Each church did a variety of projects to reach their community. He said

that he and Gracella have been working hard to iron out the details for three mission trips to various parts of the US. In June a group of eight people from four churches went to Book Link in Eubank, Ky. The next shipment is destined to be shipped to Zimbabwe very soon. Eleven people from two churches just returned from the second trip to the Kentucky Speedway to help the 200 strong KY Raceway ministry witness to over 100,000 race fans and Speedway employees over the weekend. They worked in the "Kids Zone" and throughout "Vendors' Row" (just outside of the track) passing out New Testaments to race fans and event staff. Four churches baked homemade cookies to send them. The third mission trip is planned for the last week of July. They are planning to go to St. Johnsbury, Vermont to work in a soup kitchen and thrift store. Gerald has also been meeting with others to help them plan missions work here in our "Jerusalem" and beyond to the "uttermost parts" of the earth. The Association has been helping the Tuckaseigee WMU in their plans to reach the residents of low income housing with the Gospel through a one day "Backyard Bible Club" to be held July 18th at the Cullowhee Recreation Park. He has also been helping a couple of member churches as they plan a trip to Romania to hold "Backyard Bible Club" during the summer of 2016. This quarter has been busy, and the next few months will be also, but he is glad to be busy serving the churches of the Tuckaseigee Baptist Association because they are "On Mission" to share Jesus Christ with the lost. Gerald reported 19 visits to churches, preaching 10 times and 18 meetings.

Mrs. Lee Lillard presented the WMU report. Virginia Pangle had led a trip to Camp Truett to plant flowers in the Prayer Garden. The new associational leadership have been meeting to plan several activities. Some plan to attend the August 1st annual training in Waynesville. The WMU sent around 300 packages of cookies for the KY Raceway Ministry. They are encouraging churches to collect lotion for the Red Box Prison Ministry by October. The TBA WMU will also be organizing a Day of Compassion for local nursing homes on August 8th. Churches are asked to plan to go and visit and pray with residents. Participants can also provide gift baskets for the staff. They will also be planning an outreach with Broyhill. Currently they are involved in getting ready for a Backyard Bible School at the Cullowhee Recreation Park on July 18th. They will have multiple stations for the kids to rotate through. The goal is to reach out to the lower income housing areas and invite them to this and ultimately involve them in surrounding churches.

Old Business: None New Business:

- The Doctrinal Committee presented a letter of withdrawal from the association by Shoal Creek Baptist Church. It was approved to present this at the Annual Meeting. Dennis Proffitt recommended that a letter of acknowledgement be sent to the church since Gerald has been unable to speak with Rev. Steve Jamison. They will also present information that Big Ridge Baptist Church is no longer meeting and another nondenominational church is using the building.
- Six Ministry Partnership Agreements for 2016 were presented and approved. Now we wait for approval from the Baptist State Convention.
- Mrs. Lee Lillard spoke about Backyard Bible School on July 18th. It is a multi-church outreach to the lower income housing areas. It has incurred expenses of approximately \$1,400 and have had donations to help cover some costs, leaving a remainder of \$1,000. Several churches at the meeting collectively promised \$700. Then it was approved by the Association that up to \$300 of Annie Hoyle Funds be used as needed for the Backyard Bible School on July 18, 2015. Lee requested that everyone bathe this Saturday in prayer to reach these kids for Christ.

Rev. Tim Reeves led the group in closing prayer.

Director of Missions' Annual Report 2015, Rev. Gerald Morris

This has been a year of changes. The first of several changes in the Association developed directly from last year's Annual Meeting. The vote to change the bylaws helped streamline much of the committee work needed to run the Association. This has resulted in less time meeting and more time doing the work of God.

Another change that came directly from the actions of last year's Annual Meeting is unfortunately a sad one. At last year's meeting, the Association voted unanimously for a resolution standing against Homosexual marriage. Unfortunately, the pastor and members of Shoal Creek Baptist Church took offense to this stand on Biblical principles and voted to remove themselves from the membership of the Association. I am saddened that they have taken this route and I pray for them.

One of the happiest changes is that I am able to report that the Association is ending this fiscal year "in the black." For the first time in many years, the Association collected more funds than needed to operate. This is all while continuing to expand the services we offer to the churches. This new financial standing is coming about because of several reasons. The first is that several churches have increased their regular giving. This is great because it provides stability to the Association and makes it possible to plan for the future. The second way giving increased was from several churches and individuals responding to the First Annual Alton Hooper Offering for Associational Missions. I am grateful for all who gave generously. And lastly, the March Chili cookoff between the pastors was a great success. The attendance at the cookoff fundraiser was one of the highest of the year with everyone having a great time tasting chili and fellowshipping. Thank you for your support.

We held several events that brought the churches together in worship, prayer and fellowship. The Spring Worship Rally in May was wonderful again this year with Rev. Johnny Tiller preaching, Rev. Robert Fernandez translating and Grace Morris, Brady Powell and Rich Petty bringing special music. The September Children's Rally was hosted by Scotts Creek and well attended with the Cashiers' Puppet Team emphasizing doing missions. In March the Youth Rally was hosted and sponsored by Faith. Brian Allen of Maggie Valley brought a challenging message to the youth. The Spring and Fall Associational Singings were, and always are, great times of fellowship and worship for most of the churches in the Association. I love to see the churches come together to worship our Lord. We also gathered together on two occasions for times of prayer. In May, several gathered at the Jackson County Justice Center for a time of prayer for our governmental leaders. The crowd is always much smaller than I wish but those that attend are sincere in their call to God. In September, many gathered at the schools throughout Jackson County to pray for the students, faculty and staff of those schools. We prayed that God would move in the hearts of everyone touched by the schools.

The Broyhill food drive was a success again this year. The collection started out slowly but the churches of the Association came through once again and gave generously to the children.

The last event held by the Association this year, was the September Missions Celebration. After two years of holding one day Missions events we expanded the conference to three days (four days were planned but one of the missionary couples had to back out). The Missions Conference was hosted by Faith, Lovedale, Hyatt's Chapel, Buff Creek, Scotts Creek and Cashiers Baptist Churches. The missionaries (one couple from Peru, one couple from Chili and a couple and single missionary from East Asia) rotated around to each of the churches sharing what God is doing through the International Missions Board.

The final change that has come to the Association this year was an increase of missions work. The churches of the Association came together to do missions work in their Jerusalem and beyond. Last Fall, several churches came together to reach out to the migrant workers that work in the fields of Jackson County. We did this by visiting the migrant camps at night (after the men finished working) and eating a meal with them that had been prepared by El Centro del Senor. After the meal was eaten, one of the men from El Centro preached a Gospel message. At least three men were saved. In Jackson county, several churches participated in Operation Inasmuch. This is a one day mission blitz of the community doing good deeds to earn the right to share the Gospel. This included preparing goodie bags and baskets for local teachers, emergency workers and rest home workers, visiting and having communion with shut ins, preparing small bird feeders to hang on trees at Skyland Care and Morningstar Assisted Living for the residents to enjoy and singing for the residents while they were there, fixing a floor for an elderly person, and doing cleanup in the community.

The churches of the Association came together July 18th at the Cullowhee Recreation Park for a one day Vacation Bible School/ Backyard Bible Club. In the weeks before, invitations were distributed to the multifamily housing throughout Jackson County. Several Associational (at least 10) and some non-Associational churches participated. There was over 200 participants (workers and students) involved. This was a great success and plans have been made to do this again next year at an earlier date so that this event can be used as a "kickoff" for area churches' VBSs.

Reaching out further from home, the Association offered three different mission trips out of state. The first, and shortest, was a return trip, June 19-20th, to Book Link International in Eubank, Ky to help sort, pack, and wrap Christian literature to be sent to Zimbabwe. We had eight people go from Greens Creek, Locust Field, Jarrett Memorial and Ochre Hill Baptist Churches. The next trip was to the Kentucky Speedway on July 9-11th. We joined over 200 raceway ministry volunteers to reach over 100,000 NASCAR race fans that descended on Sparta, Ky for the weekend. We worked primarily in the children's tent (Kids Zone) and passed out New Testament to the crowds. We had 11 people go from Calvary and Ochre Hill Baptist Churches.

The longest and furthest mission trip that we undertook this year was to go to St. Johnsbury, Vermont to work in the Mustard Seed Soup Kitchen and thrift store. We had seven people go from Greens Creek, Long Branch, Ochre Hill and Scotts Creek Baptist Churches. We did a variety of jobs to help this ministry. We also talked to and encouraged the new minister that was working to plant a church (named "The Bridge"). This would be the only Baptist church within 30 to 45 minutes. The Baptist State Convention of NC is working to help plant churches in Vermont because it is the least churched state in the nation with only 3-4% of the people claiming to be Christians. The trip was from July 24 to August 1. The hope is to go back and work next summer to help this new church plant grow and reach this city that needs Christ so bad.

As I stated above, this year has been a year of changes. It is great to see what the churches of the Tuckaseigee Baptist Association can do when they come together to serve Jesus Christ. I am excited at what was accomplished this year but more so about what God is going to do next year.

WNC Baptist Hispanic Ministries, by Rev. Robert Fernandez

During the past year the Lord has continued to do great things in the Hispanic community:

Primera Iglesia Bautista de Amor has been focused on spreading the Gospel and church planting. Pastor Felix Villarreal continued traveling to Mexico throughout 2015 preaching the Gospel in several communities. Several members of our local churches have assisted Felix on these mission trips. Many have been saved through these trips. Also, Pastor Villarreal has been working with Fruitland student Sergio Barranco to plant a Hispanic church in Highlands. They have partnered with First Baptist Highlands to the Spanish speaking people living in that area of Macon County.

El Centro del Senor has also been focused on Great Commission work. We have been partnering with Pastor Oniel Rojas, serving in the eastern part of Cuba. Our church has also continued to work with Fruitland graduate Martin Irias. Martin is currently working with three different church plants in Jinotega, Nicaragua. One of those groups is composed of families living in that city's garbage dump.

Casa de Dios in Haywood County was a church plant that came out of El Centro del Senor. Luis Segura and myself began working in the Bethel area approximately five years ago. About a year and a half ago, Luis began leading a group in the Candler community. El Centro del Senor's Jose Moctezuma and Jesus Rosario (both Fruitland graduates) have been assisting Brother Segura.

Fruitland Baptist Bible College's Sylva Campus has been meeting at the facilities of our association for four years. Our first cohort of students just completed their course of study. Ten Hispanic Fruitland students have applied for graduation, scheduled for December 11th! Thank you Tuckaseigee Baptist Association for allowing us the use of our building. These graduates have committed their lives to serve the Lord Jesus Christ. To God be the glory.



Residential Care for children is provided throughout BCH's statewide locations. School-age boys and girls live with professionally trained child care workers (houseparents) in a Christian, family environment. When the family is involved, 3CH's case managers work with family members to help them identify and overcome their challenges.

Emergency Care is provided on each residential campus. Emergency Care offers safe, immediate care for a child during a family crisis. Maximum length of stay is 60 days.

After Care is provided to a child and custodian following residential service.

Transitional Living helps older children learn the skills they need to live as independent adults once leaving BCH's care.

Family Care provides supportive group homes for hardworking single mothers and their children. Family Care helps nothers obtain stability so they can provide for their family.

Teen Mother and Baby Residential Care is a group home providing care and parental education to teenage mothers and their babies. The home provides an on-site day care.

Residential Wilderness Camping is provided for boys and girls in a highly-structured, outdoor environment. Cameron Boys Camp and Camp Duncan for Girls residential program gives children and families an opportunity to overcome problems through an alternative education program and group process. Weekday Education is a five-star education program in Thomasville offering developmentally appropriate classes for children ages six weeks to five years old. Developmental Disabilities Ministry (DDM) provides special needs adults long-term residential care and the opportunity to reach their highest level of independence in community-based, gender-specific group homes. North Carolina Baptist Aging Ministry (NCBAM) is a dynamic resource dedicated to serving NC's aging and thei families by providing information and referrals, connecting the aging and their families with resources to meet needs, and coordinating practical ministries. Visit www.ncbam.org

Orphan Care is provided to abandoned and neglected children in Xela, Guatemala through the Good Shepherd Children's Home. Children receive a caring home, nutritious food, clothing, medical care and other daily provisions.

Cost of Services...Cost for BCH's services is calculated on a sliding fee scale for parent or relative custodians. DSS custodians will pay based on a pre-established charge.

Accreditation...Accredited by the Council on Accreditation for Children & Family Services. In 2011, Baptist Children's Homes received a perfect review from the Council on Accreditation scoring the highest possible rating on all 667 standards.

2015 BAPTIST STATE CONVENTION BOOK OF REPORTS

Our 2015 annual meeting theme, "Echo: Reproducing Gospel Life in Others," is based on II Timothy 2:2, where the Apostle Paul wrote: "And the things that you have heard from me among many witnesses, commit these to faithful men who will be able to teach others also." What a wonderful theme for our annual meeting and a theme that goes hand in hand with the 2015 NC Baptist Foundation theme of "Pay the Blessings Forward." Both themes have to do with the responsibility of believers to leave a legacy that will result in reproducing Gospel life in others. We can accomplish this mission both through our witness and our wealth, and both are necessary for reproducing Gospel life.

The mission of the <u>NC Baptist Foundation</u> is "to serve North Carolina Baptists and others in generating an increased awareness of Christian stewardship principles as a means of financially undergirding Baptist churches, institutions and mission endeavors on a permanent basis." In 2014 the Foundation was blessed in our efforts to accomplish our mission as:

- 40 new accounts were established, most of which will permanently support
 Kingdom work in North Carolina and around the world
- Total gifts to all accounts reached a record \$16,704,409.77
- A total of \$9,027,404.27 was distributed (\$7,091,292.96 to mission endeavors and \$1,936,111.31 to individuals through charitable trusts)
- Assets under management grew from \$146,579,201.35 to \$152,648,455.47

TRUE STORY OF A CHARITABLE ANNUITY TRUST

In 1994, through a Christian estate plan, one of our Foundation donors established two twenty year term Charitable Remainder Annuity Trusts. This type of trust pays a fixed income based on a set percentage. The payment remains the same for the duration of the trust, regardless of investment returns. In this case, each trust was established with a gift of \$175,000.00 and paid the recipients 5% annually. At the end of the twenty years, whatever remained of the original gift was used to fund a permanent endowment for the benefit of one of our NC Baptist ministries.

At the end of the trust term of twenty years, the two trust beneficiaries had received slightly more than the value of the original gift that totaled \$350,000.00; they just received it over a period of years rather than in a lump sum. But here is the good news: after paying the beneficiaries more than the value of the original gift, the amount remaining to fund the permanent endowment totaled \$512,000.00. So the two trusts paid out more than the original gift, but because of investment returns, the gift remainder was considerably larger than the original gift. Now there is \$512,000.00 invested to support a Baptist ministry in our state until the Lord returns. Obviously, we cannot predict future investment returns, but this is a true story.

Our newest ministry, NC Baptist Financial Services, continued to thrive in 2014. By the end of the year NCBFS had provided 62 loans to churches totaling \$33.6 million. The total invested in Certificates of Participation, which provides the resources for loans, had reached \$46.8 million.

CareNet of North Carolina - Lifting Spirit. Holding Hope.

It is estimated that we will provide \$725,000 of free care this fiscal year (July 2014-June 2015), which expands access to many of our Baptist brothers, and sisters who have fallen on unemployment, have high—deductible insurance plans, and disability. Our 37 CareNet sites spanning 83 of the100 NC counties (new site in Alamance County and one projected in Marion) will provide approximately 51,000 hours of care representing 7,200 people. Of those receiving care approximately 47% designate affiliation with a Baptist congregation. Baptist pastors remain one of our major referral sources and we have seen a growth in demand from our Baptist pastors and their families who need our services. Thanks to the generosity of our Baptist Ministers Care Plan we are able to subsidize their care. Our health ministry partnership with the Baptist State Convention of North Carolina fulfills our vision to "Lift Spirits while Holding Hope." We are deeply grateful for this partnership.

FaithHealth Chaplaincy and Clinical Ministries

The Department of FaithHealth Chaplaincy and Clinical Ministries and the Department of FaithHealth Education served as one department, the Department of Chaplaincy and Pastoral Education. This department has provided chaplaincy ministry to Wake Forest Baptist Medical Center for more than 50 years and is the oldest chaplaincy program in the Southeast region, and one of the largest of its kind

anywhere. The chaplaincy ministry program combines ministry with education. Crisis ministry and routine visits to patients, families and staff are provided by ministers who are learning to become more effective servants of the people. These chaplain interns and residents provide routine visits Monday through Friday during regular business hours and an on-call chaplain provides coverage for emergent and crisis calls 24/7. Staff chaplains specialize in providing services to the Medical Center in the areas of Advance Care Planning and Advance Directives, support to the hospital staff and other areas.

The Department of FaithHealth Education provides a wide range of educational resources for chaplain residents, interns, hospital staff, and community clergy, congregations, and community organizations.

IMB Report Fall 2015

GOD IS WORTHY of the worship of all people, yet billions have yet to hear of Him. That's why we go. That's why we send to the growing global cities and the hard-to-access places. We go into a dark and broken world to share the only hope: the gospel of Jesus Christ.

IMB has been helping churches to participate in God's global mission since 1845. In the 21st century, we are equipping churches to send in new and creative ways. IMB exists to empower limitless missionary teams to make disciples and multiply churches among unreached peoples for the glory of God.

Redeemed and made new in Christ, we have a missionary identity that compels us to take the gospel even to difficult places and hard-to-reach peoples. In a beautiful partnership, IMB helps churches send ordinary Christians, empowered by God's extraordinary presence, to make disciples and multiply churches among unreached people for the glory of God.

Toward this end, last year Southern Baptists gave \$94.7 million through the Cooperative Program (\$94,736,418.32) and \$153 million (\$153,002,394.13) through the Lottie Moon Christmas Offering® for International Missions, supporting more than 4,700 missionaries sent out by Southern Baptist churches through IMB.



In addition, Southern Baptists gave \$6.6 million (\$6,556,271.02) for hunger relief and development ministries around the world.

Together, these gifts enabled IMB missionaries to report:

- 274,888 people professing faith in Christ
- 190,957 new believers expressing their faith through baptism
- 13,824 new churches planted

GUIDESTONE

The GuideStone Team of the Baptist State Convention of North Carolina (BSCNC) has remained strong in its efforts to serve North Carolina's more than 4,300 affiliated churches. We have weathered the many governmental changes and updates that have impacted our churches regarding employee benefits and retirement plans. Our goal continues to be keeping our North Carolina Baptist Association offices and churches up-to-date on these changes that impact them. The following information is a summary of those efforts.

Retirement

The GuideStone Team works with church staff and lay leaders in an effort to assist them in the restructuring of pastor and staff compensation packages to include retirement benefits. Many pastors and staff members do not see the benefits of participating in the Church Retirement Plan, and they will opt out of the plan if given an opportunity. Therefore, a continued effort is being made to challenge churches to be responsible employers and to assist their pastors and staff by contributing to their retirement plans in addition to their salaries and other benefits. For the calendar year ending Dec. 31, 2014, employer contributions increased approximately \$253,000 or 2.3 percent as compared with the 2013 calendar year. Total 2014 contributions by employer, employee, and convention matching dollars to employee retirement accounts increased \$675,200 (total \$20,123,925) or 3.47 percent. Nevertheless, nearly 1,900 of our 4,300 churches continue to have no participation in the plan.

Convention Protection and Matching Benefits

The following disability and survivor benefits were in place for retirement participants: 107 people received a total of \$557,667 in disability benefits, and 26 beneficiaries received \$224,640 in survivor benefits. In 2014, 4,870 North Carolina Baptist church staff received state convention matching contributions, and 5,612 church staff members received protection benefits, respectively.

The BSCNC continues to receive frequent requests for financial assistance when someone in our convention family becomes disabled or passes away. Many of these people had opted not to participate in the Church Retirement Plan; therefore, there is no financial assistance available from GuideStone and the BSCNC. However, when the church takes the lead by contributing into a pastor's or staff member's retirement plan, beneficiaries are allowed to receive the protection benefits provided by your state convention.

GuideStone Funds

The nation's largest Christian-screened mutual fund family continues to be recognized by top industry ranking firms for its outstanding fund performance. On March 31, 2015, two of GuideStone's mutual funds were awarded the Lipper Fund Awards for their outstanding performance. The Lipper Fund Awards are among the most prestigious provided by the industry ranking firms, and the 2015 awards represent the fourth year that a GuideStone mutual fund has been recognized by the rating agency.

Health Insurance

Health Care Reform Law – GuideStone remains a leader in providing detailed information regarding the impact that new tax laws have on our churches and their staff. Timely and

thorough updates of changes in the tax law can be found on the GuideStone website (guidestone.org). Major impacts for 2014 and 2015 associated with the implementation of the Affordable Care Act (ACA) include an IRS notice issued in February 2015 that waived any assessment of the \$100 per day penalty for violations of the ACA and the requirement to include in an employee's income any financial assistance the church provides for 2014 through June 30, 2015; churches are able to amend 2014 wage statements (Form W-2) if they had originally included any payment of, or reimbursement for, an employee's health care premium as gross wages (single-employee churches are not subject to most ACA mandates). GuideStone continues to issue new individual health care plans for new employees of eligible ministries, and they began writing new group health care plans for churches with as few as two employees beginning July 1, 2015.

Church Staff Compensation

Church staff participation in the 2014 Lifeway biannual Church Compensation Survey was completed on May 31, 2014. The results of the 2014 compensation survey are available online at *compstudy.lifeway.com*. Much of the year has been spent educating churches on the tax implications of the "lump sum pay packages" for pastors and churches. The taxability of such pay packages continues to be a concern.

Mission Dignity

GuideStone Financial Resources continues to provide financial assistance to elderly ministers and widows of ministers who live under financial duress and need ongoing and/or one-time assistance through Mission Dignity. During 2014, GuideStone assisted 182 North Carolinians financially.

BY-LAWS OF THE TUCKASEIGEE BAPTIST ASSOCIATION, INC.

ARTICLE I. NAME

The name of the body shall be the Tuckaseigee Baptist Association, Incorporated.

ARTICLE II. OBJECTIVES

The purpose of the Association is to be a fellowship of churches on mission in our setting. The specific objectives of the Association are as follows:

- 1. To promote harmony, understanding and spiritual power between the churches.
- 2. To afford and promote a larger fellowship of Christians in the work of Christ.
- 3. To provide such programs, projects and organizations as will strengthen the churches and assist them in achieving their goals and objectives.
- 4. To discover needs which cannot be met effectively by churches individually and to coordinate the use of resources in meeting these needs.
- 5. To encourage support by every church for the mission causes of the Association, the North Carolina Baptist Convention, and the Southern Baptist Convention.

ARTICLE III. AUTHORITY

SECTION 1. The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient.

SECTION 2. The Association shall have power to recommend measures of usefulness and guidance to our churches in matters of organization, ordinations and questions of doctrines and discipline,

SECTION 3. The Association shall have no power to infringe upon the right of local churches as autonomous bodies.

ARTICLE IV. MEMBERSHIP

SECTION 1. The Association shall be composed of regularly constituted Baptist churches in cooperating fellowship with the Southern Baptist Convention and following the teachings of the Bible.

SECTION 2. The Association shall be the sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure. Churches applying for membership shall agree to come under the watchcare of the Association for one year. It is understood that during this period of watchcare the church shall be entitled to all rights and privileges of the Association except those of voting.

Applications for membership shall be presented to the Doctrine Committee of the Association. The applications will consist of a letter from a constituted church stating their desire to affiliate with the Tuckaseigee Baptist Association. The Doctrine Committee as a part of the review process may invite the requesting church to a conference to discuss its history, its mission strategy, and any other information that may be pertinent to the application. The Doctrine Committee may then approve the application and recommend them to the Executive Committee. The Executive Committee may by a simple majority vote accept the requesting church to come under the watchcare of the Association for one year. Any church under watchcare is expected to participate in and financially support the Association. At the end of the year, the church may be voted in as a member of the Association with full privileges by a two-thirds vote of the messengers present and voting at the annual meeting of the Association, at the recommendation of the Doctrine and Executive Committees and at least one messenger be present at the meeting.

SECTION 3. Any church may withdraw from the Association at its pleasure and should notify the Association of this action in writing. Such action will be recognized by the Association at the next annual meeting.

SECTION 4. It shall be the duty of each church to furnish the Associational Clerk, before each annual session, a Church Profile, the forms provided by the Associational Clerk, giving the information requested as is applicable to each church situation.

SECTION 5. The Association may withdraw from any church which has become unscriptural in its doctrine or practices by a two-thirds majority vote of the messengers present and voting at the annual meeting. Such vote is to be taken by written ballot.

ARTICLE V. MEETINGS

SECTION 1. The Association shall hold its annual meeting on Thursday and Friday preceding the third Sunday in October. Special meetings of the Association may be called by the Executive Committee provided two weeks written notice is given to the member churches.

SECTION 2. Each church shall be entitled to be represented at the annual meeting by the pastor and one additional messenger. Churches which give to the association more than .5% of their undesignated receipts shall be entitled to an additional 2 messengers for every .5% of giving up to a total of 10 messengers for churches which give 2% of their undesignated giving."

SECTION 3. Churches are requested to elect their messengers and alternatives in conference to attend the annual meeting. SECTION 4. In case of internal dissension in a church and two parties coming to the Association, each claiming to represent the church, neither party shall be seated until the Doctrine Committee determines which party is in union with the Association. The decision is to be affirmed by a majority of the messengers present and voting.

ARTICLE VI. OFFICERS

SECTION 1. General officers of the Association shall be: Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Parliamentarian, Assistant Parliamentarian, Director of Missions, Trustees and team leaders. Team leaders shall be chosen by the Nominating Committee as needed to serve the purposes of the Association (eg. Sunday School leader, Youth/Children leader). Team leaders will work with the Moderator and/or the Director of Missions to form a team to carry out assigned duties.

Associational representatives will be elected as may be deemed appropriate and elected in the Association. Associational representatives shall be a conduit of information between outside agencies and the Association. They may also represent the Association as the outside agency's policies specify.

SECTION 2. With the exception of the Director of Missions and Trustees, the terms of office for all officers of the Association shall be for one year with the privilege of continuing re-election. The Moderator and Vice Moderator shall not be eligible for re-election but one year in succession. (1) The number of Trustees shall be three. (2) The term of service should be for three years, with the term of only one expiring each year. In the first election of Trustees, the term of service for one should be three years, another two years, and the other one year. (3) Upon the expiration of term of service, the Trustee may or may not be re-elected for another term of three years.

Each term of office shall begin with the close of the annual session. The Associational financial year will run from October 1 through September 30.

ARTICLE VII. DUTIES OF OFFICERS

SECTION 1. The Moderator shall preside and maintain the order of all meetings of the Association and Executive Committee. He shall serve as ex officio member of all committees of the Association.

SECTION 2. The Vice Moderator shall assist the Moderator and preside in the absence of, or at the pleasure of the Moderator.

SECTION 3. The Clerk shall keep a complete and accurate record of all meetings; shall prepare a "Book of Reports" to be distributed to messengers at the beginning of the annual meeting; and prepare minutes of the annual meeting (Annual Minutes) to be distributed to each church.

The Clerk shall distribute to the clerk of each church in the Association a congregational church profile as soon as they are received from the State Convention. This form is to be returned to the Clerk of the Association as soon as possible or by the deadline set by the Clerk and Director of Missions. All program reports should be returned by the same date.

An Assistant Clerk shall work with the Clerk in preparing the "Book of Reports," the annual minutes and the registration of messengers at the annual meeting.

SECTION 4. The Treasurer shall oversee the receipts and disbursements, by order of the Executive Committee of the Association, of the money of the treasury and ensure that a complete report is presented at the Annual meeting and a current report at each Executive Committee meeting.

An Assistant Treasurer shall be elected to assist the Treasurer by request and to serve in the event the Treasurer resigns or is ill or unable to function.

SECTION 5. The Parliamentarian shall upon the request of the presiding officer of the body, advise and assist the Association with respect to all matters involving Parliamentary Procedure.

An Assistant Parliamentarian shall be elected. The Parliamentarian and Assistant should always communicate with each other to ensure that this office is filled at each Associational Annual or Executive Committee meeting.

SECTION 6. Trustees have no authority except by direction of the Association and are not personally bound by signatures but are to be the legal signees for the Association. Trustees represent the Association in legal matters. Trustees act on behalf of the Association in acquisition and disposal of Associational property.

They sign all deeds of conveyance, execute all notes, bonds or mortgages, intervene in all suits, by authority of the Association.

All persons dealing with the Trustees, as Associational officers, may rely upon any written resolution duly adopted by the Association or Executive Committee, directing and authorizing the Trustees to act in its behalf and certified by the Association Moderator and Clerk.

ARTICLE VIII. RULES OF ORDER

The business meetings of the Association shall be conducted according to Robert's Parliamentary Practice or in a manner not contrary thereto.

ARTICLE IX. QUORUM

The quorum for the Annual Associational meeting or any special called meeting of the Association shall not be less than 25 percent of the member churches.

ARTICLE X. THE EXECUTIVE COMMITTEE

SECTION 1. The Executive Committee shall be composed of the General Officers and Team Leaders elected by the Association and the Pastor and one member from each church in the Association. No Pastor, by virtue of his being an Associational Officer or Program Leader shall be disqualified as a member of the Executive Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

SECTION 2. It shall be the duty of the Executive Committee to act for the Association on matters arising when the Association is not in session and to make a report of all work to the next session of the Association. This body shall meet at a time and place designated by the Moderator on Monday following the first Sunday of each quarter except for the July quarter which shall meet on the second Monday of the month of July. Special meetings of the Executive Committee may be called by the Moderator with a one week notice to the churches.

SECTION 3. All vacancies occurring on committees or among elected officers shall be filled by the Executive Committee.

ARTICLE XI. ASSOCIATIONAL STANDING COMMITTEES

SECTION 1. The Association shall have such standing committees as may be deemed necessary to promote efficiently the work of the Master in our midst. The terms of office for all committee members shall be for three years except where specifically stated otherwise.

SECTION 3. THE NOMINATING COMMITTEE shall be composed of seven members. It shall be the duty of this committee to nominate the Officers, Committees members, Team Leaders (as needed) and Institutional Agency Representatives. These nominees shall be notified prior to presenting of their names at annual session.

SECTION 4. THE STEWARDSHIP COMMITTEE shall be composed of six members including the Treasurer of the Association. This committee shall: (a) present a Budget to the Association for the following year; (b) devise plans for raising the funds for the Associational Budget; (c) audit the finances and financial records of the Association annually and anytime there is a change of Treasurer or at the direction of the Association or the Executive Committee; (d) report all audits to the Annual Association Meeting.

SECTION 5. THE BUILDING AND GROUNDS COMMITTEE shall be comprised of three members. The committee shall be responsible for and in charge of the upkeep and repairs of the Associational building, grounds, and equipment. SECTION 6. THE PERSONNEL COMMITTEE

- A. The Committee shall be composed of 7 members of which 3 are pastors.
- B. They shall recommend policies and procedures for the selection, supervision and termination of Associational staff personnel. Those policies and procedures shall be approved by the Association.
 - C. Prepare and maintain an organizational manual relation to the Association's staff personnel.
 - D. Develop and recommend to the association policies and procedures for paid and volunteer staff personnel.
- E. When a staff vacancy occurs, other than the DOM, they shall serve as the search committee. When a DOM vacancy occurs, they shall nominate a search committee and present it to the Executive Committee.
 - F. The Personnel Committee shall handle grievances as outlined in the grievance policy.

SECTION 7 THE ANNUAL MEETING COMMITTEE shall be composed of seven members. The duties of this committee shall be to

- A. recommend the church(es) to host the annual meeting and the preacher(s) and alternate preacher(s) to deliver the annual sermon for the following year,
- B. present suitable resolutions at the annual Associational meeting,

- C. bring a report to the annual meeting of those listed by the member churches as deceased since the last annual meeting.
- D. keep the historical records of the Association up-to-date,
- E. plan the program for the Annual Meeting(s) and present it to the Executive Committee at its October meeting,
- F. shall be responsible for registering messengers at the Annual Meeting(s),
- G. and shall perform all duties specified in Article XIII (amendments to by-laws).

SECTION 7 THE DOCTRINE COMMITTEE shall be composed of five pastors and two laymen.

- A. It shall examine applications of churches seeking admission into the Association in keeping with Article IV and make recommendation to the Association. It shall counsel with churches that are out of harmony of fellowship with the Association.
- B. It shall also advise churches about candidates for ordination with the following guidelines: it serves on an advisory capacity only, serves at the request of the church from which the member is seeking ordination, is to examine such candidates as to their call and fitness for the gospel ministry and make such recommendations to the church as they feel led. It should regularly inform the Executive Committee of its work.

ARTICLE XII. JOB DESCRIPTION, DIRECTOR OF MISSIONS

SECTION 1. Title and Functions.

- A. Position Title. This position shall be known as the Director of Missions for the Tuckaseigee Baptist Association.
- B. Basic Functions. The Director of Missions shall serve as a minister to the church leaders of the Tuckaseigee Baptist Association, as mission strategist, as chief administrative officer, and as a general leader of the Association.
- C. The Personnel Committee shall be responsible to maintain, update and revise a job description as required, making recommendations to the Association for approval as they are needed.

ARTICLE XIII. AMENDMENTS

The constitution may be amended at any annual meeting of the Association by a two-thirds majority of the messengers present and voting, provided the amendment has been presented to the Annual Meeting Committee at least 10 days prior to the annual meeting and presented to the Association in printed form on the first day of the annual meeting to be voted on the second day.

ARTICLE XIV. NON-PROFIT STATUS

The Tuckaseigee Baptist Association, Inc. is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the Tuckaseigee Baptist Association, Inc. shall inure to the benefit of its' members, directs, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

In the event of dissolution, the residual assets of the Tuckaseigee Baptist Association, Inc. will be turned over to one or more organizations with similar purposes which are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986.
