Association called to order at 9.30 A. M. Spent thirty minutes in devotional exercises, conducted by the Moderator.

The hour having arrived for preaching, business was suspended and Dr. Nelson preached a very earnest sermon from the word "come," as found in the following scriptures: Luke 19:5, Mat. 11:28, Cor. 6:17, John 21:12, John 11:43, Mark 6:13, John 14:3.

Sang, "Sweet By and By."

Prayer, led by Rev. C. B. Mingus.

Took recess one hour.

AFTERNOON SESSION.

Association called to order by Moderator Sentell. Prayer led by brother J. H. Tucker.

Resumed the consideration of the report on Home Missions. Further remarks by Rev. W. Haynes, Rev. S. C. Owen, Dr. Nelson and the Clerk. At the conclusion of the discussion, the following amounts were pledged

REPORT ON HOME MISSIONS.

The Home Mission Board of the Southern Baptist Convention had in its employment last year, 187 missionaries. These men of God supplied 1,114 churches and stations, preached 33,868 sermons and baptized 4,857 souls. These missionaries are scattered over 11 Southern States, District of Columbia, Indian Territory and Cuba. In the great State of Texas alone, we have 125 laborers. The success of the mission work in the "Lone Star State" has been remarkable, while that in Cuba has been marvelous. A little more than two years ago the first Baptist church was organized on that Island; since then more than 1,100 have been baptized. Eight thousand persons have applied for baptism who have not been received. Many of them, of course, were ignorant of the true qualification for church membership and desired only to exchange the Catholic for the Baptist church.

While we look with wonder and astonishment at what God is doing in Cuba, there is danger of our forgetting other fields fully as important. The priest-ridden New Orleans is as important as Havanna. It is as important to give the Gospel to the millions of our colored people and let its subuding power hold them in allegiance to the truth and duty, as to break the power of Catholicism in Cuba.

Our Home Board has aided the Board of Missions of our Western North Carolinia Convention in the prosecution of its work in our midst. Much of the good work done and now being done is attributed to the \$600 furnished by the Board at Atlants.

The Home Board has aided as far as their means would justify in church building. Sixty-four new churches have been erected at a cost of about \$54,000. They

ask North Carolina for \$5,000 this year. Our pro rata of this amount is about \$50. Your committee recommend that we raise this amount by pledges, to be paid by April 1, 1888. Respectfully submitted,

REPORT ON BAPTIST ORPHANAGE.

The Baptist Orphanage at Thomasville, although not strictly one of our enterprises, is an institution worthy the attention of every Baptist. In the last year it has cared for ninety-two children and one superanuated Baptist preacher (Dr. Jacob Retley) and his wife, both of whom died in the spring. The disbursements of the institution exceeded the receipts by about one hundred and forty dollars, for the liquidation of which they have a right to expect the co-operative efforts of every Baptist in North Carolina. We would recommend the pastors and Sunday school superintendents be requested to present the claims of the institution to their churches and schools, and that the children especially be encouraged to give to the support and training of children less fortunate than themselves. Pending the discussion, \$70 was subscribed to the capital stock of the joint stock company referred to in the report. Report adopted.

REPORT ON PERIODICALS.

It is with sadness that your committee feel called upon to report to you that which you have known before, that our own beloved paper, the Western North Carolina Baptist, has fallen, and with it we fear much of the interest felt by our convention, in religious and denominational literature has waned. But we are glad that many of those who were subscribers to the Western North Carolina Baptist in its day, have, since its death, patronized the Biblical Record, published at

Raleigh, N. C. And while we commend the Recorder to all our friends as well worthy of their support, yet we find that it does not fully meet our wants, as a convention in western North Carolina. We heartly recommend to this Association the effort now being made to form a joint stock company for the purpose of publishing a paper in Asheville, devoted to the interest of our convention.

This plan has been on foot for a short time and has met with hearty endorsement. It is the purpose of the company to have the arrangements completed by the meeting of the western North Carolina convention, so that soon thereafter the paper can be started. Ten dollars constitutes one share, and any one can take as many shares as he desires. This plan has advantages over any other we have yet tried. This company can, through a Board of Directors, control the editorship of the paper, and thereby prevent defects which otherwise are so prevalent. The finances will be controlled in the same way, which gives assurance of success and will commend it to our people as a business matter, and hail with gladness the day when such a paper shall be started and feel confident that it will be a welcome visitor in all our homes, and recommend to our brethren the propriety of taking stock in the enterprise. REPORT ON EDUCATION.

We recognize with pride and thankfulness to the Divine Dispenser of good, an increasing interest in this branch of the Master's work; we recoenize further further the urgent need of renewed and persistent efforts in this direction. Our Heavenly Father has given us abundant opportunities to improve our minds for the greater usefulness of his work on earth. He has placed among the Baptists of North Carolina two colleges, whose advantages are inferior to none in the State. He has entrusted to our care academies and high schools and female schools convenient to all, thereby increasing our responsibility in neglecting the cultivation of virtues of mind and heart, which fit us for usefulness in extending the Master's Kingdom on earth. Therefore, we recommend a more earnest heed in this branch of the Lord's work, and urgently request our brethren of ministry, as well as all others, to use their utmost endeavors to induce the youths of their congregations to patronize our Baptist schools and colleges, and fit themselves to battle with the sins of life. And we cheerfully endorse the work of Judson College, and commend its advantages to our brethren and ask a liberal patronage and support of the same. Becognizing the great importance of an educational ministry, we recommend for the encouragement thereof, a manifest increase in our contributions for Ministerial Education. The Board is now much involved and we urgently recommend a speedy liquidation of that debt.

We sympathize with our College in her struggle to raise an endowment fund, and recommend the same to the liberality of our brethren, and pray God for abundant success. Brethren, we are just beginning to reap from the good seed sown in our educational field. Shall we continue to sow, or shall the reaping cease?

REPORT ON TEMPERANCE.

Your committee notes the fact that the cause of temperance is receiving a favorable consideration by all religious assemblies. Reports and resolutions are adopted and speeches are made, all of which are having their influence in moulding public sentiment in favor of temperance and against the rum mill. Much good has been accomplished in this direction, and most of our leading spirits in our churches are zealous in the cause of temperance reform. But while this is true, the masses are not exercising that influence which the importance of the cause demands.

We boast of our Christian America and yet seventy-five thousand drunkards die annually, filling drunkard's graves, and leaving behind them many, many helpless widows and orphans who must become objects of public charity or drag out a miserable existence. Remember God says, "No drunkard shall enter the Kingdom of Heaven;" where are all this army of 75,000? How long shall our earth be deluged with crime, misery, pauperism and death before our people will arise to duty and come to the help of the Lord against the mighty. Remember, "Faith without J. L. Dear Brethren:—We have tried to occupy as near as we could the destitution in our bounds by dividing the work up between our brethren. In this several points have been supplied. Brethren R. A. Sentell, M. C. Compton, P. R. Young, J. M. Haynes, W. W. Wells and C. B. Mingus have rendered service to the Board. Their report aggregate the following work done: Days of service, 85; sermons preached, 70; addresses made, 25; religious visits, 187; tracts distributed, 10,000.

The Board is profoundly impressed with the great need of colporture work in our county and recommend to the Association the propriety of concentrating our

efforts on this particular line of mission work for the next year.

"There are many places where the preacher is a stranger and where the people have no opportunity of hearing the gospel. If these people are reached at all it must be done by the religious colporture. The amount of good done by these brethren is incalculable. They are the itinerant pioneer Missionaries. They are the forerunners of the pastors, preparing the way for them. The colporture visits a family; it may be in a log cabin in the valley, on the mountain top or by the way side. His books secures for him an easy introduction. Having shown these he converses with every member of the family on personal religion, reads the Bible and kneels with them in prayer. What must be the influence of such a visit from a stranger in families unaccustomed to religious appeals, many of them not having heard a sermon in years? Is there anything needed more, save the preached word, than the distribution of the Bible and such religious books and literature as our great Publication Society publishes and the Board furnishes? Our missionary colportures enter every community armed with the very best selections which our experience can make. A forward move in this department of our work is demanded."

DICDIDCEMENTO

Brother J. L. Morgan was re-elected Treasurer and Rev. P. R. Young was re-elected Historian by acclamation. On motion adjourned till 9.30 Sunday morning.

SUNDAY MORNING, 9.30.

Association called to order, Moderator Sentell in the chair. Prayer, led by W. Haynes. Resumed the consideration of the resolution offered by Rev. P. R. Young against the union of State and Western North Carolina Conventions. Remarks by Rev. P. R. Young. Resolution adopted, only one vote in the negative.

Resumed the consideration of the report on Foreign Missions. Report re-read by the Clerk. Remarks by Rev. R. A. Sentell and the Clerk.

Pending the discussion of this report, a collection was taken for Foreign Missions, amounting to \$15.16. Report adopted.

REPORT ON FOREIGN MISSIONS.

It is with pleasure that your committee are able to state that there seems to be an increased interest in this department of our work, and yet only five churches report anything contributed to Foreign Missions, aggregating \$44.13. Last year five churches contributed \$31.00, and the same churches, with one exception, contributed this year. All rejoice at every evidence of progress, if seen only in a very small part of the body, but feel humiliated when we think of over half of our churches doing nothing for this cause. The Foreign Mission Board asked North Carolina for \$8,000 last year, and we did not reach one-half of our quota.

One hundred dollars for our county would be but a small amount for us to give to Foreign Missions and yet we did not give half of this amount. Is it not a burning shame that we do not give quite four cents per member? Do we believe in Foreign Missions? If so, where is the evidence of our faith? Brethren, what shall we do to arouse our people on this subject? The work of the Foreign Mission Board commends itself to our confidence and sympathy. They have missionaries in every continent on the globe, who are dependent upon the Southern Baptist Convention for support. God has blessed their labors abundantly, and we have great reasons to thank Him and take courage. Last year the Board made larger appropriations than ever before, and yet came to the convention with a balance in the treasury over and above all liabilities. This year they go still further, sending out at least seven new missionaries. They do it upon their faith in the churches and that means their faith in us. Shall we disappoint them, or will we comply with our quota of the amount asked from North Carolina? To do this we must raise about \$100.00. This is not ten cents per member. Will we do it?

Rev. Mr. WEELS, W. A. NELSON, A W. SILER, Committee.

At 11 A. M., sermon by Rev. J. B. Boone, President of Judson College, text, John 17:18, "As thou hast sent me into the world, even so have I also sent them into the world." At the close of the sermon a collection was taken for Home Missions and Ministerial Education, amounting to \$5.19.

At the same hour Rev. W. W. Wells preached at the stand from Hagai, 1:2, "This people say the time is not come, the time the Lord's house should be built." At the close of the sermon a collection was taken for objects above mentioned, amounting to \$4.36. Total Sabbath collection, \$24.91.

Thus closed the third annual session, and the Haywood Baptist Association adjourned to meet Saturday before the first Sunday in September.

APPENDIX.

CONSTITUTION OF THE HAYWOOD CO. BAPTIST ASSOCIATION.

ARTICLE I.-NAME.

This Association shall be known as the Haywood County Baptist Association.

ARTICLE II.—OBJECT.

The object of this Association shall be: First to cultivate a friendly union among the churches for our mutual benefit; second, to foster and promote, under the auspices of the W. N. C. Baptist Conventions, the cause of Home Missions, Foreign Missions, Sunday School colportage and ministerial education; third, we disclaim to exercise lordship over churches, or to have any clerical power which entitles it to infringe upon the internal rights of any of its churches.

ARTICLE III.—CONSTITUENCY AND REPRESENTATION.

Sec. 1. This Association shall be composed of male members, chosen as messengers or representatives, by the Baptist churches of this union.

Sec. 2 Messengers so chosen must be members of the church they represent and must present a certificate of their appointment to entitle them to a seat.

Sec. 3. Every church shall be entitled to send at least two messengers and one additional messenger for every twenty-five members enrolled.

Sec. 4. Every church is requested to send with messengers an annual report as follows:

a. Name of messengers.

b. DIRECTORY—Name of church and the date of its organization. Name of pastor and his post-office. Name of clerk and his post-office. Name of S. S. Superintendent. Time of meeting. Time of prayer meeting.

c. Statistics—Number baptized, received by letter, restored, dismissed by letter, excluded, dead, total number of males and females, and total

membership.

d. FINANCIAL STATEMENT—Give the amount paid for pastor's salary, church expenses, church repairs, Home Missions, Foreign Missions, Sunday School and Bible colportage, ministerial education, for the poor, minute fund and all other contributions made.

e. SUNDAY SCHOOL REPORT-State whether Baptist or union, number of scholars enrolled, average attendance, number of conversions during the year, amount of money expended in support of school, what kind of literathre is used, amount of money raised by school for all objects.

ARTICLE IV.—ITS OFFICERS.

The officers of this body shall be a moderator, clerk, treasurer and historian. All officers shall be elected by ballot at every annual meeting. The moderator and clerk immediately after the enrollment of delegates; the treasurer and historian at some time after their reports shall have been reached. Provided, the treasurer and historian may be elected in any way the body may direct.

Sec. 2. THEIR DUTIES—The moderator shall preside, and observe and keep order in accordance with Mell's manuel of parliamentary law.

b. The clerk shall keep a faithful record of the proceedings of this body in a business-like manner, superintend the printing and distribution of the minutes, keep a file of the minutes of the Association, and turn them over to his successor. He shall be the custodian of the Constitution, articles of faith and covenant and shall preserve and keep the same and have a copy of the same at every annual meeting of this body.

c. The treasurer shall receive all moneys paid into this body, and pay

the same upon the order of the Association.

d. The historian shall record and keep a record of such items as would be of interest to a future historian, in a book kept for that purpose. He shall also keep a file of the minutes.

ARTICLE V.—COMMITTEES.

At each annual meeting the Moderator shall, immediately after the organization, appoint the following committees: On Foreign Missions, Home Missions, Education, Sunday Schools, Periodicals, Temperance, Baptist Orphanage of N. C., Obituaries and Changes, State of the Churches, Order of Business, Time, Place and Annual Sermon of the next Association; to nominate executive board, finance and such other committees as the body shall direct.

ARTICLE VI.-EXECUTIVE BOARD.

At each annual meeting there shall be appointed an executive board, which shall superintend the mission work of the county and carry out the resolutions and orders of the Association during its recess. This committee shall consist of the officers of the body, ex-officio, and one member from each church belonging to the body. This board shall be empowered to fill all vacancies which may occur therein during the year.

ARTICLE VII.—ASSOCIATIONAL RIGHTS.

This Association shall have the right to determine what churches shall be admitted into its union, and to withdraw from any for not complying with its rules or for violating orthodox principles as set forth and believed by us as Baptists.

ARTICLE VIII.—ITS LAWS.

This body shall be governed by Mell's manual of parliamentary laws.

ARTICLE IX.—AMENDMENT.

This Constitution may be amended at any regular meeting by a twothirds vote.
