Sound in both faith and doctrine in accord with the principles of the Gospel. Whereunto, we do here by set him apart to the full functions of the office of Elder and to the administration of the ordinances thereof. Then returned him to the Church as Elder Thomas Lee Radford. Should he ever here after depart from the Orthodox Principles of the Gospel of our dear Lord the Credentials will be null and void. Done by the order of the Church of Christ while in Conference.
