# PILGRIM'S REST CHURCH,

# TOY, GEORGIA,

SEPTEMBER 15. 16, AND 17, 1893.

1st. The introductory sermon was delivered by Elder J. W. Herin, of this body.

2nd. After one hour's intermission the messengers assembled in the house.

3rd. Elder J. F. Sikes was elected temporary Moderator, and M. F. Etheridge clerk. The Association was then organized and prayer by Elder S. J. English, of the Flint River Union.

4th. Elder J. F. Sikes and M. F. Etheridge were elected permanent Moderator and clerk.

5. Read letters from the Churches and enrolled the names of messengers.

6. Appointed the following committees on preaching: L. A. Stubbs, B. T. Collier, M. J. Ray, J. R. Roberts and G. W. Davis.

To arrange business to come before the body ; J. A. King, W. G. Hartly, and B. T. Collier.

To examine corresponding minutes: W. G. Middlebrooks, J. H. Colquit and G. W. Davis.

To write corresponding letters ; M. F. Etheridge, M. J. Ray and J. R. Roberts.

On motion, adjourned to 9 o'clock to-morrow morning.

#### SATURDAY, 9 a. m., September 16th.

Met according to adjournment. Prayer by Elder J. W. Bassett, of this body.

1. Called the roll.

2nd. Called for report of the committee appointed to bring business before the body. Report read and received, and is as follows :

"We the committee, appointed to arrange business to come before the body, beg leave to report that we think it needful for the actions of our little body to trim our identity to our true dimensions, to-wit: Five of our Churches, originally in union with us, viz: Fellowship, Damascus, Union, Mt. Cavalry and Trinity, remain with us intact. Pilgrim's Rest and Mt. Olivet are composed of members who gave up their homes and name to reremain in union with us. We therefore recommend, provided it meets the unanimous consent of our body and brotherhood, that we incorporate only the names of the seven Churches named in our present minutes, and that we call ourselves in future the 'Little Echeconnee Baptist Association,' and that we here rest our cause in the hands of our God, invoking His holy presence to guide us in doing His holy will; and to give such development as may glorify His holy name, and ever keep us from 'waring after the flesh.'"-2nd. Cor. 10:3.

That any further business be conducted as becometh the household of Faith.

3rd. Called for correspondence from the Flint River Union, and received the brethren, E. Aultman, J. F. Daniels, Elder S. J. English, Eli Nelson, G. C. Dyess, S. H. English, Thos. English and J. J. Duke, with minutes.

4th. Called for report of committee to examine corresponding minutes. Reported they find nothing claiming the attention of this body.

5th. Returned correspondence to the Flint River Union to convene with New Hope Church, Taylor County, commencing on Friday before the first Sunday in September, 1894, one mile south of Reynolds. W. G. Middlebrooks, G. W. Davis, E. L. McGee, B. T. Collier, J. A. King, J. R. Roberts, I. P. Davis, M. J. Ray, B. F. King, W. G. Hartly, L. A. Stubbs, J. H. Colquitt, J. F. Sikes, J. W. Herin, J. W. Bassett, T. J. Nelson, J. F. Renfroe, W. J. Ingram, J. F. Petty.

6th. Appointed next session of this body with Mt. Calvary Church, Monroe County, one mile from Montpellier Station, M. & B. Railroad. Usual time.

7th. Appointed union meeting with Fellowship Church, Houston County, embracing the fifth Sunday in April, 1894.

8th. Called for, read and received corresponding letters.

9th. Called for contributions, and received \$15.50 for Minutes.

10th. Agreed to have 1,000 copies of these Minutes printed.

11th. On motion, adjourned to time and place above mentioned.
