11 A. M. September 19th., 1913.

1st. The introductory Sermon was delivered by Elder J.H. Smith of Rutherford Church, Washington County, Ga.

2nd. After one hour's intermission the messengers assembled in the house. Prayer by Elder W. Y. Jordan.

3rd. Received and read letters from the churches and enrolled the names of messengers, all reporting peace.

4th. Re-elected Elder J. W. Herin, Moderator, and G. E. King, Clerk.

5th. Appointed Committee on Preaching: Brethren A. R. Johnson, T.L. Arnold, C. M. Mathews, A.M. Garvin, J.H. Colquitt, T. J. Jones.

6th. Call for petitionary letters and received none.

7th. Call for visiting Brethren and received none.

8th. Appointed next session of this body with Fellowship Church, Houston County, Ga., 5 miles South of Byron, and 3½ miles East of Powersville on C. of Ga. R.R. Commencing on Friday before and embracing the third Sunday in September 1914.

9th. Appointed next session of Union Meeting with Reedy Springs Church at Caldwell, Laurens County, Ga., on W. & T. R.R. Commencing on Friday before and embracing the 5th. Sunday in March 1914.

10th. Call for Contributions and received \$10.00 for minutes, agreed to have 500 printed.

11th. Adjourned in order to time and place above mentioned.
