

Minutes

Wednesday, October 14, 1953.

(Note: All hymn numbers are from hymn and tune book.)

The Association convened at 11 o'clock a.m. Opened meeting by singing hymns 489, 68. Prayer by Elder H. M. Bennett.

The Introductory Sermon was preached by Elder Arnold H. Bellows, from 2 Kings 4:1-7. Sang hymn 126.

The Association was organized for business by choosing Elder John D. Wood, Moderator, Arthur L. Carter, Clerk, and G. C. Spindle, Assistant Clerk.

Letters from the several churches read, and the Table was prepared from their contents. (See Statistical Table).

A resolution regarding the seating of correspondents and visitors read and adopted to become a part of our Minutes.

Appointed Brothers Hollingsworth, Spindle, and Norman a Committee to arrange the order of preaching.

Appointed Brothers Hylton and Duke a Committee to distribute Minutes of corresponding Associations.

Appointed Brothers Robey, Dade and Carter a Committee to handle the finances of the Association.

Adjourned the business of the Association until 10:30 a.m., Thursday. Continued the services as follows: Sang hymn 236. Benediction by Elder Bellows.

AFTERNOON SESSION.

Benediction by Elder T. R. Jefferson.

THURSDAY, October 15, 1953.

The Association convened according to adjournment. Opened with singing hymns 596, 224. Prayer by Elder W. J. Berry.

A Committee of all ministers and deacons of our correspondence in attendance was appointed to examine our corresponding Circular Letter and report their findings on day in course.

Adjourned until 10:30 a.m., Friday.

Continued services as follows: Sang hymn 229. Preaching by Elder S. L. Moran, no special text. Sang hymn 28. Benediction by Elder John D. Wood.

AFTERNOON SESSION

Sang hymn 591. Preaching by Elder Odell Thompson. Preaching by Elder A. J. Slauson, after singing hymn 173, from Eph. 2: 1-10. Sang hymn 111. Benediction by Elder Bennett. FRIDAY, October 16, 1953.

The Association convened according to adjournment. Opened meeting with singing hymns 608, 386, 178. Prayer by Elder Odell Thompson.

The Committee appointed to distribute Mirates reported same had been taken care of.

Appointed Deacon G. C. Spindle to write Corresponding Circular Letter for next session.

Appointed Elder John D. Wood to prepare a Resolution of Respect to Elder Landon Harris from this Association to become a part of our Minutes. Same to be mailed to Sister Harris, Old Faith Contender, and Signs of the Times. Appointed Deacon Arthur L. Carter to serve a two-year term on the Old School Baptist Home Fund.

Adopted report of Committee's recommendation of acceptance of Corresponding Circular Letter as read, and same to be made a part of our Minutes. Minutes of this session read and adopted as read. Moved and carried to adjourn session until another year. Continued services as follows: Sang hymn 169. Preaching by Elder H. M. Bennett from Deut. 18: 13. Preaching by Elder W. J. Berry. Closing remarks from several Elders and deacons.

The following contributions were received for printing Minuttes of this meeting: \$10.00 each from Mt. Zion, Frying Pan, and New Valley. For expenses of visiting ministers: \$25.00 each from Mt. Zion, Frying Pan, and New Valley Churches.

Since conditions were such among the brethren that we were unable to receive and seat some of our former correspondents and visitors at our last session; and since conditions remain the same this year, we feel it right that we make the following statement:

It is recognized that there is confusion and disorder in the Salem Association of North Carolina, and since some of our former correspondents and visitors have taken sides in their division, which has caused greater confusion; and we deem it good order not to promote either side, but leave it for them to settle themselves, therefore we went on record at our last sessas follows:

"That this Association seat all correspondents and visiting brethren who have not directly affiliated with, or have taken sides in the Salem disorder."

It is the mind of this Association to reiterate our stand, and we therefore, seat all correspondents and visiting brethren who are not affiliating with the disorder either directly or indirectly. This includes any who may have formerly been involved, but who have now declared against any affiliation.

CORRESPONDING CIRULAR LETTER

The Virginia Corresponding Meeting in session with the New Valley Church on October 14, 15, and 16, 1953, sends Christian greetings to Associations and churches with whom we correspond, and to all of our faith and order.

Dear kindred in Christ:—We indeed feel our unworthiness and inability to address you in this, our Corresponding Circular Letter, yet do we realize if it be the Lord's will that He is able to cause even those things which are counted as nothing to praise His holy name. Oftimes in our feelings we lose sight of the goodness and mercy of our God, and given to trust in the things that seem right to us, but thanks be to Him we are brought to the bar of justice and given to know that the end of these things is death. And out of these crosses come that deep searching of heart and mind as concerning our case. What evidences do we have that it was us for whom the Savior died? Indeed we would all like to know the answer to this question, but so ordained that His His people in this life should live by hope, and hope that is seen, is not hope.

But dear brethren, a good hope is as sure as the earth is below our feet, for it so pleased the Father to give us a witness to our hope as found in the Holy Scriptures. Do we not find when led by the Holy Spirit to read and understand the scriptures that within our hearts there is an Amen and Amen, and as the importance of reading and searching the scriptures seems to be bearing on our mind, we would like to call attention to the scripture speaking of the brethren of Berea, found in Acts 17:11. "These were more noble than those in Thessalonica in that they received the Word with all readiness of mind, and searched the scriptures daily, whether those things were so."

We would in deed entreat our brethren everywhere in this day to search the scriptures for guidance in the way of all truth, and receive not those things which do not have a "thus saith the Lord."
