CONSTITUTION

(Revised August 16, 1957)

ARTICLE I

The Name of this body shall be the Tuckaseigee Baptist Association

ARTICLE II

The purpose of the Association shall be the extension of Christ's kingdom on earth, creation and promotion of harmony, intelligence and spiritual power of the churches.

ARTICLE III

(1) The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient. (2) It shall have power to recommend measures of usefulness and guidance to our churches in matters of organizations, ordinations and questions of doctrines and discipline. (3) The Association shall have no power to infringe upon the right to the local churches as sovereign and independent bodies.

ARTICLE IV

(1) The Association shall be composed of ministers and messengers selected by missionary Baptist churches which have been previously received into the association. (2) The pastor and four members from each one hundred members or fraction thereof shall compose the representation of each church. (3) The association shall be the sole judge of its members. (4) Any church applying to the association for membership by letter and messenger shall come under the watchcare of the association for one year for observation. At the expiration of that time, if it is still the will of the church, it may be voted in by majority vote of the association, provided they have an acceptable letter and at least one messenger present at the time.

ARTICLE V

(1) The association shall hold its regular session on Thursday and Friday preceding the 3rd Sunday in August. (2) The association year begins on July 1 and continues through June 30 of the proceeding year. The associational reports and church letters will be within this period. (3) The Moderator may call a mid-year session at his pleasure.

ARTICLE VI

(a) The officers of the association shall be a Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Historian, Sunday School Superintendent, Training Union Director, Woman's Missionary Union Superintendent, Superintendent of Evangelism, President of Deacon's organization, Brotherhood President, Superintendent of Education, and a Parliamentarian, and such other officers as the association may desire to elect. (b) The term of office for the general officers of the Association shall not exceed two years in succession, with the exception of the Clerk and Treasurer of the as-

sociation, who may be re-elected to succeed themselves in office at the pleasure of the Association. The term of office for all members of committees of the Association shall be for not more than two years. No committee member may succeed himself until at least one year has elapsed after his official term has expired. No member of the Association may be permitted to hold membership in more than one committee during one year, except in the case of the members of the Executive Committee. (c) The term general officers shall apply to the Moderator, Vice Moderator, Clerk, Assistant Clerk and Treasurer.

ARTICLE VII

(a) The moderator shall preside and maintain the order of business of all meetings unless he otherwise provides for the Vice Moderator. He shall serve as exofficio member of all committees of the Association. (b) He shall appoint the committee on committees and all other committees pertinent to the operation of the body not named by the committee on committees in its regular report. (c) The Vice Moderator shall assist the Moderator and in case of absence or incapacitation of the Moderator, he shall act in his stead until another Moderator is elected, (d) The Clerk shall keep a complete and accurate record of all transactions; he shall prepare a book of reports to be distributed to messengers and pastors at the beginning of each day's session of the annual meeting; and he shall cause to be printed a minute concerning the records made. (e) The Clerk shall mail to the Clerk of each church in the associaion, blanks for the preparation of the church letter as soon as they are received from the state convention office. (f) The Treasurer shall receive and disburse by the order of the Executive Committee or the association while in session, the money of the treasury and make a complete report to the association at each session. (g) It shall be the duty of the Historian to keep the records of the association up to date. (h) The Associational Missionary shall be sought and recommended by the Executive Committee in a manner of its own choosing.

Within 30 days after locating such a person the Executive Committee shall present the name of the missionary nominee to a called meeting of the Association. If the Annual meeting of the Association is scheduled within 60 days, the presentation shall wait until that time.

His call shall be indefinite. His salary, allowances, etc., shall be as provided by the current budget or adjustments recommended in consultation with the Finance Committee.

Two-week vacation may be taken at his discretion.

Concerning termination of employment, his resignations shall be in writing and presented to the Executive Committee at least thirty days before it is to take effect. The Executive Committee may terminate employment by giving thirty days notice in advance.

The Missions Committee shall give full supervision and guidance to the Missionary in planning, promoting and financing his work.

The Missionary shall work closely with the associational committees and associational officers in such a way as to help each group determine its opportunities, and objectives based on the need in the churches and procedures, and means of fulfilling these.

Therefore, he shall serve as ex-officio member of all committees of the Association. It shall be his duty to administer the policies and instructions of the Executive Committee. He shall communicate with the State and Southern Convention such information as shall be mutually helpful and needful.

ARTICLE VIII

All officers shall be elected annually at the discretion of the body. All officers and committee members will hold office until the next annual association meeting.

ARTICLE IX

The business of the association shall be conducted according to Roberts Parliamentary Practice or in a manner not contrary thereto.

ARTICLE X

The Executive Committee shall be composed of the Moderator, Vice Moderator, Clerk, Treasurer, Historian, Sunday School Superintendent, Superintendent of Evangelism, President of the Deacon's Organization, President of the Brotherhood, Superintendent of Education, Associational Missionary, Parliamentarian and the pastor and one member from each church in the association. No pastor, by virtue of his being an Associational officer, shall be disqualified as a member of the Promotion Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

ARTICLE XI

It shall be the duty of the promotion committee to act for the association on matters arising when the association is not in session and to make a report of all work to the next session of the association.

ARTICLE XII

The associational quorum shall be the number present if the number satisfies the will of the Moderator.

ARTICLE XIII

The association shall have the right to withdraw by a majority vote fellowship from any church which becomes unorthodox in doctrine, or disorderly in practice, or that fails to present itself either by messenger or letter for two consecutive sessions without sufficient reason, or that ceases to be missionary in practice. The support of the causes fostered by the denomination at large and of this association in particular shall be the test of each church as a missionary body. Any church, at its pleasure, may withdraw from the association.

ARTICLE XIV

The association shall have such standing committees as may be considered necessary to promote efficiently the work of the Master in our midst, the members of these committees are to be nominated annually by the committee on committees unless otherwise determined by the association.

ARTICLE XV

This constitution shall be amended by a majority vote, providing the amendment was read on the previous day of the association. Otherwise two-thirds majority of the votes must be in favor of the amendment.

BY-LAWS

1. All vacancies occurring among the elective officers and in the Executive Committee shall be filled by the Promotion Committee.

2. The Executive Committee shall meet at a time and place designated by the Moderator on Monday following the first Sunday of each quarter. The Executive Committee shall elect its own chairman.

3. Each church Clerk shall mail to the Clerk of the association a letter properly filled out on the blank furnished him at least two weeks prior to the meeting of the body.

4. No church shall be received into the association who does not present a certificate of examination properly endorsed by the committee on organization and reception of new churches.

5. Duties of the committees of the association.

A. Order of Business Committee: This committee shall plan the annual program for the association and present it to the Executive Committee at its July meeting.

B. Committee on Committees: The duty of this committee is to bring to the annual associational meeting a nomination of the personnel of the

standing committees.

C. Finance Committee: This committee shall devise plans for raising the funds for the association budget and prepare for recommendations to the annual session of the association the budget for the disbursement of funds for the coming year.

D. Resolutions Committee: This committee is to report suitable resolutions

at the annual associational meeting.

- E. Credentials Committee: This committee serves in an advisory capacity only. This committee should examine such candidates for the ministry as come before it as to their call and fitness for the Gospel Ministry and make recommendations as they feel led to the church of which one is a member about his being ordained and help plan and arrange the proper services of ordination when such assistance is needed. The Executive Committee should be informed regularly of the work of the committee. Each church desiring to ordain a candidate is urged to consult with the committee.
- F. Nominating Committee: It shall be the duty of this committee to nominate the officers of the Association and have this report ready for the annual associational meeting.
- G. Missions Committee: (1) This committee shall be composed of the following Association officers: Sunday School Superintendent, Training Union Director, Woman's Missionary Union President, Brotherhood President, Chairman of Evangelism, Chairman of Associational Deacons, Treasurer, Moderator, and Chairman of Executive Committee, and four members at large from member churches to be elected by the association at its annual meeting for 1,2,3, and 4 years respectively on a rotating system. After the election one new member shall be elected each year to serve for a period of four years. (2) The Missions Committee shall advise and work with the Associational Missionary in promoting the work in the Association, and also lead and assist in organizing new churches, and also shall be responsible for encouraging and guiding the churches in the

association to faithfully cooperate with the association program and emphases.

(3) The committee shall meet once a quarter to receive a written report from the Associational Missionary and make helpful suggestions to him concerning his work. (4) If such advice is sought, it shall advise any group seeking to organize a new church, or seek to help any member church desiring assistance in its problems. (5) The Missions Committee shall perform the duties prescribed in the By-Laws on New Churches, and the By-Laws prescribing the job Description on the Associational Mission-

JOB DESCRIPTION ASSOCIATIONAL MISSIONARY TUCKASEIGEE BAPTIST ASSOCIATION

This Job Description is prepared for the information of the Associational Missionary, with the objective of presenting the Missionary Committees' viewpoints on the major needs of the Association. The Job Description also stipulates the responsibilities of the Association to the Missionary.

I. Function of the Associational Missionary. He is to be the chief administrative officer of the Association. He is to confine extra employment in a manner agreed upon with the Executive Committee.

II. Relationship of the Missionary:

1. He is employed by the Executive Committee of the Association. "Concerning termination of employment, his resignation shall be in writing and be presented to the Executive Committee at least thirty days prior to its effectiveness. The Executive Committee may terminate employment by giving thirty days notice in advance." (Tuckaseigee Association Constitution, Article VII,

2. General supervision of the personnel and program of the Association as they function through the Associational Office.

3. Work primarily with associational General Officers, Committees, and Organi-

4. Work closely with auxiliary organizations.

5. Lead in maintaining relationships with State and SBC Agencies.

III. Duties of the Missionary: 1. Administrative

a. Administer policies and instructions committed to him by the Association, its Executive Committee or Board.

b. Work closely with the Associational Officers, Committees, and Organizations to help each group determine (1) its opportunities and objectives based on needs in the churches, and (2) its procedures and programs for achieving these objectives.

c. Help the Association to develop annual and long-range objectives; set goals, and make plans for their attainment.

d. Correlate the work of all organizations and Committees in the Association,

and publish a Calendar of Activities.

- e. All staff to be responsible to the Missionary selection and supervision under his responsibilities until informed otherwise by the Executive
- f. Serve as ex-officio member of all committees.
- g. Have general oversight of purchasing equipment and supplies within

- h. Inform State and Southern Convention agencies of needs, problems, and potentialities within the Association.
- i. Interpret to the churches the program resources and other assistance available from the State and Southern Baptist agencies.

2. As Counselor-Shepherd

To counsel with church leaders as requested with reference to (1) Programs and procedures in their churches; (2) Calling a pastor or other staff member; (3) Actual or threatened breach of fellowship; (4) Church objectives; (5) Church policies; (6) Assist pastorless churches; (7) Assist pastors and others in counseling those who are called into church-related vocations.

3. In the Churches, extending the local ministries:

a. To visit churches by invitation of the pastor or other church leaders in the pastorless churches to provide assistance in the church program and ministry, such as: (1) Pulpit supply; (2) Study course; (3) Missionary address; (4) Deacons' Meetings; (5) Assembly programs; (6) Special day addresses; (7) Ordination services; (8) V.B.S. Planning and Promotion; (9) To interpret phases of Associational work; (10) Budget planning; (11) Building planning; (12) Revival meetings; (13) Stewardship emphasis; (14) Study objectives and long-range planning; (15) Studying and evaluating procedures, curriculum, Constitution and By-Laws, etc., (16) Church-Community Surveys, etc.; (17) Promoting a world missions concept; and (18) publishing of a regular news medium.

4. In the Associational Office:

a. Personal correspondence, promotional mail, and telephoning pertinent to his work.

b. Office conferences, answer to inquiries, etc.

- c. Assist Associational Officers, Committees, and heads of Organizations to get out promotional mail pertinent to their work.
- IV. The Schedule of Benefits Provided by the Association for the Missionary.
 - 1. His salary shall be_
 - 2. His fringe benefits shall include:
 - 3. His schedule shall include:
 - a. One day each week, chosen at his discretion, shall be reserved for rest that excludes normal Associational activities.

b. A maximum of six weeks each year outside of the Association for special work with local churches or with State and SBC agencies.

- c. An annual sick leave of 14 days maximum, with a maximum of 42 days to be accumulated. Sick leave may be advanced by the Association for one year, without Executive Committee action. Sick leave is to be recorded with the Financial Secretary of the Association.
- 4. All honoraria from churches inside or outside the Association and all honoraria from other religious work shall be his personal affair, and shall not be submitted to the Association.
 - H. New Churches in the Association: (1) Any church seeking admission to the membership of the Association shall petition in writing the Promotion Committee at least three months before the annual meeting of the Association, which petition shall be referred to the Missions Committee for its study on the petitioning church's covenant, articles of faith, history. practices, cooperative spirit, its relations to other churches of the as-

sociation and its willingness to abide by the Constitution and By-Laws of the Association. The Missions Committee shall then report to the Associational Meeting with a copy thereof submitted to the Associational Promotion Committee at least thirty days prior to the Annual Meeting of the Association, its findings and recommendations for Associational action at the next annual meeting. (2) Each church applying for membership in the Association, upon approval, shall be received under the watchcare of the Association for a period of one year. Each church shall give a written report to the missions committee and the Executive Committee each quarter of their work and giving toward associational program and state and south-wide participation.

6. The Clerk shall prepare a Book of Reports for distribution at the annual sessions containing the reports of those on the Committee on Reports. The Clerk shall notify each person to give a report, and these reports should be in the hands of the Clerk no later than two weeks before the Association meets.

PROCEEDINGS

TUCKASEIGEE BAPTIST ASSOCIATION OLD SAVANNAH BAPTIST CHURCH THURSDAY, AUGUST 14, 1969

1. The one hundred fortieth annual session of the Tuckaseigee Baptist Association was called to order by the Rev. Judson Rotan, Moderator.

2. After the hymn, "Stand Up, Stand Up for Jesus," the Rev. Wayne Caldwell, pastor of Old Savannah Church, welcomed messengers and visitors and gave the Scripture lesson, I Corinthians 13. Rev. Caldwell then led in prayer.

3. A motion was adopted that those messengers present should constitute the Association. Rev. Lloyd Wood then presented the order of business which was adopted.

4. A report on the Sunday School was given by the Rev. Lloyd Wood. The report was adopted.

5. Rev. Charles Dean gave the Training Union Report. The report was adopted.

6. Rev. Walter Middleton gave the Associational Missionary's Report. He emphasized the mission of the church. The report was adopted.

7. A report on the Associational Deacons was given by Mr. Guy Sutton. The report was adopted.

8. In the absence of Mrs. Katie Bryson, the Rev. Judson Rotan read the Historian's Report. Report adopted.

9. The Treasurer's Report was given by the Rev. Lloyd Fish, who presented this report in the absence of Mrs. Barbara Vance. Report adopted.

10. Rev. Lloyd Fish gave the Financial Report, presenting the 1969-70 Associational Budget. He moved that the budget be accepted, and after discussion, the Financial Report was adopted.

11. Mrs. Robert Clegg presented the W.M.U. Report. The report was adopted.

12. After a hymn, "On Jordan's Stormy Banks," an offering was received.

13. Visitors were recognized. Rev. Walter Middleton recognized the following new pastors in the Association: Rev. Jesse Bailey (Greens Creek), Rev. John Reid (New Savannah), and Rev. Ralph Easterly (Tuckaseigee). Rev. Joseph Reese called the roll of churches.

14. Rev. Ray McCall gave a report on State Missions. The report was adopted.

15. Rev. Lester Sutton reported on Home Missions. This report was adopted.

16. Rev. Judson Rotan called attention to a report on the American Bible Society in the BOOK OF REPORTS.

17. In the absence of Mrs. Hattie Allison, Rev. Walter Middleton moved that the report on Foreign Missions be adopted. Motion carried.

18. Rev. Jesse Bailey acted as moderator during a report on the World Mission Conference by Rev. Judson Rotan. The report on the World Mission Conference was adopted.

19. Rev. Burrell Lucas, representative of the Baptist State Convention, spoke on the need for witnessing and "Living the Faith."

20. Visitors to the Association were recognized.

21. A hymn "Blessed Assurance," was sung, after this the congregation read responsively a reading on "Faithfulness." Special music was presented by Cullowhee Church and the Rev. Lloyd Wood brought the ANNUAL SERMON. Mr. Wood spoke on "God Builds His Church."

22. Rev. Lloyd Wood closed the morning session with prayer.

LUNCH

- 23. The afternoon session was begun by singing the hymn, "Amazing Grace."
- 24. Rev. Judson Rotan read Psalm 121.
- 25. Rev. Walter Middleton made announcements.
- 26. During the Miscellaneous Business period, Rev. Lloyd Wood presented the proposed Constitutional changes. The changes were to be voted on at the Friday session.

27. The Report on Truett Camp was given by the Rev. Jesse Bailey, who showed slides taken during the summer at Truett Camp. The report was adopted.

28. Mrs. Dot England made a motion that the report on the Home for the Aging be adopted. The report was spoken to by the Rev. William Poole of the Home for the Aging. The report was adopted.

29. Mr. J. D. Parker gave the report on the Baptist Hospital. The report was

spoken to by Mr. Charles Wilson of the Hospital. The report was adopted.

30. Mr. Tom Clayton made a motion that the report on the Baptist Children's Homes be approved. Mr. Hugh Starnes, Superintendent of Broyhill Home, spoke to the report. The report was adopted.

31. A motion was made that the afternoon session be extended ten minutes.

Motion carried.

32. Rev. Ben Cooke presented a report on Evangelism. An earlier motion made by Rev. Lloyd Fish to make the county-wide revival a part of the Associational program was discussed and the motion carried. The report on Evangelism was approved.

33. The Cooperative Program Report was given by Rev. Lloyd Fish and was accepted.

34. Rev. Burrell Lucas brought a message on "The Local Church in the Mind of Jesus."

· 35. The Association was adjourned with prayer until the next day's session.

JARRETT MEMORIAL BAPTIST CHURCH FRIDAY, AUGUST 15, 1969

1. The Association was called to order by the Vice Moderator, the Rev. Jesse Bailey, with the singing of the hymn, "Work for the Night is Coming."

2. Rev. Lester Sutton, pastor of Jarrett Memorial Church read Romans 15 and

led in prayer.

- 3. Rev. Joseph Reese gave the report of the Executive Committee. The report was adopted.
- 4. In the absence of Mr. James Potts, the Rev. Walter Middleton made a motion that the report of the Credentials Committee be accepted. Motion carried.
- 5. Rev. R. D. Gregg made a motion that the report of the Time, Place, and Preacher Committee be adopted. Motion carried.

6. The hymn, "Footsteps of Jesus," was sung.

- 7. In the absence of Mrs. Mabel Rogers, the Rev. Walter Middleton made a motion that the report of Christian Education be accepted. The report was spoken to by a representative of Gardner-Webb College. The Christian Education Report was accepted.
- 8. Mr. Robert Blanton made a motion that the report of the Committee on Committees be adopted. Because a number of people assigned to committees were out-of-order, the Rev. Walter Middleton made a motion that the Committee on Committees revise its report at the next Executive Committee Meeting in accordance with the Constitution and that only those who had served on a committee for no more than two years be considered elected to office at this time. Motion carried.

9. Rev. Walter Middleton made a motion that the Christian Literature Report be adopted. Mr. Marse Grant, Editor of the BIBLICAL RECORDER, spoke to the report.

The report was adopted.

- 10. Mr. Robert Blanton moved the adoption of the Temperance Report. Report adopted.
- 11. A report on the Baptist Foundation was given by Mr. Gordon Maddery. Report adopted.
- 12. Rev. Joseph Reese made a motion that the report on the Annuity Board be adopted. Rev. Jud Rotan spoke to the report, noting that 13 churches and 1 staff member in the Tuckaseigee Association participated. The report was adopted.

13. Visitors were recognized.

14. A hymn, "All Hail the Power of Jesus' Name," was sung.

- 15. The Moderator's Message was given by Rev. Judson Rotan, who spoke on "Living the Spirit of Christ in Faith and Works."
 - 16. Rev. Lester Sutton conducted a memorial service.
 - 17. The afternoon session was closed with prayer.

SUPPER

18. The evening session was called to order by Rev. Judson Rotan, Moderator. 19. Rev. John Reid, pastor of New Savannah Church, read Scripture and led in

prayer.

- 20. Rev. Judson Rotan extended a welcome to the evening session. A roll call of churches not present the previous day showed that 28 churches have been represented.
 - 21. Mr. J. E. Brown gave the report of the Nominating Committee. Report adopted. 22. The Calendar of Activities was presented by the Rev. Jesse Bailey. After dis-

cussion and a vote to extend time 10 minutes, the report was adopted.

23. A period of Miscellaneous Business began with the Rev. Lloyd Wood reviewing the suggested Constitutional changes. Rev. Wood made a motion that the first proposed change be adopted. The change is as follows:

ARTICLE V

1. The association shall hold its regular session on Thursday and Friday preceding the 3rd Sunday in August.

(add as number 2:)

2. The association year begins on July 1, and continues through June 30 of the proceeding year. The associational reports and church letters will be within this period.

(number 2 in the present Constitution now becomes number 3:)

3. The moderator may call a mid-year session at his pleasure.

Motion carried.

Rev. Lloyd Wood made a motion that the second proposed change in the Constitution be adopted. The change is as follows:

ARTICLE VIII

All officers shall be elected annually at the discretion of the body. (add:) All officers and committee members will hold officeuntil the next annual association meeting.

Motion carried.

Time was again extended for ten minutes.

A motion was made by Rev. Lloyd Wood to delete By-law 5, section 7, and make 7 the following:

MISSIONS COMMITTEE OF THE TUCKA SEIGEE ASSOCIATION: (1) This committee shall be composed of the following Association officers: Sunday School Superintendent, Training Union Director, Woman's Missionary Union President, Brotherhood President, Chairman of Evangelism, Chairman of Associational Deacons, Treasurer, Moderator, and Chairman of Executive Committee, and four members at large from member churches to be elected by the association at its annual meeting for 1, 2, 3, and 4, years respectively on a rotating system. After the election one new member shall be elected each year to serve for a period of four years. (2) The Missions Committee shall advise and work with the Associational Missionary in promoting the work in the Association, and also lead and assist in organizing new churches, and also shall be responsible for encouraging and guiding the churches in the association to faithfully cooperate with the association program and emphases. (3) The committee shall meet once a quarter to receive a written report from the Associational Missionary and make helpful suggestions to him concerning his work. (4) If such advise is sought, it shall advise any group seeking to organize a new church, or seek to help any member church desiring assistance in its problems. (5) The Missions Committee shall perform the duties prescribed in the By-Laws on New Churches, and the By-Laws prescribing the Job Description on the Associational Missionary.

Discussion followed on the election of the Associational Missionary. Rev. Jesse Bailey made a motion that the following be added to Article VII, section h, for clarification:

(h) The Associational Missionary shall be sought and recommended by the Executive Committee in a manner of its own choosing. Within 30 days after locating such a person the Executive Committee shall present the name of the missionary nominee to a called meeting of the Association. If the Annual meeting of the Association is scheduled within 60 days, the presentation shall wait until that time.

Motion carried.

The recommended change in By-law 5, section 7, was approved.

A motion was made to accept the addition of By-law number 5 section 8 by the Rev. Lloyd Wood. Section number 8 would be as follows:

NEW CHURCHES IN THE ASSOCIATION: (1) Any church seeking admission to the membership of the Association shall petition in writing the Executive Committee at least three months before the annual meeting of the Association, which petition shall be referred to the Missions Committee for its study on the petitioning church's covenant, articles of faith, history, practices, cooperative spirit, its relations to other churches of the association and its willingness to abide by the Constitution and the By-Laws of the Association. The Missions Committee shall then report to the Associational Meeting with a copy thereof submitted to the Associational Executive Committee at least thirty days prior to the Annual Meeting of the Association, its findings and recommendations for Associational action at the next annual meeting. (2) Each church applying for membership in the Association, upon approval, shall be received under the watch-care of the Association for a period of one year. Each church shall give a written report to the missions committee and the Promotion Committee each quarter of their work and giving toward associational program and state and southwide participation.

The motion to accept this change carried.

A motion was made by the Rev. Lloyd Wood to use the name EXECUTIVE COM-MITTEE throughout the Constitution rather than the dual system of Promotions and Executive Committee. Motion carried.

A motion was made to extend the time for two minutes. Motion carried.

Rev. Joseph Reese made a motion that an Evangelism Committee be installed in the Association to work on the county-wide revival. The Committee would be made up of the following: Rev. Ben Cook, Rev. Lester Sutton, Rev. Robert Blanton, Rev. Walter Middleton, and Miss Joyce Norman. Motion carried.

Rev. Joseph Reese made a motion that it be noted in the 1969 Proceedings that all nominees be contacted before they are presented to the association and that all motions be written out and given to the clerk. Motion carried.

24. After prayer by the Rev. Judson Rotan, Rev. Charles Dean of East Sylva Church

brought the DOCTRINAL SERMON. He spoke on "Being Satisfied."

25. The one hundred fortieth annual session of the Tuckaseigee Association was adjourned with the singing of "Blest Be the Tie."

ASSOCIATIONAL MISSIONARY

EVANGELISM

- 2. Encourage pastors and members to attend the State Evangelism Conference.
- 3. Provide evangelism materials and plans to meet specific needs of various churches and associations as requested by superintendents of missions, associational chairmen of evangelism, pastors and church leaders.
- 4. Provide opportunities of dialogue on every facet of evangelism in order to discover and to utilize any worthy method to share the redemptive message of Christ with non-Christians of all races.
 - 5. Assist superintendents of missions, associational leaders, pastors, and church

leaders in planning special conferences or clinics on evangelism as follows:

Perennial Evangelism - Lay Evangelism/Personal Witnessing - Evangelistic Crusades/Revival Meetings - Evangelism Seminars to discuss topics relating to specific needs of the association - Academic Evangelism/Campus Evangelism for churches located near colleges - Mass Media Evangelism - Evangelism Related to Specialized Groups/Christian Social Ministries.

HISTORIAN

1969 marks the close of another decade in the history of the churches of the Tuckaseigee Baptist Association. This decade has, indeed, been a period of unprecedented growth in the building of modern structures of worship. Many new and impressive "church houses" are now to be seen as one travels through the county.

At present there are 47 Baptist churches in the Association. 1968 records show that these churches had a membership of some 10,000. Sunday School enrollment totaled 4,566 but baptisms fell to 188. Lovedale reported 25 baptisms, about twice as many as any other church. If statistics prove anything, there is a great need for evangelism in the Tuckaseigee Association.

Congratulations are due to Sol's Creek Church which was organized in 1869, and has recently occupied its first church building, on 100 years of service.

We also congratulate the Old Savannah Church on the dedication of a beautiful, modern church. This church exemplifies the perseverance, sacrifice and dedication of the churches in the Association in their "Faith and Work through Evangelism and Stewardship."

STATE MISSIONS

The Division of Missions works through six departments and various specialized ministries. In order to serve more effectively there is a Department of City Metropolitan Missions (centers over 2500 population); Town and Country (towns under 2500 population and all rural areas); Fruitland Baptist Bible Institute; Deaf Work; Interracial Cooperation; and recently approved Department of Chaplaincy Ministry. In addition, there are specialized ministries at Cherokee; in military areas; and the following institutions: Leonard Training School, Samarcand Training School; McCain Sanitorium; Odom Prison; and Morrison Training School.

The Division of Missions emphasizes service to local churches, especially those that may be classified as missions. Pastoral aid (financial) is granted to many churches in both rural and city areas. Lot aid is provided in needy situations. Along with financial aid, competent counsel will be given by department secretaries when requested by the church.

A close cooperative arrangement between the divisions and the local associations is cultivated. A majority of the associations is granted financial supplements by the State Convention.

It is impossible to say which mission emphasis is most important. There has been rapid growth in Seminary Extension. Two new ministries are getting healthy response--Resort and Christian Social Ministries.

The leadership of the Division of Missions is emphasizing the salvation of the whole man. Our approach is based upon deep convictions concerning the necessity of both faith and works.

Where are Southern Baptists? We stand at the crossroads. There is the road that leads to peace. There is the road that leads to security. And there is the road that leads to involvement in the world. The ones who choose to travel the road to involvement must expect to encounter tremendous obstacles and intense opposition. This opposition will come from several sources.

FOREIGN MISSIONS

Since 1845 men and women called of God have offered themselves to the Foreign Mission Board of the Southern Baptist Convention for service overseas. God has abundantly blessed and used them. Their number has increased until presently 2,441 serve in 70 countries (including 2,164 career missionaries, 145 missionary associates, 131 missionary journeymen and 4 special projects nursing personnel).

The imperative nature of our world task becomes clearer every day. Our basic responsibility is to bear witness to the truth of God's act of redemption in Jesus Christ, our Saviour. Every human being has a right to know of God's love and of the grace He has manifested in the gift of His own Son that the world may know Him.

Therefore, our main emphasis lies upon bearing witness of God's truth and leading men and women everywhere to discipleship so that they might be drawn into fellowship with a living Saviour and with one another in the fellowship of New Testament churches. This witness must be joined with deeds of love and mercy that manifest genuine Christian concern for our fellowmen and a determination to share with him all that is good, so as to lift him up to full stature and opportunity. In John 17:18 we read, "As thou hast sent me into the world, even so have I sent them into the World." Thus the sending is inherent in the Christian life itself. Any concept of mission which separates any Christian or any Christian cause from the divine sending is less than a biblical concept.

Annual increases in per capita gifts of Southern Baptists to Foreign Missions

has increased from \$1.69 in (1959) to \$2.53 in (1967).

The 1968 expenditures of the Foreign Mission Board totaled \$31,785,568.00. Of this total 91.8% (\$29,290,000.00) went directly to overseas missions. The remaining 8.2% was used by the Foreign Mission Board for general expenditures, promotions, and publicity.

The breakdown of receipts from the last fiscal year shows the church gifts total-

ling \$29,745,000.00. Of this amount 50% came from the Cooperative Program, 48% came from the Lottie Moon Christmas Offering and 2% came from special mission gifts from the churches. Receipts in the form of interest from the Southern Baptist Foundation amounted to \$119,000.00 and \$1,330,000.00 from the Foreign Mission Board reserves. Straight gifts, where no investments are made, amounted to \$293,000.00.

As Southern Baptists continue to give so does the mission work continue to grow in the various institutions on each mission field through churches, theological seminaries, hospitals, schools, publishing houses, good will centers, and a great

array of other ministries found throughout the world.

The future of Southern Baptists depends largely upon what we do about the Great Commission as we face the remaining decades of this century. May God help us to look ahead with determination, confidence, joy, and full obedience to Jesus Christ, our Saviour and Lord.

- ... We are feeding the hungry, healing the sick, clothing the naked, ministering to the enslaved, winning thousands to faith in Jesus Christ.
- ... We now have 2,371 foreign missionaries and 2,385 home missionaries.

Even in the face of OBVIOUS SUCCESS, as far as dollars given are concerned, our global conscience is not clear.

- ... The birthrate is much higher than the Christian conversion rate.
- ... Hunger and poverty, war and pestilence, fear and anger, describe all too clearly our world.

How well have we done in our state convention and our association? This year North Carolina Baptists have a goal of 6,700,000.00 for the Cooperative Program. Of this amount 2,233,780.00 or 33% will go to Southern Baptist causes. During the year the churches of Tuckaseigee Association gave 18,135.52 through the Cooperative Program.

Billy Graham wrote on March 20, 1956, in a letter to Dr. E.S. James, editor of the Texas state magazine, the BAPTIST STANDARD: "Concerning the Cooperative Program, I believe it is the greatest means ever devised by the church for the giving of one's tithe. In private and public conversation, I support the Cooperative Program

without hesitation."

This conviction is shared not only by an internationally known evangelist but by the rank and file of Southern Baptists from the Great Lakes to the Gulf and from New York to California.

But still we must ask ...

"HOW IS IT WITH OUR CONSCIENCE? HOW WELL ARE WE DOING IN WORLD MISSIONS THROUGH THE COOPERATIVE PROGRAM?"

Your committee is happy to report these gains in gifts through the Cooperative Program. Yet our consciences say there is much more we could be doing and so we make the following recommendations:

1. We recommend that our pastors focus on developing a GLOBAL CONSCIENCE

on the part of over 11,000,000 Southern Baptists.

2. We recommend that every church in the association include the Cooperative

Program in the budget on a percentage basis.

- 3. We recommend that in planning its budget each church undertake to set the percentage of its budget to be given through the Cooperative Program BEFORE rather than AFTER the other items in the budget are determined, thus implementing our conviction that missions is first rather than last in the responsibility of a Baptist church.
- 4. We recommend that our churches continue to use one of the stewardship development programs of the Stewardship Commission of the Southern Baptist Convention as the main instrument to plan, promote, and pledge the annual church budget. These stewardship development programs are:

Forward Program of Christian Stewardship Growth in Christian Stewardship Christian Family Stewardship Tithers Enrolment Week Weekend Stewardship Revival

WORLD MISSION CONFERENCE

You are encouraged to participate whole-heartedly in this endeavor.

Thus far, the following churches have committed to be a part of this World Mission Conference: East Sylva, Cullowhee, Buff Creek, Cashiers, Scotts Creek, Greens Creek, Sylva First, Jarrett Memorial, Lovedale, Mt. Pleasant, Schoal Creek, Wilkesdale, Tuckaseigee, Ochre Hill, and Old Savannah. Also, Cowee Church in Macon Association. At this hour, we still need four churches to complete our 20. If your church would like to be involved, please contact me immediately and I shall explain to you what is involved in having this World Mission Conference.

is involved in having this World Mission Conference.

There will be an Association-wide Mission Rally on Saturday night, September 13, at Scotts Creek Church in which all the churches of the association will be invited to participate to meet the missionaries and to hear a challenge concerning World Missions.

World Mission Conferences are like a telescope or binoculars. They bring into clear focus a distorted world in need. World Mission Conferences are like a microscope with a low, medium, and high powered lens. The mission book resembles the low powered lens; the visual aids are the medium powered lens; the missionaries we hear are the high powered lens. Each brings certain types of services, specific mission fields, and consecrated missionaries nearer and into clearer focus for the Baptist church members. World Mission Conferences are like a fluoroscope. The Holy Spirit beams the missionary's message through Baptist minds and hearts to reveal within themselves the selfish indifference, the unconcern, the unintentional ignorance of missions through stirred emotions and challenged responsible people determined to do more to spread the news of Christ everywhere. In the Tuckaseigee Association during the week of September 14-21, we hope this will be our objective during our World Mission Conference.

GEORGE W. TRUETT BAPTIST CAMP

To God Be the Glory! Yes, for this wonderful year at Truett Camp we must give our Lord the praise. This probably has been the best year ever in the history of the Camp. This season has shown marked progress in the improvement of facilities, program, finances, attendance, and in spiritual depth. Certainly God has blessed and we must praise His matchless Name.

The addition of a soft-ball field, two outdoor table tennis tables, a swimming pool, and an ice-making machine were the largest improvements to the facilities.

Probably the swimming pool was the most enjoyed addition.

For the first time, the Camp was able to enlist adult counselors for the Girls' Camps. Their experience and maturity provided a program that equaled the Boys' Camps.

The attendance was the best it has been in several years. It may have been the best ever. Every week's attendance exceeded the largest week of 1968. The Girls' Camps were so popular we had to add an extra week. There was an average attendance of 35 campers for the four weeks of Girls' Camps, plus an average staff of 9 each

week. The Boys' Camps averaged 30 campers with 9 staffers weekly. The average attendance for the full seven weeks was 33 campers plus 9 staffers. This gave a total average of 42 per week.

There was an average of 5 different associations represented each week. Every

association in Region 10 was represented during the season except one.

The finances increased considerably over last year. Last year only 9 churches from 5 associations contributed. They gave a total of \$1,186.00. This year witnessed 30 churches from 6 associations giving \$2,522.91. But even with the marked increase there are yet 220 churches in Region 10 who have not contributed anything. In order to improve the Camp as desired and planned, the Camp's income from the churches must increase far beyond what it presently receives. Certainly these churches that do not regularly give to the Camp should be urged to share in this ministry for Christ.

Each year the Spirit of God makes Himself known in the lives of the campers. This year was no exception. Almost every camper attending made some type of decision for Christ. Thirty of those attending received Jesus as their Lord and Saviour. There were a total of 107 decisions for Christ recorded during the camp season. These youngsters committing their lives to Christ is a blessing that far exceeds all

that was expended at Truett Camp in either time, talent, or money.

Yes, we praise the Lord for all His marvelous blessings. But we also realize that there remains much more to do. Until we can completely remodel the kitchen, and until we can erase the \$1,500 owing on two notes, we must postpone all further enlargement plans. To pay off the notes and remodel the kitchen means we need to raise approximately \$3,000 immediately. A plan to seek to raise money from individuals, over and above the church contributions, has not met with much success as yet. However, we are still working on it.

If those churches that are not giving will begin supporting the camp with regular gifts, and some of those already giving would increase their gifts, there is no limit to what can be done for the glory of God at Truett Camp next year. Lead your church into supporting YOUR camp, George W. Truett Baptist Camp, with your gifts and your

children.

BAPTIST HOMES FOR THE AGING

Never before have your Baptist Homes for the Aging been more conscious of the Lord's Presence and of His Goodness than during the past year. At a time when the economy of the Homes was at its lowest ebb, with a sizeable deficit looming larger by the moment, when the weather was at its severest on the 3rd Sunday of February, the day of the Special Offering, the churches came through with an offering that promises, at this point, to be the greatest in the Homes' history. The Lord, who is in charge of the weather and in charge of the Baptist Homes for the Aging, has surely rewarded our faith and moved upon our Baptist people to see the urgency of

our needs, and we are grateful.

Ours shall continue to be a relationship of trust in the Lord and faith in our Baptist people. We earnestly hope that a continued and sustained effort will be made by our churches to increase and strengthen the amount of the two main means of support for our ministry to the Aging-the Special Offering and the Cooperative Program. Through these two sources, one-third of the total income for the Homes is derived, and 85% of the residents, who are financially dependent, are cared for and supplemented. If we are to continue to assist these many needy persons, and if we are to reduce the deficit in the operation of the Homes, brought about by the rising cost of living, we must have more liberal support from our churches.

We do not believe that our Baptist people would want to curtail any of the vital

ministries of the Homes and that they will respond to this urgent appeal.

Since last year, the Yanceyville Home, our newest Home, has been filled to capacity, and we now have almost 200 deserving older men and women living in our midst there and in our other four Homes--Resthaven, and Hayes Home, in Winston-Salem, the Albermarle Home, in Albermarle, and the Hamilton Home, in Hamilton. These wonderful people are finding much happiness in Christian companionship with persons of their age group, and great security in knowing that they will be loved and cared for in sickness as well as in health.

It is a deeply rewarding experience to see the light and joy of Christ on an older person's face and to hear words of deep appreciation almost daily for the Christian love and nurture that North Carolina Baptists are making possible through the ministry. We believe, therefore, that our Baptist people will want to have an everincreasing part in so worthy a labor of love in the Master's Name. We know that the Lord will not fail us, and we also believe that our people will want to be as faithful as possible.

BAPTIST HOSPITAL

Our Medical Center continues a high quality program of medical care, training of medical personnel, and research in the causes and treatment of the diseases which afflict us. In the face of serious financial problems, the hospital staff is working more diligently than ever to minister to our people in keeping with their needs and

The hospital has instituted more efficient admission procedures regarding patients' to the limit of the hospital's resources. financial resources and plans for payment of hospital bills. Trained counselors are interviewing patients and their families regarding advance payments which are now required and for getting more accurate information on those who will need help. In this way they are able better to discover those patients who may be eligible for medical care assistance through Social Services departments or other health agencies, and can start proceedings at once for getting these patients certified if this has not already been done. These agencies pay a major part of the cost for a patient they certify, but not the total cost, and the Mother's Day Fund must pay the balance. A member of the family must go to the agency and give the necessary information, and getting this done is often a real problem. Many of our pastors have helped in this connection and have rendered important services for the patients and the hospital.

If it were not for the help which comes from these health agencies, our Mother's Day Fund would not last for three months. After paying the difference between what the agencies pay and the total cost for these patients, the Mother's Day Offerings are used to help as many as possible of those who are not eligible for certification and who themselves cannot pay the total cost of their care. First preference must be given to those patients whose needs are greatest and most urgent. The free care that the hospital gives must now be limited in keeping with the funds provided for this purpose, however, because the hospital cannot continue to go deeper in debt.

It is important that our people understand that all of the Mother's Day Offerings and designated gifts for this ministry are used for this purpose alone, and the hospital makes them go as far as it possibly can. The Trustees and Administration of the hospital are most grateful for the fine cooperation our pastors and our people are giving, and they earnestly solicit our understanding and generous support.

Article VIII

Add--All officers and committee members will hold office until the next annual association meeting.

Article VII

Change Promotions Committee to Missions Committee

BY-LAWS

By-Law 5, Section 7, will be deleted, and 7 shall be the following:

MISSIONS COMMITTEE OF THE TUCKASEIGEE ASSOCIATION

1. This committee shall be composed of the following Association officers: Sunday School Superintendent, Training Union Director, Woman's Missionary Union President, Brotherhood President, Chairman of Evangelism, Chairman of Associational Deacons, Treasurer, Moderator, and Chairman of Promotion Committee, and four members at large from member churches to be elected by the association at its annual meeting for 1,2,3, and 4 years respectively on a rotating system. After the election one new member shall be elected each year to serve for a period of four years.

2. The Missions Committee shall advise and work with the Associational Missionary in promoting the work in the Association and also lead and assist in organizing new churches, and also shall be responsible for encouraging and guiding the churches in the association to faithfully cooperate with the association program and emphases.

3. The committee shall meet once a quarter to receive a written report from the Associational Missionary and make helpful suggestions to him concerning his work.

4. If such advice is sought, it shall advise any group seeking to organize a new church, or seek to help any member church desiring assistance in its problems.

5. The Missions Committee shall perform the duties prescribed in the By-Laws on New Churches, and the By-Laws prescribing the Job Description on the Associational Missionary.

By-Law number 5, Section 8 will be:

NEW CHURCHES IN THE ASSOCIATION

1. Any church seeking admission to the membership of the Association shall petition in writing the Promotion Committee at least three months before the annual meeting of the Association, which petition shall be referred to the Missions Committee for its study on the petitioning church's covenant, articles of faith, history, practices, cooperative spirit, its relations to other churches of the association and its willingness to abide by the Constitution and By-Laws of the Association. The Missions Committee shall then report to the Associational Meeting with a copy thereof submitted to the Associational Promotion Committee at least thirty days prior to the Annual Meeting of the Association, its findings and recommendations for Associational action at the next annual meeting.

2. Each church applying for membership in the Association, upon approval, shall be received under the watch-care of the Association for a period of one year. Each church shall give a written report to the missions committee and the Promotion Committee each quarter of their work and giving toward associational program and

state and southwide participation.

The name EXECUTIVE COMMITTEE should be used throughout the Constitution rather than the dual system of Promotions Committee and Executive Committee.

4. The Calendar of Associational Activities was presented and approved for the year of 1969.

JANUARY 3, 1969

1. Old Brotherhood account of \$141.56 was transferred from special account at First Union Bank to the regular Associational account to be used during 1969 at the discretion of the Associational Deacon's Meeting.

2. A Committee was appointed to study needed Constitutional changes.

3. Lloyd Wood was elected to serve as Sunday School Superintendent for the Association for the remainder of the Association year.

4. Action was taken which led to the purchase of considerable office equipment during the months after this meeting. A limit of \$650.00 being allowed.

5. An Area Sunday School Training School for March 17-21, 1969 was approved for promotion.

MAY 8, 1969

1. The Association received the resignation of Robert Clegg from his committee and office positions in the Association.

2. Motion was made and approved that the Association work toward establishment of a Missions Committee, and that this committee would be charged to work WITH the Associational Missionary in the formulation and execution of the Associational

program.

3. Motion was made and approved that the minutes of the Executive Committee Meeting of August 21, 1968 be changed to specify that the tabling motion concerning Liberty Church be clarified to be applicable ONLY to "watchcare" considerations, and in no way to affect the invitation of the Association for Liberty to enter into dually aligned membership with Tuckaseigee Association.

JULY 28, 1969

No business transacted, due to lack of quorum. In addition, there was a fellowship meeting in December 1968.

ANNUITY BOARD OF THE SOUTHERN BAPTIST CONVENTION

INFLATIONARY TREND Continues

During 1968, neither inflation nor the economy showed any evidence of a slow down. Even as late as the second quarter of 1969, there was no sign of a leveling off by the inflationary trend. The cost of living rose 4.7% pushing the Consumer Price Index to a record 123.7 in December, 1968. This was the greatest increase since 1951.

This inflationary trend continued to affect the buying power of everyone, including

the retired.

To meet the needs of retiring ministers, church staff members, and denominational employees, the Annuity Board has developed the Southern Baptist Protection Program to provide an adequate retirement income. As the inflationary trend continues, many churches and agencies are upgrading their retirement programs by contributing 10% of total salary. The Annuity Board and state conventions heartily recommend this action.

Response to the three-plan Protection Program was good during 1968. The Program includes: Plan "A," the basic retirement fund; Plan "B," the supplementary fund; and Plan "C," the variable fund. Response was also good in the Life and Health Benefit Plans.

HIGHLIGHTS OF 1968

1. 3,451 new members in the Southern Baptist Protection Program

2. 23,714 members now participating in Plan "A," 1,538 more than in 1967

3. 18,086 churches providing protection for their pastors

4. 145 agencies providing protection for 9,894 employees

5. \$173,863 given in relief grants

6. \$6,543,169 paid in total relief and protection benefits

7. 3,106 applications for Health Benefit Plan, 1,677 net gain

8. 790 applications for Life Benefit Plan, 134 net gain

THIRD YEAR FOR "13th CHECK

For the third consecutive year, the Annuity Board issued a "13th check" to all recipients of life retirement benefits. The extra check, amounting to 12% of each person's annual benefit, was made possible by interest earnings in excess of the amount necessary to pay the retirement benefits. The excess earnings are distributed to plans of active members as well as to retired persons.

BAPTIST CHILDREN'S HOMES OF NORTH CAROLINA, INC.

Among church supported agencies, North Carolina Baptists are fortunate to have one of the finest programs in the nation for the care and development of dependent children and for the strengthening and supporting of family life. This is an application of the teaching and example of Christ in His earthly ministry. More than 1200 children and their families are served annually.

The Children's Homes, through a variety of quality services, is recognized as a family service agency. This is made possible by well trained and professional staff who provide leadership for group care programs, foster home care, family services, consultation with churches in preschool programs and planning for higher education of children who have been in care. This program unfolds on six campuses and through the work of regional casework centers throughout the state.

More requests for services are now coming to the Baptist Children's Homes than at any time in our previous history. All agency beds are filled and all available money is being utilized. We, too, have been caught in the rising costs of living and in an inflationary economy. A wider variety of quality services are being demanded to meet the needs of children who are the products of today's complex society. Present economic conditions make it necessary to have additional operating income with which to maintain the current program before any further expansion of services can be considered.

Friends of the Children's Homes, in Western North Carolina have responded generously to the Founders and Builders Program to raise funds with which to establish the Broyhill Home to serve children in Western North Carolina. Sufficient funds have been given and pledged to purchased the land, to prepare the site and to construct the first two cottages for children. When the campus has been completed provision will have been made for four cottages for children, a multi-purpose administration and activities building and a home for the superintendent. With the support and cooperation of Baptists and other friends of the Homes another ministry is being developed in Asheville. A home in which to serve unwed mothers and their offspring will be opened during the fall of 1969.

By the use of designated gifts and bequests from individuals and families, significant progress is being made in the long-range plans for upgrading of facilities. Two cottages are now under construction at Mills Home. A recreation building and an infirmary at Kennedy Home and two cottages for children at the Broyhill Home are scheduled for construction during the next year.

The contribution of our Baptist people through the Cooperative Program, the Thanksgiving Offering and special gifts are essential to our continued operation and are received with deep appreciation. An increasing number of friends are finding a rewarding stewardship opportunity through the establishment of trusts for the Homes and by means of wills and estate planning for the needs of dependent children. Members of the staff are available for consultation in estate planning and the preparation of wills.

When I came with the Foundation in 1962, the total assets were slightly over \$300,000. Today the total assets are in excess of \$1,000,000 which indicates a renewed interest in the services offered by our Foundation. One of our major purposes is to serve each Baptist whether he be rich or poor.

I would like to call to your attention the fact that we have four films available for your use. They are as follows: "Treasures in Heaven," "God's Will Through Yours," "Pastor, Do You Have A Will?" and "Generations to Come." These films can be obtained through the Program Services Department, Baptist State Convention, P.O. Box 9523, Raleigh, free of charge.

CHRISTIAN EDUCATION

The Division of Christian Higher Education of the Baptist State Convention functions chiefly through the Council. The Council membership is made up of the eighteen members of the Education Committee of the General Board, seven college presidents, seven chairmen of boards of trustees, and seven academic deans. Ex-officio members include the president of the Convention, president of the General Board, General-Secretary Treasurer of the Convention, and the president of the state Woman's Missionary Union.

Dr. Ben C. Fisher is director of the Division of Christian Higher Education and executive secretary of the Council. Miss Grace Yow is secretary to Dr. Fisher.

North Carolina Baptists now have a university, four senior colleges, and two junior colleges: Wake Forest University, Winston-Salem; Campbell Senior College, Buie's Creek; Mars Hill Senior College, Mars Hill; Meredith Senior College, Raleigh; Gardner-Webb Senior College, Boiling Springs; Chowan Junior College, Murfreesboro; and Wingate Junior College, Wingate.

There are currently enrolled in all North Carolina Baptist colleges approximately 12,000 students.

In these institutions there are more than 500 young men and women preparing for full-time Christian service. This includes those preparing for the gospel ministry, to be missionaries, educational directors, directors of church music, Christian college teachers, chaplains, and denominational workers.

In each college catalog may be found a statement of Christian purpose. The Christian college operates on the basic assumption that apart from religious commitment life can have no ultimate meaning. Jesus Christ is the foundation of all truth and provides the frame of reference in which all knowledge can be examined and used for the good of man and for the glory of God, and the two cannot be separated.

The North Carolina Baptist College curricula provides courses in the study of Bible, Church History, and related subjects which give students new insights and commitments to the Christian faith.

All colleges have regularly scheduled chapel services which provide an opportunity for worship, meditation, scripture, prayer, music, and preaching. Baptist colleges are not only concerned with the special role of training the Christian vocational worker, but they are also concerned with teaching and training churchmen who will take Christian views and sympathies into any vocation which they enter.

The Cooperative Program is the Baptist college lifeline. Administrations, faculties, students, trustees, and alumni are deeply grateful to North Carolina Baptists for this support.

The Baptist College Day offering has become another significant means of financial support to our Baptist colleges, and each church is urged to participate.

CALENDAR OF ACTIVITIES FOR 1969-1970

The Calendar Planning Committee after prayerful consideration recommends that the following major events be placed on the Associational Calendar for the 1969-1970 Associational year:

1. SEMINARY EXTENSION CLASSES to begin on Thursday night, September 4, to meet at the Liberty Baptist Church, Ochre Hill Baptist Church, Hamburg Baptist Church, and at a church in Savannah area. These classes should meet for 18

sessions over a four month period.

2. WORLD MISSION CONFERENCE, September 14-21, should involve 20 churches. The week will be divided into two sections, September 14-17, and September 18-21,

with 10 churches in either section.

- 3. ASSOCIATIONAL RALLY NIGHT on January 16. There will be training conferences for all church officers (Pastors, Deacons, Sunday School, Training Union, and W.M.U. Workers) and closing with an inspirational message by an outstanding speaker.
 - 4. RURAL CHURCH CONFERENCE on April 27. (Tentative)
 - 5. YOUTH NIGHT on March 14.
 - 6. "M" NIGHT on December 7.

Recognizing that it is impossible to remove all conflicts from the calendar, the Calendar Committee felt however that an effort should be made to remove as many conflicts as possible. Therefore, the Committee suggests that the 4th Monday night of each month be set aside by the pastors and churches and by the Associational Organizations as "Association Night." These nights could be used as follows:

1. "Association Night" of the first month of each quarter would be Pastor's and Sunday School Superintendent's Night. These meetings would be used by state and local leaders to Interpret the Program of the 70's.

2. "Associational Night" of the second month of each quarter would be Area Night under the direction of the Associational Missionary, in an attempt to meet with the churches of the different sections of the association, and discover how the association might best serve them.

3. "Association Night" of the third month of each quarter would be Leadership

Conferences for Sunday School and Training Union:

a. Sunday School will have conferences in September and March. b. Training Union will have conferences in June and November.

The Calendar Committee offers these suggestions recognizing that if any plan works it must be God's plan and have the cooperation of the pastors, churches and officers who make up the association. Therefore the committee urges the prayerful consideration and cooperation in this effort to harmonize the work of our Lord in this the Tuckaseigee Baptist Association.

The American Bible Society appreciates the privilege of serving all forms of Southern Baptist work around the world and the special opportunity of serving in the Crusade of the Americas. The entire program of Bible Society work is founded on these basic missionary principles:

PEOPLE MUST HAVE A BIBLE because it presents Jesus Christ, the one hope of

men and nations.

EACH PERSON MUST HAVE THE BIBLE IN HIS OWN LANGUAGE because it

speaks to his heart as no other language can speak.

THE BIBLE IS THE ESSENTIAL TOOL OF MISSIONS AND EVANGELISM. The missionary uses it in all his work. The Bible itself is a missionary. It can go where the human missionary can not go. It can stay on after he must leave-- and keep on speaking to a person's heart.

BUT, THERE IS A WORLDWIDE SHORTAGE OF BIBLES--because, IN MOST COUNTRIES, PEOPLE CANNOT AFFORD EVEN THE COST OF PRINTING THE SCRIP-

TURES.

The American Bible Society is a missionary nonprofit organization, serving churches of many denominations in the U.S.A. and abroad. It helps missionaries translate the Bible. It publishes the Scriptures without note or comment. It distributes without profit, usually below cost, and without any charge in cases of special need. For the Blind it supplies Scriptures in Braille and other raised-letter systems, Talking Bible records and tape recordings.

"GOD'S WORD FOR A NEW AGE" is the theme of the program of worldwide missionary advance being carried on by the American Bible Society, in cooperation with 34 other national Bible Societies around the world. Its aim is to provide greatly increased quantities of Scriptures urgently needed for mission work. Long range

goals are:

-- a Bible for every Christian home

-- a New Testament, at least, for every Christian

-- at least a Gospel, or other complete book of the Bible, for everyone who can

-- an opportunity for every church member to share in local Scripture distribution

DURING 1968 the American Bible Society--

--- rejoiced that some part of the Bible has been published in 1392 languages, spoken by 97 per cent of the world's people: the full Bible in 242, a Testament in 320 more, a Gospel or other complete book in 830 more. In 1968 Scriptures were published in 67 new languages. This was more than one per week -- and five times the average annual increase a few years ago. But, there are still over 1,000 languages in which not one book of the Bible has yet been published.

--- gave 2,153,015 Scripture volumes for distribution by Chaplains to our Armed Forces and Veterans, Hospitals, as a vital link between the home church and the men in service. Two out of every three members received a free copy of scripture as a gift from the American Bible Society in 1968. Military distribution was higher than in any year since World War II and was an increase of

80.8 per cent over 1967.

--- continued to develop Scriptures in everyday speech printed in attractive forms. Outstanding among these is "Good News for Modern Man," the Today's English Version New Testament. Illustrated with line drawings, it is available in paperback and in an inexpensive imitation leather binding. By summer 1969, its total distribution had exceeded 16 million copies. A similar New Testament in Popular Spanish, with the same line drawings, has been equally well received. Its total distribution by summer 1969 was more than 1 million copies. Such translations are also being published in French and a growing number of other

--- set new records by distributing 51,634,211 Scripture volumes in the U.S.A. and a total of 77,950,978 volumes, in over 800 languages, in some 150 countries. For the second straight year, one year's combined distribution of all Bible Societies broke the 1---million mark and totaled 110,488,279 volumes. This was 1 copy for every 25 people in areas open to the Bible, giving hope that a population explosion can be overtaken by a Scripture distribution explosion. SOUTHERN BAPTISTS SUPPORT THE WORK. Because the Bible Society serves mission work around the world -- and missionaries depend on the Society for Scriptures they need for their people -- Southern Baptists believe in the missionary importance

of giving to the American Bible Society. In 1968 Southern Baptist churches gave \$222,937 to the American Bible Society and ranked first among all denominations. Gifts from all churches in the U.S.A.


