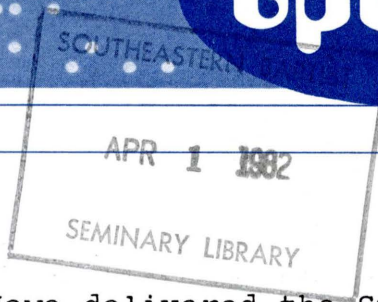

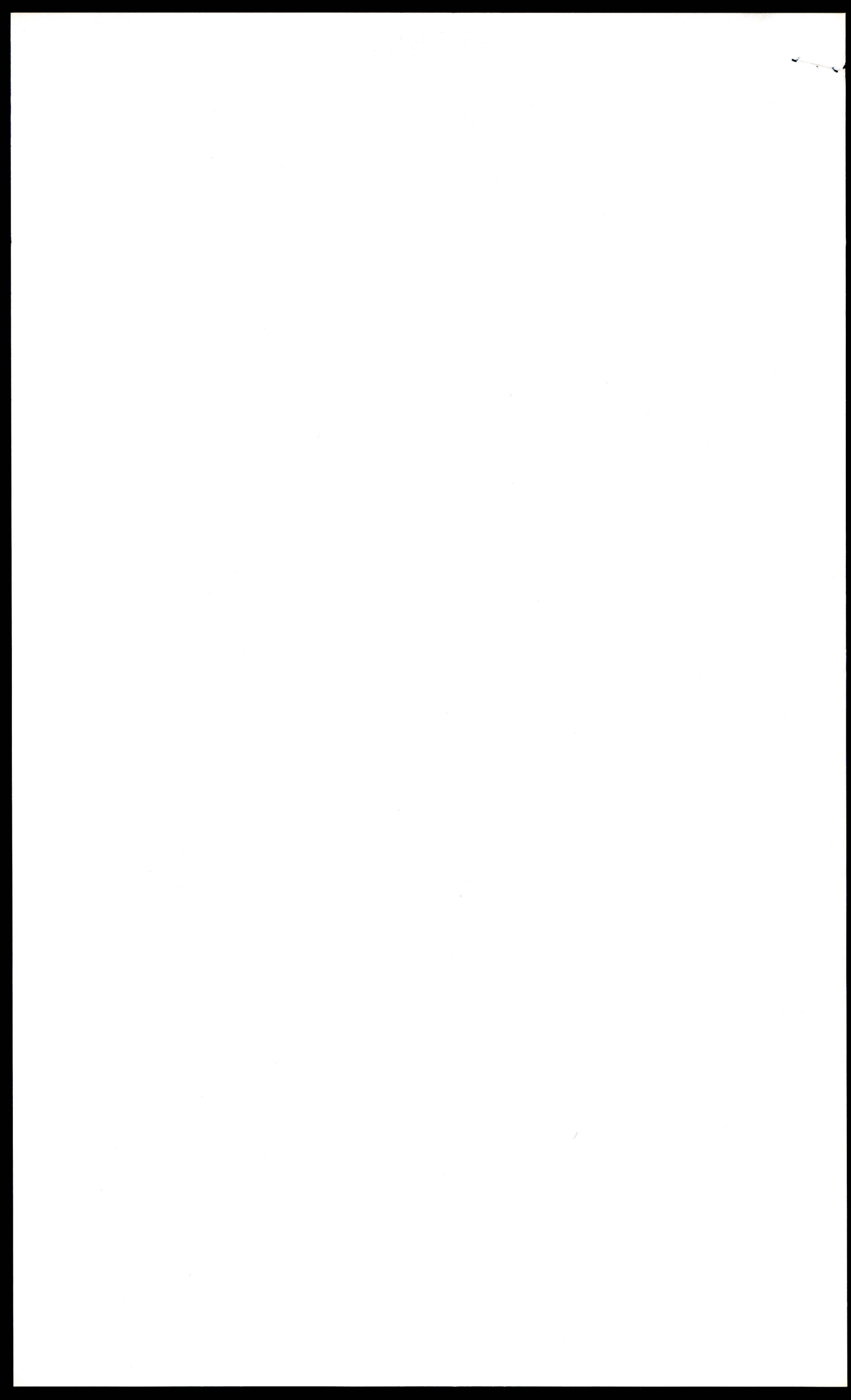

The trustees of Southeastern Seminary met on campus March 15-16. Among the actions taken were the following:

TRUSTEE
MEETING

1. Elected Dr. Charles Michael Hawn to the faculty as Associate Professor of Church Music to begin August 1, 1982.
2. Granted academic tenure to Dr. G. Thomas Halbrooks, Associate Professor of Church History.
3. Granted sabbatical leave (academic 1982-83) to: Dr. Donald E. Cook, Dr. Richard L. Hester, Dr. Glenn T. Miller, Dr. Alan P. Neely.
4. Adopted a budget for 1982-83 in amount of \$4,589,773.
5. Provided a 2% on base salary Cooperative Program Performance check for all employees, April 1, 1982.
6. Set matriculation fee beginning with the fall semester at \$225/semester (same as other 5 SBC seminaries). Surcharge for non-Baptist students is \$225/semester.



7. Declared certain items surplus to be sold at a very reasonable price first to seminary people and later to anyone interested.
8. Approved a Study-Improvement Plan for the non-faculty members on the Executive Council.
9. Named the Seminary Library Reference Collection in memory of Edwin Calhoun Osburn, the seminary's first Librarian.
10. Instructed President Lolley to apply to the Lilly Endowment for a conference on the Future of Theological Education.
11. Adopted a Master Campus Landscape Plan.
12. Increased the seminary's all risk insurance policy.
13. Disallowed the seminary from accepting any gift (as tax deductible) from a parent of a student, or any person who might claim that student as a dependent, when such a gift is restricted to the exclusive use of, or for the exclusive benefit of a student who might be the donor's dependent.
14. Re-named Johnson Classroom Building, after its renovation, to Theodore F. Adams Hall (with proper recognition to the Johnson family for the original gift for the building).
15. Established:
 - The Warren-Poe Award for Rural Church Ministry Endowment Fund
 - The George and Eleanor Balentine Endowment Fund (student aid)
 - The Broyhill Hall Maintenance Endowment Fund
 - The Canadian Baptist Student Endowed Scholarship Fund
16. Approved the Future Ministries Fund.
17. Approved a Pooled Income Fund.
18. Adopted a resolution of appreciation for California trustee, Bobby Joe Headen, who died February 18, 1982.
19. Elected Frank Jordan, pastor in National City, California, as trustee to Bobby Joe Headen's unexpired term.
20. Commissioned President Lolley to visit every new trustee during the first year of his/her service on the Board.
