PROCEEDINGS.

MT. OLIVE, WAYNE COUNTY, N C., October 6th, 1885.

The Eastern Baptist Association met in its forty-first annual session in the Mt. Olive church.

The Introductory Sermon was preached by Elder W. B. Pope. Adjourned to 2½ o'clock.

Association assembled at the appointed hour. In the absence of the former Moderator, who was kept away by sickness, Elder W. M. Kennedy was called to the chair pro tem.

Religious exercises conducted by the Moderator. Elder T. Carrick led in

List of churches called and a majority found to be represented Brethren L. R. Carroll and J. T. Bland were appointed reading clerks.

On motion, a Finance Committee was appointed consisting of B. Matthews, J. C. Hines and E. D. Wells.

On motion, brother I. Carroll was recognized as a delegate from Mt. Holly. Committee of Arrangements was appointed, consisting of pastor and deacons of this church and J. T. Bland.

Association proceeded with next order of business, which was the election of

officers for the ensuing year.

The following brethren were appointed tellers: For Moderator—B. S. Montford and Kedar Vann. For Clerk—C. E. Daniel and F. A. Fennell. For Treasurer—J. H. Loftin and E. C. Herring.

Result-Elder W. M. Kennedy was elected Moderator; Elder J. L. Britt

re-elected Clerk; A. M. Faison re-elected Treasurer.

It was moved and carried that committees be appointed on the same subjects

as last year.

Article 3 of the Constitution was changed so as to read as follows: "This Association shall be composed of all ordained ministers, members of churches of this body, and three delegates from each church, elected by the church in conference assembled."

Invitation extended to visiting brethren.

The following accepted the invitation: Elder J. W. Wildman, representative of Home Mission Board; Elder W. B. Pope, Elder D. C. Kelly, of Cape Fear Association; Kedar Vann, of the South River Association.

A letter from Capernaum, which had been inadvertently stricken from the roll of churches, was presented to the Association, and after statements in regard to the matter by Elder C. S. Cashwell, the letter was received and the church, by its own request, dismissed to join the Atlantic Association.

The Clerk was instructed to inform them of the action of the Association. Petitionary letters were called for. Letters from Caswell and Teachey were presented and referred to a committee. Committee—J. T. Bland, O. Black-

burn and B. S. Peterson.

On motion committee on Home Missions was appointed. Committee Elders J. W. Wildman, R. T. Bryan and F. A. Fennell, and made special order for to-morrow 10 o'clock.

Committee of Arrangements reported, as follows:

Preaching to-night at the Baptist church by Elder J. W. Wildman; at the Methodist church by Elder Thos. Carrick. Association meet to-morrow at 9 o'clock; Missionary Sermon at 11 o'clock, by Dr. T. H. Pritchard; adjourn at 12½ o'clock; meet again at 2 o'clock, and adjourn at will.

On motion, adjourned. Prayer by Elder R. T. Bryan.

SECOND DAY-MORNING SESSION.

WEDNESDAY, October 7th, 1885.

Religious exercises conducted by Elder R. T. Vann.
Moderator called the Association to order.
Roll of delegates called.
Minutes of yesterday read and approved.
Visiting brethren were invited to seats. Dr. T. Whitfield announced himself

present in the interest of Foreign Missions, Elder C. J. Nelson and Bro. J. E. Peterson as messengers from Atlantic Association; Elder R. T. Vann as representative of Board of Education; Bro. J. E. Ray as Corresponding Secretary of Baptist State Convention; Elder C. S. Farriss Associate Editor of BIBLICAL RECORDER; Elder W. R. Gwaltney as messenger from Beulah Association; Bro. J. B. Brewer as messenger from West Chowan Association and representative of Chowan Baptist Female Institute; Bro. M. M. Hargrove from Oxford Female Seminary; Bro. J. H. Mills as representative of Baptist Orphanage Association. All were cordially welcomed by the Moderator.

Committee to examine Petitionary Letters reported, as follows:

Your committee appointed to examine petitionary letters from Caswell and Teachey Baptist churches, beg leave to report that they have examined into the constitution of said churches and are satisfied that the organization of said churches is regular in all respects, having adopted the usual church covenant and the articles of faith taken from the New Hampshire confession. REPORT ON HOME MISSIONS.

The Home Mission Board of the Southern Baptist Convention aims to preach the gospel in destitute places in the South and to the Indians, to furnish instruction to the colored ministry, and to aid in the building of houses of worship where they are needed. During last year the Board had employed 185 missionaries, who supplied 426 churches and stations; baptized 2,931; received 1,733 by letter and constituted 53 new churches. Of these missionaries there labored in Arkansas 21, Florida 34, Indian Territory 21, Louisiana 6, Texas 81, Western North Carolina 12, and in other States 10.

The Board received last year \$67,247.82, of which \$55,633.17 were spent in the support of missionaries, and about \$5,000.00 in church building. During the present year the Board has spent about \$15,000.00 in church building and has two hundred missionaries employed. This enlargement of work will require more money. The Board asks North Carolina for \$5,000.00, and asks

the Eastern Association to contribute \$100.00 of the amount.

If we can raise from all sources this year \$100,000.00, the Board can pay its 200 missionaries now in the field, furnish instruction to the colored ministry in every State in the South, and induce the building of a hundred houses of worship. Houses of worship are needed There are a thousand white Baptist churches in the South which have no houses of worship—many of these are places of great importance. Twenty-five county towns in Arkansas are without either Baptist churches or houses of worship. There is a pressing need-for fifty missionaries in that State to-day. In Louisiana there are twenty-eight parishes or counties where there is not a Baptist preacher or house of worship.

The five thousand dollars expended in Florida "does not half supply the needs of the field. West Florida alone requires to supply her wants more than all the State receives." Then the mountain region of Georgia, Tennessee, Kentucky, Virginia and Western North Carolina is a vast field for missionary labor. The Secretary of the Board says: "The truth is that it would require five times the amount we ask to supply all the destitution which appeals to us

for help."

In view of the needs of the work we recommend that the Eastern Association raise among the churches for this work at least one hundred dollars and forward it before next April to Bro. Briggs, and this amount be apportioned among the churches, and printed in the minutes with the name of some member in each church to whom Home Mission intelligence may be sent for distribution.

REPORT ON FOREIGN MISSIONS.

Christianity is a missionary religion. "If any man have not the spirit of Christ, he is none of his," Rom. 8:9. Christ was a foreign missionary, and his marching order is, "Go ye therefore and disciple all nations." His spirit is the missionary spirit. We are glad that christians everywhere are growing in this spirit. The Southern Baptists are literally carrying out the command to teach all nations, for they have about fifty missionaries besides native assistants who are preaching in every grand division of the world. China in Asia, Italy in Europe, Brazil in South America, Mexico in North America and in Africa.

God is blessing our labors everywhere. We have fallen far short of our duty in this great work. God's never failing promises, his blessings upon our efforts, the millions of heathen whose sad cry is, "Come over into Macedonia and help us," God's direct command, and our sympathy for lost souls, all these urge us to increase our praying, our working and our giving. Great is our sin if we do not. God has given North Carolina three men for the field instead of one, and this calls upon us who remain at home to increase our efforts.

The Foreign Mission Board asks for \$100,000.00 from the South. North Carolina is asked to raise \$8,000.00 of this amount, which is only eight cents per member. Brethren, surely you are willing to raise and will raise the small

amount of eight cents per member in your Association.

Your committee recommend that each church try to raise its proportionate of this sum. We also recommend that each church try to get the *Foreign Mission Journal* in every family.

EVENING SESSION.

Moderator called Association to order. Prayer by Elder C. S. Farriss.

Committee to whom was referred the case of Magnolia church difficulty, reported as follows:

Your committee appointed to look into the matter of the two letters sent up from Magnolia church, beg leave to make the following report:

I. That upon examination we find neither letter nor set of delegates came up in regular form, but the letters were sent by two respective factions.

2. We recommend that this Association do not recognize either set of dele-

gates.

3. We recommend the following statistical table, as agreed upon by both factions, to be inserted in the minutes of the Association: baptized, I; received by letter, 6; dismissed by letter, 9; excluded, 2; died, 2; No. of males, 87; No. of females, 161. Whole number, 248. Pastor's salary, \$100.00; church expenses, \$12.00; minute fund, \$2.00. Church clerk, G. M. Swinson, P. O. Magnolia.

4. We would recommend that on Saturday before the third Sunday in October, that the good men of two factions of Magnolia Baptist church come to-

gether in regular conference, pay up the pastor, T. J. Baker, and ask for his

resignation, and then unite on some man as pastor of the church.

5. We recommend that the brethren of Magnolia Baptist church lay aside all prejudice and personal feelings in this matter, and that with the pastor, whom the church shall call, that the church shall use such discipline as may be necessary to purge out all members who may not be living christian lives; Provided, however, that said discipline be not by some unbending rule, but that it be in accordance with the teachings of the New Testament.

Trustees of Warsaw High School reported, as follows:

At the last session of this body we reported this school in a flourishing condition. Various needed improvements had recently been made upon the property, which added much to its general appearance, comfort and value. The prospects were truly gratifying. Hence it is with intensified regret that we now report the entire destruction of the school building by fire on the evening of the 21st February, 1885.

The indomitable courage and perseverance of the Principals, however, were equal to the emergency, and in less than three days other buildings were rented, and the school was progressing as before, but of course under less favorable

circumstances.

The Principals have recently purchased and enlarged, at their own expense, certain other property adjoining the school property, and are making earnest efforts to estublish such a school as will not only reflect credit upon themselves, but the entire Association.

Brethren, such effort, such zeal, such perseverance in support of such a cause, is worthy of our immediate recognition, and demands our warmest co-operation and support. Another building on the old site is absolutely necessary to make the school what it has been, what it ought to be, and what it will be if you so desire it. Do you desire it?

On motion, Bro. J. H. Mills was requested to address the Association upon the subject of the Baptist Orphanage of the State. He delivered an address of great power upon the subject of Charity, and raised for the Orphanage in cash \$46.80.

On motion, decided to hold a session of the Association to-night, and Associational Missions made special order.

Adjourned. Prayer by Bro. John E. Ray.

NIGHT SESSION.

Moderator mentions the fact that the former Moderator of this body, Elder J. L. Stewart, is kept away by sickness. Prayer is offered for him, led by Elder J. B. Barlow.

Associational Missions being special order, report of Executive Committee was read.

REPORT OF EXECUTIVE COMMITTEE.

Dear brethren, at the beginning of the past associational year, the means at our disposal did not enable us to secure the services of a missionary for the whole of his time.

During the year we have had in our employ for a part of their time brethren C. S. Cashwell, J. P. Faison and W. M. Kennedy. Rev. C. S. Cashwell has preached regularly once a month since March at Rose Hill, and reports three baptisms. Rev. J. P. Faison has given one-fourth of his time since May to the church at Salem, at which place he, with the assistance of Rev. E. S. Alderman, held a series of meetings in which the church was much revived and a Sabbath school organized. He has also spent some time at Catharine Lake and other places lower down in Onslow. We also made a small appropriation to the churches at Hallsville and Chinquepin, which enabled them to secure the services of Rev. W. M. Kennedy, which resulted in twelve baptisms and several others awating baptism at Chinquepin.

Dear brethren, our destitution is indeed great and the cries which come up are numerous and urgent and as we of your committee have no strength of our own with which to help them, we are entirely dependent upon the strength which we receive from the churches. Brethren will you help them?

Pending motion to adopt, the Association was addressed by Bro. J. E Ray Collection taken up for State Missions amounting to \$18.00

REPORT ON STATE MISSIONS.

The object of the State Mission Board is to send the gospel into every portion of North Carolina which is destitute of Baptist preaching. For more than

fifty years this work has been prosecuted, and men have been sent into nearly every county in the State, carrying the glad news of salvation. God has wonderfully blessed the efforts put forth, and the Holy Spirit has accompanied the word, and the seeds sown produced bountiful harvests.

Within the past three years thirty-nine new churches have been organized, twenty-eight meeting-houses erected, and more than three thousand souls have professed faith, as the direct results of the labors of our missionaries alone.

The demands upon the State Board of Missions are continually increasing, and newer and wider and more inviting fields keep opening up to our Baptist people, until this year the Board has commissioned seventy men and sent them out to break the bread of life to the perishing souls who are so eagerly asking for it.

But "there remaineth yet much land to be possessed." There are six counties in the State in which there are only four Baptist churches, and six counties in which there is not one Baptist preacher. The Board of Missions is doing all it can to supply this destitution and is now crying to the churches for means to pay the men already sent out.

Brethren, let our motto be: "North Carolina for Jesus Christ," and not rest satisfied until there is a Baptist church in every town and neighborhood in the State. Respectfully submitted,

There are thirty-one young men studying for the ministry at Wake Forest, twenty-eight of whom are aided by the Board of Education, and many more would be there, were the means at command to help them prepare for the work

Your committee would earnestly recommend the churches to pray the Lord of the harvest to send forth more laborers into the field, and to encourage in every legitimate way those among us who may feel called of God to preach the

REPORT ON SUNDAY SCHOOLS.

Your Committee on Sunday Schools has made a careful examination of the reports from the churches and find much that is encouraging. 43 churches have reported, and of this number 36 have Sunday schools, and some have mission schools; thus enabling us to report 43 schools, with 286 officers and teachers, and 2,465 pupils.

A large majority of the schools meet throughout the year. Some of our

churches have not reported schools, yet we know that many of them are laboring in union schools; we would urge upon them the importance of making their schools Baptist schools as soon as practicable.

From the statistics we are forced to the conclusion that but few of our church members are laboring in the Sunday schools; this is not as it should be, and we trust that, so far as they can, the pastors will see that all their members become active laborers in this great work.

We deem it advisable that the Association appoint a Sunday School Board to labor in the interest of this work within our bounds, and hope that you will consider this matter.

CHURCH COVENANT.

Having been led, as we believe, by the Spirit of God, to receive the Lord Jesus Christ as our Saviour, and on the profession of our faith, having been baptized in the name of the Father, and of the Son, and of the Holy Ghost, we do now, in the presence of God, angels and this assembly, most solemnly and joyfully enter into covenant with one another, as one body in Christ.

We engage, therefore, by the aid of the Holy Ghost, to walk together in Christian love; to strive for the advancement of this church in knowledge, holiness and comfort; to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the church, the relief of the poor, and the spread of the Gospel through all nations.

We also engage to maintain family and secret devotion; to religiously educate our children; to seek the salvation of our kindred and acquaintances; to walk circumspectly in the world; to be just in our dealings, faithful in our engagements and exemplary in our deportment; to avoid all tattling, backbiting and excessive anger; to abstain from the sale and use of intoxicating drinks as a beverage; and to be zealous in our efforts to advance the Kingdom of our Saviour.

We further engage to watch over one another in brotherly love; to remember each other in prayer; to aid each other in sickness and distress; to cultivate Christian sympathy in feeling and courtesy in speech; to be slow to take offense, but always ready for reconciliation, and mindful of the rules of our Saviour, to secure it without delay.

We moreover engage, that when we remove from this place we will as soon as possible unite with some other church, where we can carry out the spirit of

this covenant, and the principles of God's word.

RULES OF ORDER.

- I. On the meeting of the Association, the Moderator of the preceding session shall preside until his successor is known. In case of his absence a chairman pro tem. shall be elected.
- 2. Each session of the Association shall be opened with religious exercises, to be conducted by whomsoever the presiding officer may name.
- 3. At each daily session, and previous to proceeding to business, the names of the delegates shall be called, and the proceedings of the previous daily session read.
- 4. The members shall observe toward the officers and each other that courtesy which becomes Christians.
- 5. Any member wishing to speak shall rise and address the presiding officer. He shall confine himself strictly to the question under consideration, and avoid personalities.
- 6. No member shall speak more than twice on the same question without permission.
- 7. All motions seconded shall be definitely stated by the presiding officer before discussion.
- 8. No motion shall be withdrawn after discussion.
- 9. When a question is under discussion, no motion or proposition shall be received except to adjourn, to amend, to commit, to postpone to a definite time, which several motions shall have preference in the order in which they are stated.

10. After a motion has been decided, any member having voted in the majority may move a reconsideration.

11. No member shall absent himself during the session of the Association without permission of the presiding officer, and no one shall take final leave of absense without the permission of the Association; and if any shall do so their absence shall be noted in the minutes,

12. All questions, except such as relate to the Constitution, shall be decided by a majority of votes.

13. The Association shall have the right to decide what subjects shall be admitted to consideration.

14. The Rules of Order may be altered or amended at any session of the Association by a majority of votes.

CONSTITUTION OF THE EASTERN ASSOCIATION

ARTICLE 1. This Association shall be denominated and known as the Eastern Association.

ARTICLE 2. The object of this Association shall be the promotion of Christ's kingdom among men; and the means of accomplishing this shall be in strict conformity to the New Testament.

ARTICLE 3. This Association shall be composed of all ordained ministers members of churches of this body, and three delegates from each church elected by the church in conference assembled.

ARTICLE 4. The delegates from each church shall bear a letter certifying their appointment and communicating information relative to the state of the church: *Provided, however*, That when any church has prepared a letter and through inadvertence the letter fails to be presented, her delegates may be received without its presentation.

ARTICLE 5. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be chosen annually from among its members by ballot, by a majority of the members voting, and continue in office until their successors are elected.

ARTICLE 6. It shall be the duty of the Moderator to enforce an observance of the Constitution, preserve order, appoint committees, decide all questions of order, give his opinion on any question under discussion after others have spoken, and give the casting vote in case of a tie.

ARTICLE 7. It shall be the duty of the Clerk to record the proceedings of each annual session and superintend their printing and distribution among the churches

ARTICLE 8. It shall be the duty of the Treasurer to receive all funds sent up by the churches, or collected during the session of this body, and disburse the same as ordered by the Association. He shall also make to the Association an annual report of the condition of the treasury.

ARTICLE 9. The Association shall appoint an Executive Committee of seven members, which committee shall have the superintendence of Associational Missions and Colportage. They shall have power to disburse all sums paid by the Treasurer of the Association for the objects under their charge, and during intervals between the meetings of this body to receive and disburse funds for those objects, and to take such steps for their advancement as they shall deem advisable, and shall make an annual report to the Association of their doings.

ARTICLE 10. The Association shall not maintain fellowship with any of the churches which neglect to preserve Gospel order.

ARTICLE II. The Association may invite visiting and corresponding brethren to seats, and extend to them all the privileges of the body except that of voting.

ARTICLE 12. The annual session of this Association shall commence on Tuesday after the first Lord's Day in October, at such place as may be chosen.

ART. 13. By appointment of the Association there shall be an Introductory Sermon of a denominational character, and a Missionary Sermon.

ART. 14. This Constitution may be amended at any annual session by a vote of two-thirds of the members present.
