CONSTITUTION,

1st. This Association shall be known as the Brushy Mountain Baptist Association, and shall be composed of delegates chosen by the churches, each church being entitled to three delegates, and all regular ordained ministers as members ex-

2nd. The object of this Association shall be the promotion

of God's kindgom in the hearts of men.

3rd. The delegates thus selected should bear from each respective church a letter certifying their appointment, and communicating information relative to the state of the church and interest thereof.

4th. The Association just formed shall choose by ballot a Moderator, Clerk and Treasurer who shall continue in office for one year, and until others are chosen. The last two

offices may be held by the same individual.

5th. It shall be the duty of the Moderator to preside at meetings of business; to keep order during each session; to decide questions of order, subject to an appeal of the house by any member; and to perform all other duties pertaining to his office.

6th. It shall be the duty of the Clerk to keep a faithful and correct record of all the proceedings of each session of the Association; to keep a printed copy of the minutes of each session of the Association, and every ten years have

them bound for the use of this body; and to perform other duty assigned to him by the Association.

7th. It shall be the duty of the Treasurer to keep a correct record of all the funds coming into his hands and to report the same at the order of the Association.

8th. There shall be a Committee of Arrangements consist-

ing of five members, besides the Moderator and Clerk.

9th. All letters of grievances or queries, together with all letters from corresponding Associations requiring any attention thereon, shall be submitted to the Committee of Arrangements, and reported back to the Association.

10th. This body shall have no coercive power to exercise lordship over God's heritage, but shall only be considered an advisory council in all matters respecting the internal regula-

tions of the churches.

11th. When an offense may have been committed by one church against another, or where a series of difficulties may have arisen in an indiividual church, it shall be the duty of the Association (after due labors have been had between the offending and offended churches, or an individual church, as the case may be) to take the matter into consideration and advise upon it.

12th. The Association shall not maintain permanant fellowship towards any of her churches which neglect to institute and preserve gospel order among their members, nor any of the churches and ministers that treat her constitution with contempt; but shall sustain with all her influence such

as promote gospel principle and order.

13th. It shall be the province of this Association to invite

visiting and corresponding brethren to seats, who shall be entitled to speak on any point under discussion, but not to

14th. The Association shall in all cases, (except in matters pertaining to the constitution), be governed by a majority of the members present, and shall not adjourn until they have gone through the business of the Association, except in extraordinary cases.

15th. Each church having an ordained or a licensed minister shall report the same to the Association, in order that

they may appear on the face of the minutes.

16th. The Association shall furnish the churches with the minutes of her proceedings; and it shall be the duty of the

churches to enable her to do so.

17th. The Association shall have a fund, created and sustained by voluntary contribution from the churches, which shall be held by the Treasurer and subject to the disposition of a majority of the Association present at any annual

18th. The Association shall hold an annual session at such time and place as the body may from time to time designate.

19th. By appointment of the Association, there may be an Introductory, a Missionary and a Denominational Sermon preached at each annual session.

20th. This Constitution may be altered or amended at any

time, two-thirds of the members present concurring.

BY-LAWS.

1st. At each assembling of the Association, for the transaction of business, the Moderator shall invite members to order; then the Association shall be opened by praise and

2d. When the Moderator takes his chair, each member shall take his seat, and the minutes of the preceeding day

shall be read.

3d. The Moderator may speak to points of order, in preference to other members, arising from his seat for that purpose; and on points of order, no member shall speak more than once without leave of the house.

4th. He shall rise to put a question, but may state it

sitting.

5th. All committees shall be appointed by the Moderator, unless otherwise ordered by the body.

6th. He shall have a general direction of the house: he shall have a right to name any member to perform the duties

7th. When any member is about to speak in debate or deliver any matter to the Association he shall rise from his

seat and respectfully address the Moderator, and confine himself to the question under debate, and avoid personality. And when two or more rise at the same time the Moderator is to name who is to speak first. No member shall speak oftener than twice on the same question, without leave of the

8th. While the Moderator is putting any question or addressing the Association no person shall speak, stand up, walk out, or across the house; nor when a member is speaking, entertain private discourse, stand up or pass between him and the chair.

9th. After a motion is stated by the Moderator or read by the Clerk, it shall be deemed to be in possession of the Association, but may be withdrawn before a decision or amend-

10th. All papers addressed to the Association shall be presented by the Moderator.

11th. No member shall absent himself from the Association without leave.

12th. If any member, in speaking or otherwise, transgress the rules of the Association, the Moderator shall, or any member may, call him to order; in which case the member so called to order, shall sit down.

13th. In all elections, the Moderator may vote: in other cases he shall not vote, unless the Association be equally

14th. These Rules of Decorum may be altered or amended by a majority concurring.

ABSTRACT OF PRINCIPLES.

1st. We believe in one only true and living God, and that there are three persons in the Godhead-the Father, the Son and the Holy Ghost, and these three are one.

2d. We believe that the old and new Testaments are the word of God and the only rule of Faith and Practice.

3d. We believe in the impotency of man to deliver himself from his present fallen state.

4th. We believe that Salvation is by Grace through faith

in our Lord Jesus Christ.

5th. We believe the Baptism and the Lord's Supper are ordinances instituted by Jesus Christ and should be practiced by all true believers.

6th. We believe that Baptism is immersion of a believer in water by a qualified administrator, and that only persons thus baptised should take the Lord's Supper.

7th. We believe in the final perseverance of the Saints in Grace to Glory.

8th. We believe in the resurrection of the dead and a Gen-

9th. We believe that the happiness of the Righteous and the punishment of the Wicked will both be Eternal.

MINUTES

OF THE

BRUSHY MOUNTAIN ASSOCIATION

THIRTY-THIRD ANNUAL SESSION

North, Wilkesboro, N. C., Aug. 23, 1906.

The Brushy Mountain Association met in its thirtythird annual session in the meeting house of the Harmony Baptist Church, at 12:30 p. m., Thursday, Aug. 23, 1906.

In the absence of M. McNeil, who was appointed to preach the annual sermon, it was preached by Rev. W. F. Staley of North Wilkesboro, N. C., Text, Zech. 4:8. Theme, The Function of the Holy Spirit during this age.

C. C. Wright, Moderator of the previous Association, then assumed the chair and called the body to order.

The roll of churches was called and the following were represented by delegates with letters: Cub Creek, Edgewood, Harmony, Moravian Falls, Mt. Carmel, Mt. Zion, New Hope, North Wilkesboro, Pleasant Grove, Pilgrim, Shady Grove, South Fork, Stony Hill, Walnut Grove, Wilkesboro, and Zion Hill, and the letters were read by W. F. Staley and W H. REPORT OF HOME MISSIONS.

Home Missions as applied to the work of Evangelizing our own country, under the auspices of the Home Board of Atlanta, Georgia, presents a work that should appeal to every Baptist in the Association, as well as elsewhere.

The great work done in our State in aiding our Mountain Schools should make us peculiarly grateful. Besides but for the efforts of this Board in the past, many, now strong points, in our State would be struggling for existence or unheard of. One million dollars could be used by the Board profitably with glorious results.

The new work recently undertaken by the Board promises much for the future of our destitute fields, especially in our large cities, where the influx of imigration is greatest.

We pray that our people may arise to their privilege and meet the opportunity of extending this great work.

We had on the field in 1905, 718 Missionaries; 88,016 sermons and addresses; 10,551 baptisms; 10,019 additions by letter-total additions 20,570. For this year, 1906, we have 838 missionaries; 102,339 sermons and addresses, 12,630 baptisms; 12,178 additions by letter—total additions 24,808. Increase since 1905, missionaries 120; sermons 14,323; baptisms 2,179; additions by letter 2,159-total 4,238.

REPORT ON STATE MISSIONS.

The work of giving the gospel to the destitute in North Carolina, establishing churches, organizing Sunday Schools, aiding weak churches, and promoting Christian benevolence among our people, is the work of the State Mission Board. We believe that God will bless our labors in this work. Eternity only will reveal to us the result of our work done in North Carolina We believe that we could do no greater work than to support our Missionaries in this great mission work. The great work of christianizing our State belongs to us as Baptist.

We pray God to send more laborers into the field that His Kingdom may be set up in the hearts of our people. We recommend that every church in this Assoriation make a lib-

eral offering to the great work.

THIRD DAY—MORNING SESSION.

The Association met at 9:45 a.m. and the devotional exercise was conducted by Rev. Asa Brown.

The record of vesterday's proceedings was read and adopted.

The following visitors were recognized and welcomed. Rev. M. L. Kesler of the Orphanage, Rev. D. W. Pool of the Alexander Association, and Rev. T. E. Readmon of the Brier Creek Association.

The report on education was read by W. F. Staley.

REPORT ON EDUCATION.

"Education is either from nature, from man, or from things: The developing of our faculties and organs is the Education of nature; that of man is the application we learn to make of this very developing, and that of things is the experience we acquire in regard to the different objects by which we are affected. All that we have not at our birth and that we stand in need of at the years of maturity is the Gift of Education."—Rousseau. We are living in an Educational age; never before in the history of our race has there been greater emphasis laid on the value of Education, than at the present time. Our schools are crowded each session and the call to-day is for Educated men and women. Therefore we realize that Education is an indispensable factor in the development of men and women in any station of life. What sculpture is to a block of marble, Education is to the Human soul. It evokes our latent powers, and lifts from obscurity to prominence and usefulness. It sharpens our mental powers, so we are enabled to serve God, and humanity better. We ragard illiteracy as a misfortune. Some states have compulsory law which has proved to be a great blessing. If boys and girls abuse their opportunities to acquire an Education it becomes a crime. We further recognize that the State is inadequate to impart Christian Education, consequently as Baptist there is a special work for us to do. When we patronize our Institutions of learning a twofold benefit is derived, first, Mental Training, second, Heart Culture. The Christian atmosphere in our schools is conclusive to developing strong Characters. Each year finds over three hundred young men and women in our College and University, and between sixty and

seventy-five Ministerial students in Wake Forest College. For a preparatory school we recommend Mars Hill College. For Collegiate course Wake Forest College, and for women the Seminary at Oxford, and the Baptist Female University. For Ministerial students the Southern Baptist Theological Seminary. We earnestly urge that our people will seek to patronize our own institutions of learning, which will strengthen the work of the denomination.

REPORT ON THE ORPHANAGE.

The condition of our Orphanage at Thomasville is gratifying to a high degree. The past year has been one of unusual prosperity. We have cared for three hundred and thirteen children and paid about \$6,000,00 of the indebtedness incurred in establishing a system of water works. The general health of the children has been most excellent. The grounds have been greatly beautified and improved. Several new buildings have been completed and some of the old ones have been torn down and the material used in the construction of others. The demand upon us was never more pressing than now, and some important improvements will be made at once. The dining room will be enlarged, the Aydlett building will be erected and a new Infirmary will be erected as soon as the money can be had to build it. Just this week the Liberty Association [assumed the responsibility of building a new Tabernacle for the annual meetings which will hold between three and five thousand people. Also a new stand pipe and reservoir will be erected to hold about fifty thousand gallons. Two new barns have been built, and other general improvements will be made as they are demanded. Our General Manager has given acceptance to our people and all together the Orphanage was never in a more hopeful condition than now. It cost just six dollars per day to run it, yet the steady stream of of contributions coming in from our churches have met this great demand. We urge that our people increase their pledges as it is desired that the remaining indebtedness of five thousand dollars be wiped out before the next general annual meeting.

EVENING SESSION.

The Association was called to order by the Moderator and prayer was offered by D. W. Pool.

Letters from Lewis Fork and Mt. Pleasant churches were read and the delegates enrolled.

On motion of W. C. Meadows, Foreign Missions were taken up, and the report was read by A. T. Pardew for the Committee:

REPORT ON FOREIGN MISSIONS.

What are these among so many? The hungry multitudes sit in the shadow of death waiting for the bread of life. Three or four hundred men from our whole Nation gone out to save a lost world are only enough to sow the Gospel seed at most. What shall the harvest be? They that sow in tears shall reap in joy. Let us pray for all Saints and preach in all the world as the test of our love for Christ. Jesus says that all power in Heaven and in Earth is given unto me. Go ye therefore and teach all nations. Teaching them to observe all things whatsoever I have commanded you. Peter opened his mouth and said, of a truth I perceive that God is no respecter of persons, but in every nation, he that feareth God and worketh righteousness is accepted with him. Paul said to the heathen God commandeth all men, everywhere, to repent. Our success in Foreign Missions must depend upon the observing all things commanded. Our duty at home is to pray the Lor1 of the harvest to send forth laborers into the harvest, observing the New Testament doctrines in finding the men and the means. Our Lord sent about eighty men through Palestine. Peter's preaching among one hundred and twenty believers won three thousand converts in one day. Barnabas and Saul recognized their call to the Foreign fields from the Holy Ghost, through the church at Antioch. We have forgotten that the Lord's call to the men means a call to the churches, for prayer, means and work, as directed by the New Testament. A. T. PARDEW,

The following letter from the Women's Missionary Society of North Wilkesboro church, was read by W. F. Staley:

TO THE WOMEN OF THE BRUSHY MOUNTAIN ASSOCIATION:

Having never written to you of our work in the Women's Missionary Society, we thought we would write and give you an idea of what we are doing and what we hope to do. Our Society has been organized since November the 24th, 1902, and during that time we have been steadily climbing. At this writing we have twenty-three members; not all are members that should be. Since last August we have paid out about \$95.00. I think that doesright well for our women, though we expect to do more another year. The ladies had the parsonage papered and painted inside which adds much to the appearance. Most of the money paid for this work was made by the ladies doing fancy work and selling it and different other things to earn money. It is a good thing for any church to have a Missionary Society. We learn of the needs of our Missionaries, of the work they are doing and of the work we should do. It is not impossible for the ladies in our country churches to have Missionary Societies. We meet just once a month and that is not very often. In the country you could meet that often or if not, once in two months and you would be doing something to spread the Gospel. Christ said "Go ye into all the world and preach the Gospel to every creature." We can't do that but we can give of our means to send some one to preach. If it be little we can do, it is that much for the Master and we will be blest if we do our best. We ask for your prayers in our work, that we may do what our hands find to do, and that we will accomplish something in His name.

The report on Ministerial Relief was read by M. McNeil:

REPORT ON MINISTERIAL RELIEF.

The progress which the Ministerial Relief Board has made during the sixteen years of its organization is to be very much appreciated by the Baptist hosts of North Carolina.

The first year's work of the Board was twenty-two beneficiaries with an apportionment of only about ten dollars for each beneficiary for the year. In the year 1905 the Board had twenty-six beneficiaries, and gave them on an average over fifty dollars each. An increase of over five hundred per cent. within fifteen years. The Board for the year 1905 helped twenty-six beneficiaries, representing eighteen Associations. The Board received from the churches during the year of 1905, \$2,120.85, one-third of this amount, \$706.85 was placed to the permanent interest bearing fund, leaving \$1,-414.00 to be used by the Board.

The permanent interest bearing fund amounts now to \$5,455.98. Interest on that fund for last year was \$360.48.

Brethren, we desire to call your earnest attention to the growing need of the work before us as to the need of the old servans of God; many of them spent their strength on home fields when there was but little remuneration to themselves, but laid the foundation upon which we are building.

We urge the churches to greatly increase their pledges to this

object.

M. MCNEIL, H. H. JONES, W. Z. HESTER, Committee.

The report was put on its merits and discussed by M. McNeil, Geo. White, after which pledges were taken amounting to \$31.00 and the report adopted.

The following is a report of the Executive Committee:

We the Executive Board beg leave to submit the following report: We find that Brother A. T. Pardew has done the following work; preached seventy-five days, had sixty conversions, forty baptisms. The work in revival meetings and on temperance is quite

In looking over the needs of special missionary work in the Association, we find a section in the South Eastern part of the Association where the Mormans are inculcating their doctrines. We therefore recommend that a missionary be employed and placed in the field immediately.

A spirit of fraternity and brotherly love prevails and a determination to pull together to advance the interest of the Kingdom.
