

RE: Ratification of International Human Rights Conventions

After consultation with Professor Jean-Bernard Marie, my colleague at the International Institute of Human Rights, Strasbourg, France, I am sending you a copy of the most complete argument to date in favor of U.S. ratification of the Genocide Convention and U.N. Covenants.
