The Choctowhatchee Association of the Old School Baptist or Primitive Baptist faith and order met its eighteith annual session with the church at Mt. Zion, Henry County, Ala., September 26, 27, 28, 1919.

1. Called for and read letters from ten churches and minuted their state and enrolled the messengers.

2. Elected by ballot Elder J. J. Byrd moderator and J. L.

Bodiford clerk.

- 3. By motion with a second the body agreed to take last year's minutes as a guide for this session.
- 4. Invited visiting ministers and brethren to seats with us.
 5. Appointed the following brethren as a committee on finance and preaching: J. G. Belcher, W. J. Vickers. J. F. Scarborough, with messengers of this church, T. Q. Culpepper, A. C. Gray, J. C. Money.

6. Called for petitionary letters. None

7. Appointed brother C. M. Langford to write the corresponding letter.

GOSPEL ORDER.

The churches composing this association may be represented by messengers from their repective churches bearing a statement certifying their appointment together with the number baptized and received by letter, restored, dismissed, excommunicated and died since our last association, and we desire that each church will name three messengers they desire to transact business for them in the association.

2. We declare that each church is a sovereign fully clothed by the Great Head of the Church with authority to execute gospel dissipline and cannot transmit its business to any other body for consideration and final judgment. Therefore, we, as an association, declare we will not receive from any church disciplinary questions to

be discussed or adjusted.

The association when convened shall be governed and ruled

by a proper and regular decorum.

4. The association shall have a moderator and clerk, who shall

be chosen by suffrage of the members present.

5. New churches may be admitted into this union, who petition by letter and messengers, and shall be received and its reception manifested by the Moderator giving the right hand of fellowship.
6. The association shall endeavor to furnish the churches with

the minutes of the association. The best method for effecting that

purpose shall be at the discretion of the association.

The minutes of the association, when printed, shall be regularly filed by the clerk, and by him shall be kept for the use of the association, and shall endeavor to have said book present at each association meeting.

8. Amendments to his plan of government may be made at any time by a majority of the union when they may deem it neces-

If any church in the association shall ask for a letter of dismission the request may be granted provided she is in full fellowship with sister churches in the association.

RULES OF DECORM.

1. Every motion seconded shall command the observation of

the body if not withdrawn by the member who made it.

2. Every person wishing to speak in the association shall first arise and address the Maderator, and shall not be interrupted while speaking, except he depart from the subject or use unbecoming lan guage.

No person shall speak more than three times on the same 3.

subject without leave of the body.

4. Any person laughing or whispering in time of speech shall

be reproved by the Moderator.

5. Every person speaking in debate shall adhere to the subject and not cast reflections on any who have spoken before him.

6. No member shall absent himself from the body without

leave from the Moderator.

7. The names of members shall be enrolled and called overwhen called for by the body.

8. The Moderator shall have the right of debate on filling the

chair; but shall not vote, except in tie, nor shall he move or second 9. The Clerk shall keep a regular record of the proceedings of the body, and keep a regular file of same; and have it at each meeting of the body.

10. No motion or second shall command the observation of the

Moderator except by rising.

11. The minutes of the proseedings shall be read and signed by the Moderator and Clerk before the association rises.

THINGS WHICH OUR CHURCHES DO NOT FELLOWSHIP

It is and has been the sense of the churches composing the Choctawchee Association since their organization not to hold in fellowship members who endorse or affiliate with the modern mis sion enterprise such as boards, conventions, church missions, the ological schools, Sunday schools, or any human society as auxiliary to the church of God, or Free Masonry or any other secret order or unscriptural religous society that does now exist, or may hereafter exist, founded upon the wisdom of men.

ARTICLES OF FAITH.

We believe in the one true and living God, the Father, the Son and the Holy Ghost, and these three are one.

We believe the scriptures of the Old and New Testaments

are the word of God and the only rule of faith and practice.

We believe in the doctrine of eternal and particular election

We believe in the doctrine of orginal sin.

5. We believe in man's impotency to recover himself from the fallen state he is in by nature, of his own free will and ability.

6. We believe that sinners are justified in the sight of God only by the imputed righteousness of Christ.

7. We believe that God's elect shall be called, regenerated and sanctified by the Holy Ghost.

8. We believe that the saints shall persevere in grace and

never fall finally away.

9. We believe that baptism and the Lord's supper are the ordinances of Jesus Christ and that true believers are the only subjects of these ordinances, and that immersion is the true mode of baptism, and that washing the saints' feet is a duty enjoined by Christ on all followers, and should be attended to in the church until his second coming.

We believe in the resurrection of the dead and a general

judgment.

We believe the judgment of the wicked will be everlasting 11.

and the joys of the righteous will be eternal.

12. We believe that no person has any right to administer ordinances but such as have regularly called and come under the hands of a presbytery.
