# PRESIDENT PATTERSON'S PERSPECTIVE

#### ON GRADUATE STUDIES AT SEBTS

 Dr. Paige Patterson, SEBTS president, responds to questions regarding the future of the seminary in general and the Graduate Studies program in particular.

## Q. What is your current assessment of the Graduate Studies Program at SEBTS?

A. From the outset we have enjoyed good leadership, but now with Dr. Köstenberger we have the very best conceivable. He brings to the program both intensity and sensitivity. I have been amazed at the ready market for our students. Finally, I am very pleased with the recent SACS recognition of the strength of the program.

## Q. What reports can you share with us concerning the impact of our Graduate Studies graduates in their various ministry positions?

### Q. What are the core values of the Ph.D. program at SEBTS?

There are four: a high view of Scripture, academic excellence, world-class mentoring, and building a community of learners. There are other institutions committed to academic excellence, but there may not be a high view of Scripture. Other programs may have world-class mentoring but are highly competitive rather than community-oriented. Our aspiration here at SEBTS is to cultivate all four core commitments simultaneously rather than focusing lopsidedly on just one or the other of these values.

## Q. How do you assess the current state of SEBTS's Ph.D. program?

A. There's no point in being too self-congratulatory; we should be self-critical where necessary.

On the positive side, we have a solid, consolidated, sound program that is well-designed and undergirded by a strong faculty and outstanding support by the administration. Many of our students, too, would be the envy of other schools: they are spiritually mature, experienced in ministry, yet genuinely humble, open to

learn, and willing to serve God without preconditions.

But there is room for improvement, too. Still, we are weak in certain areas as far as faculty expertise is concerned. Also, I would like us to make an even more concerted effort in attracting quality students both in the Southeast and nationwide. Another frontier would be to have more networking with other institutions or visiting scholars, perhaps in form of colloquia or other interfaces or joint efforts.

Finally, we are, I believe, not yet where we ought to be in preparing our students to use foreign languages in their research, particularly German. I would like us to do better in this regard, for I believe this is one of the most important marks of quality in the kinds of dissertations that are produced at a given institution. We are looking into several ways right now how we could further improve in this area.

Q. What do you see in the future for doctoral studies at SEBTS, say, in the next five years?

A. I am excited about the emphasis on Calling Out the Called. We want to identify those the Lord has called out and help train them for strategic ministry here in North America and in other parts of the world. Just the other day I had opportunity to meet with a


