

## PROCEEDINGS OF THE

# ELK RIVER ASSOCIATION.

## Friday.

The introductory sermon was delivered by Elder W. A. Cashion; subject: "New creation;" after which the messengers from the churches met and were called to order by the former Moderator.

Singing and prayer by Elder J. E. Frost.

The letters from the churches were called for and presented by their messengers; letters read and messengers invited to seats. The letters showed the state of the churches to be as exhibited in the table.

The Association was organized by choosing Elder J. E. Frost, Moderator, and John B. Bramblett, Clerk. The Association then proceeded to business as follows:

1st. Read the Rules of Decorum.

2nd. Called for petitionary letters. None present.

3rd. Called for corresponding letters from Associations with whom we are in correspondence, with the following result:

Appointed Wiley Woods, James Bramblett, J. G. Woods and Daniel Warden, together with the Moderator and Clerk, a committee to arrange the order of business for Saturday.

Appointed the Clerk a committee on correspondence.

Appointed Elders J. G. Woodfin, I. C. Herndon' and S. F.

Cayce to preach to the people on Saturday.

A petition was filed by Brother W. P. Tolley, asking the Association to consider the propriety of erasing the 12th article from our Confession of Faith.

On motion the Association adjourned to meet Saturday at 9

## Saturday.

The Association met according to adjournment. Prayer by Elder W. A. Cashion. Then proceeded to business as follows:

1st. Called the roll; a quorum present.

Mud Creek-messenger, Elder W. A. Cashion-commencing

On motion of Elder W. A. Cashion the time of holding the Association was referred back to the churches to say what day the Association shall begin.

The following resolution was adopted:
