






Dedicated in Honor of Rev. Cecil M. Frady

The 2007 annual minutes are dedicated to Rev. Cecil M. Frady. Cecil Frady was born Dec. 22, 1927 in Willits, N.C., where he was reared by his grandparents, Anias and Ida Mae Frady. He was born again from above at Tuckasegee Baptist Church May 7, 1948. He joined the church and was baptized. He served U.S. Army from June 1948 to April 1953. Was named soldier of month several times and was commended by his commanding officer for his caliber of work. During basic training he acted as Sgt. And received

certificates of leadership, responsibility, loyalty, and devotion to duty.

Cecil surrendered to Gospel Ministry in April 1958. That fall he entered Cullowhee High School in tenth grade. He graduated from Fruitland Baptist Bible Institute in March 1962. Cecil felt the call two weeks after he was saved, but ran for ten years.


He was ordained July 31, 1960 at Tuckasegee Baptist Church. His first pastorate East Fork Baptist Church (June 1960-December 1964), Holly Springs Baptist Church (December 1964-November 1970). Then he became the first associational missionary to the Macon Baptist Association - December 31, 1989.

He married Jean Houston of Tuckasegee, NC, youngest child of Baxter and Cardia Houston of Macon Co. She served as his secretary and clerk many years at the association. They have two children, Linda F. Fisher, graduate of North Carolina Baptist Hospital School of Nursing and Randall D., graduate of Mars Hill College.

Cecil was active in home, local, state and foreign missions. Cecil has lead groups on foreign mission projects, as well as North Carolina and West Virginia projects. He was also involved in upgrading Truett Camp. Macon Association was privileged to pilot the "Mountain State 200" in West Virginia building first church in Greenbank, WV. During the time he served the association the Home Office was constructed.

In January 1990 Cecil pastored Tuckasegee Baptist Church until 1994. He served at Lovedale from 1995 to October 2001. He was the Interim Pastor at East Fork from April 2004 till September 2006.

Cecil did a lot of work in overseeing volunteer work clearing and getting grounds ready for Moody Children's Home - and headed up Radio-thon to raise money for Children's Home, raised \$33,000. He has raised potatoes and corn for Children's Home about 30 years.



**Dedicated in Memory of
Rev. J. C. Robinson**

The 2007 annual minutes are dedicated in the memory of Rev. J.C. Robinson, of Glenville. He went to be with the Lord on Saturday, Sept. 22, 2007, at the age of 85. The Rev. Robinson was a native and lifelong resident of Jackson County. He was the son of the late Nelson and Pauline Bryson Robinson. He was preceded in death by his beloved first wife of 55 years, Mary Sue Rogers Robinson. He was then married to his loving wife Ina Lee for six and a half years. He had two boys, four grandchildren, and two great grandchildren.

The Rev. Robinson was a veteran of World War II, and proudly served as a member of the United States Navy 73 Seabees in the South Pacific from 1943 to 1945. He spent his early years as a farmer and a truck driver.

In 1966, he was ordained as a Baptist minister.

From 1966 until his retirement, he served as a pastor for several Baptist churches in Western North Carolina: Big Ridge, Cashiers, River Valley (Andrews), Lovedale, and Clear Creek. He was ordained as a deacon in 1948. He held almost every position in the church. He led the music at Hamburg Baptist Church before and after he pastored. He also held positions in the association.

Rev. J. C. Robinson was faithful to fulfill his duties in the church in all that he did. He was an integral part of the community. He was someone who could provide counsel, give advice or direction. He served Jesus faithfully by telling people about his Lord.

PROCEEDINGS
178th ANNUAL MEETING
FIRST SESSION, THURSDAY, OCTOBER 18, 2007

1. Pine Creek Baptist Church hosted the first session of the 178th Annual Meeting of the Tuckasegee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 91 present: 65 Messengers and 26 visitors representing 20 churches.
2. Rev. Matthew Ledbetter, Moderator, welcomed everyone.
3. Rev. Emery Brooks led the congregation in singing "Victory in Jesus".
4. Rev. Johnny Norris welcomed everyone to Pine Creek Baptist Church. The Pine Creek Baptist Church Choir had special music.
5. Rev. Johnny Norris, pastor of Pine Creek Baptist Church, brought scripture and sermon from Luke 15:13-24 and James 1:17.
6. The 178th Annual Meeting was called to order by Moderator Matthew Ledbetter after a time of fellowship.
7. Rev. Matthew Ledbetter asked for changes to the Agenda. No changes were made and it was approved.
8. Rev. Matthew Ledbetter, recognized new pastors at the Associational Meeting: Rev. Keith Dean from Big Ridge, Rev. Scotty Patrick from Cashiers, and Rev. Felix Villarreal from Primer Iglesia Bautista Del Amor. No visitors were recognized.
9. The Moderator announced the appointment of Committee on Committees and Resolutions Committee on page 12 and it was approved.
10. Rev. Emery Brooks led the congregation in singing, "Won't It Be Wonderful There". Afterward Matt had the pastors come down to the altar and break up in pairs to pray.

REPORTS

11. **Director of Missions** - Rev. Virgil Holloway gave his report as Director of Missions. It was located on page 4. He said it has been a joy to serve in the association. He would like to see more people saved.
12. **Music** - Rev. Emery Brooks gave the Music report listed on page 5. He said six churches hosted and 23 churches were represented at the association's annual singing. Hopefully more will participate next year to sing praises to the Lord.
13. **WMU** - Janice Burnette reported that we can do so much more as an association than alone. Feel free to join any activities that are announced in the *Baptist Herald*. She encouraged us to get children involved in missions so they will look beyond themselves and help others. On November 18th there will be an International Mission Study at Scotts Creek to study about Moldova. Report listed on page 6.
14. **Historical** - Mildred Wilson reported she gets her information from the Congregation Profile and monthly newsletters. Her report was listed on page 7 and 8.

COMMITTEES

15. **Stewardship** - Rev. Mike Moore presented the proposed 2008 budget to be voted on during the second session. The budget is on page 9. He challenged each church to consider giving \$25 more each month to the association. He reported that if we don't reach our budgeted amount we will be out of undesignated funds. Let us pray that as part

of Jackson County and Tuckaseegee Baptist Association, we will make our Lord look good and not bad.

16. **Committee on Committees** - Kenneth Miller presented their report on page 12 to be approved. No further nominations were made and it was approved.

17. **Nominating Committee** - Brad Stillwell presented their report on page 13 to be accepted for 2007-2008. The Truett Camp Representative position had not been filled. No further nominations were made and the motion carried.

18. **Place and Preacher Committee** - Brad Stillwell presented their report on page 3. It was approved with no opposition. Next year's annual meetings will be at New Hope Baptist and Lighthouse Baptist. Rev. Dale Roberts and Rev. Gene Hawkins will be preaching.

19. **Memorials Committee** - Eloise Shuler and Alice Cabe read the names of church's deceased members of the past year. This was located on page 14 with some additions they had after calling churches that had not turned in profiles. Eloise also read a poem (*Our God Knows Best*) and Rev. Virgil Holloway lead in prayer. They will be dedicating the 2007 annual minutes in honor of Rev. Cecil Frady and in memory of Rev. J. C. Robinson.

20. Matt then had another time of prayer for Karla Allred who has cancer and for the family of Conner Galloway who died unexpectedly. His dad is a coach at Smoky Mountain High.

MISSIONS

21. **Cashiers Baptist** - Benny Rice gave a missions report on the trips that Cashiers, Hamburg and Yellow Mountain made to Gulfport and other places.

22. **Moses Creek Baptist** - Rev. Marlan Keener reported they had been to Gulfport and Montana on mission trips.

23. Matt then led the congregation to sing *When We All Get to Heaven*.

24. Webster youth group was unable to come and sing as planned due to the unexpected death of Conner Galloway. There was a gathering in his memory at the ball field.

25. Rev. Marty Dupree, team leader of Evangelism and Church Growth of the Baptist State Convention of NC, brought the evangelistic message. It was a very challenging message to everyone to be conscious of spreading God's gospel message with all that you meet.

26. Leland Cooper of Pine Creek Baptist Church led in the Benediction prayer.

SECOND SESSION, FRIDAY, OCTOBER 19, 2007

1. Long Branch Baptist Church hosted the second session of the 178th Annual Meeting of the Tuckaseegee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 90 present: 70 Messengers and 20 visitors representing 22 churches.

2. Rev. Matthew Ledbetter, Moderator, welcomed everyone and called the meeting to order.

3. Rev. Avery Brown welcomed everyone to Long Branch Baptist Church and read Mark 26.

4. The Long Branch Baptist Church Choir had special music.

5. Emery Brooks led the congregation in singing, "Jesus Saves".

REPORTS

6. **SWARM** - Bob Tucker presented their annual report. The report was on page 22.

7. **Truett Baptist Camp** – Richard Roberson presented the annual report on page 23. They reported that it was actually over 100 saved at their camp due to the retreats they have on weekends also.

8. **Jackson Co. Bible Club** – Rev. Gerald Morris said that over 100 kids are being reached each week and that two-thirds of them are unchurched. It is in the Fairview, Blue Ridge, Scotts Creek and Smokey Mountain Elementary Schools. It is not at Cullowhee Valley Elementary School because no one has volunteered to be a helper. They have a teacher and a room available to use, but not a second person to help. Everyone is encouraged to help by sending money or snacks, praying and becoming a helper or teacher.

9. **NC Baptist Men** - Matt encouraged people to get disaster relief training. In Gulfport after Hurricane Katrina, 70 tractor trailers of water and 550,000 meals have been served, 155,000 volunteer days have been provided, 131,000 showers provided, and 230,000 recovery jobs have been done. They are close to reaching their goal of providing 700 homes by January 2008. He encouraged everyone to give, pray and get involved in training.

10. **Baptist Retirement Homes** – Gayle Brown presented his report on page 24.

11. **Baptist Children's Homes** – Rev. Lewis Smith presented a role play of John Haynes Mills the founder of the Baptist Orphanage in 1884.

Emery Brooks led the congregation in singing "Are You Washed in the Blood."

12. Gracella Morris reports now that over the two days a total of 25 churches had been represented and 89 messengers were present.

13. A mission report was presented by Matt Bishop from Webster Baptist Church. A group made up mostly of youth led by Rev. David Powell went on a mission trip. They went evangelizing from house to house, did concrete work on two churches, and did VBS every afternoon with over 100 kids.

14. Rev. Mark Rodgers presented a missions report about their trips to New York, Gulfport and Moldova.

15. Matt then led the congregation in praying for Rev. Virgil Holloway and his family.

16. Brad Stillwell presented an addition to the Nominating Committee report. Brad Hughes had volunteered to be the Truett Baptist Camp Representative. This addition to their report was accepted.

17. **Executive Committee** The moderator pointed to the executive committee report beginning on page 57. It is a summary of the executive meetings held throughout the year.

18. **Credentials Committee** - Rev. Cecil Frady said that the committee recommended that Lighthouse Baptist Church be accepted into the full membership of the Tuckaseegee Baptist Association. There was 100% approval. (This had been done last year and didn't really need to be voted on again.) Cecil recommended that The Lord's Center (El Centro Del Señor) of Cullowhee and The First Baptist Church of Love (Primer Iglesia Bautista Del Amor) of Glenville be accepted under the watchcare of the association for one year. Praise the Lord! All were in favor and none opposed it.

19. **Stewardship** - Rev. Mike Moore moved that the 2008 budget presented the previous session be approved. Page 9. No discussion followed and it passed.

20. **Regional Hispanic Ministry** – Rev. Robert Fernandez presented his report on page 27. He wanted everyone to prayerfully consider giving money for Spanish resources at

Fruitland Baptist Bible Institute. They are also trying to start a new mission in Swain County. He is working with 1st Baptist in Bryson City and 1st Baptist in Cherokee on this startup.

21. **Resolutions Committee** – Brad Hughes presented the following resolution.

Whereas, we the 178th Annual Session of the Tuckaseige Baptist Association are meeting at Pine Creek Baptist Church and Long Branch Baptist Church;

And whereas, the Association has enjoyed the hospitality, fellowship, and food so graciously offered by these two wonderful congregations;

And whereas, our speakers, Rev. Johnny Norris, Rev. Marty Dupree, and Rev. Marlan Keener have inspired, challenged, and blessed us with God-breathed messages;

And whereas, our convention-wide and associational representatives have informed us of various mission endeavors, and our associational committees and officers have given of their time to serve;

And whereas, our associational secretary and clerk, Gracella Morris, continually goes beyond the call of duty in her service to this association and our Lord;

And whereas, our Director of Missions, Dr. Virgil Holloway, has led this association with a strong emphasis on missions and evangelism, mingled with unity;

And whereas, our Moderator, Rev. Matt Ledbetter, and Vice-Moderator, Rev. Avery Brown, have presided over these sessions and other meetings with proficiency and competence;

Be it therefore resolved, that, we extend sincere appreciation for the joyful kindness and Christian love expressed by those afore mentioned, and in humble gratitude for their service to our Lord and Savior, Jesus Christ.

Brother Moderator, we, the Resolution Committee, move the adoption of this resolution of appreciation).

This was approved.

2006-2007 WMU Annual Report to the Tuckaseegee Baptist Association

The WMU emphasis for 2006-2007 has been "Live the Call." Our churches began the year in September by promoting the North Carolina State Missions Offering. Then we held a training and planning session in October at the Baptist Center.

The International Mission Study, focusing on Nigeria and West Africa, was held in November at the Baptist Center. Special guest was Clemmey Queen, who gave a presentation about his son Greg's work in West Africa. Along with this event, we participated in a World Crafts Fair and placed an order of over \$300. Several churches and others from outside our county participated in this event. To celebrate Focus on WMU in February, we held an associational Missions Fair at Lovedale Baptist Church. Eight churches (Cashiers, East Sylva, Greens Creek, Locust Field, Lovedale, Scotts Creek, Sylva First, and Wilkesdale) shared displays of mission trips and ministries they had done. Also, there were six other displays (El Centro Del Señor, Jackson County Bible Clubs, Baptist Children's Homes, Crisis Pregnancy Center, SWARM, and North Carolina WMU).

In the spring, we promoted the Annie Armstrong Easter Offering for North American Missions. We recognized our Director of Missions, Virgil Holloway, on his birthday in April. We sent a donation to Snowbird Wilderness Outfitters in memory of his son, Larry, who had passed away.

The annual meeting was held at the Lovedale Baptist Church on April 26, featuring the ministry of the Christian Women's Job Corps site in Haywood County. *The number 1 ministry of WMU nationally that receives positive acclaim is CWJC. Christian Women's Job Corps provides a Christian context in which women in need are equipped for life and employment. They are given, not a hand out, but a hand up. Participants gain important practical life skills and self-respect, but also assurance in the knowledge that God loves them.* The offering taken at this meeting was given to the CWJC ministry. New officers were installed, and they received training at FBC Swannanoa in July.

Several women from three of our churches attended Missions Extravaganza at Ridgecrest, enjoying the selection from over 150 conferences, inspirational worship times, and missionary testimonies. Again this year, Sandra James served as President of NCWMU, and Janice Burnette was a member of the state Executive Board.

We sponsored a Pastor Appreciation Dinner in May at the Baptist Center. Also, WMU set out flowers around the Baptist Center and at the Mildred Cowan Memorial Prayer Garden at Truett Baptist Camp.

Throughout the year, WMU has been involved in various missions projects. A total of 739 shoeboxes were collected from our Baptist churches to support the Operation Christmas Child ministry. Soup labels were collected to help missionaries purchase vans for their use on the field. Soft drink tabs were collected and given to the Dialysis Center, who uses them to purchase snacks for patients. A food drive for Broyhill Children's Home was promoted in April, and GA's helped sort the items. United Christian Ministries, Community Table, rest homes, and the Council on Aging also were helped by WMU. Several churches provided meals for the Hispanic church in Cullowhee. We provided meals for the Hispanic retreats at High Street Baptist Church in Canton, NC, on April 21, and at Faith Baptist Church on September 8.

United Christian Ministries of Jackson County (UCM) assisted over 6,200 persons last year. The majority of the households served had children in the home. Four and one-half percent were new persons seeking assistance for the first time.

We are providing groceries, diapers, toothpaste, toothbrushes, soap, tissue paper, laundry soap, beds, refrigerators, couches, prescription assistance, assistance to keep the electricity from being shut off, heating oil, gas, or wood, motel assistance for the family that has left their home with domestic violence and the shelter is not available, rental assistance for someone who is not working due to illness, water bill assistance, transportation to a doctor's appointment, clothing assistance or referral assistance. Over 3,500 bags of groceries were given to the less fortunate last year; that equals over 27,000 pounds of food.

Last Thanksgiving a turkey and all the fixings were given to 211 families.

Four hundred ninety two bags of household/persons items were given last year.

The above is only a partial listing of the things our ministry has provided.

BAPTIST CHILDREN'S HOMES OF NORTH CAROLINA

(July 2006-July 2007)

Oak Ranch added to ministry. . . Baptist Children's Homes (BCH) entered into a relationship with Oak Ranch, a residential program for at-risk boys, to manage the facility. Located on the Lee-Harnett County line near Broadway, Oak Ranch features two existing cottages, administrative buildings and an eight-horse equine therapy component.

"This is a historic event," said BCH President Michael C. Blackwell. "Baptist Children's Homes and Oak Ranch share a vision to provide hope and healing to children. This is a natural merger, and we look into the future with great hope and tremendous expectation."

Plans are in place to accept boys into care at Oak Ranch beginning in October, 2007, but the property and Oak Ranch's distinctive equine therapy program are already being utilized by BCH residents and staff members from the institution's statewide locations.

New Program Helps Children With Intensive Challenges. . . BCH's new Level III program outreaches to children who are struggling to overcome a greater degree of emotional and behavioral issues. The service is designed to provide a highly structured and supervised residential environment that is responsive to the need for intensive, active therapeutic treatment and interventions.

Currently, BCH offers Level III child care services at Kennedy Home in Kinston and Moody Home in Franklin.

Developmental Disabilities Ministry Continues To Grow. . . On August 27, 2006, members of the Three Forks association, BCH staff and other supporters gathered for the dedication ceremony of two new Developmental Disabilities Ministry (DDM) homes for developmentally disabled adults in Zionville

The Three Forks Home is named in honor of the association for gifting the original Camp Joy property for the new homes. Lindsay Home is named in memory of Winifred B. Lindsay who donated a lead gift of \$400,000. Churches, businesses, organizations and other community friends helped raise funds to build the homes. The new DDM homes are a part of Joy Cove Ministries serving families in Watauga County and the surrounding community.

BCH held a groundbreaking ceremony on September 10, 2006 to celebrate the expansion of its Developmental Disabilities Ministry to Sanford. BCH recently began building the two group homes to serve special needs adults in the Lee County area.

The Sanford based ministry has been tapped Willett Ministries. Jane Willett-Cromer, a resident of Gulf and mother of a developmentally disabled adult, gave three and a half acres of land for the Sanford-based homes to BCH in the memory of her husband Howard.

BCH and Cross Road Retirement Community in Asheboro hosted a "Laying the Foundation" ceremony on October 14, 2006. The ceremony celebrated the construction of BCH's new DDM group home. The group home is located on the Cross Road Retirement Community campus which is owned by Cross Road Baptist Church. It will be called "The Asheboro Home," and dedication ceremonies are scheduled for August 26, 2007.

The 3,000 square-foot facility offers a residence for six developmentally disabled adult women and will serve families in Randolph County and the surrounding community. The home was built in cooperation with the U.S. Department of Housing and Urban Development (HUD). BCH will operate the home, providing the services and the staff.

Baptists Touch BCH Through Technology. . . Children in BCH's care greeted Messengers at the 2006 annual session of the Baptist State Convention at the Greensboro Coliseum through the power of technology. Using a web camera link, five children at Mills Home in Thomasville carried on live, real-time conversations with convention attendees and thanked them for their love and support. Mills Home children answered questions and gave "high fives" to Messengers who viewed them on a large, flat panel display screen.

New Website Introduced. . . BCH also introduced the redesigned BCH Family (www.bchfamily.org) website during the November convention. The new website offers streamlined navigation making it easy to find information about BCH's statewide services and a variety of ways to support the ministry. New features include online journals and photo galleries from the ministries locations around the state.

Charity & Children Marks 120 Years. . . *Charity & Children (C&C)* marked its 120th anniversary in 2007. Throughout its history, it has been a strong voice speaking for Baptist Children's Homes conveying news, information, and children's success stories. The free publication is mailed to as many as 62,000 subscribers a month, with estimated readership in excess of 170,000 per issue.

Seven year *C&C* editor Jim Edminson introduced a new look for the paper in January utilizing concisely written stories, the use of vivid, large photos, ample white space, and contemporary artwork to make the publication more approachable to readers.

The BCH news publication is produced each month by its publisher and BCH president Michael C. Blackwell, Edminson, and Blake Ragsdale who was named Managing Editor in late 2006.

BCH Named One Of Triad's "Best Places To Work". . . BCH was a finalist in the *Triad Business Journal's* annual "Best Places to Work" competition. The institution finished in the elite four of the "charitable nonprofits" category. BCH president Michael C. Blackwell, accompanied by members of his President's Management Group, accepted the award at a ceremony in High Point.

BCH's state administration offices, Mills Home residential campus and Weekday Education facilities in Thomasville, and group homes for developmentally disabled adults in Winston-Salem comprise BCH's Triad area services.



THE NORTH CAROLINA BAPTIST FOUNDATION, INC. 2006 ANNUAL REPORT

The mission of the North Carolina Baptist Foundation since its inception in 1920 has been to assist the Convention and its institutions and agencies in increasing an awareness among North Carolina Baptists of Christian estate stewardship principles as a means of financially undergirding churches, institutions and mission endeavors on a permanent basis. The uniqueness of the ministries and services provided by the institutions and General Board staff merits increased financial support. The Foundation accomplishes these objectives by offering assistance in estate planning counsel, Will preparation, planned giving, charitable remainder trusts, endowment funds and church fund management.


During 2006, the Foundation assisted individuals in establishing 49 endowment funds and 8 charitable remainder trusts totaling \$2.6 million and received \$6.5 million in contributions to existing endowments, all of which will ultimately benefit countless Baptist causes on a permanent basis. Programs were provided for churches and associations during the year to promote Make Your Will Month, Christian estate stewardship and church fund management. Over \$2.6 million from churches and institutions came under management to enhance numerous ministries including scholarships, building funds, cemetery funds, benevolence funds, general operating funds and other various mission causes. Overall, the Foundation received \$11.7 million in contributions during 2006 for Christian causes.

The Foundation employs professional money managers to invest these funds according to an investment policy adopted by its Board. Four investment pools are offered: a growth fund, a balanced fund, an income fund and a fixed income fund. The Foundation uses the services of Salomon Smith Barney to help select top money managers and evaluate performance. As of December 31, 2006, the Foundation held \$153.1 million under management.

During 2006, our distributions totaled \$8.4 million, with charity receiving \$5.9 million and individuals, through trusts, receiving \$2.5 million. During the 86-year history of The North Carolina Baptist Foundation, Inc., \$31.6 million has been distributed to individuals and \$59.2 million to Baptist churches, institutions and mission causes for a grand historical total of \$90.8 million.





Report for 2007 Book of Reports

Office of GuideStone Financial Resources for the Baptist State Convention of NC, Inc.

The GuideStone Team has been extremely busy during this past year to ensure prompt and accurate delivery of information related to retirement, insurance, staff compensation, tax issues, etc. that impact dramatically the care of persons who serve on church staff here in North Carolina. We celebrated the retirement of Amy Strickland as Administrative Specialist on our team and welcomed Betty Pleasant to that ministry position after a number of years in the convention's administrative offices. We are very grateful for the ministry of these ladies in assisting church staff and key church leaders.

On January 2, 2007, Guidestone Financial Resources, an agency of the Southern Baptist Convention headquartered in Dallas, Texas, introduced a new family of funds, *My Destination Funds*, which are date targeted to a retirement participant's projected retirement date at some point in the future. For those participants who choose to invest using these funds the hassle of keeping up with an appropriate asset allocation as the participant grows older is now removed. These funds are professionally managed and the asset allocation is adjusted automatically as the participant ages. This is a "great and wondrous" development since many church staff are focused primarily on ministry to people rather than managing their retirement account. Furthermore, the retirement funds at GuideStone exceeded their respective mutual fund peer universe median as measured by Lipper rankings during this past year.

The successful transition to a single provider for medical insurance for the GuideStone medical plans reaped great rewards as 57% of Personal Plan participants received no rate increase or a reduction in premiums. This is a "great and wonderful" thing for those who are covered with GuideStone medical insurance. Life and disability coverage continues to be tweaked to meet the needs of our church employees. Beginning with the 2007 fall semester all students enrolled at one of the Southern Baptist seminaries (we have Southeastern Seminary in North Carolina) will be covered with \$10,000 of life insurance at no cost to the student and the 31 day of open enrollment from matriculation for new students continues to be very attractive.

The Church Retirement Plan is a major emphasis of the GuideStone team. We are working hard to educate church staff and key church leaders to the best retirement plan on the market today for employees of our Baptist churches. On April 1 of this year annual church budget eligibility requirements for the Mission/Church Assistance Fund were dramatically adjusted from the previous requirement of less than \$40,000 per year to less than \$75,000 per year. Many of our church pastors will now qualify to receive \$50 per month for a five year period, but they must be active participants in the church retirement plan to receive this "great and wonderful" benefit.

Finally, we gladly promote the Endowment ministry at GuideStone to provide ongoing and one-time financial assistance to retired ministers and widows of ministers who are living in poverty. As of March 31, we had 204 North Carolinians, who have met the very strict guidelines and are receiving financial assistance from GuideStone Financial Resources. Please assist us in identifying those persons who might qualify for this assistance.



Dear Associational Leadership,

The theme of this year's 177th Baptist State Convention's annual session focuses upon the *Great and Wondrous Things* that God has been doing in and through North Carolina Baptists. I hope that as you gather to celebrate the many *Great and Wondrous Things* that God has been doing through the churches of your association this year, that you will join the Council on Christian Higher Education as we, too, celebrate God's work on the college and university campuses of institutions of higher education that cooperate with the Baptist State Convention of North Carolina.

The student body of each campus is growing, new facilities are being built, and students are provided with opportunities to grow academically and spiritually. Allow me to provide an example of only a few of the *Great and Wondrous Things* that God has done on each of the five campuses this year:

Campbell University – 2,835 undergraduate students; establishment of a football program; construction of a new convocation center and new chapel.

Chowan University – significant renovations underway; improvement of athletic facilities; growth of endowments now totaling over \$21 million dollars; numerous students participated in missions trips and journeys to the Holy Land.

Gardner-Webb University – nearly 4,000 students from 34 states and 33 countries; new facilities for students with disabilities; new degree program – Master of Arts in Religion; marching band established; numerous students participated in missions trips to the Gulf Coast region, Canada, and Ecuador.

Mars Hill College – celebrated 150th anniversary; mission teams to Honduras, Greece, and New Orleans; established teacher education graduate degree program; new math and science building underway; renovations to athletic facilities.

Wingate University – over 1,800 students; 57 graduates comprised the School of Pharmacy's first graduating class; students involved in supporting the hunger relief efforts of the Charlotte Men's Shelter and Harvest Food Bank.

This year, undergraduate students were given the opportunity to apply for the Convention's Baptist Scholars Program scholarships on-line. The new application process is faster, easier, and much less complicated than the former paper applications.

I also hope that you will make plans to attend the annual session of the Baptist State Convention of North Carolina, to be held in Greensboro on Monday, November 12 through Wednesday, November 14. Please plan to stay for the Council on Christian Higher Education presentation on Wednesday as the council will be highlighting the *Great and Wondrous Things* God is doing in the lives of Baptist students as they "Call to Me ..." Jeremiah 33 : 3.

I remind you that your generous gifts to the Cooperative Program provide important support to these five schools through scholarships and other unrestricted funds. These five schools, Campbell University, Chowan University, Gardner-Webb University, Mars Hill College, and Wingate University, strive to provide educational opportunities from a Christian world view with a Baptist distinctive and are able to do so as you both give and pray for students, faculty, and campus leadership alike.

ANNUAL REPORT
Fruitland Baptist Bible Institute
July, 2006-June 2007

Students at Fruitland Baptist Bible Institute are here basically because they have received a call from God to serve him. Many of them are older. One student, after hearing other students talking about running from God, said, "If these professors don't let up, I am going to run some more". He graduated from Fruitland with an Associates degree. He recently received his Bachelor's degree from another school. We have students who come to Fruitland without a High School diploma. They get a G. E. D and finish Fruitland. Many of them have completed Master's degrees and even Doctorates.

Christian education has been going on here at Fruitland since 1899. The campus was purchased by the Baptist State Convention of North Carolina in the early 1940's as a site for a conference center. Fruitland Baptist Bible Institute actually began on this campus in 1946.

A personal visit became the catalyst for the actual beginning of Fruitland as a Bible Institute. Dr. J. C. Canipe was the pastor of First Baptist Church of Boone, North Carolina. He learned that a fellow pastor in the area, Vilas Minton, was sick and needing some help. Dr. Canipe took a supply of groceries to the Minton family. He and Pastor Minton became friends. Later, Pastor Minton asked whether Dr. Canipe would start some classes for him and other pastors who had not had the opportunity for formal preparation for ministry. Dr. Canipe began some classes in the facilities of the First Baptist Church. Several pastors from the surrounding area joined the local pastors in attending these classes. Dr. Canipe was invited by the Baptist State Convention to move these classes to the Fruitland campus and the Bible institute began. We completed sixty years of service in 2006.

Fruitland continues to serve students with unique needs. Our student body is diverse in ages, ethnic and national backgrounds, academic achievement, and spiritual development. The common characteristics of these students are faith in Christ, and experience of a call to ministry, and a sense of need for basic academic, spiritual, and practical preparation.

Presently, Fruitland offers an associate degree in religion/church ministries involving two years of study. The degree requires either high school graduation or the G. E. D. and the completion of one-hundred and twenty-five quarter hours of academic credit. During the 2006-2007 year the cumulative, non-duplicated enrollment was 267. Many students go on to other institutions and graduate with honors.

Once again this year many special events took place. We had Founder's Days with Dr. Gray Allison of Memphis, Tennessee and Dr. Herb Reavis of Jacksonville, Florida. In October we had our annual Alumni Day and Preaching Week. Dr. D. L. Lowrie, retired pastor of First Baptist Church, Lubbock, Texas, was a visiting professor. His wife, Alice, spoke for the annual Women's Retreat led by Mrs. Ann Ridings.

Dr. Kenneth Ridings continues to serve as President of Fruitland. The expansion of the chapel is well under way. Hopes are high that it will be ready for graduation in December. Fruitland continues to fulfill a commitment to be "true to God's Word and loyal to His purpose." We invite you to come and visit the campus just east of Hendersonville, North Carolina. Your Cooperative Program, 2007

Throughout 2007 your Cooperative Program continued to be the best way for North Carolina Baptists to work together and cooperatively support a global, nationwide and statewide program of missions, evangelism and ministry. No other program will send a Christian dollar to as many places or touch as many lives for God's Kingdom! The 2007 Cooperative Program budget is for \$37,786,000. It is only when we work together as Baptists and consolidate our missions dollars into a single unified budget that we can support major ministries and missions projects needed to share the gospel with a lost world!

Our Cooperative Program supports thousands of missionaries, ministry specialists and many types of work, yet it operates quite simply. Here's how:

Each November when North Carolina Baptists hold their annual meeting, they adopt a Cooperative Program budget, currently in two-year cycles. That budget determines what work we support together and how much. During the year congregations of all sizes, located across the state, send in their Cooperative Program checks to the Baptist State Convention office in Cary. There the accountants divide up the money according to the budget and send it on its way to the many ministries we support. That's why we say we give through the Cooperative Program, not to it! The Cooperative Program is a channel, the way we divide up money among Baptist causes we support; it is not a destination.

This is how we as North Carolina Baptists support five colleges and a Bible institute, a major children's home, missions work across North America and around the world, plus a newspaper and a foundation.

Your Cooperative Program also supports the staff of your Baptist State Convention. This staff -- your state missionaries -- help hundreds of churches like yours each year in many kinds of work, from prayer ministry and church outreach programs to Sunday School and music, to discipleship training, insurance and retirement programs for church staffs, among others.

Your Cooperative Program also provides hefty support to Woman's Missionary Union and North Carolina Baptist Men, augmenting the support you and other North Carolina Baptists provide these important organizations through the North Carolina Missions Offering.

Bright outlook

Consider that more than 1,500 churches increased their Cooperative Program giving amount for 2006 over 2005. That means more than a third of the convention's churches have voted with their pocketbooks for the 1-3-6 Challenge!

What's that? It's a challenge to every church to increase its Cooperative Program giving by 1 percent of its undesignated receipts over three years. If all convention churches will do so, it will produce \$6 million a year in additional funds for the convention's vast program of work!

Biltmore Baptist church in Arden, led all convention churches on increasing Cooperative Program giving -- in 2006 the church gave \$92,216 more than in 2005!

And consider the example of Peninsula Baptist Church, Mooresville.

This amazing 1,300-member congregation led all convention churches in total giving -- and set a record in the process! Peninsula's members contributed a record \$422,607 through the Cooperative Program during 2006. This was the first time in recent history that a single church gave more than 1 percent of the convention's total budget, which is \$37.7 million in 2007! But that wasn't all. Peninsula also placed second in the amount of increase given through the Cooperative Program -- \$69,341 more than in 2005, second only to Biltmore. Further, Peninsula gave 26.8 percent of its undesignated receipts through the Cooperative Program, making it fourth in percentage giving among convention churches.

Some churches with much larger budgets than Peninsula's have the potential for joining the "1% Fellowship" but they do not come close to matching Peninsula's percentage of giving. "Peninsula Baptist in Mooresville is an exceptional church with a great heart for missions," said Milton A. Hollifield Jr., executive director-treasurer of the convention.

All Sizes!

Peninsula presents a stirring lesson in missions support for congregations that are much larger.

But there are many North Carolina Baptist churches with fewer members which excel in missions giving. For example, consider Westview Baptist Church in Shelby, led by pastor Steve Ellis. Westview led the convention in total Cooperative Program giving in 2006 among churches with fewer than 400 members. Westview's 399 members gave \$54,012 through the Cooperative Program, which was almost 20 percent of their undesignated receipts. That percentage was the third highest for Cooperative Program giving among churches with fewer than 400 members.

Poplar Grove Baptist Church in Boone led the convention in the percentage of undesignated receipts given through the Cooperative Program. This 101-member church led by pastor Brian Davis gave slightly more than 20 percent of its undesignated receipts through the Cooperative Program.

Consider Oak Forest Baptist Church in Fletcher, led by senior pastor Matthew Williamson. This 294-member congregation gave just over \$9,400 through the Cooperative Program in 2005, nothing in 2006, but then \$15,350 in 2006, the biggest increase of any church with fewer than 400 members.

Such reports show that churches of all sizes can participate in one of the world's largest programs of Christian missions!

An ad series in the Biblical Recorder during 2007 featured some of the churches which made increases in Cooperative Program giving. The pastors of these churches were happy to promote their church's missions support record in this public forum.

Mud Creek Baptist Church, a Hendersonville church led by pastor Greg Mathis, was increasing its Cooperative Program by 6 percent over a three-year period.

Hopewell Baptist Church in Monroe doubled its Cooperative Program giving for 2007 and committed to increase it more for 2008, reported pastor Lee Pigg. In Raleigh, Trinity Baptist Church, led by pastor Jeff Roberts, increased its Cooperative Program giving by more than \$28,000 for 2006.

Fuquay-Varina Baptist Church, located in the town of the same name, increased its Cooperative Program giving by more than \$25,000 and was one of the top overall contributors. Chris Conner is pastor.

These are just a few of the churches which boldly responded to the 1-3-6 Challenge and went beyond. Again, that challenge is for every church to increase its giving through the Cooperative Program by 1 percent of its undesignated receipts over three years. If all the convention-affiliated churches will do so, it would result in an additional \$6 million a year for missions causes we Baptists hold dear.

But there's a prior challenge. That challenge is for more North Carolina Baptists to learn about the amazing variety and depth of missions, evangelism and ministry they support through their Cooperative Program.

We have had the Cooperative Program since 1925. It has served Baptists so well, that if we woke up tomorrow and did not have it, we would rush to recreate the same thing! It is work supporting and worth supporting more.

Giving will skyrocket when all North Carolina Baptists realize there's no other method which will send a Christian dollar to more places or touch more lives for God's Kingdom, than a dollar given through the Cooperative Program.

NONPROFIT CORPORATION

1. The name of the corporation is:

2. The period of duration of the corporation shall be: perpetual.

BY-LAWS OF THE TUCKASEEGEE BAPTIST ASSOCIATION, INC.

ARTICLE 1. NAME

The name of the body shall be the Tuckasegee Baptist Association, Incorporated.

ARTICLE II. OBJECTIVES

The purpose of the Association is to be a fellowship of churches on mission in our setting. The specific objectives of the Association are as follows:

1. To promote harmony, understanding and spiritual power between the churches.
2. To afford and promote a larger fellowship of Christians in the work of Christ.
3. To provide such programs, projects and organizations as will strengthen the churches and assist them in achieving their goals and objectives.
4. To discover needs which cannot be met effectively by churches individually and to coordinate the use of resources in meeting these needs.
5. To encourage support by every church for the mission causes of the Association, the North Carolina Baptist Convention, and the Southern Baptist Convention.

ARTICLE III. AUTHORITY

SECTION 1. The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient.

SECTION 2. The Association shall have power to recommend measures of usefulness and guidance to our churches in matters of organization, ordinations and questions of doctrines and discipline,

SECTION 3. The Association shall have no power to infringe upon the right of local churches as sovereign and independent bodies.

ARTICLE IV. MEMBERSHIP

SECTION 1. The Association shall be composed of regularly constituted Baptist churches in cooperating fellowship with the Southern Baptist Convention and following the teachings of the New Testament.

SECTION 2. The Association shall be the sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure. Churches applying for membership shall agree to come under the watchcare of the Association for one year. It is understood that during this period of watchcare the church shall be entitled to all rights and privileges of the Association except those of voting.

Applications for membership shall be presented to the Credentials Committee of the Association. The applications will consist of a letter from a constituted church stating their desire to affiliate with the Tuckasegee Baptist Association. The Credentials Committee as a part of the review process may invite the requesting church to a conference to discuss its history, its mission strategy, and any other information that may be pertinent to the application. The Credentials Committee may then approve the application and recommend them to the Executive Committee. The Executive Committee may by a simple majority vote accept the requesting church to come under the watchcare of the Association for one year. It is suggested that any church under watchcare participate in the missions program of the Association. At the end of the year, the church may be voted in as a member of the Association with full privileges by a two-thirds vote of the messengers present and voting at the annual meeting of the Association, provided that the church submits an acceptable letter and at least one messenger be present at the meeting.

SECTION 3. Any church may withdraw from the Association at its pleasure and should notify the Association of this action in writing. Such action will be recognized by the Association at the next annual meeting.

SECTION 4. It shall be the duty of each church to furnish the Associational Clerk, before each annual session, an annual letter, the forms provided by the Associational Clerk, giving the information requested as is applicable to each church situation.

SECTION 5. The Association may withdraw from any church which has become unscriptural in its doctrine or practices by a two-thirds majority vote of the messengers present and voting at the annual meeting. Such vote is to be taken by written ballot.

ARTICLE V. MEETINGS

SECTION 1. The Association shall hold its annual meeting on Thursday and Friday preceding the third Sunday in October. Special meetings of the Association may be called by the Executive Committee provided two weeks written notice is given to the member churches.

SECTION 2. Each church shall be entitled to be represented at the annual meeting by the pastor and one additional

messenger. Churches which give to the association more than .5% of their undesignated receipts shall be entitled to an additional 2 messengers for every .5% of giving up to a total of 10 messengers for churches which give 2% of their undesignated giving."

SECTION 3. Churches are requested to elect their messengers and alternatives in conference to attend the annual meeting.

SECTION 4. In case of internal dissension in a church and two parties coming to the Association, each claiming to represent the church, neither party shall be seated until the question is decided as to which party is in union with the Association. The decision is to be made by a majority of the messengers present and voting.

ARTICLE VI. OFFICERS

SECTION 1. General officers of the Association shall be: Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Historian, Parliamentarian, and Assistant Parliamentarian. Program leaders shall be Sunday School Director, Church Training Director, Music Director, Chairman of Evangelism Committee, Seminary Extension Director, Chairman of Mission Committee, Director of Missions, Trustees, Pastor Conference President, Youth Director, Stewardship Director, Vacation Bible School Director, Woman's Missionary Union Director, Brotherhood Director, Deacons Chairmen, Senior Adult Director, Singles Ministry Director, and such other officers as the Association may desire to elect.

Associational representatives will be elected for the following institutions and agencies: (1) Truett Camp, (2) Baptist Children's Homes, (3) Baptist Hospital, (4) North Carolina Baptist Homes, Inc. (Homes for the Aging), (5) Biblical Recorder, (6) Christian Education, (7) Annuity Board and other representatives as may be deemed appropriate and elected in the Association.

SECTION 2. With the exception of the Director of Missions and Trustees, the terms of office for all officers of the Association shall be for one year with the privilege of continuing re-election. The Moderator and Vice Moderator shall not be eligible for re-election but one year in succession. (1) The number of Trustees shall be three. (2) The term of service should be for three years, with the term of only one expiring each year. In the first election of Trustees, the term of service for one should be three years, another two years, and the other one year. (3) Upon the expiration of term of service, the Trustee may or may not be re-elected for another term of three years.

Each term of office shall begin with the close of the annual session. The Associational financial year will run from January 1 through December 31.

ARTICLE VII. DUTIES OF OFFICERS

SECTION 1. The **Moderator** shall preside and maintain the order of all meetings of the Association and Executive Committee. He shall serve as ex officio member of all committees of the Association.

He shall appoint the Committee on Committees and all other committees pertinent to the operation of the body not named by the Committee on Committees in its regular report.

SECTION 2. The **Vice Moderator** shall assist the Moderator and preside in the absence of, or at the pleasure of the Moderator.

SECTION 3. The **Clerk** shall keep a complete and accurate record of all transactions; shall prepare a "Book of Reports" to be distributed to messengers at the beginning of each day's session of the annual meeting; and shall cause to be printed minutes concerning the records made.

The Clerk shall distribute to the clerk of each church in the Association blanks for the preparation of the church letter as soon as they are received from the State Convention. This form is to be returned to the Clerk of the Association not later than four weeks prior to the meeting of the body or by the deadline set by the Clerk and Director of Missions. All program reports should be returned by the same date.

An **Assistant Clerk** shall work with the Clerk in preparing the "Book of Reports," the annual minutes and the registration of messengers at the annual meeting.

SECTION 4. The **Treasurer** shall receive and dispense by order of the Executive Committee of the Association while in session, the money of the treasury and make a complete report at the Annual meeting and a current report at each Executive Committee meeting.

An **Assistant Treasurer** shall be elected to assist the Treasurer by request and to serve in the event the Treasurer resigns or is ill or unable to function.

SECTION 5. The **Historian** shall keep the records of the Association up-to-date.

SECTION 6. The **Parliamentarian** shall upon the request of the presiding officer of the body, advise and assist the Association with respect to all matters involving Parliamentary Procedure.

An **Assistant Parliamentarian** shall be elected. The Parliamentarian and Assistant should always communicate with each other to ensure that this office is filled at each Associational Annual or Executive Committee meeting.

SECTION 7. The **Program Leaders** and the **Institutional Agency Representatives** shall perform all duties customary to

their titles and shall make a written report to the annual session of the Association.

SECTION 8. Trustees have no authority except by direction of the Association and are not personally bound by signatures but are to be the legal signees for the Association. Trustees represent the Association in legal matters. Trustees act on behalf of the Association in acquisition and disposal of Associational property.

They sign all deeds of conveyance, execute all notes, bonds or mortgages, intervene in all suits, by authority of the Association.

All persons dealing with the Trustees, as Associational officers, may rely upon any written resolution duly adopted by the Association or Executive Committee, directing and authorizing the Trustees to act in its behalf and certified by the Association Moderator and Clerk.

ARTICLE VIII. RULES OF ORDER

The business of the Association shall be conducted according to Robert's Parliamentary Practice or in a manner not contrary thereto.

ARTICLE IX. QUORUM

The quorum for the Annual Associational meeting or any special called meeting of the Association shall not be less than 25 percent of the member churches.

ARTICLE X. THE EXECUTIVE COMMITTEE

SECTION 1. The Executive Committee shall be composed of the General Officers and Program Leaders elected by the Association and the Pastor and one member from each church in the Association. No Pastor, by virtue of his being an Associational Officer or Program Leader shall be disqualified as a member of the Executive Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

SECTION 2. It shall be the duty of the Executive Committee to act for the Association on matters arising when the Association is not in session and to make a report of all work to the next session of the Association. This body shall meet at a time and place designated by the Moderator on Monday following the first Sunday of each quarter except for the July quarter which shall meet on the second Monday of the month of July. Special meetings of the Executive Committee may be called by the Moderator with a one week notice to the churches.

SECTION 3. All vacancies occurring on committees or among elected officers shall be filled by the Executive Committee.

SECTION 4. In the event that a vacancy occurs with the Trustees, the Executive Committee should fill such vacancy for the remainder of the term.

ARTICLE XI. ASSOCIATIONAL STANDING COMMITTEES

SECTION 1. The Association shall have such standing committees as may be deemed necessary to promote efficiently the work of the Master in our midst. The terms of office for all committee members shall be for one year except where specifically stated otherwise.

SECTION 2. COMMITTEE ON COMMITTEES. It shall be the duty of this committee to nominate at the general meeting all standing committees as set forth under Article XI.

SECTION 3. THE NOMINATING COMMITTEE shall be composed of seven members. To this group the Directors of Sunday School, Discipleship Training, Woman's Missionary Union, Brotherhood and Music Ministry will be added.

It shall be the duty of this committee to nominate the Officers, Program Leaders and Institutional Agency Representatives. These nominees shall be notified in writing not less than one month prior to presenting of their names at annual session.

SECTION 4. THE ORDER OF BUSINESS COMMITTEE, composed of three members, shall plan the annual program of the Association and present it to the Executive Committee at its October meeting.

SECTION 5. THE CREDENTIALS COMMITTEE shall be composed of three pastors and two laymen. It shall examine applications of churches seeking admission into the Association in keeping with Article IV and make recommendation to the Association. It shall counsel with churches that are out of harmony of fellowship with the Association. It shall be responsible for registering messengers at the Annual Meetings."

SECTION 6. THE PLACE AND PREACHER COMMITTEE shall be composed of three members. The duties of this committee shall be to recommend the place or places for the following annual meeting and to recommend the preacher and alternate to deliver the annual sermon for the following year.

SECTION 7. THE RESOLUTIONS COMMITTEE shall be composed of three members. It is appointed by the Moderator at the October Executive Committee meeting. It shall be the duty of this committee to present suitable resolutions at the annual Associational meeting.

SECTION 8. THE MEMORIAL COMMITTEE shall be composed of three members. It shall be the duty of this committee to bring a report to the annual meeting of those listed by the member churches as deceased since the last annual

meeting and shall lead a memorial service in their memory.

SECTION 9. THE STEWARDSHIP COMMITTEE shall be composed of six members including the Treasurer of the Association. This committee shall: (a) present a Budget to the Association for the following year; (b) devise plans for raising the funds for the Associational Budget; (c) audit the finances and financial records of the Association annually and anytime there is a change of Treasurer or at the direction of the Association or the Executive Committee; (d) report all audits to the Annual Association Meeting.

SECTION 10. THE CONSTITUTION COMMITTEE shall be composed of three members and shall perform all duties specified in Article XV.

SECTION 11. THE ORDINATION COMMITTEE shall be composed of five designated Pastors and all other Pastors who desire to sit with the committee.

A. The committee serves on an advisory capacity only and serves at the request of the church from which the member is seeking ordination.

B. The committee should examine such candidates for the ministry as come before it as to their call and fitness for the gospel ministry and make such recommendations to the church as they feel led.

C. The committee should assist in arranging the proper service of ordination when such assistance is requested.

D. The Executive Committee should be informed regularly of the work of the committee.

E. Each church desiring to ordain a candidate is urged to consult with the committee, and shall give two weeks notice in which the committee is to do its work.

SECTION 12. THE EVANGELISM COMMITTEE. The duties of the committee shall be to direct and propose a perpetual program and spirit of evangelism in the Association. It shall arrange and direct all Associational-wide evangelistic activities.

SECTION 13. THE ASSOCIATIONAL MISSIONS DEVELOPMENT COUNCIL shall be composed of eight (8) members, nominated by the Associational Committee on Committees and elected by the Association at the annual meeting. The committee shall be: Missions Development Director, Promotion Director, Survey Director, Associational WMU Mission Action Director, Associational Brotherhood Director, Sunday School Outreach Director, Church Training Director, and Associational Deacons President. The Missions Development Director, Promotion Director, and Survey Director shall be elected for a three-year term, with one member named each year. The other five positions shall be filled by the person who is elected to fill those five Associational offices.

The duties of the AMDC are to lead the associational missions development in the five mission performance tasks: (1) call churches to be on missions; (2) train, develop, and encourage church and Associational workers; (3) provide resources and services to churches and leaders; (4) provide opportunities for working together in missions, ministry and growth; (5) establish and maintain appropriate communications and relationships with the community and the denomination.

SECTION 14. THE BUILDING AND GROUNDS COMMITTEE shall be comprised of three members. The committee shall be responsible for and in charge of the upkeep and repairs of the Associational building, grounds, and equipment.

SECTION 15. THE PERSONNEL COMMITTEE

A. The Committee shall be composed of 7 members of which 3 are pastors.

B. They shall recommend policies and procedures for the selection, supervision and termination of Associational staff personnel. Those policies and procedures shall be approved by the Association.

C. Prepare and maintain an organizational manual relation to the Association's staff personnel.

D. Develop and recommend to the association policies and procedures for paid and volunteer staff personnel.

E. Develop policies and procedures regarding continuing education and development for the Director of Missions and other Associational staff.

F. When a staff vacancy occurs, other than the DOM, they shall serve as the search committee. When a DOM vacancy occurs, they shall nominate a search committee and present it to the Executive Committee.

G. The Personnel Committee shall handle grievances as outlined in the grievance policy.

ARTICLE XII. THE ASSOCIATIONAL COUNCIL

The ASSOCIATIONAL COUNCIL shall be composed of the Director of Missions, the Moderator, the Vice Moderator, the Program Leaders: Sunday School, Discipleship Director, Woman's Missionary Union, Brotherhood Director, Chairman of Deacons, Missions Development Director, Chairman of Evangelism, Chairman of the Finance Committee, Vacation Bible School Director, Youth Director, Director of the Singles, Director of the Senior Adults, and Music Director. The Director of Missions is to serve as Chairman and a secretary shall be elected from the group.

The purpose of the council is to coordinate the planning of the various programs of the Association, to develop an Associational calendar, and to give mutual support to the various organization and program units in carrying out their assignments.

The council shall meet quarterly.

ARTICLE XIII. THE ASSOCIATIONAL PASTORS' CONFERENCE

The Associational Pastors' Conference provides regular meetings for the Baptist ministers of the Association. The purpose of the conference is for fellowship and mutual support, for doctrinal and professional discussion and for promotion of church, Associational and other denominational programs. The conference is not an administrative or executive body.

ARTICLE XIV. JOB DESCRIPTION, DIRECTOR OF MISSIONS

SECTION 1. Title and Functions.

A. Position Title. This position shall be known as the Director of Missions for the Tuckaseegee Baptist Association.

B. Basic Functions. The Director of Missions shall serve as minister to the churches and church leaders of the Tuckaseegee Baptist Association, as mission strategist for the Association, as chief administrative officer for the Association, and as a general leader of the Association.

SECTION 2. Responsibilities.

A. Minister to Churches and Church Leaders.

1. The Director of Missions shall serve as pastor to the pastors of the Association. Upon request, the Director of Missions shall provide counseling and consultation for pastors regarding spiritual, vocational, congregational, personal or family concerns. The Director of Missions shall be available to assist pastors considering a move, shall orient new pastors to the Association, shall develop systems of pastoral support and fellowship, and shall provide growth opportunities for pastors.

2. Upon request, the Director of Missions shall assist and counsel pastors and church leaders regarding ministries, programs and procedures within the churches, including but not limited to building planning, budget procedures, long range or strategy planning, curriculum evaluation or review, issues of church policy and organization, church-community surveys, outreach, and spiritual growth.

3. Upon request, the Director of Missions shall assist and counsel churches regarding the calling of pastors or church staff, conflicts between a pastor and church, or conflicts within a church's fellowship. The Director of Missions shall assist churches without a pastor in their ministries and programs at their request and shall provide advice for persons considering a Christian vocation.

4. The Director of Missions shall be available upon request to preach or teach in and for churches on such occasions as revivals, pulpit supply, study courses, stewardship or missions emphasis, promotion or recognition assemblies and services, special day addresses, Vacation Bible School, and similar events.

5. The Director of Missions shall take the initiative to regularly visit churches for worship and fellowship, taking care to treat all churches as equal partners in the Association.

6. The Director of Missions shall develop opportunities to foster fellowship and mutual commitment between and among the churches.

B. Mission Strategist.

1. The Director of Missions shall encourage churches to develop and maintain a missions perspective and to extend their ministries and outreach beyond the local church field and community through broader involvement and cooperation with other churches in missions activities.

2. The Director of Missions shall interpret to the churches the needs of persons and groups within the Association's area and shall lead the Association to start new churches or ministry activities appropriate to the needs.

3. The Director of Missions shall encourage and lead volunteer involvement in mission activities beyond the Association's boundaries, such as home and foreign missions partnerships and disaster relief.

4. The Director of Missions shall interpret to the Association the mission work of the churches and conventions of the denomination at the state and national levels and shall encourage churches to support such work with their prayers, finances and personal commitment.

C. Chief Administrative Officer.

1. The Director of Missions shall administer all policies and instructions committed to that office by the Association in annual session or by the Executive Committee.

2. The Director of Missions shall work with the Executive Committee to plan, organize, coordinate, communicate and evaluate the total work of the Association.

3. The Director of Missions shall work with and assist Associational officers, committees and program leaders to implement the specific objectives of the Association and to communicate these activities to the churches and encourage their involvement.

4. The Director of Missions shall serve as an ex officio member of all committees and program departments of the Association.

5. The Director of Missions shall publish a regular Associational news medium to promote the work and fellowship of the Association among the churches and shall otherwise communicate with the churches as required.

6. The Director of Missions shall supervise the Associational office staff and any volunteers or other paid employees, full or part time, who are directly involved in ministries or activities sponsored by the Association.

7. The Director of Missions shall act as office and property manager and purchasing agent for the Association in all matters not assigned to the Trustees of the Association.

D. General Leader of the Association.

1. The Director of Missions shall interpret the work of the Association in the churches.

2. The Director of Missions shall maintain relationships with pertinent Baptist conventions and bodies, and especially with those denominational offices charged with Associational development and support, informing those bodies of the needs and potentialities in the Association and interpreting the overall work of the denomination to the churches.

3. The Director of Missions shall relate to other Christian and service organizations, such as local relief and assistance groups, hospital chaplaincy programs, groups that minister to the homebound or terminally ill, ministerial conferences or support groups, and similar organizations, as appropriate.

4. The Director of Missions shall relate to and represent the work of the Association to various business, social, educational, governmental and civic groups.

5. The Director of Missions shall act as chief public relations and information officer for the Association, promoting its work to the general public through the various communications media and responding to inquiries and requests for information as required.

SECTION 3. Terms of Employment.

A. Employment. The Director of Missions is employed by the Tuckaseegee Baptist Association.

B. Call, Termination and Interim.

1. A person shall be called to the office of Director of Missions according to the following procedures:

a. When a vacancy occurs in the office of Director of Missions, the Personnel Committee shall nominate a search committee to be elected by the Executive Committee. Election of the search committee shall take place within 30 days of the occurrence of the vacancy. If a regular meeting of the Executive Committee is not scheduled within 30 days, a special meeting shall be called by the Moderator. Executive Committee members shall be given two weeks' written notice of the names of the nominees to serve on the search committee and the date, time and place of the meeting.

b. Once elected, the search committee shall solicit and screen candidates according to qualifications and procedures which the committee shall determine. The search committee shall recommend and present one candidate for election by the Association.

c. Election of the candidate by the Association shall take place within 30 days of the search committee's decision to recommend. If the annual session of the Association is not scheduled within 30 days, a special session of the Association shall be called by the Moderator. The Association shall be given two weeks' written notice of the name of the candidate and the date, time, and place of the meeting.

d. Election of the candidate shall be by majority vote. If the candidate fails to receive a majority vote, the search committee shall be immediately dissolved and the Personnel Committee shall begin the process over again.

2. The term of service of the Director of Missions shall be indefinite. Employment of the Director of Missions may be terminated according to the following procedures:

a. The Director of Missions may resign by giving written notice 60 days in advance. The resignation may be accepted on behalf of the Association by the Executive Committee in regular or called session. By mutual agreement of the Director of Missions and the Executive Committee, the period of 60 days' notice may be waived.

b. The Director of Missions may be involuntarily terminated by the Association in annual or called session.

(1) No final action to terminate the Director of Missions shall occur unless both the Director of Missions and the Association have endeavored to resolve any existing conflict by lesser means. In addition, no final action to terminate the Director of Missions shall occur without prior investigation by the Personnel Committee according to established grievance procedures. The Personnel Committee shall then make a report of its findings to the Association. The Association shall consider, but shall not be bound by or required to follow, the recommendations of the Personnel Committee. If such an investigation and report has not occurred, any action to terminate the Director of Missions shall be referred to the Personnel Committee for investigation before final action is taken.

(2) Action by the Association to terminate the Director of Missions, whether in annual or called session, shall require 30 days' written notice to the Association following completion of the Personnel Committee's investigation. Action to terminate shall be by majority vote.

(3) If the Association in session votes to terminate, the Director of Missions shall receive full pay and benefits for a period of 60 days following the effective date of the termination.

3. When a vacancy occurs in the office of Director of Missions, the Executive Committee may elect an Interim

Director of Missions according to the following procedure:

a. The Personnel Committee shall recommend a candidate, negotiate terms of employment, and present the recommendations to the Executive Committee for approval. Such election may take place at the same time and in the same manner as election of the search committee, or at any other appropriate time.

b. The Personnel Committee shall supervise the work of the Interim Director of Missions. Authority to extend, terminate, or otherwise change the terms of employment of the Interim Director of Missions shall be retained by the Executive Committee.

C. Accountability.

1. The Director of Missions shall be supervised by the Personnel Committee acting on behalf of the Association.

2. The Personnel Committee shall arrange for an annual evaluation of the Director of Missions.

3. The Personnel Committee shall establish a grievance policy to provide an orderly and appropriate process to hear grievances and complaints against the Director of Missions by members or churches of the Association.

D. Pay and Benefits.

1. Salary, retirement, insurance and other financial benefits for the Director of Missions shall be proposed by the Budget and Finance Committee and established by the Association in the annual budget. The Budget and Finance Committee shall solicit recommendations concerning pay and benefits for the Director of Missions from the Personnel Committee, but shall not be bound to accept those recommendations.

2. Travel allowance for the Director of Missions shall be deemed by the Association to be a business expense and not a personal benefit for the Director of Missions.

3. The Director of Missions shall receive two weeks paid vacation annually. The period of two weeks shall incorporate ten working days, including two Sundays. Unused vacation shall not accrue to the following year.

4. The Director of Missions shall receive sick leave at the rate of one day per month, accruing on the first day of the month, not to exceed 120 working days. Additional sick leave may be credited against future months. If the Director of Missions is involuntarily terminated by the Association, any unused sick leave accrued shall be financially reimbursed to the Director of Missions in addition to the 60 days' pay and benefits required by the act of termination.

5. The Director of Missions shall be granted one day off each week in addition to Saturday.

6. The following holidays shall be observed: New Year's Day, Easter Monday, Memorial Day, July 4, Labor Day, Thanksgiving Thursday and Friday, and December 25 and 26 at Christmas.

7. The Association acknowledges the flexibility of schedule required by the Director of Missions. The Director of Missions' time shall be organized in a professional manner, with the work schedule devoted to activities that will benefit the work of the Association, whether in the office or on the field and whether during the normal work day or at night. The Director of Missions shall establish office hours for the office secretary and shall be available, either through personal office hours or some other established procedure, to any in the Association needing assistance.

8. The Director of Missions may attend denominational conventions and meetings, continuing education and professional development events, and other assemblies and conferences pertaining to the work of the office. The Association through its annual budget may reimburse the Director of Missions for expenses incurred while attending such meetings.

9. The Director of Missions may use up to three weeks of paid leave annually to lead or participate in revivals, world missions conferences, and similar meetings outside the Association, which result in an honorarium or other reimbursement above and beyond expenses. The Director of Missions may lead revivals and conferences within the Association as schedule permits, such activities being included in the job responsibility of minister to the churches of the Association.

10. The Director of Missions may serve as interim pastor of a church or churches in the Association. Such activity may not exceed three months in a given calendar year without prior approval of the Personnel Committee. The Director of Missions may engage in pulpit supply and similar activities as schedule permits, such activities being included in the job responsibility of minister to the churches of the Association.

11. The Director of Missions may lead or participate in mission trips, mission partnerships, disaster relief, and other direct mission opportunities outside the Association, such activities being included in the job responsibility of mission strategist for the Association. Such activities may not exceed three weeks in a given calendar year without prior approval of the Personnel Committee.

12. The Director of Missions shall keep a record of leave and time spent off the Associational field, including vacation, sick leave, conventions and conferences, continuing education events, revivals and similar meetings, and mission trips. The record shall be submitted to and maintained by the Treasurer of the Association.

13. The Director of Missions shall be free to use off duty time to engage in personal activities and pursuits. Such activities shall not interfere with the professional responsibilities or activities and meetings that require the presence of the Director of Missions. The Director of Missions shall be aware that all personal activities reflect on the office and the job

responsibility of general leader of the Association.

14. No honorarium shall be expected or required for any service performed by the Director of Missions in conjunction with official duties. However, any individual, group or church is free to present an honorarium if they so desire, and such may be retained by the Director of Missions and not submitted to the Association.

SECTION 4. Adoption.

A. This job description supersedes, repeals and takes the place of any conflicting articles or statements in this Constitution or other documents of the Association.

B. The Personnel Committee shall be responsible to maintain, update and revise this job description as required, making recommendations to the Association for approval as they are needed.

ARTICLE XV. AMENDMENTS

The constitution may be amended at any annual meeting of the Association by a two-thirds majority of the messengers present and voting, provided the amendment has been presented to the Constitutional Committee at least 10 days prior to the annual meeting and presented to the Association in printed form on the first day of the annual meeting to be voted on the second day.

ARTICLE XVI. NON-PROFIT STATUS

The Tuckaseegee Baptist Association, Inc. is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the Tuckaseegee Baptist Association, Inc. shall inure to the benefit of its' members, directs, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

In the event of dissolution, the residual assets of the Tuckaseegee Baptist Association, Inc. will be turned over to one or more organizations with similar purposes which are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986.
