

# MINUTES

Wednesday, October 12, 1949.

### CORRESPONDING CIRCULAR LETTER

(Written by Brother L. D. Duke)

The Virginia Corresponding Meeting, in session with the Mt. Zion Church, Loudoun County, Virginia, October 12th, 13th and 14th, 1949, to the churches composing this Meeting, and to the associations, churches and meetings with which we correspond, we send christian greetings.

Dear Brether:—Once again we feel to be blessed by our God to meet together in the bonds of christian fellowship. Once again it is our blessed privilege to meet together with our brethren, sisters and friends of this, the Virginia Corresponding Meeting, for our mutual

pleasure and association.

We wish to extend to these, our visiting brethren, a most cordial welcome and trust that this occasion shall redound to their spiritual edification and enjoyment. However, it is with heavy hearts that we, at this time, endeavor to carry on in the wake of our recent sorrowful bereavement. There is a void in our hearts which we, at this time, feel can never be filled. Nevertheless, we cannot stand still, we dare not turn back; we must go on. We must be made to realize that all things are of God and made for His glory; that He rules in the heavens and in the earth and that His works are perfect.
