




Dedicated in Honor of Reverend Robert Fernandez

The 2013 Annual Minutes are dedicated in honor of Reverend Robert Fernandez. Robert was born in Cuba and migrated to the United States at the age of two with his parents and older brother. This exile to the United States was a result of the turmoil with Cuba during the 1960s. They lost everything they had and came to America with nothing. Through hard work and the Providence of God, Robert's parents began to build a new life.

Robert became a Christian as a boy in sixth grade. Shortly thereafter his parents became Christians through the work of a Hispanic ministry supported by an American congregation – the church that Wanda attended.

As Robert entered his high school years he began his Christian service as a Summer Camp Counselor and helping at weekly youth groups meetings. (Since he was one of the only teenagers with a car, a blue duster, he drove everyone to the meetings.) The Hispanic ministry and American church continued to work together and through the partnership Robert and Wanda fell in love and married in 1979. Just five years later, Robert became an American Citizen. He and Wanda have also raised two foster children.

Although Robert's career path was in the field of business with a focus in retail management, he continued his service to Christ as a Sunday School teacher, and Camp Counselor. In 1989 Robert was transferred to Sylva as a manager of Revco. Years later he began his service in the ministry. Once he was ordained and licensed, he served as a fill in pastor for several local churches. In 2001 he began his fulltime studies at Fruitland, leaving behind his retail career as manager. Once he completed his degrees at Fruitland, he earned both a Bachelor's and Masters degree from Luther Rice University.

Being a fluent speaker of Spanish, Robert was approached to begin working with Hispanic families in need. This work began with him translating for those in need but then evolved into Mission work, with the planting of a Hispanic Church in Cullowhee housed at the Cullowhee Methodist Church. This congregation began with one person. Today, this church has an average weekly attendance of 48 with over 30 baptisms during the years. Now in its twelfth year, this church even supports its own missionaries.

Four years ago, a Hispanic church was planted in Haywood County. It began with one family. Now its average attendance is 26, with eight baptisms and with more forthcoming.

Robert has been coordinating Regional Support for all of the growing Hispanic works in Western North Carolina as well as mentoring pastors.

Several years ago, he began serving as the Professor of the Hispanic studies program at Fruitland Baptist Bible Institute. Now this program has expanded across the state with satellite campuses in Sylva, Statesville, and Wilmington. Robert is now the Director of all Hispanic Studies at Fruitland.

Today, Robert is very busy as he serves the Lord and follows the Great Commission to make disciples. He pastors the Hispanic congregation in Jackson and Haywood Counties. He serves as Director of Hispanic Studies at Fruitland. He provides medical and other interpreting services to those in need. Through his willingness to serve, God is blessing the Hispanic community of Western North Carolina.



Dedicated in Honor of Raymond and Pat Deitz

The 2013 Annual Minutes are dedicated in honor of Raymond and Pat Deitz. Raymond Deitz was born August 29, 1944 and Pat was born September 15, 1945. They have two sons, two daughters, and six grandchildren. Raymond graduated from Sylva-Webster High, Sylva, NC and Pat from Brevard High School, Brevard, NC.

Raymond and Pat are members of Faith Baptist Church. He is Brotherhood Director, team leader for Raymond's Raiders and serves on the Nominating committee and Pastor Search Committee. Pat is Mission Director, Adult Ladies Sunday School teacher and a member of Women of Faith (WMU) at Faith. She also teaches Sunday School at Mountain Trace Nursing Home. They both have been to Vermont and Maine volunteering with The New England Partnership. They are both certified in Disaster Relief. Raymond has worked in

New York, North Carolina and Kentucky with NCBM Disaster Relief.

Raymond began his mission journey back in March of 1980 when he went with a Baptist Men's group to Honduras to help build a church. After that first trip he went on every trip that he was able to go and in 1990 he started taking teams down once a year to work with the IMB Missionary in Choluteca, Honduras. The teams built churches and houses, but most of all shared the Love of Christ. He and Pat did this each year till 1999 when they went to live and work in Honduras for eight years.

Raymond retired from DuPont, Brevard, NC. After retirement he became very active in volunteer mission work in Honduras, Nicaragua and worked with North Carolina Baptist Men in Disaster Recovery and Relief work beginning with Hurricane Andrew going with a team from the Tuckasegee Baptist Association. He was a part of The Handyman Ministry during this time. He has been Brotherhood Director for the Association. Pat has been the historian for the Association. Raymond and Pat have made helping others part of their Christian journey.

Raymond and Pat were NC On-Site Coordinators for the NC/Honduras Partnership after Hurricane Mitch devastated Honduras in October 1998. They severed with Baptist Men for eight years. They loved working with the Honduran brothers and sisters but most of all rejoiced when one of them received Christ.

PROCEEDINGS
184th ANNUAL MEETING
FIRST SESSION, THURSDAY, OCTOBER 17, 2013

1. East Fork Baptist Church hosted the first session of the 184th Annual Meeting of the Tuckaseegee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 85 present: 59 Messengers and 26 visitors representing 17 churches.
2. Dennis Proffitt, Vice Moderator, welcomed everyone. Rev. Keith Dean, Moderator, was sick and unable to moderate.
3. Rev. Dennis Burrell welcomed everyone to East Fork Baptist Church. He read scripture from Psalms 126:5-6. East Fork's choir provided special music.
4. Rev. Dennis Burrell brought the message from Exodus 32:32 with the topic of "Have you been touching heaven for someone you know?"
5. The 184th Annual Meeting was called to order by Dennis Proffitt, Vice Moderator.
6. The agenda was approved as presented.
7. Rev. Ernie Jamison of New Hope Baptist Church was recognized as a new pastor.
8. Dennis presented the appointment of Committee on Committees and Resolutions Committee on page 11. He added James Roper from Lighthouse Baptist and Laura Brown from Calvary Baptist to the Resolutions Committee.
9. Grace Morris, music director, led the congregation in singing, "Just a Little Talk with Jesus".

REPORTS

10. **Director of Missions** - Rev. Gerald Morris gave his report as Director of Missions. It was located on page 3. He talked about the three areas that had been focused on this year. (1) Exalt our Savior in children's rally and Spring Worship Rally. (2) Equip the Saints through the Sunday School and Church Leadership Training and the Student Right's Seminar. Educate everyone on missions through the Mission's Celebration coming up on November 10th. (3) Evangelize the lost through BookLink, Felix Villarreal's Mexico mission trips, and five Migrant Camp outreaches. Reach out to the Western Carolina University's 10,000 students. Then he called everyone to come together at the altar to pray.
11. **Music** - Grace Morris gave the Music report listed on page 5.
12. **WMU** - Mrs. Lee Lillard presented the WMU report on page 6. She added that the WMU is supporting a "Raising the Roof Campaign at Camp Mundo". The goal of the WMU is teaching missions and sharing the Lord with others. The next mission project is to encourage churches to get involved in the "All God's Children's Christmas project". It will benefit the financially or spiritually needy with the project ending with a party on December 13th. They want to share the love of Christ and the Gospel. Each church will get a packet with more details. In the Spring they want to get out in the neighborhoods and knock on doors and invite people to Christ.
13. **Camp Truett** - Samantha Blanton, who has gone from being a camper to counselor, presented some of her experiences about Camp Truett. She said that the main focus as a counselor is to teach the youth about the love of Christ and to have fun. She works with the two music weeks. She played a small sample of the kids' performance at the end of the week. She described the daily activities and facilities. It was very informative and she encouraged everyone to send their kids.

COMMITTEES

13. **Memorials** - Virginia Pangle and Laura Brown read the names of members from each church that had passed away during the past year. They had flowers on display. The minutes

will be dedicated this year in honor of Rev. Robert Fernandez, pastor of El Centro del Señor and Raymond and Pat Dietz of Faith Baptist Church. Laura described what Robert has done in the region and in the association. Virginia described about the mission work that Raymond and Pat has been involved in. Refer to the pictures and descriptions that will be in the minutes at the front of the book. Steve Lillard led in prayer.

14. **Stewardship** - Rev. Mike Moore presented the proposed 2013-2014 budget to be voted on during the second session. The budget was on page 7. He spoke about success of the special emphasis that Gerald had done during the year to raise additional funds.

15. **Committee on Committees** – Rob Sutton presented their report on page 11. It was approved.

16. **Nominating Committee** – Karen Burnette presented their report on page 12. No further nominations were made and the motion carried.

17. **Place and Preacher Committee** - Their report on page 14 was presented by Steve Lillard. It was approved with no opposition.

18. **Credentials Committee** – Rev. Clemmey Queen presented a letter from Hamburg Baptist Church stating that the church was withdrawing from the Tuckaseegee Baptist Association and the NC Baptist State Association. This was accepted. Karen Burnette asked if there would be contact from the association to Hamburg Baptist Church. Gerald said that it had already been done.

19. **Miscellaneous Business** – No additional business.

20. Grace Morris led the congregation in singing, “Victory in Jesus”.

MISSIONS

21. **Long Branch Baptist** – Lee Lillard presented a report and pictures about some of the mission projects of their church. In August, people from their church and Virginia Pangle from Locust Field Baptist went to BookLink in Kentucky. They have an ongoing project to collect and distribute furniture and appliances. This year they helped 18 families. Lee has organized transportation for 25 people on Wednesdays. Eight people have been saved since spring. Two parents have started coming as a result of their children coming to Long Branch. They support two international missionaries. The biggest project that Long Branch has spearheaded has been the Migrant Ministry. In 2012 people from the Tuckaseegee Baptist Association went to one migrant camp to share a meal and music with the workers and share some goodies that people from the association has collected. Rev. Mark Tice preached and Rev. Robert Fernandez interpreted. One man got saved! In 2013 the goal became to go to five camps and share a meal and goodies with them. The Gideons also distributed Bibles. As of this time they had already been to four camps. It is a project that has reached 200 men with the Gospel. Different preachers have preached each night. Testimonies and the plan of salvation has been presented each time also.

22. **Ochre Hill Baptist** – Kim Fiskeaux presented a report with pictures of their trip to Huntington, West Virginia through Youth on Mission/SCORE. They had 27 to go that broke up into two teams to do home repairs. The teams partially replaced shingles on a very steep roof and painted a house and garage for another lady. It also had a very steep roof with dormer window that had to be painted. They also went and did some cleaning and sorting at a YMCA one day. There were three nights of worship.

23. **Scotts Creek Baptist** – Cole Young, a junior at Smoky Mountain High School, told about his mission trip to South Africa through Global Expeditions and showed slides. He said that men shared with men and women shared with women. It was very cold and they were aware of how

important it was to share with each person, because you didn't know if the Africans would freeze to death during the night. He showed many slides and one in particular shows the extreme difference between the neighborhoods that are just across the road from each other. One neighborhood would have large pools and the other neighborhood consisted of people in huts. There were 456 salvations throughout all the Global Expeditions.

24. Bill Carpenter lead the benediction prayer.

SECOND SESSION, FRIDAY, OCTOBER 18, 2013

1. Locust Field Baptist Church hosted the second session of the 184th Annual Meeting of the Tuckaseegee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 86 present: 55 Messengers and 31 visitors representing 18 churches.
2. Dennis Proffitt, Vice Moderator, welcomed everyone and called the meeting to order.
3. Rev. Jason Buchanan welcomed everyone to Locust Field Baptist Church and read Isaiah 6:8. Locust Field's choir sang.
4. Grace Morris, music director, led the congregation in singing "The Old Rugged Cross."

REPORTS

5. **United Christian Ministries** - Kathy Cross, UCM director, presented her report on page 24.
6. **Baptist Men** – John Burnette showed a video about the work of the Baptist Men. He said there were 14 programs to be involved in. People are encouraged to volunteer, pray, give, and go. In 2011, 294,694 meals were served and there were 1,151 salvations. In 2012, 405,990 meals were served and there were 184 salvations. So far in 2013, 31,415 meals have been served with 48 salvations. Thankfully there have not been many disasters this year. They are offering special training for college age students at the Red Springs Camp and one at the Shelby Camp.
7. **Baptist Campus Ministry** – Caleb Mayfield presented a report about what is going on at Western Carolina University and encouraged churches to be praying for them. He said God is still alive and He is in control. Pray very hard for these students and that there will be a sweeping of the Holy Spirit on the campus. There is going to be a shift on how we do things.
8. **Baptist Children's Homes of NC** –Rev. Lewis Smith shared that they have 18 locations. He showed the Thanksgiving Offering video and encouraged people to show it at their churches. There were 69 salvations this year in the homes. 70% of the children placed at BCH are unchurched.
9. Grace Morris led the congregation in singing, "Somebody Loves Me".
10. Dennis reported that there were 53 messengers, 30 visitors and 18 churches represented on Friday. On Thursday there were 86 total and 17 churches represented.
(This is a little different after Gracella got back to the office and compared more carefully all the attendance sheets.)

MISSIONS

11. **Video presented by MM in China.** Gerald showed a video via the computer. MM encouraged everyone to lift them up in intercession and to support the Lottie Moon Christmas Offering. (Note: Name withheld due to security concerns.)
12. **Cashiers Baptist Church** – Benny Rice spoke about the three-year commitment they have made to help in Romania. 15 men worked on a church and presented testimonies. They also have a four-year commitment to work in Hazelton, Pennsylvania. Nine people went from the church and worked on the church, distributed tracts, invited people to church and painted a school. They also have had nine people go to Boone, NC to work at the Operation Christmas Child Processing Warehouse for two days. The church also packed 620 individual boxes. Each

month they have one Sunday that is called WOW (Working Outside the Walls of the church.) They go into homes in the community doing small repairs, providing firewood, etc.

13. **La Primera Iglesia Bautista de Amor** – Rev. Felix Villarreal reported that he has started a new mission in Highlands, NC. He said people come here to work and he wants them to come to know Christ here. Six years ago there was a couple who accepted Christ here and wanted to go home to Mexico to share Christ there. They put out a call for help to build a church. It is the only Baptist church for mile and miles. He tries to take two trips to Mexico each year. He just got back from a trip where 80 people were saved. He went and shared in a prison for the first time. He shared Mark 5:1-8 through the power of Jesus. 40 were saved in the prisons. He encourages anyone to go with him that can go. It is tiring but rejoicing.

COMMITTEES

14. **Stewardship Committee** - Rev. Mike Moore moved that the 2013-2014 budget on page 7 presented the previous session be approved. It was approved. He prays that many will come to know the Lord Jesus Christ through all these expenditures.

15. **Resolutions Committee** – James Roper presented the following resolution.

Whereas East Fork and Locust Field Baptist Churches have hosted meetings, provided abundant meals, and extraordinary hospitality to messengers of the Tuckasegee Baptist Association, and Whereas Rev. Dennis Burrell presented (and we believe also Rev. Mike Farmer will present) motivating, encouraging, and uplifting messages, and

Whereas associational and convention-wide representatives have given informative and challenging reports, and

Whereas Grace Morris has so capably led us in worshipful singing, and

Whereas Rev. Keith Dean and Dennis Proffitt have so efficiently presided over these sessions and other meetings, and

Whereas our Director of Missions, Rev. Gerald Morris, has brought wise leadership that strongly promotes missions and unity, and

Whereas, our committee officers and members have given of time and energy to serve the association well. Be it therefore resolved that we extend sincere appreciation to all who have served to honor our wonderful Savior Jesus Christ. Bro. Moderator, I move that this well deserved resolution of appreciation be approved. It was approved.

16. Grace Morris led the congregation in singing, "I Am Blessed".

October 1, 2012 - The quarterly meeting, of the Tuckaseegee Baptist Association was called to order by Rev. Keith Dean, Moderator and was held at the Baptist Center. Director of Missions Report 2012-2013, by Gerald Morris

Some time back I read of a church's mission statement and it really stuck with me. The three parts to their statement were Evangelize the lost, Equip the saints and Exalt the Saviour. This struck me as good goals for any church or association. I want to use it as a framework for this report.

Evangelize the lost- I believe the Great Commission is very clear that this should always be the driving force behind much that we do in our personal, church and Associational lives. As individual churches and an Association we have been quite successful in this area this year. We have seen several churches do missions here in Jackson County to international missions.

Several churches and individuals have been involved in collecting Bibles, Christian books and old Sunday School literature to send overseas through BookLink. This year we sent over 5,000 pounds. But that is not all, during Spring break the Association sponsored a two day trip to help pack materials for shipment. That is not all, we also had three county churches (2 in the Association and 1 outside) that took groups to help at BookLink.

Felix is continuing to take trips into Mexico for the purpose of evangelizing the lost and encouraging churches. Everyone who has traveled with him has been very blessed by the trip. He would love to take many others with him as he continues reaching out to the "uttermost parts of our world."

Closer to home I have been blessed at the outpouring of love that the churches have shown through the Migrant Camp Ministry. I cannot even count how many churches have been involved in this mission. Many have collected supplies, Bibles or money, cooked, served and spoke at each of the camps. I know that nearly all of the Associational churches have been involved in some way with this foreign mission in our own backyard. I know lives have been changed and look forward to this ministry continuing into the future.

This is just some examples of the many ways the churches of the Association are reaching out in their Jerusalem, Judea, Samaria and Uttermost parts of the world.

Equip the Saints -

This year we have continued to expand training opportunities for the churches. In the Spring we had our annual Church Leadership/Sunday School Conference. We provided a variety of classes on a wide range of subjects through the help of some grants from the Baptist State Convention. Also with the help of the NC Baptist Foundation we were able to host Mark Creech of the NC Christian Action League to discuss what rights Christian students have in the public schools.

Coming up this November, we will be hosting our first Missions Celebration. This will be a time for the churches to come together to hear about the work of our International Mission Board missionaries. I am always excited to hear what God is doing through the missionaries we support by our Cooperative Program and Lottie Moon offering dollars.

I have also worked with individual churches helping with various training needs. I am always available to help during pastoral transition, conflict or other special needs

Exalt the Savior -

Each year that I have had the honor of being your Director of Missions I have been blessed to see how the churches have come closer and closer together. This has been most evident in the way we

worship together. Last year was full of times that we came together to exalt our Saviour. The annual meetings keep getting better each year as the Holy Spirit has visited us to make each meeting more worship than business. The Spring and Fall Annual Singings continue to be wonderful times for the churches to come together to worship God in song.

The Adult, Youth and Children's rallies were also a great times for the churches to come together to worship. Each one was a great time to come together as one instead of always being separated in our worship.

As you can see, we have had a wonderful and busy year. As I write this, I am already excited about what God is going to do in the future. Please let me share with you some of the things that I hope to see come about in this new Associational year.

I want to continue our move toward more and more outreach, here in Jackson County and beyond. One grand opportunity that has been given a new urgency is reaching out to the students of Western Carolina University. With the Baptist State Convention pulling back on its ministry to students at the colleges throughout North Carolina we must step up to reach this important mission field. I am currently working with the Baptist campus minister and the Western regional campus consultant to come up with a plan on how to reach the students at WCU. This will require the churches of our Association to reach out in new ways. Please pray that God will show you how you can be faithful to this need.

One way to reach out to students at WCU has already presented itself to us in the form of "adopting" an international student. Through simply agreeing to host an international in your home at least once a month, you can be used by God to reach a student that may have never heard the Name of Jesus. Many of the international students are from countries that are closed to the Gospel. If you think that you might be interested, please call me for further details.

As I noted above, we have had great success in doing a short "mini-mission" trip for two days to BookLink in Kentucky. I would now love to expand our horizons with a longer, more involved trip. I am looking at various mission trip styles and length in a variety of areas. If you have always wanted to go on a mission trip, please let me know where and what type (construction, VBS, prayer walk, etc.) that God has laid on your heart.

This coming year we plan to have a Creation Science emphasis. I believe it is important that we believe the Bible from the very first verse and that we are sure of our beliefs and be able to defend them. Because of that we are planning to host a Creation Science seminar in the Spring of 2014. In conjunction with this, I plan on leading at least one trip to the Creation Museum in Northern Kentucky. This museum is world class and very interesting as it presents very clearly the message that we can trust the Bible when it describes the way God created everything. Please contact me if you would be interested in taking such a trip.

I thank you for the privilege of serving you and your church. It has been a wonderful three years and you have been very supportive. If you look at the financial records in this Book of Reports you can see that many of the churches have given generously. But we still have a shortfall of income, though not as big as in the past. Please be in prayer about how your church can give to keep the Association going so we can continue to work together to do more than we ever could apart.

United Christian Ministries received \$ 93,337.02 in donations last year. Churches contributed \$ 50,214.99; and individuals \$26,073.86. Businesses contributed \$3,315.07; with grants and funding raising totally \$13,733.10.

The funds helped 9,749 persons in Jackson County. 3,814 were children. 367 families came to UCM for the first time last year.

7346 bags of food was distributed last year meaning over 100,000 pounds of food was given to families to prepare meals at their home. UCM used \$15,287.23 on food purchases. Many, many donations of food were made. In addition 253 turkeys were given to families in November; over 150 of those turkeys were donated. More than 300 food boxes were prepared to assist children needing food during the Christmas school break. All of the food for the 300 food boxes was donated.

\$50,815.19 was used to help families with utilities and heating assistance with assistance given to 386 families. \$8,012.39 was used to help with rental assistance assisting 63 families.

United Christian Ministries helped others with lodging, personal items, household items, prescriptions, winter coats, furniture, and diapers.

2012 REPORT FOR NORTH CAROLINA BAPTIST FOUNDATION

The North Carolina Baptist Foundation is the trust agency of the Baptist State Convention with a mission "to serve North Carolina Baptists and others in generating an increased awareness of Christian stewardship principals as a means of financially undergirding Baptist churches, institutions and mission endeavors on a permanent basis." With our focus on that mission everyday, we make it our aim to "Arise...shine...that His glory shall be seen." (Isaiah 60: 1-2)

To that end, in 2012 our staff made 203 presentations in Baptist churches and associations, institutions and agencies, as well as statewide Baptist senior adult conferences. We co-hosted Senior Adult Festivals at Chowan University, Mars Hill College and Baptist Children's Homes, enabling us to further spread the word about the importance of Christian estate planning in supporting ministry in perpetuity. We did the same in sponsoring the 17th annual Noel Inspirational Retreat at Caraway Conference Center using as our theme, "Finishing Well." Once again we co-sponsored two important events with the Baptist State Convention, the 37th annual NC Baptist Development Officer's Conference and the 12th annual NC Baptist Heritage Award Luncheon.

To the end of supporting missions and ministries in perpetuity, we established 78 new accounts in 2012 totaling \$3,028,727.77. In addition, we received \$3,540,804.29 into existing accounts for total receipts of \$6,569,532.06 in 2012. During that same period, we distributed \$2,051,223.49 to individuals through charitable trusts and \$6,610,767.69 to charities, for a total distribution of \$8,661,991.18.

An important element of our ministry is to invest wisely the Kingdom assets entrusted to us. In making those investments, our primary focus is to protect the corpus by managing the risk, while at the same time achieving a good return. In 2012 each of our 4 funds provided positive returns. Our Growth Fund was up 9.27%, our Balanced Fund was up 6.99%, the Income Fund was up 5.91% and the Fixed Income Fund was up 6.42%. We were able to achieve these positive returns while at the same time applying appropriate social screens on our investments.

Our newest ministry, NC Baptist Financial Services, also continues to thrive. In 2012, some 18 loans were closed in the amount of \$9.5 million. Since its beginning in 2009, some 44 loans have been made totaling over \$25 million. The Church Growth Investment Fund, the investment arm of NCBFS and the primary funding source for loans, grew to over \$35 million. NCBFS has made loans to NC Baptist churches for expansion to include new sanctuaries, family life centers, educational buildings, land purchases and major renovation projects.

The North Carolina Baptist Foundation seeks everyday to arise and shine by encouraging and enabling NC Baptists to be good stewards and support Kingdom work so that 'His glory shall be seen.'

He is a national leader in improving health by connecting congregations and health care providers in covenantal partnerships of care. He initiated FaithHealthNC, a ministry to strengthen the Medical Center's dynamic relationships with North Carolina Baptists and others, focused on improving the well-being of church members and neighbors before, during and after hospitalization. Extending the Ministries of North Carolina Baptists

CareNet of North Carolina will provide over 39,000 hours of faith-integrated counseling in 2013. The Cooperative Program provides vital support to our statewide network of 32 counseling centers, ensuring that fees are affordable and that no one is turned away for financial reasons. Nearly 50 percent of our 6,300+ clients are North Carolina Baptists, and we will subsidize over \$500,000 this year in the costs of their counseling. Newer sites include three locations with Baptist Children's Homes (Mills Home, Kennedy Home and Oak Ranch) and two N.C. Baptist Association offices (New River and Raleigh).

The Center for Congregational Health will provide consultation ministries to nearly 150 churches and organizations in 2013, including many in the Baptist State Convention of North Carolina. Churches torn by conflict and heartache are being renewed and revitalized in their mission to serve.

Our Chaplaincy and Pastoral Education department extends the love of God through ministries to our patients and their families and provides life-changing education through programs of Clinical Pastoral Education. In FY 2013, we provided care to patients through more than 56,000 ministry contacts and trained nearly 40 ministers.



Report from the Baptist State Convention of North Carolina

For period July 1, 2012 to June 30, 2013

The Baptist State Convention of North Carolina (Convention) exists to help local churches fulfill their divinely appointed mission from God. The Convention staff, under the leadership of Executive Director-Treasurer Milton A. Hollifield Jr., is committed to helping Baptist churches and associations maximize their ministry outreach for the purpose of building God's Kingdom.

Associational Partnerships

The Convention enjoys partnering in ministry with 78 associations across the state. One way the Associational Partnerships Team works with local Baptist associations is through Ministry Partnership Agreements. Through these agreements the Convention partners with local associations, providing funding, coaching and training resources for church planting, resort ministry, ethnic and language ministry, and community ministry projects.

Another way Associational Partnerships works with local associations is through Church and Community Ministry personnel serving in the associations. This office provides training, resourcing and encouragement to these ministry evangelism servants. Each year, Associational Partnerships and the North Carolina Associational Missions Conference co-host a summer conference that allows for networking, sharing and training, which are vital to effective associational ministry. The conference theme this year was "Commissioned, Called and Committed for Kingdom Ministry." Guest speaker Tom Billings, associational missionary for Union Baptist Association in Houston, Texas, shared about "Great Commission Initiatives" Training.

Associational Partnerships also sponsored the annual Associational/Convention Staff Retreat. This year's emphasis was "Missionary Leadership: Gateway to Missions." The guest speaker was Stan Albright, national director for associations for the North American Mission Board. When a vacancy occurs, Associational Partnerships helps search committees as they seek to fill associational ministry positions. In addition, the office provides training for search committees. This office helps associations and churches understand the demographics of the area in which they are called to serve. Understanding the demographics of an associational area can help leaders be more effective in their planning and outreach. Convention churches can access this information through the Percept organization.

Church Planting

This year the Convention assisted 101 new church plants. Included in this number were Anglo, Hispanic, Asian, African-American, Vietnamese, Chinese, Haitian, India, Korean, Laotian and Nepali churches, among others. In 2012, new church plants reported 3,036 professions of faith in Jesus Christ and made 111,000 evangelistic and cultivative contacts during the year. The work is being done not only by those able to serve full-time, but also by bivocational planters. In 2012, 26 bivocational planters received support through the Baptist State Convention of North Carolina. One of the primary components of the church planting process in North Carolina is Basic Training for Church Planters, a weeklong training event. This year 237 people were trained at this event. Unreached people groups continue to grow in North Carolina, as does Convention efforts to plant more new language churches.

Disciple-making Culture

Congregational Services seeks to lead North Carolina Baptist churches in creating a disciple-making culture in which lives are changed by the power of God. Congregational Services assists churches in Sunday School, church administration, church building and planning, music and worship, children's ministry, preschool ministry and family ministry. Congregational Services continued the focus on "Looking at your church in 3D." BSCNC staff helps churches walk through a process of discovering, developing and delivering in order to create a disciple-making culture. The goal of this effort is to see people growing in their knowledge of God, abiding in Christ and investing in the lives of others. Disciple-making includes making disciples of all nations. Multicultural ministries assists churches by contextualizing the message to those who are in their communities, providing training and resources, and in developing a missionary mindset toward reaching the different cultures and communities of North Carolina.

Embrace

The Embrace ministry year launched with the Embrace Mother/Daughter Retreat and Girls Embrace Ministry Retreat. Both retreats were held the same weekend at Caraway Conference Center and Camp and guest speaker

Erin Davis encouraged both groups. Embrace partnered with LifeWay Christian Resources' Women's Events area to host joint leadership training. Embrace also hosted a leadership training event at Southeastern Baptist Theological Seminary to help equip women in evangelism, discipleship and missions. In addition to group plenary sessions and break out sessions, women learned through hands-on mission opportunities. Embrace led a mission trip to Boston, which was coordinated as part of the Convention's larger partnership in this area through the Office of Great Commission Partnerships.

New Strategy

This year the Convention's Executive Committee and Board of Directors approved a five-year strategy: "Impacting Lostness through Disciple-making." The strategy calls for a commitment to both strengthening churches and planting churches through facilitation of a disciple-making culture that utilizes a relationship-driven model of consultation, beginning in the most concentrated areas of lostness across the state. Although lost people live throughout the entire state, the most concentrated areas of lostness in North Carolina are in eight population centers: Asheville, Charlotte, Fayetteville, Greenville, Hickory, Wilmington, the Triad area (Greensboro, Winston-Salem and High Point) and the Triangle area (Raleigh, Durham and Chapel Hill).

These pockets of lostness increase every year. The population in North Carolina increased 18 percent from 2000 to 2010. During this same period, the population in these eight areas increased 22 percent, comprising nearly 75 percent of the state population. Strategy teams, comprised of local associational and church leaders, will be formed across the state to develop strategies for impacting lostness. These teams will be formed in the population centers and beyond. The Convention will employ strategy coordinators who will live and work in the population centers, assisting local strategy teams fulfill their locally developed strategies. In like fashion, additional Convention staff will assist strategy teams that develop outside the population centers across the state. The Board also affirmed a new structure for the Convention staff to more effectively implement the five-year strategy. One of the new teams being created to fulfill the strategy is the Collegiate Partnerships Team, which will include three regional campus ministry consultants and two international ministry consultants.

Great Commission Partnerships

The Office of Great Commission Partnerships assists North Carolina Baptist churches and associations in developing, implementing and maintaining an effective missions strategy. Through partnerships in New York, Boston and Toronto, North Carolina Baptists are helping share the gospel in some of the most unreached areas of North America. This year 22 North Carolina Baptist churches served with church planters throughout the Greater Toronto Area. Churches are also working with church planters through partnerships in Boston and New York City.

To assist with the Moldova partnership, the Office of Great Commission Partnerships led a five-day missions conference in Moldova that helped train international and domestic missionaries of the Baptist Union of Moldova. One of the major highlights of the year was the Next Generation Missional Journey New York experience for students involved in their second year of the training program. Partnering with the Metropolitan New York Baptist Association, the students shared the gospel with Muslims, Hindus and Buddhists. The students also participated in people group research among Sri Lankans and other South Asian people groups.

Missions Development

The theme for the 2013 North Carolina Missions Offering and Week of Prayer was "Compelled by Christ: Proclaiming Release, Relief & Redemption" (www.ncmissionsoffering.org). This offering is the visible expression of North Carolina Baptists who desire to impact eternity. The offering supports the work of NC Baptist Men, church planting, missions education and promotion, associational projects and mission camps.

The 1% Challenge was introduced to North Carolina Baptists. If all 4,300 North Carolina Baptist churches increased their Cooperative Program giving by one percent, the result would be an additional \$6 million each year for ministry and missions. If all 45,000 Southern Baptist churches across the country accept the 1% Challenge, the result would be an additional \$100 million. In Cooperative Program promotion, a variety of resources were made available and sent to churches. These resources highlight the biblical mandate for missions, and how North Carolina Baptists participate in fulfilling the Great Commission through the Cooperative Program. The "52 Sundays" prayer guide was produced, which features international, North American and North Carolina missionaries supported by North Carolina Baptists and devotionals on prayer, stewardship and missions. An accompanying PowerPoint was also developed. Other resources include brochures, bulletin inserts and videos.

Prayer

The annual statewide prayer conference was held in Winston-Salem at Old Town Baptist Church. The conference featured Logan Carson, Darryl Craft, John Franklin, Hugh Morrison and Bryon Paulus. As follow up to the "Awaken" theme for the 2012 Annual Meeting, 16 associational prayer retreats and rallies were scheduled with associations this year. The purpose of these retreats was to pray for, encourage and foster a desire to pray toward revival and spiritual awakening. Regional prayer conferences, summits and solemn assembly gatherings were also held in partnership with associations and churches across North Carolina.

Scholarships

For the 2013-2014 academic year, almost 700 Baptist Scholarships were awarded totaling more than \$700,000. Students applying for the Baptist Scholarship were required to answer two essay questions: "Give your personal testimony" and "How is the Cooperative Program relevant to today's generation?" Returning applicants answered essay questions about how attending a Baptist school has impacted their testimony, and how their campus ministry has influenced their life.

Sharing the Gospel

The Intentionally Evangelistic Church Strategy (IECS) remains the primary strategy for assisting churches and associations in their efforts to win North Carolina to Christ. IECS seminars were offered in different regions of the state, and this year the Multicultural Evangelism Office also hosted IECS trainings. The 2013 statewide evangelism conference was held at Pleasant Garden Baptist Church. The theme was "Culture Reach: Understanding, Loving and Relating to Muslims." Speakers included Fred Luter, Nik Ripken, Nabeel Qureshi, Mike Licona, Zane Pratt and Alex McFarland.

Youth Ministry

Attendance for the 2013 summer Youth Weeks camps was nearly 7,000 over seven weeks at the North Carolina Baptist Assembly at Fort Caswell. Total decisions included 526 first time professions of faith, more than 4,000 rededications and 408 called to full-time Christian ministry. The theme was "Speak Up, Step Up, Stand Up," which focused on helping students learn to stand up for their faith and to live as a witness for Jesus Christ.

The 2013 Youth Weeks mission offering project consisted of students packaging food to help alleviate hunger in Haiti, and food was purchased with their mission offering. Students gave more than \$60,000, making it possible to send 200,000 meals to Haiti and to support for a year an orphanage in Haiti. Two statewide events were held to reach Hispanic youth and young adults. The youth ministry team offered North Carolina Baptist churches training in missions, discipleship, worship, transitions after graduation and youth ministry planning.

Report for 2013 Book of Reports

Office of the GuideStone Team of the Baptist State Convention of NC, Inc.

During this past year the GuideStone Team of the Baptist State Convention of North Carolina worked closely with GuideStone Financial Resources of the Southern Baptist Convention to provide ministry to the more than 4,300 churches in our state convention. The following summarizes these efforts:

Retirement

- Encouraging churches to provide retirement as a benefit to staff remains a huge challenge! When given a choice, many church staff employees choose not to participate...sad! In the past year more than 2,000 of our 4,300 churches had NO participants in the plan.
- 2012 State Convention Protection Benefits—the following disability and survivor benefits were in place for retirement participants—114 persons received a total of \$606,750.06 in disability benefits and 36 deaths resulted in a distribution of \$404,412.52 to beneficiaries.
 - Three recent deaths of pastors detail both good and bad news. In two of those deaths the participants (79 and 63 years of age) were active participants in the retirement plan. As a result, the widows received death benefits of \$10,000 and \$25,000 respectively. The third minister (45 years of age) was **NOT** an active participant; therefore, the widow did **NOT** receive what would have been a death benefit of \$75,000, and the neighboring churches were encouraged by the Director of Missions to take up love offerings to pay for this pastor's funeral expenses...VERY SAD NEWS!
 - A church secretary, who was forced to leave work on January 4 because of a disability illness, is now in line to qualify for a disability benefit because her church has provided all their staff with retirement contributions as a benefit of employment. Without question this church stepped up to the plate and did the right thing for their employees.
- GuideStone Funds---continue to receive high marks compared to like funds in the financial world. GuideStone Funds rank No. 6 of 226 mutual fund families according to fi360 Fund Family Fiduciary Rankings, as of March 31, 2013.

Insurance

- Health Care Reform Law—GuideStone continues to provide timely updates for churches on their website as the new law moves toward full implementation in 2014.
- According to CEO, O. S. Hawkins, GuideStone is working diligently with other denominations to get administrative and legislative “fixes” to church health plans that were left out of the national debate on health care reform.

Staff Compensation

- Appropriate structure and administration of compensation is another ongoing concern. Unfortunately, the antiquated “lump sum pay package” is alive and thriving in North Carolina.

Mission:Dignity

- GuideStone Financial Resources in Dallas continues to provide financial assistance to those elderly ministers and widows of ministers who live under financial duress and need ongoing and/or one time assistance through Mission:Dignity. During this past year almost 200 North Carolinians were assisted financially by GuideStone.

Finally, as my own retirement approaches, it has been an honor and privilege to serve all of our churches and their employees with appropriate information/products to meet their needs. CHRISTIAN HIGHER EDUCATION SPECIAL COMMITTEE

The Christian Higher Education Special Committee of the Board of Directors serves North Carolina Baptists as a liaison for the Baptist State Convention of North Carolina and its affiliated educational institutions: Campbell University, Gardner-Webb University, Mars Hills University and Wingate University. The Committee promotes the Convention's Baptist Scholarship Program for undergraduates attending one of the affiliated educational institutions and seeks to find ways that these institutions can assist churches in the fulfillment of the congregation's divinely appointed mission.

Many great things are happening on the campuses of the five affiliated educational institutions and our committee gives all the glory and honor to God for how the students, faculty and staff from each of these schools are faithfully serving God.

In May, faculty from Campbell's Lundy-Fetterman School of Business led a Church Administration Conference in partnership with Convention staff. The conference provided critical training for church administrators. In addition, more than 3,000 students have applied to Campbell's new medical school, which opened in August.

Students and staff from Chowan University participated in several mission trips during the past year. Members from Chowan's football team served alongside NC Baptist Men disaster relief volunteers in New Jersey during their 2012 Christmas break. In May, 15 students and staff travelled to Ethiopia to minister to street children. Enrollment for the 2012-2013 academic year is the school's largest undergraduate enrollment since 1971.

Thirty-six Gardner-Webb University students and faculty participated in three university-sponsored mission trips this summer to Brazil, India and Hawaii. The university partnered with NC Baptist Men to send students and faculty to Hawaii. The highly anticipated Physician's Assistant program is scheduled to open in 2014.

Mars Hill College officially became Mars Hill University in August. The university also hosted more than a dozen faith-based groups this summer, which utilized campus facilities for numerous camps and conferences.

In January, more than 70 Wingate University students participated in a day of caring on Martin Luther King Jr. Day. Wingate students volunteer more than 10,000 hours of community service each year. Some projects include Alternate Spring Break, MLK Day of Service and the annual "Don't Dump - Donate!" recycling drive.

The Convention continues to provide scholarships to students attending the affiliated educational institutions as funds are available. The North Carolina Baptist Scholarship is awarded annually to full-time undergraduate students who are members of a church affiliated with the Baptist State Convention and attending one of the five affiliated schools. For the 2013-2014 academic year, almost 700 Baptist Scholarships were awarded totaling nearly \$700,000. To apply, interested students can visit www.ncbaptist.org/scholarships.

For several years the Committee has been working toward establishing a Fruitland Baptist Bible Institute Scholarship. Our Committee is pleased to announce that the first student should be awarded the scholarship during the 2013-2014 academic year. The two-year scholarship is awarded to Fruitland students who, upon graduation from Fruitland, desire to continue their education at one of the educational institutions affiliated with the Convention. A maximum of two students at each participating affiliated institution would be eligible for the scholarship.

Our Committee thanks North Carolina Baptists for continuing to support Christian higher education and making it possible for students to grow in their faith and knowledge of the Lord Jesus Christ.

BY-LAWS OF THE TUCKASEIGEE BAPTIST ASSOCIATION, INC.

ARTICLE 1. NAME

The name of the body shall be the Tuckaseigee Baptist Association, Incorporated.

ARTICLE II. OBJECTIVES

The purpose of the Association is to be a fellowship of churches on mission in our setting. The specific objectives of the Association are as follows:

1. To promote harmony, understanding and spiritual power between the churches.
2. To afford and promote a larger fellowship of Christians in the work of Christ.
3. To provide such programs, projects and organizations as will strengthen the churches and assist them in achieving their goals and objectives.
4. To discover needs which cannot be met effectively by churches individually and to coordinate the use of resources in meeting these needs.
5. To encourage support by every church for the mission causes of the Association, the North Carolina Baptist Convention, and the Southern Baptist Convention.

ARTICLE III. AUTHORITY

SECTION 1. The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient.

SECTION 2. The Association shall have power to recommend measures of usefulness and guidance to our churches in matters of organization, ordinations and questions of doctrines and discipline,

SECTION 3. The Association shall have no power to infringe upon the right of local churches as sovereign and independent bodies.

ARTICLE IV. MEMBERSHIP

SECTION 1. The Association shall be composed of regularly constituted Baptist churches in cooperating fellowship with the Southern Baptist Convention and following the teachings of the New Testament.

SECTION 2. The Association shall be the sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure. Churches applying for membership shall agree to come under the watchcare of the Association for one year. It is understood that during this period of watchcare the church shall be entitled to all rights and privileges of the Association except those of voting.

Applications for membership shall be presented to the Credentials Committee of the Association. The applications will consist of a letter from a constituted church stating their desire to affiliate with the Tuckaseigee Baptist Association. The Credentials Committee as a part of the review process may invite the requesting church to a conference to discuss its history, its mission strategy, and any other information that may be pertinent to the application. The Credentials Committee may then approve the application and recommend them to the Executive Committee. The Executive Committee may by a simple majority vote accept the requesting church to come under the watchcare of the Association for one year. It is suggested that any church under watchcare participate in the missions program of the Association. At the end of the year, the church may be voted in as a member of the Association with full privileges by a two-thirds vote of the messengers present and voting at the annual meeting of the Association, provided that the church submits an acceptable letter and at least one messenger be present at the meeting.

SECTION 3. Any church may withdraw from the Association at its pleasure and should notify the Association of this action in writing. Such action will be recognized by the Association at the next annual meeting.

SECTION 4. It shall be the duty of each church to furnish the Associational Clerk, before each annual session, an annual letter, the forms provided by the Associational Clerk, giving the information requested as is applicable to each church situation.

SECTION 5. The Association may withdraw from any church which has become unscriptural in its doctrine or practices by a two-thirds majority vote of the messengers present and voting at the annual meeting. Such vote is to be taken by written ballot.

ARTICLE V. MEETINGS

SECTION 1. The Association shall hold its annual meeting on Thursday and Friday preceding the third Sunday in October. Special meetings of the Association may be called by the Executive Committee provided two weeks written notice is given to the member churches.

SECTION 2. Each church shall be entitled to be represented at the annual meeting by the pastor and one additional messenger. Churches which give to the association more than .5% of their undesignated receipts shall be entitled to an

additional 2 messengers for every .5% of giving up to a total of 10 messengers for churches which give 2% of their undesignated giving."

SECTION 3. Churches are requested to elect their messengers and alternatives in conference to attend the annual meeting.

SECTION 4. In case of internal dissension in a church and two parties coming to the Association, each claiming to represent the church, neither party shall be seated until the question is decided as to which party is in union with the Association. The decision is to be made by a majority of the messengers present and voting.

ARTICLE VI. OFFICERS

SECTION 1. General officers of the Association shall be: Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Historian, Parliamentarian, and Assistant Parliamentarian. Program leaders shall be Sunday School Director, Church Training Director, Music Director, Chairman of Evangelism Committee, Seminary Extension Director, Chairman of Mission Committee, Director of Missions, Trustees, Pastor Conference President, Youth Director, Stewardship Director, Vacation Bible School Director, Woman's Missionary Union Director, Brotherhood Director, Deacons Chairmen, Senior Adult Director, Singles Ministry Director, and such other officers as the Association may desire to elect.

Associational representatives will be elected for the following institutions and agencies: (1) Truett Camp, (2) Baptist Children's Homes, (3) Baptist Hospital, (4) North Carolina Baptist Homes, Inc. (Homes for the Aging), (5) Biblical Recorder, (6) Christian Education, (7) Annuity Board and other representatives as may be deemed appropriate and elected in the Association.

SECTION 2. With the exception of the Director of Missions and Trustees, the terms of office for all officers of the Association shall be for one year with the privilege of continuing re-election. The Moderator and Vice Moderator shall not be eligible for re-election but one year in succession. (1) The number of Trustees shall be three. (2) The term of service should be for three years, with the term of only one expiring each year. In the first election of Trustees, the term of service for one should be three years, another two years, and the other one year. (3) Upon the expiration of term of service, the Trustee may or may not be re-elected for another term of three years.

Each term of office shall begin with the close of the annual session. The Associational financial year will run from January 1 through December 31.

ARTICLE VII. DUTIES OF OFFICERS

SECTION 1. The **Moderator** shall preside and maintain the order of all meetings of the Association and Executive Committee. He shall serve as ex officio member of all committees of the Association.

He shall appoint the Committee on Committees and all other committees pertinent to the operation of the body not named by the Committee on Committees in its regular report.

SECTION 2. The **Vice Moderator** shall assist the Moderator and preside in the absence of, or at the pleasure of the Moderator.

SECTION 3. The **Clerk** shall keep a complete and accurate record of all transactions; shall prepare a "Book of Reports" to be distributed to messengers at the beginning of each day's session of the annual meeting; and shall cause to be printed minutes concerning the records made.

The Clerk shall distribute to the clerk of each church in the Association blanks for the preparation of the church letter as soon as they are received from the State Convention. This form is to be returned to the Clerk of the Association not later than four weeks prior to the meeting of the body or by the deadline set by the Clerk and Director of Missions. All program reports should be returned by the same date.

An **Assistant Clerk** shall work with the Clerk in preparing the "Book of Reports," the annual minutes and the registration of messengers at the annual meeting.

SECTION 4. The **Treasurer** shall receive and dispense by order of the Executive Committee of the Association while in session, the money of the treasury and make a complete report at the Annual meeting and a current report at each Executive Committee meeting.

An **Assistant Treasurer** shall be elected to assist the Treasurer by request and to serve in the event the Treasurer resigns or is ill or unable to function.

SECTION 5. The **Historian** shall keep the records of the Association up-to-date.

SECTION 6. The **Parliamentarian** shall upon the request of the presiding officer of the body, advise and assist the Association with respect to all matters involving Parliamentary Procedure.

An **Assistant Parliamentarian** shall be elected. The Parliamentarian and Assistant should always communicate with each other to ensure that this office is filled at each Associational Annual or Executive Committee meeting.

SECTION 7. The **Program Leaders** and the **Institutional Agency Representatives** shall perform all duties customary to their titles and shall make a written report to the annual session of the Association.

SECTION 8. **Trustees** have no authority except by direction of the Association and are not personally bound by signatures but are to be the legal signees for the Association. Trustees represent the Association in legal matters. Trustees

act on behalf of the Association in acquisition and disposal of Associational property.

They sign all deeds of conveyance, execute all notes, bonds or mortgages, intervene in all suits, by authority of the Association.

All persons dealing with the Trustees, as Associational officers, may rely upon any written resolution duly adopted by the Association or Executive Committee, directing and authorizing the Trustees to act in its behalf and certified by the Association Moderator and Clerk.

ARTICLE VIII. RULES OF ORDER

The business of the Association shall be conducted according to Robert's Parliamentary Practice or in a manner not contrary thereto.

ARTICLE IX. QUORUM

The quorum for the Annual Associational meeting or any special called meeting of the Association shall not be less than 25 percent of the member churches.

ARTICLE X. THE EXECUTIVE COMMITTEE

SECTION 1. The Executive Committee shall be composed of the General Officers and Program Leaders elected by the Association and the Pastor and one member from each church in the Association. No Pastor, by virtue of his being an Associational Officer or Program Leader shall be disqualified as a member of the Executive Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

SECTION 2. It shall be the duty of the Executive Committee to act for the Association on matters arising when the Association is not in session and to make a report of all work to the next session of the Association. This body shall meet at a time and place designated by the Moderator on Monday following the first Sunday of each quarter except for the July quarter which shall meet on the second Monday of the month of July. Special meetings of the Executive Committee may be called by the Moderator with a one week notice to the churches.

SECTION 3. All vacancies occurring on committees or among elected officers shall be filled by the Executive Committee.

SECTION 4. In the event that a vacancy occurs with the Trustees, the Executive Committee should fill such vacancy for the remainder of the term.

ARTICLE XI. ASSOCIATIONAL STANDING COMMITTEES

SECTION 1. The Association shall have such standing committees as may be deemed necessary to promote efficiently the work of the Master in our midst. The terms of office for all committee members shall be for one year except where specifically stated otherwise.

SECTION 2. COMMITTEE ON COMMITTEES. It shall be the duty of this committee to nominate at the general meeting all standing committees as set forth under Article XI.

SECTION 3. THE NOMINATING COMMITTEE shall be composed of seven members. To this group the Directors of Sunday School, Discipleship Training, Woman's Missionary Union, Brotherhood and Music Ministry will be added.

It shall be the duty of this committee to nominate the Officers, Program Leaders and Institutional Agency Representatives. These nominees shall be notified in writing not less than one month prior to presenting of their names at annual session.

SECTION 4. THE ORDER OF BUSINESS COMMITTEE, composed of three members, shall plan the annual program of the Association and present it to the Executive Committee at its October meeting.

SECTION 5. THE CREDENTIALS COMMITTEE shall be composed of three pastors and two laymen. It shall examine applications of churches seeking admission into the Association in keeping with Article IV and make recommendation to the Association. It shall counsel with churches that are out of harmony of fellowship with the Association. It shall be responsible for registering messengers at the Annual Meetings."

SECTION 6. THE PLACE AND PREACHER COMMITTEE shall be composed of three members. The duties of this committee shall be to recommend the place or places for the following annual meeting and to recommend the preacher and alternate to deliver the annual sermon for the following year.

SECTION 7. THE RESOLUTIONS COMMITTEE shall be composed of three members. It is appointed by the Moderator at the October Executive Committee meeting. It shall be the duty of this committee to present suitable resolutions at the annual Associational meeting.

SECTION 8. THE MEMORIAL COMMITTEE shall be composed of three members. It shall be the duty of this committee to bring a report to the annual meeting of those listed by the member churches as deceased since the last annual meeting and shall lead a memorial service in their memory.

SECTION 9. THE STEWARDSHIP COMMITTEE shall be composed of six members including the Treasurer of the Association. This committee shall: (a) present a Budget to the Association for the following year; (b) devise plans for raising the funds for the Associational Budget; (c) audit the finances and financial records of the Association annually and anytime

there is a change of Treasurer or at the direction of the Association or the Executive Committee; (d) report all audits to the Annual Association Meeting.

SECTION 10. THE CONSTITUTION COMMITTEE shall be composed of three members and shall perform all duties specified in Article XV.

SECTION 11. THE ORDINATION COMMITTEE shall be composed of five designated Pastors and all other Pastors who desire to sit with the committee.

A. The committee serves on an advisory capacity only and serves at the request of the church from which the member is seeking ordination.

B. The committee should examine such candidates for the ministry as come before it as to their call and fitness for the gospel ministry and make such recommendations to the church as they feel led.

C. The committee should assist in arranging the proper service of ordination when such assistance is requested.

D. The Executive Committee should be informed regularly of the work of the committee.

E. Each church desiring to ordain a candidate is urged to consult with the committee, and shall give two weeks notice in which the committee is to do its work.

SECTION 12. THE EVANGELISM COMMITTEE. The duties of the committee shall be to direct and propose a perpetual program and spirit of evangelism in the Association. It shall arrange and direct all Associational-wide evangelistic activities.

SECTION 13. THE ASSOCIATIONAL MISSIONS DEVELOPMENT COUNCIL shall be composed of eight (8) members, nominated by the Associational Committee on Committees and elected by the Association at the annual meeting. The committee shall be: Missions Development Director, Promotion Director, Survey Director, Associational WMU Mission Action Director, Associational Brotherhood Director, Sunday School Outreach Director, Church Training Director, and Associational Deacons President. The Missions Development Director, Promotion Director, and Survey Director shall be elected for a three-year term, with one member named each year. The other five positions shall be filled by the person who is elected to fill those five Associational offices.

The duties of the AMDC are to lead the associational missions development in the five mission performance tasks: (1) call churches to be on missions; (2) train, develop, and encourage church and Associational workers; (3) provide resources and services to churches and leaders; (4) provide opportunities for working together in missions, ministry and growth; (5) establish and maintain appropriate communications and relationships with the community and the denomination.

SECTION 14. THE BUILDING AND GROUNDS COMMITTEE shall be comprised of three members. The committee shall be responsible for and in charge of the upkeep and repairs of the Associational building, grounds, and equipment.

SECTION 15. THE PERSONNEL COMMITTEE

A. The Committee shall be composed of 7 members of which 3 are pastors.

B. They shall recommend policies and procedures for the selection, supervision and termination of Associational staff personnel. Those policies and procedures shall be approved by the Association.

C. Prepare and maintain an organizational manual relation to the Association's staff personnel.

D. Develop and recommend to the association policies and procedures for paid and volunteer staff personnel.

E. Develop policies and procedures regarding continuing education and development for the Director of Missions and other Associational staff.

F. When a staff vacancy occurs, other than the DOM, they shall serve as the search committee. When a DOM vacancy occurs, they shall nominate a search committee and present it to the Executive Committee.

G. The Personnel Committee shall handle grievances as outlined in the grievance policy.

ARTICLE XII. THE ASSOCIATIONAL COUNCIL

The ASSOCIATIONAL COUNCIL shall be composed of the Director of Missions, the Moderator, the Vice Moderator, the Program Leaders: Sunday School, Discipleship Director, Woman's Missionary Union, Brotherhood Director, Chairman of Deacons, Missions Development Director, Chairman of Evangelism, Chairman of the Finance Committee, Vacation Bible School Director, Youth Director, Director of the Singles, Director of the Senior Adults, and Music Director. The Director of Missions is to serve as Chairman and a secretary shall be elected from the group.

The purpose of the council is to coordinate the planning of the various programs of the Association, to develop an Associational calendar, and to give mutual support to the various organization and program units in carrying out their assignments.

The council shall meet quarterly.

ARTICLE XIII. THE ASSOCIATIONAL PASTORS' CONFERENCE

The Associational Pastors' Conference provides regular meetings for the Baptist ministers of the Association. The purpose of the conference is for fellowship and mutual support, for doctrinal and professional discussion and for promotion of church, Associational and other denominational programs. The conference is not an administrative or executive body.

ARTICLE XIV. JOB DESCRIPTION, DIRECTOR OF MISSIONS

SECTION 1. Title and Functions.

A. Position Title. This position shall be known as the Director of Missions for the Tuckaseegee Baptist Association.

B. Basic Functions. The Director of Missions shall serve as minister to the churches and church leaders of the Tuckaseegee Baptist Association, as mission strategist for the Association, as chief administrative officer for the Association, and as a general leader of the Association.

SECTION 2. Responsibilities.

A. Minister to Churches and Church Leaders.

1. The Director of Missions shall serve as pastor to the pastors of the Association. Upon request, the Director of Missions shall provide counseling and consultation for pastors regarding spiritual, vocational, congregational, personal or family concerns. The Director of Missions shall be available to assist pastors considering a move, shall orient new pastors to the Association, shall develop systems of pastoral support and fellowship, and shall provide growth opportunities for pastors.

2. Upon request, the Director of Missions shall assist and counsel pastors and church leaders regarding ministries, programs and procedures within the churches, including but not limited to building planning, budget procedures, long range or strategy planning, curriculum evaluation or review, issues of church policy and organization, church-community surveys, outreach, and spiritual growth.

3. Upon request, the Director of Missions shall assist and counsel churches regarding the calling of pastors or church staff, conflicts between a pastor and church, or conflicts within a church's fellowship. The Director of Missions shall assist churches without a pastor in their ministries and programs at their request and shall provide advice for persons considering a Christian vocation.

4. The Director of Missions shall be available upon request to preach or teach in and for churches on such occasions as revivals, pulpit supply, study courses, stewardship or missions emphasis, promotion or recognition assemblies and services, special day addresses, Vacation Bible School, and similar events.

5. The Director of Missions shall take the initiative to regularly visit churches for worship and fellowship, taking care to treat all churches as equal partners in the Association.

6. The Director of Missions shall develop opportunities to foster fellowship and mutual commitment between and among the churches.

B. Mission Strategist.

1. The Director of Missions shall encourage churches to develop and maintain a missions perspective and to extend their ministries and outreach beyond the local church field and community through broader involvement and cooperation with other churches in missions activities.

2. The Director of Missions shall interpret to the churches the needs of persons and groups within the Association's area and shall lead the Association to start new churches or ministry activities appropriate to the needs.

3. The Director of Missions shall encourage and lead volunteer involvement in mission activities beyond the Association's boundaries, such as home and foreign missions partnerships and disaster relief.

4. The Director of Missions shall interpret to the Association the mission work of the churches and conventions of the denomination at the state and national levels and shall encourage churches to support such work with their prayers, finances and personal commitment.

C. Chief Administrative Officer.

1. The Director of Missions shall administer all policies and instructions committed to that office by the Association in annual session or by the Executive Committee.

2. The Director of Missions shall work with the Executive Committee to plan, organize, coordinate, communicate and evaluate the total work of the Association.

3. The Director of Missions shall work with and assist Associational officers, committees and program leaders to implement the specific objectives of the Association and to communicate these activities to the churches and encourage their involvement.

4. The Director of Missions shall serve as an ex officio member of all committees and program departments of the Association.

5. The Director of Missions shall publish a regular Associational news medium to promote the work and fellowship of the Association among the churches and shall otherwise communicate with the churches as required.

6. The Director of Missions shall supervise the Associational office staff and any volunteers or other paid employees, full or part time, who are directly involved in ministries or activities sponsored by the Association.

7. The Director of Missions shall act as office and property manager and purchasing agent for the Association in all matters not assigned to the Trustees of the Association.

D. General Leader of the Association.

1. The Director of Missions shall interpret the work of the Association in the churches.

2. The Director of Missions shall maintain relationships with pertinent Baptist conventions and bodies, and especially with those denominational offices charged with Associational development and support, informing those bodies of the needs and potentialities in the Association and interpreting the overall work of the denomination to the churches.

3. The Director of Missions shall relate to other Christian and service organizations, such as local relief and assistance groups, hospital chaplaincy programs, groups that minister to the homebound or terminally ill, ministerial conferences or support groups, and similar organizations, as appropriate.

4. The Director of Missions shall relate to and represent the work of the Association to various business, social, educational, governmental and civic groups.

5. The Director of Missions shall act as chief public relations and information officer for the Association, promoting its work to the general public through the various communications media and responding to inquiries and requests for information as required.

SECTION 3. Terms of Employment.

A. Employment. The Director of Missions is employed by the Tuckaseegee Baptist Association.

B. Call, Termination and Interim.

1. A person shall be called to the office of Director of Missions according to the following procedures:

a. When a vacancy occurs in the office of Director of Missions, the Personnel Committee shall nominate a search committee to be elected by the Executive Committee. Election of the search committee shall take place within 30 days of the occurrence of the vacancy. If a regular meeting of the Executive Committee is not scheduled within 30 days, a special meeting shall be called by the Moderator. Executive Committee members shall be given two weeks' written notice of the names of the nominees to serve on the search committee and the date, time and place of the meeting.

b. Once elected, the search committee shall solicit and screen candidates according to qualifications and procedures which the committee shall determine. The search committee shall recommend and present one candidate for election by the Association.

c. Election of the candidate by the Association shall take place within 30 days of the search committee's decision to recommend. If the annual session of the Association is not scheduled within 30 days, a special session of the Association shall be called by the Moderator. The Association shall be given two weeks' written notice of the name of the candidate and the date, time, and place of the meeting.

d. Election of the candidate shall be by majority vote. If the candidate fails to receive a majority vote, the search committee shall be immediately dissolved and the Personnel Committee shall begin the process over again.

2. The term of service of the Director of Missions shall be indefinite. Employment of the Director of Missions may be terminated according to the following procedures:

a. The Director of Missions may resign by giving written notice 60 days in advance. The resignation may be accepted on behalf of the Association by the Executive Committee in regular or called session. By mutual agreement of the Director of Missions and the Executive Committee, the period of 60 days' notice may be waived.

b. The Director of Missions may be involuntarily terminated by the Association in annual or called session.

(1) No final action to terminate the Director of Missions shall occur unless both the Director of Missions and the Association have endeavored to resolve any existing conflict by lesser means. In addition, no final action to terminate the Director of Missions shall occur without prior investigation by the Personnel Committee according to established grievance procedures. The Personnel Committee shall then make a report of its findings to the Association. The Association shall consider, but shall not be bound by or required to follow, the recommendations of the Personnel Committee. If such an investigation and report has not occurred, any action to terminate the Director of Missions shall be referred to the Personnel Committee for investigation before final action is taken.

(2) Action by the Association to terminate the Director of Missions, whether in annual or called session, shall require 30 days' written notice to the Association following completion of the Personnel Committee's investigation. Action to terminate shall be by majority vote.

(3) If the Association in session votes to terminate, the Director of Missions shall receive full pay and benefits for a period of 60 days following the effective date of the termination.

3. When a vacancy occurs in the office of Director of Missions, the Executive Committee may elect an Interim Director of Missions according to the following procedure:

a. The Personnel Committee shall recommend a candidate, negotiate terms of employment, and present the recommendations to the Executive Committee for approval. Such election may take place at the same time and in the same manner as election of the search committee, or at any other appropriate time.

b. The Personnel Committee shall supervise the work of the Interim Director of Missions. Authority to extend, terminate, or otherwise change the terms of employment of the Interim Director of Missions shall be retained by the

Executive Committee.

C. Accountability.

1. The Director of Missions shall be supervised by the Personnel Committee acting on behalf of the Association.
2. The Personnel Committee shall arrange for an annual evaluation of the Director of Missions.
3. The Personnel Committee shall establish a grievance policy to provide an orderly and appropriate process to hear grievances and complaints against the Director of Missions by members or churches of the Association.

D. Pay and Benefits.

1. Salary, retirement, insurance and other financial benefits for the Director of Missions shall be proposed by the Budget and Finance Committee and established by the Association in the annual budget. The Budget and Finance Committee shall solicit recommendations concerning pay and benefits for the Director of Missions from the Personnel Committee, but shall not be bound to accept those recommendations.

2. Travel allowance for the Director of Missions shall be deemed by the Association to be a business expense and not a personal benefit for the Director of Missions.

3. The Director of Missions shall receive two weeks paid vacation annually. The period of two weeks shall incorporate ten working days, including two Sundays. Unused vacation shall not accrue to the following year.

4. The Director of Missions shall receive sick leave at the rate of one day per month, accruing on the first day of the month, not to exceed 120 working days. Additional sick leave may be credited against future months. If the Director of Missions is involuntarily terminated by the Association, any unused sick leave accrued shall be financially reimbursed to the Director of Missions in addition to the 60 days' pay and benefits required by the act of termination.

5. The Director of Missions shall be granted one day off each week in addition to Saturday.

6. The following holidays shall be observed: New Year's Day, Easter Monday, Memorial Day, July 4, Labor Day, Thanksgiving Thursday and Friday, and December 25 and 26 at Christmas.

7. The Association acknowledges the flexibility of schedule required by the Director of Missions. The Director of Missions' time shall be organized in a professional manner, with the work schedule devoted to activities that will benefit the work of the Association, whether in the office or on the field and whether during the normal work day or at night. The Director of Missions shall establish office hours for the office secretary and shall be available, either through personal office hours or some other established procedure, to any in the Association needing assistance.

8. The Director of Missions may attend denominational conventions and meetings, continuing education and professional development events, and other assemblies and conferences pertaining to the work of the office. The Association through its annual budget may reimburse the Director of Missions for expenses incurred while attending such meetings.

9. The Director of Missions may use up to three weeks of paid leave annually to lead or participate in revivals, world missions conferences, and similar meetings outside the Association, which result in an honorarium or other reimbursement above and beyond expenses. The Director of Missions may lead revivals and conferences within the Association as schedule permits, such activities being included in the job responsibility of minister to the churches of the Association.

10. The Director of Missions may serve as interim pastor of a church or churches in the Association. Such activity may not exceed three months in a given calendar year without prior approval of the Personnel Committee. The Director of Missions may engage in pulpit supply and similar activities as schedule permits, such activities being included in the job responsibility of minister to the churches of the Association.

11. The Director of Missions may lead or participate in mission trips, mission partnerships, disaster relief, and other direct mission opportunities outside the Association, such activities being included in the job responsibility of mission strategist for the Association. Such activities may not exceed three weeks in a given calendar year without prior approval of the Personnel Committee.

12. The Director of Missions shall keep a record of leave and time spent off the Associational field, including vacation, sick leave, conventions and conferences, continuing education events, revivals and similar meetings, and mission trips. The record shall be submitted to and maintained by the Treasurer of the Association.

13. The Director of Missions shall be free to use off duty time to engage in personal activities and pursuits. Such activities shall not interfere with the professional responsibilities or activities and meetings that require the presence of the Director of Missions. The Director of Missions shall be aware that all personal activities reflect on the office and the job responsibility of general leader of the Association.

14. No honorarium shall be expected or required for any service performed by the Director of Missions in conjunction with official duties. However, any individual, group or church is free to present an honorarium if they so desire, and such may be retained by the Director of Missions and not submitted to the Association.

SECTION 4. Adoption.

A. This job description supersedes, repeals and takes the place of any conflicting articles or statements in this Constitution or other documents of the Association.

B. The Personnel Committee shall be responsible to maintain, update and revise this job description as required,

making recommendations to the Association for approval as they are needed.

ARTICLE XV. AMENDMENTS

The constitution may be amended at any annual meeting of the Association by a two-thirds majority of the messengers present and voting, provided the amendment has been presented to the Constitutional Committee at least 10 days prior to the annual meeting and presented to the Association in printed form on the first day of the annual meeting to be voted on the second day.

ARTICLE XVI. NON-PROFIT STATUS

The Tuckaseegee Baptist Association, Inc. is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the Tuckaseegee Baptist Association, Inc. shall inure to the benefit of its' members, directs, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

In the event of dissolution, the residual assets of the Tuckaseegee Baptist Association, Inc. will be turned over to one or more organizations with similar purposes which are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986.
