#### THE PRESENCE OF SOUTHERN BAPTISTS in the Evangelical Theological Society AND THEIR INFLUENCE: An Interview with Dr. Köstenberger and Dean Bush



For those students who have never participated at an ETS meeting, but plan to attend this year's meeting in San

Antonio, Texas, Nov. 17–19, will you explain in a few words what one should expect from such a meeting in terms of scholarship and interaction?

*Dr. Köstenberger*: Professional meetings such as this one provide a premier opportunity for students to learn about the academic calling. They can go and listen to the plenary addresses and paper presentations. They can browse the book tables and buy books at 50% off. They can also meet some of the scholars who write the books and, if close to graduation, interview with prospective employers. Overall, while attending such a meeting for the first time may be daunting, attendance is a must for those who are seriously pursuing an academic calling.

Dean Bush: Dr. Köstenberger is right. ETS is a professional society that exists to foster academic research, but it is friendly toward students and younger scholars.

What are some of the benefits that SEBTS students could gain from participating at an ETS meeting? I am here referring to both the opportunity of familiarizing oneself with the current theological discussions in evangelicalism and major theological figures as well as to the benefits in terms of professional opportunities that open up for the participants, especially for those who will be looking for a teaching position in the near future. Do ETS meetings provide such benefits and in what way?

Dean Bush: Through ETS I have had the opportunity to meet the best evangelical thinkers in the world. I use ETS to build relationships, keep up with the latest theological debates, look at the latest theological publications, and participate in the work of the society to foster professional growth. It is the single most important meeting I attend each year. Ph.D. students especially would benefit from participating in the conference.

To shift the discussion towards the upcoming ETS meeting, the theme is "What is Truth?" Is there a specific reason for choosing such a topic? And what connection is there, if any, between this theme and the recent discussion concerning the orthodoxy of "Open Theism."

Dr. Köstenberger: "What is Truth?" is a topic that was chosen by the ETS executive committee several years ago. It is deliberately worded in a broad and general sense in order to engage not only the biblical disciplines but also systematic theology, hermeneutics, philosophy, ethics, and other theological disciplines. There is no intentional connection with open theism, though there is an obvious tie-in that some of the presenters at this year's meeting may intend to explore.

Dean Bush: That's right. Themes for the meetings are set several years ahead. We try to have a theme that can be approached by biblical scholars as well as theologians, historians, philosophers, and so forth. Not every paper will address the theme, but many will, and the extensive scholarly attention to truth is something you won't find at any of the non-confessional society meetings (such as AAR). There is no explicit link between this year's theme and the open theism debate. Last year's theme on "the boundaries of Evangelicalism" was probably aimed at the open theism issue. But we have used many different themes over the years. The theme usually governs the topic of the plenary sessions but not each individual paper.

Last year's ETS meeting in Atlanta focused on this theological current called "Open Theism" and on Clark Pinnock and John Sanders who are members of ETS. The decision of the Society was not to revoke their membership. However, the ETS Executive Committee, in response to a motion made by Dean Bush, is seeking to clarify the doctrinal reference to biblical inerrancy in the doctrinal statement of the Society. What are some of the main points that are being considered and how will that affect the debate over "Open Theism"?

Dr. Köstenberger: In response to Dean Bush's motion, the ETS executive committee has recently adopted a unanimous resolution that will be presented to the membership at the November meeting with a view toward proposing it, or a similar statement, as a bylaw at a subsequent meeting. The resolution reads as follows: For the purpose of advising members regarding the intent and meaning of the reference to biblical inerrancy in the ETS Doctrinal Basis, the Society refers members to the Chicago Statement on Biblical Inerrancy (1978). The case for biblical inerrancy rests on the absolute trustworthiness of God and Scripture's testimony to itself. A proper understanding of inerrancy takes into account the language, genres, and intent of Scripture. We reject approaches to Scripture that deny that biblical truth claims are grounded in reality. The intent of this statement is not to revisit the "open theism" issue but to flesh out the meaning of inerrancy in the ETS Doctrinal Basis in light of concerns raised when dealing with open theism that the meaning of this clause is not adequately specific and concrete.

Dean Bush: I have been concerned that the "open theism" debate (and the failure to remove John Sanders in particular from membership) would cause some to lose confidence in the society's commitment to inerrancy. I am very pleased with the resolution that will be brought to the ETS this year, and I hope it is overwhelmingly adopted.

Can you comment on the position of Norman Geisler in ETS, knowing that he was a strong advocate of the idea that "Open Theism" poses a threat to the doctrine of the inerrancy of Scripture in the last year's meeting? Where do Southern Baptists stand in relation to his view? *Dr. Köstenberger:* I think the resolution speaks for itself and, if adopted as a bylaw by the membership in due course, sends a strong signal that the ETS has not weakened in its commitment to inerrancy but continues to uphold it as a meaningful standard for membership in the Society.

Dean Bush: Norman Geisler is a good friend and colleague. I appreciate his work greatly. It will be a great loss for ETS if his resignation remains permanent. My hope is that the resolution/ bylaw mentioned above will be sufficient to dissuade others from leaving the ETS. I was opposed to open theism on the ground that I think it is in principle contrary to the ETS doctrinal basis. But we were a few votes short of the necessary 2/3 majority needed to remove Sanders from membership. Pinnock actually claimed that he was willing to revise some of his views. Geisler did not accept that and protested the vote by his resignation. There were also other issues (some procedural and some personal). I understand his point, and I support Geisler's right to express himself as he wishes. I still have confidence in the ETS, however. Southern Baptists will follow their own consciences, but I believe that most of us have deep concerns about the loss of Divine foreknowledge in "open theism." I have other concerns as well.

Where do you stand in this debate and how do you actively participate in defining the future direction of ETS? Do you think that inerrancy and "Open Theism" are mutually exclusive theological positions, and if so, can your position within ETS influence the outcome of the debate?

Dr. Köstenberger: I plan to continue as editor of the Journal and as member of the ETS executive committee. The Journal has had a positive role in defining the issues and facilitating debate, and this will continue. The committee will continue to meet its constitutional obligations as well. Personally, I have grave reservations about the viability of open theism and will continue to find appropriate ways to express those concerns.

Dean Bush: I have written on open theism in the recent Faith and Mission and in my book The Advancement. I hope ETS will see a decline in interest in open theism. I don't mind theological debate, and several of my own views are controversial in ETS, but to the best of my ability I always try to affirm the full truthfulness of biblical affirmations. I don't know how much influence I have, but I will continue to seek ways to strengthen ETS and to reaffirm its doctrinal basis.

Obviously you are both Southern Baptists with a high view of Scripture and you adhere to the inerrancy of Scripture as defined and consolidated during the conservative resurgence of the 1980s. At that time the conservatives won the battle over the Bible and its inerrancy. What role could the conservative Southern Baptists have, if any, in the future of ETS, given its current discussion?

*Dr. Köstenberger*: Conservative Baptists, as full and voting members of the Society, have had, and continue to have, a strong voice in the deliberations and

> future direction of the Society. This is an indication of the larger influence of Southern Baptists beyond their own denomination on evangelicalism at large. Clearly, biblical inerrancy is an issue that transcends any one denomination or even scholarly society. As the history of interpretation shows, the interpretive outcome is very different depending on the view of Scripture a given interpreter holds. Personally, I can certainly attest to the fact that holding to biblical inerrancy is not an undue constraint that makes true scholarship impossible but a necessary affirmation, given Scripture's teaching about its own nature and the nature of God himself, and one that in no way inhibits scholarly exploration and discovery.

Dean Bush: Dr. Köstenberger stated my view exactly. If the SBC controversy teaches us anything it is that inerrancy is a vital principle for the true church. ETS is denominationally pluralistic, but we find fellowship in our common commitment to the Word of God. The SBC experience has not gone unnoticed in ETS, and I pray that we will be a positive influence on ETS.

Among those who will give plenary addresses at the ETS meeting in November are two conservative Southern Baptists: Dr. Al Mohler, president of SBTS and Dr. Andreas Köstenberger, director of PhD studies at SEBTS. How important will these addresses be to the presence and influence of Southern Baptists in ETS?

Dr. Köstenberger: I'll leave it to others to comment.

Dean Bush: Well, I think it is obvious that these two addresses will be very important. Mohler is a nationally known spokesman for evangelical Christianity, and our own Dr. Köstenberger is rapidly

gaining recognition as a preeminent New Testament scholar. I am glad to know both of them. Together these two will take a strong stand for truth and thereby will reveal why Southern Baptists are growing in influence in ETS and in the wider Christian community.

And one last question directed to
Dr. Köstenberger: could you give us
an abstract of your plenary address
in November at ETS? Hopefully this
will motivate more SEBTS PhD students to participate in this year's
ETS meeting, if for no other reason than to support you.

Dr. Köstenberger: I can certainly use all the help and support there is! Addressing the whole society on a topic as important as truth in the Bible is a great challenge and opportunity. In my plenary address, I plan to discuss the ramifications of Pilate's question to Jesus, "What is truth?" from a historical, literary, and theological vantage point. I will first try to establish the historicity of the account; then look at the passage in light of the various larger themes which tie it in with the rest of the Gospel; and finally look at the major characters in the passage one at a time. Hopefully, my address will set the stage for the other plenary speakers who will explore the contemporary cultural, hermeneutical, and philosophical challenges related to truth in our day.

Dean Bush: This is going to be a great year to attend ETS.

The Ph.D. community at Southeastern expresses its sincere appreciation to Dr. Köstenberger and Dean Bush for responding to our questions. We look forward to Dr. Köstenberger's plenary address at ETS this year as well as both his and Dean Bush's future influence in the scholarly circle. We are blessed to have such prolific scholars on the faculty of Southeastern and we are sure that the influence of Southern Baptists in ETS will grow as a result of their contributions.
