Dr. Albert L. Meiburg has been unanimously elected as Dean of the Faculty at Southeastern. This action climaxes a process in <u>DEAN</u> which faculty, administration, trustees, students, and alumni at various points have participated. The process began with a revised job description for the Dean and a set of qualifications for the individual holding

the office. In time, unanimous concurrence by the faculty, the president, and the trustees accompanied the recommendation of Dr. Meiburg as the fourth Dean at the Seminary.

Dr. Meiburg comes highly qualified, with twenty years' experience in theological education. His particular strength has been in the development of models for clinical pastoral education. He is currently on the faculty at Colgate-Rochester/Bexley Hall/Crozer.

The Meiburgs will move to Wake Forest in time for him to begin work on August 1, 1975.
