MINUTES.

FRIDAY, SEPTEMBER 15th, 1899.

1st. The Introductory sermon was delivered by Elder S. J. English of the Flint River Corresponding Association.

2nd. After one hour's intermission, the messengers assembled in the house. Prayer by Elder English.

3rd. Called for and read letters from the Churches, and enrolled the names of messengers.

4th. Re-elected Elder J. W. Herin Moderator, and M. F. Etheridge Clerk.

E. Green, E. L. McGee and M. J. Ray; To Write Corresponding Letter—J. M. Middlebrooks, M. F. Etheridge and L. A. Stubbs.

6th. Called for correspondence from the Flint River Corresponding Association, and received Elder S. J. English, F. E. Glover and H. Dixon, with minutes.

7th. On motion, adjourned to 9:30 A. M. to-morrow.

SATURDAY, 9:30 A. M., SEPT. 16th.

Met pursuant to adjournment. Prayer by Elder J. W. Herin.

1st. Called the roll.

2nd. Committee on business reported the same order as last year.

3 rd. Returned correspondence to the Flint River Corresponding Association, to convene with Englishville Church, Macon county, commencing on Friday before the 5th Sunday in July, 1900. A. R. Johnson, J. P. Stanaker, W. G. Middlebrooks, W. E. Green, E. L. McGee, A. L. Mathews, J. M. Middlebrooks, James Colquitt, Wm. Thames, E. T. Trice, J. W. Herin, M. J. Ray, J. F. Renfroe and S. B. Busbay.

4th. Appointed Union Meeting with Pilgrim's Rest Church, Houston, embracing the 5th Sunday in April, 1900.

5th. Next session of this body will be held with Union Church, Crawford county, at usual time, 8 miles north of Fort Valley, 8 miles west of Byron, Ga.

6th. Called for, read and adopted Corresponding Letter.

7th. Called for contributions, and received \$9.50 for minutes.

8th. Agreed to have 500 minutes printed.

9th. Adjourned to time and place above mentioned.
