#### FACULTY OPPOSES BUSH

Following a visit by L. Russ Bush, III on January 27, the faculty of Southeastern Seminary has released official statement opposing an President Drummond's nomination of him as Vice President of Academic Affairs and Dean of the Faculty. The exact content of the document has not yet been released to the public, but a member of the Faculty Dean Search Committee stated that an open letter submitted to Dr. Bush by the SEBTS Chapter of the SBA was formally incorporated into the report. The letter requested that Dr. Bush remove his name from consideration for the vacant administrative post. Bush is clearly aligned with the political fundamentalist takeover group.

Rumors continue to abound that he has been the trustee's choice for Dean from the start. One faculty member was reportedly approached at conference in professional a November, 1988, by a colleague from another school with a disturbing message. The colleague claimed that he had heard from an acquaintance of L. Russ Bush that the Southwestern would be professor Seminary Southeastern's next Dean. This information came as an unexpected shock to the SEBTS faculty member, since Bush's name had not been among those on the first list of proposed candidates issued by President Lewis Drummond to the Faculty Dean Search Committee.

It is commonly conjectured on campus that Dr. Bush may become the next President of Southeastern when Dr. Drummond resigns the position. Drummond is 62 years old and thus nearing retirement age. Many surmise this is the source of that Southeastern's true allure for Bush. Whatever the case, Dr. Bush continues to assert that he is God's man for the task at hand. There is little doubt that Bush will be Southeastern's new Vice President of Academic Affairs and Dean of the Faculty.

### KIETH PARKS TARGETED

The Fundamentalist Southern Baptist Advocate has targeted R. Kieth Parks, President of the SBC Foreign Mission Board for his vocal support of the Southern Baptist The paper calls for his Alliance. dismissal on the basis that he is simply "very supportive of the work SBA, which is not of the a Cooperative Program cause." #### AAUP INVESTIGATES SOUTHEASTERN

A special task force of the respected American Association of University Professors visited the campus of Southeastern Seminary on January 18, 1989, to investigate allegations that the trustees and administration of the institution have disregarded the common etiquette and long-standing procedures of the traditional academic community. The committee arrived on campus for a pre-arranged two day visit during which it had intended to meet with leaders, the student faculty. administration, trustees, and former administrative officers of Southeastern. The delegation met with various faculty and student leaders as well as past-President Randall Lolley, but trustees and current administrative officers refused participate in to the proceedings.

The task force left Southeastern particularly concerned about the negation of academic freedom and the impoverishment of academic community at Southeastern. One member of the committee, professor of Mercer University if Georgia asserted, "I thought I had seen a fundamentalist 'takeover' at Mercer, but it was a cake-walk compared to this. I have never seen such cruel disregard for an academic community as I have seen (at Southeastern)."

Should the AAUP find violations of its standards in its forthcoming official report, "censure" of Southeastern is quite likely. A censure is a reprimand issued by the AAUP to an academic institution it considers to have flagrantly violated its standards. Academicians are encouraged to avoid institutions that are under censure when considering teaching positions, and students who graduate from a censured institution are often at a disadvantage when attempting to gain admission to other educational establishments.
