ANNUAL MEETING: WOMEN IN MINISTRY, SBC - JUNE 9-10, 1984, KANSAS CITY, MISSOURI Sandra Richardson, Homemaker, Raleigh, NC

"Exercising Our Gifts" was the theme of the annual meeting of Women in Ministry, SBC held June 9-10, 1984, in Kansas City, Missouri, preceding the meeting of the SBC. Not only was the theme preached about and reflected on, it was acted out as women presided, preached, sang, prayed, and shared their individual stories.

prayed, and shared their individual stories. Viewed from a variety of perspectives the participants did not fit any stereotype. I guessed the age range to be from the late 20's to the early 60's. The avenues of ministry in-cluded the following positions: Associational Consultation in Church Growth and Education, Minister of Religious Education, Pastor, Student, Homemaker and New Mother, Chaplain, Chair of Athletice Department (from a co-ed Baptist College in Texas), Director of Christian Social Ministries, Associate Minister, State WMU Staff. I talked with women from 13 states. Some of then were ordained and some of them were not.

then were ordained and some of them were not. Furthermore, the group was not all women! Men who had been present for all sessions were especially evident in the Sunday morning worship service when we had to carry in chairs and open doors to accomodate the crowd of 250. I overheard one man remark to his two friends at the conclusion of the service: "We could not have had a finer worship experience anywhere!" The worship service did indeed set the stage for us to focus on the God who had called us together. The sermon of that hour by Susan Wright and the presentations earlier in the meet-ing by Linda Weaver Williams and Elizabeth Barnes spoke both the challenge and and the com-fort of God's will. A highlight of any gathering is seeing friends. I enjoyed seeing friends from my seminary days of 20 years ago. In those days I did not know any woman who felt called to be a pastor. We have served as missionaries, student workers, professors, chaplains, ministers of chil-

dren's work denominational servants, etc. It occurred to me when Baptist Tel Net was launched late in the week at the convention that 20 years ago I did not know anyone who felt called to serve God through the technology of satellite communication. BTN is a new way of telling the old, old story. Likewise, God is calling more women to pastoral ministries today because "in the fullness of time" God has al-

At the meeting in Kansas City I was happy to be a part of a host of women who have been busy responding to God's call in the past and a part of the women who today are pioneering new territory. THE 1984 SOUTHERN BAPTIST CONVENTION, KANSAS CITY John Steely, Professor, SEBIS, Wake Forest, NC

Before saying anything about the convention itself, one should recognize the FORUM. (An alternative meeting to the Pastors' Conference, held Monday afternoon just prior to the convention, the FORUM was attended by approximately 2,000 persons, had six major addresses, music and even a collection. As one of the platform members said, "How Baptist can you get?" Forum tapes are available. Three cassettes - tapes, postage and handling: \$15 - all orders should be prepaid. This event was of equal significance with the convention and at the FORUM an affirmative attitude toward women in ministry surely was evident. The issue of greatest importance for women in the Convention itself was the resolution "On ordination and the role of women in ministry," which was passed Thursday morning, the last day of the convention. Three resolutions bearing on this topic had been submitted to the convention and automatically referred to the Resolutions Committee. The text of the re-solution has been published, so there is no need to repeat it here. As far as content is concerned, it will suffice to say that it employs dubious exegesis in an attempt to support its case against the ordination of women. The "whereas" elements in the resolution should be carefully read and examined.

This is all the more important because the chair ruled that those "whereas" elements were not subject to debate or discussion until after the "Therefore, be it resolved" had been dealt with. Time allotted for this resolution expired, however, before any opportunity was allowed for questioning the highly questionable assertions on which the conclusion was grounded.Therefore the resolution as a whole cannot be claimed to have had even minimal discussion.

It is only fair to say that the chair repeatedly noted that a resolution of the conven-tion has no binding force, but is only the opinion of a majority of the messengers present and voting at a specific time and place. Therefore those who see the resolution as setting a stone wall before them should take heart; no such stone wall exists that did not already exist before the convention.

One other observation about women and the convention: the participation of women in the convention program appeared to this observer to be significantly less than it has been in the past few years. It perhaps is to be attributed to the same orientation in th Resolu-tions Committee and the Program Committee, an orientation that would clearly define and significantly limit women's share in the major functions of the Southern Baptist Convention.
