Association met pursuant to adjournment. Moderator read John x; 18 verses. Prayer by Elder Utley.

Roll called. Minutes of yesterday read. Consideration of Report of Executive Committee being in order, remarks were made by B. Oliver, J. D. Hufham, J. L. Stewart: pledges made.

Report adopted.

REPORT OF THE EXECUTIVE COMMITTEE.

Your Executive Committee submits the following report:

We have aided the churches at Chinquepin, Dobson's Chapel, and Brown's meeting house, and have made a small appropriation for several points of interest on the sound above Wilmington. Encouraging results have attended our efforts at all these points. At Chinquepin, 6 have been baptised and three await baptism; at Dobson's Chapel, 9 have been baptized, and at Brown's meeting house, 5; while at all these churches larger congregations and encouraging interest is reported. At the points on the sounds two have been baptized and a church organized at Middle Sound, one of those points.

The report of our Treasurer will show besides the above, a small amount paid to Elder J. T. Leary, which is for the past year's services; bro. Leary having inadvertently failed to report till the present year.

The regular missionaries of your committee, Elders G. S. Best and B. G. Covington, have met with the most encouraging success. Elder Best has labored diligently in his field, in Jones and a portion of Onslow counties and has baptized 26 at the different points, and received 5 others upon certificates of baptism, by which the cause has been greatly strengthened. Elder B. G. Covington has zealously and efficiently cultivated his field in Onslow county. He has baptized in that field 54, and 4 others have been received and await baptism, and 2 have been received on certificates of baptism. Two churches have been organized at very important points; one at Enon, 15 miles from any other church and six miles from the ocean; the membership being comprised of refined, intelligent persons with a good deal of wealth, which will render her self-sustaining; the other near Swansboro, which, while pecuniarily weaker than that at Enon, compares very favorably with it in other respects. The church at Jacksonville has been greatly strengthened and rendered nearly or quite self-sustaining.

We have thus given you, dear brethren, a concise statement of what we have done during the year and the results actually accomplished by the Master's blessings upon the efforts of your missionaries. But this does not exhibit all that has been effected, provided the proper efforts are continued; for all the people in this whole section are ripe for the gospel, as we teach and proclaim it. There are other important points, which are calling loudly upon us for the gospel and the whole country is ready to receive it. There still exists much destitution, and now is the time so come up to the full measure of our duty and go up and possess the land. To do this, we need more consecration and greater liberality to enable us not only to keep our present force in the field, but to send out at least one other good, strong man, and to procure and circulate our denominational literature. Now, dear brethren, is the time to help, to do all we can. The Lord help us to do our full duty.

REPORT ON FOREIGN MISSIONS.

God is fulfilling His promise to His Son, "Ask of me and I will give Thee the heathen for Thine inheritance and the uttermost parts of the earth for Thy possession." As early as we could understand, we heard our now sainted fathers, praying the Lord with his mighty hand to open the nations to the gospel of Christ.

These prayers have been answered. India is largely christianized. Kind Words is published in Memphis, Tennessee. It is our Southern Baptist Sunday School paper. It has an extensive circulation and is worthy of a still larger patronage.

We feel that each church ought to have a Sabbath school and instruct the children of her members and others who avoid them, and thus do what they can to train them for usefulness, for Jesus and for Heaven.

Elder Albritton read the report on Spiritual Condition of the Churches. Adopted.

REPORT ON THE SPIRITUAL CONDITION OF THE ASSOCIATION.

The committee on the Spiritual Condition of the churches report that the letters indicate that the present year has been one of spiritual declension.—Only 192 baptisms are reported, fewer by 221 than those of last year. Last year 25 Sabbath schools were reported; this year 20 schools are reported; five less than those of last year. Only one third of the churches manifest any interest in the Sabbath school work. Five of the 60 churches have sent up about \$15 for Foreign Missions. Fifty-five churches have ignored the Foreign Missionary enterprise in their letters. The greater part of the churches have preaching but once a month, and no prayer meetings.

Brethren, these are humiliating statements, since they show that many of our churches are sinfully slumbering in this day of golden opportunities and tremendous responsibilities. Let us pray God to awaken them and bring them to repentance.

Elder Kennedy read the report of Trustees of Warsaw High School. Remarks by Elders Cohen, Stallings and Kennedy.—Adopted.

REPORT ON WARSAW HIGH SCHOOL.

The Trustees of Warsaw High School beg leave to report, that in December last they held a meeting of the Board at the Seminary to take into consideration the preservation of the property, and the general interests of the school. And after due consultation we agree to lease the house and grounds to the present Principal of the school, Bro. Royal, for the term of five years for the sum of seventy-five dollars per annum, the rent to be paid annually, and the money thus obtained to be expended in repairing and otherwise improving the property. We refer you to the report of the Principal of the school for information relative to its present condition, from which you will see that at no time since the war has the Institution been in a more healthy and prosperous state than at the present.

We heartily commend the school to the patronage of our people generally, with the full assurance that those who send their sons and daughters to this school will not regret it.

REPORT ON OBITUARIES.

Your committee on Obituaries report that since our last session, our esteemed brother, Elder J. J. Rhodes, a member of Tuckahoe church, who for many years had been actively engaged in the work of the ministry, has been called from the toils of earth, as we trust to his reward in heaven. As the annual letter from the church, of which he was a member, gives no data upon which to found an extended obituary, we can only say that brother Rhodes was an exemplary christian and faithful and zealous minister of the gospel of Christ.

The church at New Hope mourns the death of Bro. Lewis Carroll, who was baptized by Elder Lewis Williams about thirty years ago, and was ordained a deacon of the church a few months thereafter, which office he filled to the satisfaction of the church until the time of his death.

We also notice the death of H. G. Barnhill, a deacon of Haw Bluff church, who was for many years a prominent member of his church and a useful member of this Association.

It is also our sad duty to report the death of Capt. Wm. Sutton, a member and deacon of the church at Union, for an extended account of whose active, benevolent, christian life, reference is made to the letter of said church to this Association, the portion of which relating to his death we hereto append as a part of the report.

[Extract from the Letter from Union.]

"DEAR BRETHREN:—We are unexpectedly called on to mourn the death of our worthy Senior Deacon, Captain William Sutton, who died at his residence in this county on the 30th day of August last, in the 49th year of his age. For upwards of a fourth of a century, Bro. Sutton had been a worthy member of the Baptist Church. But during the time that this church ceased to exercise the function of a living organization, he grew somewhat lukewarm as an active church member, but maintained his character as a christian. At this period of his life he was actively engaged in extensive secular business, and was a leading politician, having for many years served his county in the General Assembly of the State. He was a Captain of Artillery in the late war, and languished for many months in a northern prison. The last few years of his life, however, were spent in active and untiring efforts to advance the cause of Christ in this community and to build up a permanent church at this place. When this church was re-organized, about three years ago, Bro. Sutton assumed the entire support of the pastor, as well as the incidental expenses of the church. And although other members and friends contributed liberally, he simply received it as a thank offering to God, declaring at the same time, that he felt, that it would be a pleasure to him to bear the entire burden alone. Nor was this all. He gave liberally to other objects of benevolence, outside of his own church, for his large and liberal heart took in the whole range of christian benevolence and love. Capt. Sutton was a man of public spirit, a warm-hearted and enterprising citizen. At the time of his death, he had on hand the project of establishing a school of high character at this place for the education of the youth in this community. In his social relations, he was calm, dignified and pleasant. In his domestic relations, he was devoted to the happiness of his family. An affectionate husband and father, he did all in his power to make those dependent upon him comfortable and happy, and to lead them to Him, who has promised never to leave nor forsake them.

Dear Brethren: We feel deeply the loss we have sustained; we miss his boundless charity, his pleasant songs, his fervent prayers and his heart searching and melting exhortations. In our great grief and sorrow, we crave an interest in your prayers. We feel that not only this church, but the whole Association has sustained a great loss in the death of this truly estimable and worthy christian gentleman."

CONSTITUTION OF THE EASTERN BAPTIST ASSOCIATION.

ARTICLE 1. This Association shall be denominated and known as the Eastern Association.

ART. 2. The object of this Association shall be the promotion of Christ's Kingdom among men; and the means of accomplishing this shall be in strict conformity to the New Testament.

ART. 3. This Association shall be composed of delegates chosen by the churches connected with it, each church being entitled to three delegates, who shall be members of that church.

ART. 4. The delegates from each church shall bear a letter, certifying their appointment, and communicating information relative to the state of the church, *provided*, however, that when any church has prepared a letter and through inadvertence the letter fails to be presented, her delegates may be received without its presentation.

ART. 5. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be annually chosen from among its members by ballot, by a majority of the members voting, and continue in office until their successors are elected.

ART. 6. It shall be the duty of the Moderator to enforce an observance of the Constitution, preserve order, appoint committees, decide all questions of order, give his opinion on any question under discussion after others have spoken, and give the casting vote in case of a tie.

ART. 7. It shall be the duty of the clerk to record the proceedings of each annual session, and superintend their printing and distribution among the churches.

ART. 8. It shall be the duty of the Treasurer to receive all funds sent up by the churches or collected during the session of this body and disburse the same as ordered by the Association. He shall also make to the Association an annual report of the condition of the Treasury.

ART. 9. The Association shall appoint an Executive Committee, consisting of not less than five or more than seven members; which committee shall have the superintendence of Associational missions and Colportage. They shall have power to disburse all sums paid by the Treasurer of the Association for the objects under their charge and during intervals between the meetings of this body, to receive and disburse funds for those objects, and to take such steps for their advancement as they shall deem advisable, and shall make an annual report to the Association of their doings.

ART. 10. The Association shall not maintain fellowship with any of her churches which neglect to preserve gospel order.

ART. 11. The Association may invite visiting and corresponding brethren to seats, and extend to them all the privileges of the body except that of voting.

ART. 12. The annual session of this Association shall commence on Tuesday after the first Lord's day in October, at such place as may be chosen.

ART. 13. By appointment of the Association, there shall be an Introductory Sermon of a denominational character, and a Missionary Sermon.

ART. 14. This Constitution may be amended at any annual session, by a vote of two-thirds of the members present.
