# Credentials of Elder Thomas Lee Radford.

All the undersigned Elder, Minister of the Gospel of Christ, met July 26th 1975 in Compliance to a call by the Primitive Baptist Church of Christ at Martinsville, Va. for the purpose of ordaining Bro. Thomas Lee Radford to the full function of the ministry. We being of the same faith and order resolved ourselves into a presbytery by electing a Moderator and Clerk. We then proceeded to examine Bro. Sound in both faith and doctrine in accord with the principles of the Gospel. Thereunto, we do here by set him apart to the full functions of the office of Elder and to the administration of the ordinances thereof. Then returned him to the church as Elder Thomas Lee Radford. Should he ever here after depart from the Orthodox Principles of the Gospel of our dear Lord the Credentials will be null and void. Done by the order of the Church of Christ while in Conference. Martinsville Va. Given under our hand this the 26th day of July in the year of our Lord 1975.
