CHALK LEVEL, HARNETT Co., N. C., THURSDAY, November 4th, 1880.

The Fifth Annual Session of the Little River Baptist Association, convened with the Baptist church, at Baptist Grove, Harnett county, N. C.

Exercises introduced by singing, "When torn is the

bosom."

Elder H. D. Judd not being present, the Denominational Introductory Sermon was preached by Elder A. N. Campbell, from Romans iii: 2: "Much every way." After sermon prayer by Bro. Archie Betts.

After an intermission of 25 minutes, the Association was called to order by the former Moderator, Elder William Brunt, who read 24th Psalm; hymn, "Remark my soul the narrow bound;" the Moderator led in a fervent petition for the guidance of the Holy Spirit.

Bro. W. S. Mann was appointed Clerk pro. tem., Bro. Hil-

liard being absent.

### FRIDAY MORNING, November 5th, 1880.

The body Assembled for worship. Sang "Am I a soldier of the cross." Elder T. Harrison continued the exercises by reading the 67th Psalm and led the congregation in prayer.

Roll called and delegates promptly responded.

Proceedings of yesterday read and approved. Corresponding Messengers were invited to seats, and the following responded:

Elder J. M. Holleman represented the RECORDER.

Petitioning letters were again called for, upon which the church at Bethlehem presented a letter asking admittance into our union.

On motion, a committee consisting of Elders A. N. Campbell, J. C. Marcom and Alvin Betts, was appointed to examine the Articles of Faith and Church Covenant.

On motion, the petitioning letter was laid on the table

until said committee reported.

On motion, the same Order of Business of last year was adopted for the present session.

On motion, speeches were limited to ten minutes.

Committee on Bible Schools reported, and after a speech by Elder Harrison, on motion, the report was adopted, as follows:

Your committee on the subject of Bible Schools beg leave to submit

the following:

We find that your last committee on this subject say: "We fear that some of our chur hes do not place the properes imate on Bible Schools." While we admit that some of our churches do not realize the importance of Bible training, yet we think we may safely say that the interest in Bible schools is rapidly increasing; although we regret to say that not moe than half of the churches report Bible schools, though we hope it is by neglect of the clerks of the different churches. We hope it will be looked after more carefully in the future, and we trust that all the churches will engage in the B ble school work. We find that the first Bible school was organized in 1782, and at this time there are thousands of schools all over the land. God grant that Bible schools may be organized in every section throughout this neighborhood.

Also, insist on pastors to present the subject of Missions to their churches, and take up a collection for Home Missions next year.

Committee on Foreign Missions reported as follows:

"Whoso hath this world's goods, and seeth his brother have need and shutteth up his bowels of compassion from him, how dwelleth the love of God in him?" Suppose we were to find a brother in need of daily bread, and we should not administer to his necessities, that, of course, would be unchristian-like. Much more important is it, for us to administer to the necessities of the soul than the body. The command is "go teach all nations." There is a work for all; they that cannot preach can support those whom God hath called to preach. If we neither preach nor support those who do preach, how can it be said of us that we love one another?

Committee on Periodicals reported, and, on motion, the adoption of the report was deferred till to morrow morning.

Committee on Education called on to report, and the following report was offered, and after a few remarks from the Moderator, and Elders Holleman, Betts and Bro. A. D. Jones, on motion, the report was adopted, as follows:

Your committee on Education would ask to submit the following: Education is said by all to be a good thing. To prove this, we only have to refer to what it has done for man. We would ask every Christian if there is not a sin of omission lying at our doors? If so, will we not in the future try to remove it by doing all we can to educate our rising generation, as there seems to be a greater demand for it now than at any previous time?

### SATURDAY MORNING, Nov. 6th, 1880.

Elder O. Churchill introduced the exercises by reading 67th Psalm. Sang, "I love to steal awhile away," and led in prayer.

Roll called, and minutes of yesterday read and approved. The adoption of the report on Periodicals, which was read yesterday, was taken up and some interesting remarks by Elders Holleman and Churchill, advocating the Biblical Recorder as the organ of North Carolina Baptists; on motion, the report was adopted.

Your committee on Periodicals beg leave to report the following: We thing every Baptist family in the State should take the Recorder, not y because it is our denominational paper, but for its fearless advocacy of gospel truth. We think there is not a paper edited that is so well calculated to spread the truth and influence the minds of the young in sound religious knowledge as the Recorder. We, therefore, hope the

brethren will see that its circulation shall continue to spread until every Baptist family shall read the *Recorder*. Also, we recommend *Kind Words* as a Sunday School paper.

The number of baptisms for the past Associational year have been 26. The receptions by letter have been 20; dismissions by letter have been 24. We have received by restoration 4, and excluded 10. So we find that the total increase has been 27.
