9th. Appointed union meeting with Trinity Church, Upson County, Ga., commencing Friday before the fifth Sunday in May, 1909.

10th. Called for visiting brethren and received Elder J. H. Smith of Rutherford Church, Washington County, Ga.

11th. Called for contributions and received \$8.50 for minutes; agreed to have 300 printed,

12th. Adopted Corresponding Letter.

13th. Adjourned in order to time and place above mentioned.
