PROCEEDINGS 190th ANNUAL MEETING FIRST SESSION, TUESDAY, OCTOBER 15, 2019

1. Greens Creek Baptist Church hosted the first session of the 190th Annual Meeting of the Tuckaseigee Baptist Association. It began at 6:05 p.m. A total of 72 present: 58 Messengers and 13 visitors representing 21 churches.

2. Chuck Norris, Moderator, welcomed everyone and presented the theme and Bible verse.

3. Rev. Tom Lavin, pastor of Greens Creek Baptist Church, was sick and could not attend the meeting. He had asked Rev. Gerald Morris to welcome everyone and Rev. Ernie Jamison lead the altar prayer. Chuck and Rita Norris provided special music.

4. Rev. Aaron Langston, pastor of Pine Creek Baptist Church, brought the message from Romans 5:4-11.

5. Eddie Potts led the congregation in singing Love Lifted Me.

6. The 190th Annual Meeting was called to order by Chuck Norris, Moderator.

7. The Order of Business was presented and approved.

8. First time visitors were asked to stand and be recognized: Chase & Victoria Slaven of New Savannah, Tom Slagle of Faith and Angie Gregg of the NC Baptist Aging Ministry. Rev. Roger Stewman was recognized as the new pastor of Mt. Pleasant Baptist Church.

9. <u>Stewardship</u> – Rev. Mike Moore presented the proposed 2019-2020 budget to be voted on during the second session. The budget is on page 8. He said the there was little change in the budget. Mostly an increase in the personnel costs.

10. <u>Annual Meeting Committee</u> - Laura Brown presented a thank you to the host churches, annual meeting preachers and officers and volunteers in the association for their work in the association this year. <u>Place and Preacher</u> – Laura Brown presented the Place and Preacher recommendations for 2020. It was approved.

<u>Memorials</u> - Laura Brown and Virginia Pangle read the names of members from each church that had passed away during the past year.

12. Director of Missions - Rev. Gerald Morris presented his report on pages 3 and 4.

13. Eddie Potts lead the congregation in singing Amazing Grace.

MISSION REPORTS

14. Faith Baptist – Tracy Salter, Sarah Anderson and Emily Anderson spoke about the Deep Impact mission trips that their church was involved in this past year. They had an older group go to Caswell and a younger group go to one of the camps. Deep Impact involves mission work and worship services. 1 youth was saved this year on their trip. Some of their ministries included construction, prayer walking, beach outreach, servant evangelism, block parties, and giving out Bibles. They are going to be raising money to go on a Deep Impact trip to South Africa on July 22, 2021. They invited others to join them. 15. Unity Baptist – Brenda Slaughter told about their work with Mission of Hope in Richwood, West Virginia. She's been working with this coalmining town for 30 years, first sent by the Home Mission Board. She goes four weeks out of the year with a team of 15 or more. They have VBS, go into a nursing home, the school, daycare and provide a community dinner. They have worked to provide for their physical needs so that they will listen about their spiritual needs. Please pray for them.

SECOND SESSION, THURSDAY, OCTOBER 17, 2019

1. Mt. Pleasant Baptist Church hosted the second session of the 190th Annual Meeting of the Tuckaseigee Baptist Association. It began at 6:00 p.m. A total of 57 present: 51 Messengers and 6 visitors representing 16 churches. There was a total of 22 churches represented for both nights. 2. Chuck Norris, Moderator, welcomed everyone.

3. Rev. Roger Stewman welcomed everyone to Mt. Pleasant Baptist Church and lead an altar prayer.

4. <u>WMU</u> - Doris Melton, Associational WMU Director, presented her report on page 6 and 7.

5. Eddie Potts led the congregation in singing, Leaning on the Everlasting Arms.

6. Chuck Norris presented the registration report for both nights. It differed slightly as Gracella found some changes when typing up the proceedings following the meetings.

7. <u>Stewardship Committee</u> – Rev. Mike Moore presented the proposed budget for the 2019-2020 year on page 8. It was approved.

8. <u>Nominating Committee</u> – Kent Moore presented their report on page 13. No further nominations were made and the Nominating Committee List was approved.

MISSION REPORTS

9. <u>Cashiers</u> - Tracy Fowler spoke about the church's WOW program. It is Worship Outside the Walls on the first Sunday evening of each month. It includes witnessing, visiting shutins, the nursing home, doing yard work, a wood ministry, packing military boxes, sewing, and sending 40+ cards each month. She also said that in the spring some of the men go and build churches in Romania. In July a group went over to conduct VBS in three villages. Bennie Rice talked about their trip to Vermont this year to help build a fellowship hall that would provide bathrooms and Sunday School rooms. They had partnered with Allens Creek Baptist Church in Waynesville, NC to do this. Tracy and Bennie invited anyone to go that would like to participate in their mission trips.

10. <u>Ochre Hill</u> – Cheryl Blanton shared about their mission trip to Burgaw, NC in July. 20 people went to help restore 2 homes after Hurricane Florence flooded a wide area. She also spoke about the Lord's Closet that occurs at least once a month. She encouraged anyone to come and volunteer, bring canned foods, monetary donations and gently used clean clothing.

11. <u>Christmas Backpacks</u> – Gerald encouraged everyone to take part in the December 7th party planned to distribute the Christmas Backpacks at Victory Baptist Church. It is a joint project between Jackson and Macon Counties. Many volunteers are needed.

12. Eddie Potts led the congregation in singing, Victory in Jesus.

13. Rev. Jimmy Grissom provided special music.

14. Rev. Hayward Tomblin, pastor from Cashiers Baptist Church, brought the message from Colossians 1:9-14. He encouraged each church and the association to boldly proclaim Christ in this world. We are strengthened through Christ.

Executive Committee Report 2018-2019

January 14, 2019 - 7:00 p.m.

The quarterly meeting was called to order by Chuck Norris, Moderator at the Baptist Center. There were 11 executive committee members and one visitor with seven churches represented. (No quorum and no business conducted.) Chuck led the group in an opening prayer. Eddie Potts led the group in singing "Victory in Jesus". Rev. Emery Brooks, pastor of New Savannah Baptist Church, lead the devotion. No changes were made to the agenda. No new members were recognized. The July 9, 2018 executive committee minutes and the October through December 2018 financial statement were presented.

Associational WMU Director, Doris Melton, reported that plans are in the works for a county wide Associational WMU planning meeting for March. As soon as she gets confirmation for a host church, the date and time will be announced. This meeting will include a salad supper and will give everyone an opportunity to have input on project selections for the calendar year. Plans for the TBA WMU Associational Annual Meeting will also be discussed. In the meantime, Ms. Melton will make contact with Ms. Margaret Harding and the Red Box Ministry so that those attending the planning meeting will be able to select a project for the coming year. The goal of 500 bars of soap for this prison ministry was almost double with 915 bars collected this past year. Matthew 25:40 "And the King shall answer and say unto them, Verily I say unto to you, Inasmuch as ye have done it unto one of the least of these my brethren, ye have done it unto me."

Rev. Gerald Morris presented his Director of Mission's Report. The quarter had been a time of evaluation He is always tinkering with what we do to be better at serving you and your church. Early last year he shared with the churches the need to make repairs and improvements on the Baptist Center building. As usual, the churches stepped up to the need and those needs have been met. The two biggest jobs were to replace the fluorescent lights in the building with LED and to install siding on the outside. The men of Moses Creek Baptist replaced all of the lights in the building except those in the big meeting room. They decided to wait on those because they are still working well and do not use enough to save vey much electricity.

A&M General Services is in the process of installing vinyl siding, soffits and metal fascia and should be finished soon. This was a needed upgrade because the wooden siding on the back of the building was in such shape that it needed to be replaced. With the vinyl siding we will not be required to paint every few years to maintain the building. Several other repairs/ improvements were made and he appreciates all that have volunteered to keep our building looking great.

The semiannual Associational Singing was again a great time of fellowship for the churches and has become a time that many look forward to each Spring and Fall.

The Annual Meetings in October were a great success and he has heard positive feedback on the changes made to streamline the meetings and to make hosting it easier for each church.

He was able to help plan a fourth trip to Lumberton to help with the rebuild efforts. This time he was not able to go but Sergio Barranco, pastor from Highlands, was able to lead men from La Primera, Faith and El Centro to work three days. They were able to accomplish a great deal once again. Gerald is looking at the possibility of leading a group in the next couple of months. Please let him know if you could go on a Thursday-Saturday trip.

In September the sixth annual Missions Conference was held and plans are being made for this year's. In the past few years a limited number of churches hosted five missionaries during five sessions over four days. This year we are trying something new. He wants to invite five missionaries for two days (Saturday and Sunday). On Saturday, a Missions Fair would be held where the missionaries would have displays and meet with you directly. Local missions/ ministries will be invited to the missions fair also. A mission speaker may speak that night. On Sunday, the missionaries would then speak at churches for the morning and evening services. Your church could request a speaker for either service or maybe even both. Please let Gerald know if you are interested in hosting a missionary in your church. More details will come.

April 15, 2019 - 7:00 p.m.

The quarterly meeting was called to order by Chuck Norris, Moderator at the Baptist Center. There were 13 executive committee members with eight churches represented. Chuck led the group in an opening prayer. Eddie Potts led the group in singing "At the Cross". The agenda was changed with Doris Melton presenting her WMU report next and Rev. J.D. Grant unable to be there to give the devotion. No new members were recognized.

Associational WMU Director, Doris Melton, presented the following report. The WMU leadership team met March 23, 2019 at Faith Baptist Church to plan for our WMU Annual meeting. Faith Baptist Church will be our host and the door of the church will open at 6 pm with a salad supper to begin promptly at 6:30 pm. Our meeting will follow at 7 pm with Tracy Salter to be the keynote speaker. All WMU groups are encouraged to attend. The project for our Red Box Ministry is sandwich bags of hard candy with a goal of 500 bags. All WMU groups are asked to share any activities that they are involved in or plan for this year at our meeting. As we celebrate Easter, remember the women who went to the tomb only to find it empty. According to the Gospel of Mark 28:7, they were told to "go" and "tell" (his disciples) that "He is risen from the dead". We as WMU women have an opportunity to share this message through our prayers, projects, and substances. Gerald Morris presented his Director of Mission's Report as follows: Once again as I prepare this report I am amazed at what God is doing through the churches of the Tuckaseigee Baptist Association. During this past quarter I have been busy preaching at and visiting churches, preparing for missions and training events and providing support to churches and pastors. The Association exists only for the purpose of supporting your church in its divinely appointed task of glorifying our Lord. Therefore the churches of this Association ARE the Association. To that end, Gracella and I have been working diligently this past quarter to prepare missions and training opportunities and I have been visiting, encouraging, counseling churches and church leaders.

Missions and Evangelism

I have been working with Tom and Shirley Smith, a retired missionary couple living in Waynesville, to find ways to reach the International students attending WCU. In February, the Smiths, Randy Brooks and I attended a Chinese Lunar New Year festival on the WCU campus. We were able to make contact with the director of the program. This past week we attended the annual International Festival on the WCU campus. We were able to talk to several international students. We are praying that these contacts will bear much fruit in the future.

We have been working on the preparations for the September 2019 Missions Conference. This year we are trying a new format for the conference. It will be on Saturday and Sunday. Lovedale Baptist is hosting a missions fair and speaker on Saturday. At the Missions Fair, several local, state and national missions groups will be setting up booths and will be available to answer questions and discuss their ministry. The Missions Conference will continue Sunday morning and evening as 10 churches host missionaries from the International Mission Board. The missionaries will be speaking about their work throughout the world. Our Missions Conference has attracted attention in the surrounding counties. Because of this I met with two representatives from the Haywood Baptist Association about how they can start their own Missions Conference.

We have also been busy with other missions planning. I planned to lead an April trip to Lumberton to help with the rebuild effort, but the trip was ultimately cancelled because many of the volunteers were not able to take time off from work for the trip. Just last night (4/14) I was in contact with men from Cashiers Baptist about planning a trip soon. (possibly May)

We have also been working on the annual three-day mission trip to the NASCAR race in Kentucky in July. We usually work in the children's tent. This is a great trip for families - even if you do not like racing.

The Missions Committee met to plan the mission trips, outreaches and to award scholarship funds. The committee is recommending the need to suspend the scholarship program until the Annie Hoyle funds are replenished to the \$10,000 level that was set in the past.

The Committee discussed two missions outreach opportunities in Jackson County. The first opportunity is Mountain Heritage Day. The committee is asking for help in manning a booth at the festival hosted at WCU in September. I have met

with the Mountain Heritage Center about developing a display that will attractively advertise the work of the Baptists in Jackson County over the years and share about churches in the Association.

The committee also began planning the Christmas Backpack distribution. We are partnering with Macon Baptist Association and Victory Baptist Church to plan a distribution party.

Church support

As your Associational Missionary, I enjoy helping churches in their God given duties to glorify the Lord. One of the ways I do this is to visit churches. By visiting I get to hear the needs of the church, celebrate special events and support the pastors and other leaders of the church.

One special day I was able to attend El Centro Del Señor's first worship service at Webster Baptist Church as the two churches begin a wonderful new partnership. El Centro's needs had outgrown their current facilities and a partnership with Webster is a perfect fit. After worshipping with El Centro and Webster I immediately went to worship with several Associational churches at the Annual Spring Worship Rally. I always love to see God's churches coming together as one to worship Him.

One of the ways the Association helps the churches is to help strengthen the pastors that serve them. Gracella and I had the great pleasure in hosting the second Pastors' and Wives' Banquet. Everyone enjoyed the meal catered from Bogart's and the wonderfully encouraging message from Lewis Smith. Most everybody stayed around after the meal for quite some time for fellowship. We are working on providing more opportunities for pastors to get together for encouragement and support.

I also attended the Creation Science Seminar at the WCU campus. Jobe Martin presented a very compelling case as to why we can trust the Word of God when it comes to creation over evolution.

Gracella and I plan to attend the Go Georgia Conference and would like to invite anyone who is interested in going to come along. This conference is hosted by the Georgia Baptist Convention and is comprised of many different classes over a two day period. There are classes for all parts of the church (Sunday School, evangelism, music, financial, etc.) The Go Georgia Conference is on two dates in August at two locations. If this sounds interesting to you, please let me know and I will get you more information.

Looking forward to the 2020 Associational Church Leadership training, I met with Chris Schofield. Chris is the Director of the Office of Prayer for the NC Baptist State Convention. He will be coming to teach about prayer at the Leadership Training on Saturday and will preach the message on Sunday evening at the Spring Worship Rally. I am looking forward to this time of renewal through prayer.

Building and Grounds

This quarter has been a flurry of activity around the Baptist Center. Mauricio was able to install the vinyl siding and guttering on the building. The siding has added a fresh new look to the building, and we have already received many comments about how nice it looks. Mauricio went above and beyond in the work that he was contracted to do. He did several additional things to improve the building and grounds.

The last few days we have been busy receiving bids for a new heat pump for the Baptist Center. Over the last couple of years the heat pump has been requiring more and more costly repairs. The present unit is almost 20 years old and is in need of replacement. We have several bids and I will be meeting soon with the Buildings and Grounds committee to decide how we want to proceed.

Association Support

May is Associational Emphasis month. We would ask you to please remember us in your prayers. Pray that Gracella and I will have the wisdom to serve each church. Also, pray for each sister church and its leadership. Pray especially for those churches without pastors. It is becoming more and more of a struggle to find qualified pastoral candidates.

I would also like to remind you about this year's Associational Offering. While I have been serving the Association, the churches have done a fantastic job of supporting the Association financially and each year we have been close to meeting our expenses. For the last few years we have alternated between having a little money left over and not having quite enough. Last year we were lacking \$600 to meet all of our expenses. No changes were made to the agenda and no new members were recognized.

The April 14, 2019 executive committee minutes and the October 2018 through June 2019 financial statement were presented and approved.

Associational WMU Director, Doris Melton, presented the following report. "But my God shall supply all your need according to his riches in glory by Christ Jesus." Philippians 4:19. I am happy to report that WMU groups in the TBA are busy! Cookies were baked and matchbox toys gathered and given to our TBA Director, Gerald Morris, for the Kentucky Raceway Ministry by Calvary, Locust Field, Long Branch and New Savannah Baptist Churches. Deep Impact at Faith Baptist Church went to Fort Caswell at Oak Island where they served on construction projects, servant evangelism, children's beach ministry, and served at a thrift store. One student was saved at Deep Impact Caswell. Cameron Cabe is serving as Deep Impact Director and Ruthie Salter is serving as the Deep Impact summer intern. They are on their way to Puerto Rico this week, please pray for them. In addition, Faith Baptist Church has a "30 project" going on with their youth to collect items for United Christian Ministry. Ochre Hill's mission group has gone to the coast this month to assist with North Carolina "Hurricane Rebuilding". Locust Field Baptist Church will be hosting a yard sale to support WMU projects. Calvary Baptist Church WMU raised over \$500 for mission projects with a "Build Your Own Sandwich," an after-church meal and will be going to Deep Creek on August 11, 2019 for service and outreach. Missions and Evangelism

We have continued working on the **Missions Conference** coming up this September. This year we are trying a new format for the conference. The conference will be on Saturday evening and Sunday. Lovedale Baptist is hosting a missions fair and speaker on Saturday. At the Missions Fair, several local, state and national missions/ministry groups will be setting up booths and will be available to answer questions and discuss their ministries. If your church has done any missions/ outreach locally, nationally or internationally we would love for you to host a booth and share what God is doing through your church.

The Missions Conference will continue Sunday morning and evening as 10 churches host missionaries from the International Mission Board. The missionaries will be speaking about their work throughout the world. If you would like for your church to host a missionary speaker we currently have one morning speaker slot and two for the evening service (I think the evening service is a better time to host a speaker because it is less formal with more time to hear and ask questions).

Three Associational churches were represented by eight people that went for three days to the NASCAR race in Kentucky last week. Gracella's mother and sister graciously hosted us for two nights. The Annie Hoyle funds and an anonymous donor paid for the gas while New Hope Baptist furnished the van. With everyone working together the expense for each participant was minimal. This year we worked in the Ponderosa Campground. Duties included serving food, providing games and entertainment for children, distribution of New Testaments and Gospel information and most of all sharing the Gospel throughout the campgrounds.

We are still working on an outreach tent for **Mountain Heritage Day**. The plan is to host a tent so that we can share the Gospel and invite people to church. We will need help manning the tent from 10 a.m. -5 p.m. We will also need help setting up the tent at 8 a.m. and taking it down after 5:30 p.m. My hope is to have someone from each area of the county to invite people to a church that is close to where they live. This will be a wonderful opportunity to reach thousands of people with the Gospel and invite them to your church. Please let me know ASAP if you can help.

The **Christmas Backpack Distribution** planning is moving along. We are partnering with Macon Baptist Association and Victory Baptist Church to plan a distribution party December 7. The plan is to host children from both counties at Victory Baptist Church. During the time with us they will go to the gym where there are booths each with a part of the Roman Road plan of salvation. Then the children will have a chance to respond to the Gospel. They will then be taken into the cafeteria and fed lunch. Before leaving, they will be given an age appropriate backpack that has school supplies, canned food, toys and a Bible.

Several churches will need to be involved in several ways. First of all we need churches to begin now packing backpacks (instructions attached). We will also need many people on December 7th. There will be a planning meeting July 23 at 6:30 p.m. at Victory Baptist Church near the top of Cowee. This would be a great time to hear more about what is going on. Prayerfully consider sending a representative from your church to that meeting.

We delivered several thousand pounds of used **Sunday School literature** in two separate loads in June. We delivered approximately 5,000 pounds to Book Link Int. in Eubank, Ky and a pickup truck load to a church in Shelby, NC that delivers it to a ministry called "Love Packages."

Church support

Recently a large part of helping churches has been during times that the church does not have a pastor. I have been preaching at several of the churches and when I have not been available I have been able to share a list of men that are willing to preach when needed. With eight churches (one fourth of the churches in our Association!) without a pastor now there is a great need for men of God to be willing to pastor. But, I am not seeing many coming forward to lead God's church. Please pray that God will raise up a new generation of men that are willing to do the hard work of pastoring a local congregation.

This quarter I also worked with two churches' search teams. One is searching for their first children/youth leader and the other is searching for a new pastor. It is always an honor and privilege to help search teams begin their important task.

The Spring Worship Rally was wonderful but not very well attended. Mike Weaver, missionary to Peru, preached on our need to shy away from superstitions and focus on trusting God. His message was a challenge to all there and I wish more could have heard it.

Training

As your Associational Missionary, I have the pleasure of helping the churches of the Association in a large variety of ways. I have been to several training events in my ongoing quest to learn how to serve you better and also to find good training to the Association.

I have been encouraged that the State and National Conventions have begun to see the need to help existing churches more. I am seeing more emphasis in "church revitalization." In May, I attended the "Renovate" conference in Georgia. I heard great speakers and many great ideas that can be used to help small churches begin to grow again. I also have been listening to a great online lessons about church revitalization.

In June, I attended training at the Buncombe Baptist Association on how to prevent Child Sexual Abuse. It was not a pleasant evening but is was informative. I have some great information that I can share with you and your church about this important topic.

Also in June, I attended training at the Transylvania Baptist Association on refocusing your Sunday School. This training we very informative and inspirational. I have invited Mike Miller, the TBA DOM, to come and teach this class here at next year's Associational Church Leadership Training.

We have been working on the line up for next year's Associational Church Leadership Training and the line up of teachers is already good. As I stated above, we have Sunday School training but in addition we are working on classes for church security, child safety and others. If your church would like a class on another subject, please let me know ASAP so that I can work on that for you.

Gracella and I plan to attend the Go Georgia Conference August 22 and 23 in Statesboro, Ga and would like to invite anyone who is interested to come along. The Go Georgia Conference is hosted by the Georgia Baptist Convention and is comprised of many different classes over a two day period. There are classes for all parts of the church (Sunday School, evangelism, music, secretarial, financial, etc.) If this sounds interesting to you, please let me know and I will get you more information.

Building and Grounds

This year we have seen great improvements in the building and grounds of the Associational Baptist Center. I continue to hear compliments on the siding of the building. It has made the building brighter and protected for many years to come.

Unfortunately, the **heat pump** decided it was time to stop working. Much of this quarter, more than I had hoped, I have been occupied with getting the heat pump replaced. The new one was installed a couple of weeks ago, but unfortunately it came with a bad part. The installer has been working hard to obtain a part and replace it. Hopefully by the time that you read this the air conditioning will be working again.

The building continues to be used for God's kingdom in several ways. Fruitland continues to teach Bible courses here in Spanish each Friday night. They have also expanded to teaching courseling courses one Saturday a month. In a gesture of thanks, the Friday night class has been keeping the grass mowed around the building for a number of years now. This has saved the Association a lot of money.

Other groups have been using the building for meeting such as the Association WMU, Broyhill Food Roundup, etc. It is wonderful to see this building being used to serve God.

Association Support

Director of Missions Report 2018-2019, Gerald Morris

The 2018-2019 Associational year has once again been an exciting and busy one. It has been exciting to see how God is working in Jackson County through His churches as they come together as one. It has been busy because we see the day of the Lord approaching.

One of the biggest challenges this year has been the number of churches that have been without a pastor. At one point there were eight churches (one fourth) looking for a new pastor. This resulted in me preaching most Sunday mornings and many evenings both Sunday and Wednesday services, an average of $1\frac{1}{2}$ times a week for the year. I have also met with pulpit committees and consulted with several leaders in the church on how to find supply preachers and how to look for their next pastor.

In my continued support of God's church, I have often been a listening ear and an understanding heart. I love when a church leader feels able to come to me and share what is on his heart. Often in church leadership, pastoral or otherwise, there are few that you can confidently share your burdens. I count it as a privilege to serve in this way. I am available during or outside office hours, at the office, at the hospital or anywhere, in times of crisis and times of joy. I love being a "pastor to the pastors."

I also count it a joy to celebrate our pastors and their families. To that end, Gracella and I, with the help of many others, were privileged to host the pastors' and wives' fellowship meal in the Spring of 2019. We are working on plans to make this an annual, if not more often, event. It is wonderful to see pastors coming together so that iron can sharpen iron.

Work on the building and grounds of the Association has continued over from last year. The major projects that were completed this year were to replace the siding and guttering, converting most of the lights in the building with better looking and more efficient LED lights and replacing the failing heat pump. All of these repairs were necessary but should also prove beneficial in the years to come with savings on the power bill. I would love to thank everyone that helped with improving the building and protecting it for the future. The only unfortunate side effect of all of this work is that it has depleted the Annie Hoyle Endowment Fund to the point that we will have to pause the awarding of Mission Scholarships until the fund can be replenished.

It is wonderful to see the Baptist Center being used so much for God's Kingdom work. This year we have seen Fruitland continue to use the building for their Bible classes in Spanish but also to expand to having Biblical counseling classes taught in Spanish. The building is often used for many other uses; WMU meetings, pastors' appreciation meal, Mission Conference meal, and collections for Broyhill's Food Roundup, Christmas backpacks, WMU Red Boxes and Book-Link.

In May, Moses Creek hosted the Associational Spring Worship Rally. The speaker this year was Mike Weaver. He is a retired missionary who served in Peru and has spoken at our Missions Conference in the past. The congregation was small but the preaching was challenging and Spirit-led.

Missions should always be and have been a big focus on our work in the Association this year. I led our annual mission trip to the Kentucky Speedway to join churches from all over the US to reach out to the thousands of NASCAR fans.

September was a particularly busy month starting off with the Youth Missions Event. What was planned as a small food giveaway in which the youth of the churches would deliver food donated by Manna Foodbank bloomed into an "all hands on deck" mission project for over 100 people from several churches (association and non-association member churches). The volunteers packed and delivered food to needy people throughout the county.

The Missions Fair and Conference, held on the third weekend of September, was a great success. This was the first year for the Missions Fair and we had 11 groups and churches (local, state and international) and five IMB missionaries set up booths to share what God is doing.

Following the Missions Fair, we held a supper for the IMB missionaries, host church contacts and all of the pastors in the Association. Then on Sunday, we had five IMB missionaries speak to 10 churches throughout the area. We are already working on plans for next year and how we can work on a combination of one day and multi-day conferences.

The success of the Mission Conference has encouraged other associations in the area to explore the possibility of starting one. I have consulted with Haywood and Tennessee River Associations about how we go about hosting this wonderful conference each year.

The last Saturday of September found us engaged in a new mission endeavor. The Association set up and sponsored a booth at WCU's Mountain Heritage Day. At the booth, we featured a display with information and history of the churches of the Association. With the display we were able to invite some people to a church near where they live. We also gave out various things to spread the Gospel (New Testaments, Tracts, coloring sheets) but the most popular item was a small cookbook with several recipes. The final recipe on the back was entitled "Recipe for Hope" and was the plan of salvation using the Romans Road. We were able to give 200-250 of the cookbooks to visitors and vendors. The response was great until the rain reduced the crowd.

I have been fortunate to find several excellent training events to help equip me for serving the churches. I was able to attend training on church revitalization, Sunday School emphasis (I have invited this teacher to our Spring SS training), how to deal with problems in the church, child abuse prevention and a creation seminar held at WCU. I feel that these trainings will bear fruit in the future.

The finances of the Association continue to be a mix of "good news-bad news". First the bad news - as you can see from the financial statements, our income did not meet all of our expenses again this year. I believe this is due to a lower amount taken up for the Special Offering during the May Associational Emphasis. Next Spring maybe your church can renew your commitment to giving to this important offering and we can raise enough to meet all of our needs.

The good news is that many churches have increased their giving each month and continue to do so. This has led us to close the gap between income and expenses. We have come so far from nine years ago when I started this position.

I would also like to brag for a moment and say that we have a higher number of churches financially supporting the Association than any other association that I have seen in the state of North Carolina.

I love to see how God has used the cooperation of the churches of the Tuckaseigee Baptist Association and can't wait to see how God is going to use us this new year.

Doing more together for God, than we ever could apart.

BY-LAWS OF THE TUCKASEIGEE BAPTIST ASSOCIATION, INC.

ARTICLE I. NAME

The name of the body shall be the Tuckaseigee Baptist Association, Incorporated.

ARTICLE II. OBJECTIVES

The purpose of the Association is to be a fellowship of churches on mission in our setting. The specific objectives of the Association are as follows:

1. To promote harmony, understanding and spiritual power between the churches.

2. To afford and promote a larger fellowship of Christians in the work of Christ.

3. To provide such programs, projects and organizations as will strengthen the churches and assist them in achieving their goals and objectives.

4. To discover needs which cannot be met effectively by churches individually and to coordinate the use of resources in meeting these needs.

5. To encourage support by every church for the mission causes of the Association, the North Carolina Baptist Convention, and the Southern Baptist Convention.

ARTICLE III. AUTHORITY

SECTION 1. The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient.

SECTION 2. The Association shall have power to recommend measures of usefulness and guidance to our churches in matters of organization, ordinations and questions of doctrines and discipline,

SECTION 3. The Association shall have no power to infringe upon the right of local churches as autonomous bodies.

ARTICLE IV. MEMBERSHIP

SECTION 1. The Association shall be composed of regularly constituted Baptist churches in cooperating fellowship with the Southern Baptist Convention and following the teachings of the Bible.

SECTION 2. The Association shall be the sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure. Churches applying for membership shall agree to come under the watchcare of the Association for one year. It is understood that during this period of watchcare the church shall be entitled to all rights and privileges of the Association except those of voting.

Applications for membership shall be presented to the Doctrine Committee of the Association. The applications will consist of a letter from a constituted church stating their desire to affiliate with the Tuckaseigee Baptist Association. The Doctrine Committee as a part of the review process may invite the requesting church to a conference to discuss its history, its mission strategy, and any other information that may be pertinent to the application. The Doctrine Committee may then approve the application and recommend them to the Executive Committee. The Executive Committee may by a simple majority vote accept the requesting church to come under the watchcare of the Association for one year. Any church under watchcare is expected to participate in and financially support the Association. At the end of the year, the church may be voted in as a member of the Association with full privileges by a two-thirds vote of the messengers present and voting at the annual meeting of the Association, at the recommendation of the Doctrine and Executive Committees and at least one messenger be present at the meeting.

SECTION 3. Any church may withdraw from the Association at its pleasure and should notify the Association of this action in writing. Such action will be recognized by the Association at the next annual meeting.

SECTION 4. It shall be the duty of each church to furnish the Associational Clerk, before each annual session, a Church Profile, the forms provided by the Associational Clerk, giving the information requested as is applicable to each church situation.

SECTION 5. The Association may withdraw from any church which has become unscriptural in its doctrine or practices by a two-thirds majority vote of the messengers present and voting at the annual meeting. Such vote is to be taken by written ballot.

ARTICLE V. MEETINGS

SECTION 1. The Association shall hold its annual meeting on Tuesday and Thursday following the second Sunday in October. Special meetings of the Association may be called by the Executive Committee provided two weeks written notice is given to the member churches.

SECTION 2. Each church shall be entitled to be represented at the annual meeting by the pastor and one additional messenger. Churches which give to the association more than .5% of their undesignated receipts shall be entitled to an additional 2 messengers for every .5% of giving up to a total of 10 messengers for churches which give 2% of their undesignated giving."

SECTION 3. Churches are requested to elect their messengers and alternatives in conference to attend the annual meeting.

SECTION 4. In case of internal dissension in a church and two parties coming to the Association, each claiming to represent the church, neither party shall be seated until the Doctrine Committee determines which party is in union with the Association. The decision is to be affirmed by a majority of the messengers present and voting.

ARTICLE VI. OFFICERS

SECTION 1. General officers of the Association shall be: Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Parliamentarian, Assistant Parliamentarian, Director of Missions, Trustees and team leaders. Team leaders shall be chosen by the Nominating Committee as needed to serve the purposes of the Association (eg. Sunday School leader, Youth/Children leader). Team leaders will work with the Moderator and/or the Director of Missions to form a team to carry out assigned duties.

Associational representatives will be elected as may be deemed appropriate and elected in the Association. Associational representatives shall be a conduit of information between outside agencies and the Association. They may also represent the Association as the outside agency's policies specify.

SECTION 2. With the exception of the Director of Missions and Trustees, the terms of office for all officers of the Association shall be for one year with the privilege of continuing re-election. The Moderator and Vice Moderator shall not be eligible for re-election but one year in succession. (1) The number of Trustees shall be three. (2) The term of service should be for three years, with the term of only one expiring each year. In the first election of Trustees, the term of service for one should be three years, another two years, and the other one year. (3) Upon the expiration of term of service, the Trustee may or may not be re-elected for another term of three years.

Each term of office shall begin with the close of the annual session. The Associational financial year will run from October 1 through September 30.

ARTICLE VII. DUTIES OF OFFICERS

SECTION 1. The Moderator shall preside and maintain the order of all meetings of the Association and Executive Committee. He shall serve as ex officio member of all committees of the Association.

SECTION 2. The Vice Moderator shall assist the Moderator and preside in the absence of, or at the pleasure of the Moderator.

SECTION 3. The Clerk shall keep a complete and accurate record of all meetings; shall prepare a "Book of Reports" to be distributed to messengers at the beginning of the annual meeting; and prepare minutes of the annual meeting (Annual Minutes) to be distributed to each church.

The Clerk shall distribute to the clerk of each church in the Association a congregational church profile as soon as they are received from the State Convention. This form is to be returned to the Clerk of the Association as soon as possible or by the deadline set by the Clerk and Director of Missions. All program reports should be returned by the same date.

An Assistant Clerk shall work with the Clerk in preparing the "Book of Reports," the annual minutes and the registration of messengers at the annual meeting.

SECTION 4. The Treasurer shall oversee the receipts and disbursements, by order of the Executive Committee of the Association, of the money of the treasury and ensure that a complete report is presented at the Annual meeting and a current report at each Executive Committee meeting.

An Assistant Treasurer shall be elected to assist the Treasurer by request and to serve in the event the Treasurer resigns or is ill or unable to function.

SECTION 5. The Parliamentarian shall upon the request of the presiding officer of the body, advise and assist the Association with respect to all matters involving Parliamentary Procedure.

An Assistant Parliamentarian shall be elected. The Parliamentarian and Assistant should always communicate with each other to ensure that this office is filled at each Associational Annual or Executive Committee meeting.

SECTION 6. Trustees have no authority except by direction of the Association and are not personally bound by signatures but are to be the legal signees for the Association. Trustees represent the Association in legal matters. Trustees act on behalf of the Association in acquisition and disposal of Associational property.

They sign all deeds of conveyance, execute all notes, bonds or mortgages, intervene in all suits, by authority of the Association.

All persons dealing with the Trustees, as Associational officers, may rely upon any written resolution duly adopted by the Association or Executive Committee, directing and authorizing the Trustees to act in its behalf and certified by the Association Moderator and Clerk.

ARTICLE VIII. RULES OF ORDER

The business meetings of the Association shall be conducted according to Robert's Parliamentary Practice or in a manner not contrary thereto.

ARTICLE IX. QUORUM

The quorum for the Annual Associational meeting or any special called meeting of the Association shall not be less than 25 percent of the member churches.

ARTICLE X. THE EXECUTIVE COMMITTEE

SECTION 1. The Executive Committee shall be composed of the General Officers and Team Leaders elected by the Association and the Pastor and one member from each church in the Association. No Pastor, by virtue of his being an Associational Officer or Program Leader shall be disqualified as a member of the Executive Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

SECTION 2. It shall be the duty of the Executive Committee to act for the Association on matters arising when the Association is not in session and to make a report of all work to the next session of the Association. This body shall meet at a time and place designated by the Moderator on Monday following the second Sunday of each quarter except for the October quarter which shall be replaced by the Annual Meeting. Special meetings of the Executive Committee may be called by the Moderator with a one week notice to the churches.

SECTION 3. All vacancies occurring on committees or among elected officers shall be filled by the Executive Committee.

ARTICLE XI. ASSOCIATIONAL STANDING COMMITTEES

SECTION 1. The Association shall have such standing committees as may be deemed necessary to promote efficiently the work of the Master in our midst. The terms of office for all committee members shall be for three years except where specifically stated otherwise.

SECTION 3. THE NOMINATING COMMITTEE shall be composed of seven members It shall be the duty of this committee to nominate the Officers, Committees members, Team Leaders (as needed) and Institutional Agency Representatives. These nominees shall be notified prior to presenting of their names at annual session.

SECTION 4. THE STEWARDSHIP COMMITTEE shall be composed of six members including the Treasurer of the Association. This committee shall: (a) present a Budget to the Association for the following year; (b) devise plans for raising the funds for the Associational Budget; (c) audit the finances and financial records of the Association annually and anytime there is a change of Treasurer or at the direction of the Association or the Executive Committee; (d) report all audits to the Annual Association Meeting.

SECTION 5. THE BUILDING AND GROUNDS COMMITTEE shall be comprised of three members. The committee shall be responsible for and in charge of the upkeep and repairs of the Associational building, grounds, and equipment. SECTION 6. THE PERSONNEL COMMITTEE

A. The Committee shall be composed of 7 members of which 3 are pastors.

B. They shall recommend policies and procedures for the selection, supervision and termination of Associational staff personnel. Those policies and procedures shall be approved by the Association.

C. Prepare and maintain an organizational manual relation to the Association's staff personnel.

D. Develop and recommend to the association policies and procedures for paid and volunteer staff personnel.

E. When a staff vacancy occurs, other than the DOM, they shall serve as the search committee. When a DOM vacancy occurs, they shall nominate a search committee and present it to the Executive Committee.

F. The Personnel Committee shall handle grievances as outlined in the grievance policy.

SECTION 7 THE ANNUAL MEETING COMMITTEE shall be composed of seven members. The duties of this committee shall be to

A. recommend the church(es) to host the annual meeting and the preacher(s) and alternate preacher(s) to deliver the annual sermon for the following year,

B. present suitable resolutions at the annual Associational meeting,

- C. bring a report to the annual meeting of those listed by the member churches as deceased since the last annual meeting,
- D. keep the historical records of the Association up-to-date,
- E. plan the program for the Annual Meeting(s) and present it to the Executive Committee at its October meeting,
- F. shall be responsible for registering messengers at the Annual Meeting(s),
- G. and shall perform all duties specified in Article XIII (amendments to by-laws).

SECTION 7 THE DOCTRINE COMMITTEE shall be composed of five pastors and two laymen.

- A. It shall examine applications of churches seeking admission into the Association in keeping with Article IV and make recommendation to the Association. It shall counsel with churches that are out of harmony of fellowship with the Association.
- B. It shall also advise churches about candidates for ordination with the following guidelines: it serves on an advisory capacity only, serves at the request of the church from which the member is seeking ordination, is to examine such candidates as to their call and fitness for the gospel ministry and make such recommendations to the church as they feel led. It should regularly inform the Executive Committee of its work.

ARTICLE XII. JOB DESCRIPTION, DIRECTOR OF MISSIONS

SECTION 1. Title and Functions.

A. Position Title. This position shall be known as the Director of Missions for the Tuckaseigee Baptist Association.

B. Basic Functions. The Director of Missions shall serve as a minister to the church leaders of the Tuckaseigee Baptist Association, as mission strategist, as chief administrative officer, and as a general leader of the Association.

C. The Personnel Committee shall be responsible to maintain, update and revise a job description as required,

making recommendations to the Association for approval as they are needed.

ARTICLE XIII. AMENDMENTS

The constitution may be amended at any annual meeting of the Association by a two-thirds majority of the messengers present and voting, provided the amendment has been presented to the Annual Meeting Committee at least 10 days prior to the annual meeting and presented to the Association in printed form on the first day of the annual meeting to be voted on the second day.

ARTICLE XIV. NON-PROFIT STATUS

The Tuckaseigee Baptist Association, Inc. is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the Tuckaseigee Baptist Association, Inc. shall inure to the benefit of its' members, directs, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

In the event of dissolution, the residual assets of the Tuckaseigee Baptist Association, Inc. will be turned over to one or more organizations with similar purposes which are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986.

DID YOU KNOW????

In 2018 United Christian Ministries had 10,423 client contacts; THAT IS 40 LESS CLIENTS THAN THE PREVIOUS YEAR. We are pleased that 40 clients from the previous year did not need our services again in 2018. One of our goals is to help our clients have sufficient resources and the ability to care for themselves.

Seventy-one percent were over the age of 18. Twenty nine percent were children in the household.

United Christian Ministries gave out more than 271,670 pounds of food. Four hundred fifty school break bags were delivered to our elementary schools in December. Our ministry also furnished 130 households with a turkey for their Thanksgiving meal.

Food donations were abundant during the year.

Our ministry helped with electric bills for 243 families in the amount of \$33,448.78.

Thirty- four families received \$4966.29 in heating assistance.

Fifty- three families received help in the amount of \$9918.50 to pay rent and prevent eviction.

Forty- eight families received \$1266.78 for medical assistance.

Diapers/depends were given 186 times.

Household items and personal items were given 2799 times; our ministry spent \$2522.38 purchasing these items during the year. Many donations were also received during the year.

One thousand five hundred forty-eight dollars and forty cents helped 28 families with their water bills.

In addition to all the food donations, \$19,046.86 was spent for food.

Transportation assistance was given to 6 families in the amount of \$230.00

Donated linens, bed covers, furniture, and kitchen items were also given to our clients.

Six hundred twenty- six families were assisted with clothing.

Two hundred eight individuals were first time clients to our ministry in 2018.

- We have also been able to purchase certain supervised recreational activity equipment to implement as a part of summer camp as well as to be able to offer our "off season" guests as they attend (IE. Mountain bikes, Sit on top Kayaks, Canoes, Pellet Rifles, Archery Equipment, etc.)
- Our partnership with the local High School carpentry class continues to be a huge blessing. We have been able to extend the partnership into this school year as well with several smaller projects
- Continued work to upgrade safety concerns such as exposed electric lines, having lighted Exit signs and fire extinguishers in the proper locations, etc. are an ongoing task.
- We were able to schedule volunteer groups to come in to assist us in some of the renovation tasks on other buildings that is much needed. IE. Bath house at the pool
- The property and home which joins the camp, at 126 Truett Lane, was purchased for housing the Summer Camp and Special Programs Coordinator and family. The house was in need of some repair and rejuvenation which is 99% complete at this point.

Ongoing Goals:

We continue to work on improvements across the property. Our next goals are:

- Repair / Seal sections of our asphalt drive and parking area
- To replace the mattresses in the Conference Center that have springs "popping through" them
- To replace outdated and worn furniture in our Conference Center Meeting room. We have already acquired a large conference table from the surplus of the convention.
- We have two apartments that are in great need of remodeling
- Our "Lodge" which is being evaluated now for structural issues we are addressing due to floor collapsing.
- Truett staff continue visiting the local churches to create a greater awareness of the Camp property and what we have to offer in the community. A much greater emphasis has been placed on marketing and social media to 6 different surrounding states (SC, GA, FL, AL, TN, VA) along with our 76 associations in NC.

Attendance:

Attendance continues to hold steady. We have added several new programs to our schedule with the goal in mind to better serve our NC Baptist Churches while creating opportunities for increased revenue for improvements. IE. Coed Youth camp, Grand Parent camp, Children's Camp, Father / Son weekend, Man Camp, Valentines Marriage Retreat, Senior Adult Retreat, Worship Leader retreat, Mother / Daughter retreat.

Personnel:

Truett currently has 4 full time staff and has recently hired our first Intern that started Sept. 16th. We have also heavily recruited volunteers from several organizations to join us through our summer season and "off season" with great success.

Final Remarks:

Please continue to pray for us in the Western end of NC...we are dealing with a great deal of challenges to "get the word out" and to let our NC Baptists know we are even out here, let alone the services we are trying to offer and have them attend. We realize it is going to be challenging to inform folks about who we are and what we have to offer so "keep us in your prayers".
