

The 2017 Annual Minutes are Dedicated to Lewis and Jean McClure Keener

Lewis Keener was born to Rufus and Mattie Blanton Keener on 9/12/27. He was raised in a loving Christian home and attended Ochre Hill Baptist Church most of his life. On 9/1/50 Lewis married Jean McClure and they had two daughters. Lewis was an active Deacon, Sunday School teacher and was instrumental in the building of the new Ochre Hill Baptist Church and parsonage. He also formed the Bus ministry at Ochre Hill and had 3 buses run every Sunday morning throughout the surrounding communities for several years. Many children came to know the Lord thru this ministry. Lewis loved music and sang in the church choir and loved to sing at local rest homes. In later years Lewis and Jean joined Scotts Creek Baptist Church where he continued to serve as a deacon and sing in the choir. Lewis was always a dedicated Christian, loving his Lord and his family. Failing health led to his passing in 2011. Lewis was loved and respected by all those who came in contact with him.

Jean McClure Keener was born to Nettie and Paul McClure on 8/21/30. She was also raised in a loving Christian home with 11 brothers and sisters. All eleven are still living with Jean being the oldest. Jean attended Mount Pleasant Baptist Church until her marriage to Lewis Keener and then they attended Ochre Hill together. Jean was very active with the GA and WMU programs. She has always had a love for missions. At Ochre Hill she and many others raised money to help support the mission programs by quilting many beautiful quilts and other projects. She has always been a dedicated Christian and dedicated to her Lord and family. As she and Lewis joined Scotts Creek Baptist Church in later years she still attends WMU programs after 70 years. She also dedicates her time each year folding and getting the Samaritan Shoe Boxes ready to be filled. Jean is always mindful of meeting the Mission Offering Goals throughout the year. At 87 Jean is still attending Scotts Creek Baptist Church and is a silent "prayer warrior."

### PROCEEDINGS 188th ANNUAL MEETING FIRST SESSION, THURSDAY, OCTOBER 12, 2017

1. La Primera Iglesia Bautista de Amor hosted the first session of the 188<sup>th</sup> Annual Meeting of the Tuckaseigee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 84 present: 55 Messengers and 29 visitors representing 15 churches.

2. Rev. Mike Moore, Moderator, welcomed everyone

3. Rev. Felix Villarreal, pastor of La Primera Iglesia Bautista de Amor, welcomed everyone to their new church building. He thanked everyone for their support to make this happen. He opened with altar prayer. The Hispanic worship band provided special music.

4. Rev. Felix Villarreal, pastor of La Primera Iglesia Bautista de Amor brought the message.

5. The 188th Annual Meeting was called to order by Rev. Mike Moore, Moderator.

6. The Agenda was approved as presented.

7. Dr. John Edwards was recognized as a visitor. Dr. Edwards announced that the chaplaincy program at Harris Hospital had been removed. He encouraged pastors to take turns volunteering. He also stated that it was rumored that the Gideon Bibles are no longer being permitted in the patients' rooms. He encouraged everyone to lobby the hospital for this to change.

8. Grace Morris, music director, led the congregation in singing, When the Roll is Called Up Yonder.

REPORTS

9. **Baptist Children's Homes of NC (BCH)** – The Haywood Cottage from Broyhill Children's Homes came and presented a clip from the BCH DVD and the girls also did a stick presentation to music. They also sang *Jesus Loves Me*.

10. **Director of Missions** - Rev. Gerald Morris gave his report. It was located on page 3-5. He bragged on the Tuckaseigee Baptist Association by saying they were the best in the state. Gerald responded to Dr. Edwards announcement that it also meant that there is no one in charge of the Rest Home schedule and he is checking with the rest homes on that.

11. <u>NC Baptists on Mission</u> – Rev. Paul Langston reported that volunteers have been very busy in the past year responding to Hurricane Matthew with an example of serving 470,000 meals. In Lumberton, NC 220 families lost their homes. NCBM have rebuilt 60 homes and are working on 44 homes now. He said trained and untrained volunteers are needed. Right now 60% of the volunteers are women and students. Volunteers are now responding to Texas, Florida, Puerto Rico and some islands hit by hurricanes. He said there are multiple ways to share the Gospel with different partnerships that NC has built with other states and countries. He encouraged people to Pray, Give, and Go.

12. Grace Morris lead the congregation in singing Amazing Grace.

#### COMMITTEES

#### 13. Annual Meeting Committee

<u>Memorials</u> - Laura Brown and Virginia Pangle said the minutes will be dedicated this year to Lewis and Jean McClure Keener. Descriptions of these two people are at the front of this book. Laura and Virginia also read the names of members from each church that had passed away during the past year. Flowers were presented to Ms. Keener.

<u>Place and Preacher Committee</u> – Laura Brown presented the Place and Preacher report for the 2018 meetings on page 12.

**Proposed Annual Meeting Changes** – Gracella Morris presented the proposed changes for the dates of the annual meetings and executive committee meetings. The changes would also affect the By-Laws. They also were proposing a change from a full meal to "coffee and cookies" type refreshments to be served at 5 p.m. The changes listed on page 13 and 14 were presented to be voted on the next day. 14. **Stewardship** – Rev. Mike Farmer presented the proposed 2017-2018 budget to be voted on during the second session. The budget was on page 8-9.

15. <u>Miscellaneous Business</u> – Rev. Mike Moore presented a plaque to Gracella Morris that had the following on it: Grateful Appreciation to Gracella B. Morris for Your 15 years of Dedication and Service to the Tuckaseigee Baptist Association. 2017.

#### MISSIONS

16. <u>Cashiers</u> – Benny Rice reported on their mission trips to Romania. On one trip the men go to build churches. They get the church built with a roof on it and provide enough money for supplies to finish it. For the past two years they have had a crew go during the summer to do Vacation Bible School with multiple churches. He thanked the association for their Annie Hoyle Endowment Funds that have helped to fund their trips. Cashiers has also been doing mission work regularly in Oceania, West Virginia. Carlton and Cindy Fowler go on a regular basis to relieve a pastor and his wife. Others also go periodically.

17. **Faith**– Ruthie and Tracey Salter, Katlin and Donna Watson presented a report about their experiences in Honduras with Deep Impact through the NC Baptists on Mission. They worked on medical and Vacation Bible School teams. They had four youth go this year and plan to take eight next year. They thanked everyone for their support of their mission trips.

18. <u>Lighthouse</u> – Rev. Matt Ledbetter shared about their trips to Mexico. They have had two trips this year to share the Gospel. He thanked the association for the Annie Hoyle funds and told about future plans to share the Gospel in Mexico with a partnership with Miguel Riaz and his family. 19. Rev. Ernie Jamison led the benediction prayer.

#### **SECOND SESSION, FRIDAY, OCTOBER 13, 2017**

1. Long Branch Baptist Church hosted the second session of the 188<sup>th</sup> Annual Meeting of the Tuckaseigee Baptist Association. A delicious meal was served at 4:30 p.m. A total of 65 present: 50 Messengers and 15 visitors representing 13 churches. There was a total of 17 churches represented for both nights.

2. Rev. Mike Moore, Moderator, presented the Thank You on page 10 from the Annual Meeting Committee.

3. David Dalton welcomed everyone to Long Branch Baptist Church and asked Rev. Mike Farmer to lead an altar prayer.

#### REPORTS

4. <u>Music</u> – Chuck Norris gave the Music report listed on page 6.

5. <u>WMU</u> – Doris Melton presented the WMU report on page 7.

6. <u>Camp Truett</u> – The report is on page 27. Michael Allen, new assistant director for Camp Truett said that there were 20 salvations this past summer and many, many recommitments. They served 337 campers this year. He said that pastors, youth pastors and laymen were needed to come speak and work at the camp (especially during the boys week).

7. **HOMEBASE College Ministry** – Rev. Jim Dean told about the new Baptist Children's Homes partnership with Western Carolina University to reach students without parental support. They are using the former Baptist Student Union building on campus as a resource center. They have served 150-230 students a week since school started. Activities include three Bible studies, meals, computers, cooking lessons, etc.

8. <u>Smoky Mountain Pregnancy Care Center (SMPCC)</u> – Nancy Brito spoke about their program that exists to save the lives of unborn children by sharing the love of Jesus Christ through spiritual, physical, emotional, and education support of their clients. In the last 12 months, 1500 clients received free, non-judgmental care. They are now promoting a capital campaign to fully fund a permanent home in Cullowhee, NC.

9. Chuck Norris led the congregation in singing, Victory in Jesus.

10. Rev. Mike Moore presented the registration report for both nights. It differed slightly as Gracella found some changes when typing up the proceedings following the meetings.

11. <u>Stewardship Committee</u> – Rev. Mike Farmer presented the proposed budget for the 2017-2018 year. It was approved.

12. <u>Annual Meeting Committee</u> – Gracella Morris presented the proposed changes to the annual and executive committee meetings and the by-laws. It was approved. They are listed on page 13 and 14.

13. <u>Nominating Committee</u> – Kent Moore presented their report on page 15. No further nominations were made and the Nominating Committee List was approved.

14. <u>Missions Committee</u> – Kim Fiskeaux reported that the association helped the Banner Baptist Church in Gatlinburg, TN to reach their neighbors with the Gospel after the wildfires damaged/destroyed nearly 1,700 buildings in November 2016. They also sent a crew of people to help. The committee also helped plan the annual trip to the KY Speedway in July to share the Gospel with over 100,000 NASCAR fans. This year they worked in the KidZone area. The Missions Conference was a wonderful success again this year. This year seven churches spanning three counties hosted five missionaries from the International Missions Board. A new project this year is the Christmas Backpack Outreach. 120 backpacks are going to be distributed to the elementary schools via local churches. Also the Missions Committee awarded missions scholarships from the Annie Hoyle fund. This year they awarded \$5,200 to four churches. Through these scholarships we have been partners in reaching Mexico, Romania, Honduras, and Kentucky.

#### MISSIONS

15. <u>Webster</u> – Joni Carter reported that their church had gone to Nicaragua. It was her first time to go and she regretted that she had not previously gone many times. They work with the Globe Ministries in three communities to share that Jesus is the only way to salvation. People are so grateful for the smallest things and are so content. They reach the people through Bible studies and playing games with them.

16. <u>Calvary</u> – Doris Melton said that their church organized a WMU group with 7 people three years ago. Some of their local mission projects have included making pillows for cancer patients, raising money for one of their members who had cancer, supporting a missionary in Uganda, helping Teen Challenge, doing pastor appreciation, Red Box Collection, Angel Fund to help kids at Fairview Elementary School, and "pounding" one of their elderly members for Christmas. God is good! She challenged everyone to not limit God. She said their next project is to collect coats and sweaters.

17. **Ochre Hill** – Kim Fiskeaux talked about the new clothes closet that has been started at Ochre Hill. The Lord's Closet has grown from 1 room of clothes to 3 rooms at the church and off season clothes being stored at the parsonage. They have served 60-70 people every time they have opened. Currently they open every fourth Wednesday from 4-6:00 p.m. to give away food and clothes.

18. Chuck Norris led the congregation in singing, Somebody Loves Me.

19. One Accord provided special music.

20. Rev. Scott Carter, pastor from Webster Baptist Church, brought the message from Ezekiel 37:1-14.

21. Chuck Norris led the congregation in singing Press On, It Won't Be Long.

22. Rev. Kent Lowdermilk closed the meeting with the Benediction.

#### **Executive Committee Report, Gracella Morris, Clerk**

#### **October 3, 2016**

The quarterly meeting, of the Tuckaseigee Baptist Association (TBA) was called to order by Rev. Mike Moore, Moderator. It was held at the Baptist Center. There were 18 executive committee members and one visitor with ten churches represented. Donal Shuler led the group in an opening prayer. Chuck Norris led the group in singing "Down at the Cross". Rev. Craig Tucker had the devotion. Darrin Sutton was recognized as a new member.

Mrs. Lee Lillard presented the WMU report. The leadership group went to a regional training held here in Sylva. At lunch their group made plans to provide supper for the mission conference on Saturday, September 24<sup>th</sup> for the missionaries and host churches. She also announced that the Women's Retreat with Allison Speer as speaker/singer had been postponed until the spring. Tuckaseigee's WMU has also been collecting toothbrushes for the Red Box Prison Ministry this year. 500 individually wrapped toothbrushes are needed. They are also planning a surprise for the churches that she could not reveal yet.

The July 11, 2016 executive committee minutes and the October 2015 through September, 2016 financial statement were presented and approved.

Rev. Gerald Morris presented his quarterly Director of Missions report. He referred to his annual report in the Book of Reports. He pointed out that Wilkesdale Baptist Church is no longer a part of the association. The few remaining members voted to merge with the Sylva Assembly of God Church to form a new non-denominational church on June 19<sup>th</sup>. Since they are no longer a Baptist Church they are no longer eligible to be a member of the Association.

Gerald discussed the Missions Conference held in September. He was very excited about the missionaries that came and spoke at the host churches. He encouraged the churches to visit one of the host churches when missionaries come to speak.

Gerald's tenure as a member of the Board of Directors for the Baptist State Convention of NC ended in September. He also ended his service to the churches of the Tennessee River Baptist Association in Swain County. Gerald also encouraged churches to get involved in leading a Bible Study at the Old Baptist Student Union building at WCU.

Gerald also shared that the director of Camp Truett died and would have to be replaced. He serves on their board and encouraged everyone to pray for them as they looked to hire a new director and an assistant director with a wife who could run the office.

#### January 2, 2017

The quarterly meeting, of TBA was called to order by Rev. Mike Moore, Moderator. It was held at the Baptist Center. There were 13 executive committee members and nine visitors with seven churches represented. Rev. Mike Moore led the group in an opening prayer. Chuck Norris led the group in singing "Down at the Cross". Rev. Paul Langston of the NC Baptists on Mission had the devotion. Tracy and Ruthie Salter, Tammy and Cameron Cabe, and Donna and Kate Watson were recognized as visitors.

Mrs. Lee Lillard presented the WMU report. The leadership group will be meeting to make future plans. The October 3, 2016 executive committee minutes and the Oct. - Nov. 2016 financial statement were presented by Gracella. Rev. Gerald Morris presented his quarterly DOM report. He had been called to preach several times this quarter. Most of the times that he had been asked to preach were for churches that are without a pastor. It is always an honor for him to help churches as they make the transition between pastors. Please pray for our churches that are currently without a pastor: Cashiers, Long Branch, Ochre Hill, and New Savannah. The Missions/Evangelism Committee has been working hard to discern God's will for our outreach efforts in 2017. The Committee has three motions and a proposal tonight that will help the churches of the association do their part in fulfilling the Great Commission. Two mission opportunities that arose in 2016, were disaster recovery in Eastern NC from Hurricane Matthew and in Eastern TN from the wildfires in Sevier County. NC Baptists on Mission is working hard to help the thousands of people that lost everything due to the hurricane and subsequent flooding. Gerald was in touch with Robert Nichols, DOM of the Sevier Association of Baptist, and Pete Lamon, Pastor of Banner Baptist Church (one of the churches that was damaged by the wildfires) to see how we could help our neighbors to the west. The greatest need that they have is long term help to assist families that lost their homes. Gerald and Gracella took \$1,600 worth of gift cards

and checks to the Sevier Association of Baptists for the victims from TBA on December 15<sup>th</sup>. He said the association is currently still taking donations of gift cards. In the future he hopes that the churches will partner with Banner Baptist to help them reach their community for Christ by helping meet the needs of the victims of the fire.

In a continuing quest to improve the Association's service to the churches, Gerald is always looking for training opportunities. One such time was with the "Upside down Church" training by Taylor Field (a pastor in New York City) and sponsored by the NC Baptist on Mission. It was a challenging look at how we are doing church compared to how we should be doing church. The NC Baptist on Missions Conference is also available.

NC Baptist on Mission offers Disaster Relief Training. This year, the training closest to us will in Buncombe Co. May 19 and 20. This training will prepare you to respond to a disaster in a safe and efficient manner. The wildfires in TN were a good lesson in the need for the Association to have a team that is trained. Several people contacted me wanting to help immediately after the fires, but the only people that could help were ones that have been trained. If we wait for a disaster to occur to seek training it is too late.

The finances of the association are doing OK at this time thanks to the yearly payments from the sale of the Wall Estate property. The first of five payments were received in October for \$3,849.58. This money will help for the next few years, but he reminded everyone that the Association is supported by the churches and the churches cannot be served without their financial and prayerful support. Please consider increasing the amount that your church gives so that we never get in the precarious position we were a few years ago.

Rev. Paul Langston presented information about how the churches can get involved in the mission work that the NC Baptist on Mission is doing. He had pamphlets and books. He also told about some of the disaster relief work he has directly been involved with in Eastern NC with the Hurricane Matthew victims.

#### **No Old Business**

#### **New Business**

- Gerald presented a motion from the Missions Committee that \$1,000 of Annie Hoyle funds be set aside for use in disaster relief work by the Association in TN and/or Eastern NC. The Missions Committee would oversee the spending of this money and report to the Executive Committee. This money would be used to cover the expenses of traveling to and from disaster relief work and for buying materials needed in this work. This was approved.
- Gerald presented a motion from the Missions Committee that \$700 of Annie Hoyle funds be sent to La Primera Iglesia Bautista de Amor for Rev. Felix and Pat Villarreal's mission trip to Mexico in March. This was approved.
- Gerald presented a motion from the Missions Committee that \$1,500 of Annie Hoyle funds be sent to Faith Baptist Church for their Honduras Partnership Mission Trip in the summer. This was approved.

Darrin Sutton led the group in closing prayer after announcements and prayer requests.

#### April 3, 2017

The quarterly meeting, of TBA was called to order by Rev. Mike Moore, Moderator. It was held at the Baptist Center. There were 21 executive committee members and one visitor with eleven churches represented. Rev. Clemmey Queen led the group in an opening prayer. Rev. Shane Danner led the group in singing "Are You Washed in the Blood". Rev. Aaron Langston, pastor of Pine Creek Baptist Church had the devotion. He was also recognized as a new member. No changes were made to the agenda.

Mrs. Lee Lillard presented the WMU report. The associational WMU meeting is April 6th at Faith Baptist Church. New officers will be nominated and elected. She encouraged everyone to attend the April 18th Missions meeting. Host churches are needed for the Christmas Backpack Outreach. The Backyard Bible Schools will also be discussed to be held in Jackson County and a possible one in Eastern North Carolina to help victims of Hurricane Matthew who are living in motels. She also requested prayers for the ministry that she and Steve are organizing. It will be reaching people spiritually and physically through household goods, clothing and food.

The January 2, 2017 executive committee minutes and the Oct. 2016 - Feb. 2017 financial statement were presented and approved.

Rev. Gerald Morris presented his quarterly DOM report. This quarter has been a time of planning for the rest of the year and the Missions Committee has been busy. The committee and Gerald have been planning to reach Jerusalem to the Uttermost parts by bringing the churches of the Association together. The Jerusalem outreach will be done this December but will take much planning before. The committee has requested twenty backpacks from the North American Mission Board's Appalachian Regional Ministries for each of the elementary schools in Jackson County. These backpacks are packed by churches all over the SBC and contain school supplies, food, toys, a Bible and information about the Gospel and an invitation to join a mail order Bible study. The plan is for churches in the neighborhood of each school to take on the task of presenting the backpacks to needy kids and share the Gospel with the kids and their parents at an event designed by the churches.

The Mission Committee is also encouraging each church to reach their community through "Operation Inasmuch." This is a one day mission/ service blitz in your community during the last of April or May. The Samaria mission will once again be a trip to the Kentucky Speedway to work with the Kentucky Raceway Ministry in various areas to pass out tracts, Bibles and other literature. This trip will take place July 6-8 and is open to anyone that is interested. Reaching the

world with the Gospel should always be on our mind even if you can't go overseas. This is why the Association is offering, once again, a trip to Book-Link in Kentucky. A group will be going April 14-15 to help prepare literature for shipping overseas. This is in addition to the opportunity that is available here in Jackson County to help prepare the material received in Western North Carolina.

The Missions Committee is also excited to see the Missions Conference come together for September. Three missionaries have already been confirmed (from India, the Middle East and Sub Saharan Africa). Each year it is exciting to hear what God is doing through our SBC missionaries.

The outpouring of support for those that were affected by the fires in the Gatlinburg area has been wonderful to see. Gerald was in contact with the Director of Missions for the local Association and pastors in the area and it seems that the recovery effort is over and the rebuilding part is slow in starting. The Tennessee Baptist Men have finished their work and do not plan to assist in rebuilding. He was referred to two organizations that are taking over the rebuilding of homes and he can share this information to anyone who is interested. He was also told about a young family that lost their home and did not have insurance. The father is trying to rebuild the house and may need some help. Gerald also has this information for anyone interested in following up with this need.

This year a mission trip to Vermont has not been planned. With back to back mission trips, last year was very hectic for Gerald's family and he decided to slow down this summer. He hopes to continue the mission work in Vermont but wants to take this year to reevaluate the options.

In Gerald's continuing quest to improve service to our churches, he attended two training events this quarter. In February, Gracella and Gerald traveled to the Shelby Mission Camp to learn about the Backpack ministry discussed above. They learned about how to request and administer the distribution of the backpacks. He then traveled to Brevard where the Transylvania Baptist Association hosted a GuideStone Financial Resources Tax Seminar. He learned more about how pastors can structure their taxes to save money. He is planning with Davis Blount, GuideStone representative for the Baptist State Convention, to bring the seminar to our Association.

The Spring Associational Singing was well attended and the offering, once again, was divided between the Baptist Children's Home and the Association. People have reported having a wonderful time of worship and fellowship.

It was Gerald and Gracella's pleasure to host the pastors and their wives at a meal in March at the Baptist Center. Grants were received from the Baptist State Convention to cover the costs of the meal and a speaker. The youth from Faith Baptist Church helped serve the food and Buddy Freeman, pastor of the First Baptist Church of Marshall, entertained them with comedy. Over 40 people attended. They are looking at ways to provide the pastors and their families more opportunities to fellowship and relax.

Calvary and Faith Baptist church came to the Baptist Center and performed several items of maintenance around the building and grounds. They were able to do some cleaning and repairs that were much needed. There are many more jobs that need to be done and any help would be greatly appreciated. The Buildings and Grounds Committee will be looking into several larger projects that are needed around the Baptist Center. These jobs will probably take professional, outside help.

The month of May will be our annual Alton Hooper memorial offering for the Tuckaseigee Baptist Association. Please consider taking up a special offering and increasing your regular contributions so that the great work of the Association can continue. Gerald invited Rev. Lloyd Fish to share about the Alton Hooper Offering for TBA and encourage churches to take up the challenge to raise a mile of pennies for the offering. A mile of pennies is over \$800. **No Old Business**

#### July 10, 2017

The quarterly meeting, of the Tuckaseigee Baptist Association was called to order by Rev. Mike Moore, Moderator. It was held at the Baptist Center. There were 17 executive committee members and one visitor with nine churches represented. Kenneth Miller led the group in an opening prayer. Chuck Norris led the group in singing "*Tis So Sweet to Trust in Jesus*". Rev. Mike Moore had the devotion. Doris Melton of Calvary Baptist Church was recognized as a new member. No changes were made to the agenda.

The April 3, 2017 executive committee minutes and the Oct. 2016 - June 2017 financial statement were presented and approved.

Rev. Gerald Morris presented his quarterly DOM report as follows. I am excited that God is bringing the churches of the Association together more and more to see His work done in Jackson County and beyond. I am so excited to see that the majority of the meetings that have occurred were about sharing the Gospel of Jesus Christ.

The Missions Committee has been very busy planning and executing outreach and missions activities. With this last quarter we saw the culmination of the work to help the Gatlinburg wildfire victims. Bannertown Baptist Church (our church contact in Gatlinburg) and the other churches in the area have finished their work in helping with immediate needs. It was an honor to help in their time of need.

The Missions Committee has been looking forward to future projects. The committee is working on a plan to reach out to the attendees of Mountain Heritage Day at WCU this September 30th. The plan is for people from churches throughout the Association to help man the booth and share information about their churches and (of course) the Gospel of Jesus Christ. We are looking for people from several of the churches so that we can share the great things that are going on. I will be sharing more information as we get it. We are also open to ideas. Another outreach that the Missions Committee is working on is the Backpack Ministry sponsored by the Baptist Men of NC. Several Associational churches are partnering together to distribute backpacks to children in all of the public elementary schools in Jackson County. The backpacks will be distributed at an evangelistic event at the beginning of December.

The Missions Committee is pleased about how the Missions Conference planned for September 17-20 is shaping up. We have commitments from missionaries that have served or are serving in South Asia, Southeast Asia, the Middle East, East Asia and Subsaharan Africa. Please pray that this conference will be a blessing and an encouragement to our churches. Please plan to attend as many services that you can. Scotts Creek, Ochre Hill, Cashiers and Faith Churches are hosting this conference. Attend and see what God is doing through Southern Baptists to reach the world with the Gospel.

Gracella and I have been busy in the Association with various projects. The first is the annual Broyhill Food Roundup in April. It is a blessing each year to see the churches of the Association come together to help supply a great need. We appreciate all of the help that we received in sorting, packing and delivering the food.

Gracella and I attended the open house for the "HOMEBASE" at WCU. This is a new ministry at WCU aimed at helping students that have grown up in the foster care and have "aged out of the system." The graduation rate for these students, who lack parental support, is dismal and the ministry is designed to provide the support these students need to be successful in school and life. Jim Dean, director of HOMEBASE, welcomes any questions and help that you have.

The Alton Hooper Memorial fundraiser has been a great success. The Mile of Pennies emphasis has been fun and fruitful. The churches raised 3,050.78 for a total of  $3\frac{1}{2}$  miles of pennies. We know of a few more churches that have not turned in their offering so this amount will increase in the near future. This offering is bringing us closer to meeting our yearly expenses.

The finances of the Association also continues to benefit from the Wall estate land sale. The original agreement was that the purchaser was going to pay half of the sale price at closing and then make five yearly payments. Earlier this quarter we were called and told that they were going to pay off the remaining balance. The Finance Committee has been prayerfully meeting about how to be good stewards of this money. I see it as a blessing that we can now have a little "breathing room" in our finances. We will not be so restricted in what we can do to serve the churches in the Association.

I know I say it a lot, but it's because it is true. I am honored to be able to serve our Lord by serving the churches of the Tuckaseigee Baptist Association. It is a pleasure to see how the churches have come together to do more for God than we ever could apart.

Doris Melton, president of the WMU, presented her WMU report. The association's WMU planted flowers at Camp Truett and prepared cookies for the KY Raceway Ministry. They have plans to attend the leadership training in Hendersonville, NC, help Hurricane Matthew victims, and participate in the BackPack project to help our needy students in the local schools. They are also collecting toothpaste for Red Boxes for the Women's Prison Ministry. Doris has a goal to get acquainted with all of the churches' WMUs.

### No Old Business

- Gerald presented from the Annual Meeting Committee written recommended changes to the Annual Meeting' days and meals and changes to the By-Laws. All changes would take effect <u>after</u> 2017 Annual Meetings. These recommendations will be presented at the 2017 Annual Meeting.
- Gerald reported that the association did not take a group to KY to work at Book Link. A group worked locally at the Book Link WNC and no Annie Hoyle funds were needed.
- Gerald reported that \$125 of Annie Hoyle Endowment Funds were spent for gas for the KY Raceway Mission Trip. New Hope Baptist Church provided the van.

# **Director of Missions' Annual Report 2017**

Looking over the calendar for this last year has revealed another busy year for the churches of the Association as we come together to do more for God than we ever could apart. Let me, as in years past, share with you some of the many things that the Association has assisted the churches in doing through three categories; worship/fellowship, evangelism/missions and discipleship.

#### Worship/ Fellowship

The Association has had the pleasure of assisting the churches in coming together to worship our Lord in two ways this year.

In May, the Association partnered with Webster Baptist Church for the National Day of Prayer. We have held this event at the Justice Center for many years but I noticed last year that we were duplicating what Webster had been doing recently. So beginning last year, Webster invited everyone to join them in this time of prayer for our nation.

The Associational year ended with our Annual Campus Prayer Journey. At the time of writing this, I am still receiving reports of the turn out. Each year a faithful few have turned out in May and September to pray for our country and our schools. I believe completely that our nation and our schools are in more desperate need of prayer than before. We will never see our nation heal and turn back to God until His people begin to pray earnestly.

It has been a pleasure to worship with the churches of the Association this year. This year I have been called on to preach more than in past years because we have lost several pastors to churches outside of the county. I am always grateful to preach at a church and I love to assist in any way that I can.

We did not have the worship rallies this year (for youth and adults) because we are looking to go to a two year rotation of some of our events in the Association because the calendar was becoming quite full and we did not want to wear out the churches and ourselves with too many events.

It was a great pleasure for Gracella and me to be able to host, with help from several churches, a Pastor and Wives dinner and fellowship last March. With funds that we obtained through several grants, the Association was able to provide food and entertainment for the pastors and their wives.

#### **Evangelism/**Missions

Seeing a dream come true, the Missions Committee was the busiest committee of all this year. We met several times this year to plan mission trips and projects and to award scholarships from the Annie Hoyle fund.

The committee was instrumental in helping plan a response to the Gatlinburg fires. The churches were able to come together and collect much needed funds to help a sister church (Banner Baptist) in Gatlinburg reach their neighbors with the Gospel after the devastating wildfires that killed 14 people and damaged/destroyed nearly 1,700 buildings. The Association was also able to send a crew of people to help Banner Baptist Church to sort and prepare donations for distribution to the community. This response was a great demonstration of how the churches of the Association can come together to serve better than we could have apart.

The Committee also helped plan our annual trip to the Kentucky Speedway in July to share the Gospel with over 100,000 NASCAR fans. It is always a pleasure to take a group of people from Association churches to serve in whatever capacity needed. This year we were assigned to the children's tent.

The Missions Conference was a wonderful success again this year. For the fifth year we have hosted missionaries that have come from the mission field to share what God is doing. This year seven churches spanning three counties hosted five missionaries from the International Missions Board. We were blessed with missionaries from five of the seven areas that the IMB serves. The missionaries came from South Asia, Southeast Asia, East Asia, North Africa/Middle East and Sub Saharan Africa. Each of the missionaries brought a challenging and uplifting message.

The Missions Committee is in the planning stages of our first Backpack Distribution. We have requested 20 backpacks from the Appalachian Regional Ministry of NAMB for each of the elementary schools (and churches have been filling more). Churches in the area of each school are coming together to plan a party to distribute these backpacks and share the Gospel. More information will come soon.

One of the most enjoyable jobs for the Missions Committee has been the awarding of missions scholarships from the Annie Hoyle fund. This year we were able to award \$5,200 to four churches. Through these scholarships we have been partners in reaching Mexico, Romania, Honduras, and Kentucky.

I would like to share one more bit of information in relation to missions. This year has been a one of disasters all around us. With the Gatlinburg fire, hurricanes in Texas, Florida and the Caribbean the Southern Baptist Disaster Relief has been very busy. With each disaster people have called our office to see how they could help. The best way to help is to pray, give (money) and go. The best way to be prepared to go is to be trained. Next Spring the NC Baptists on Missions will be hosting a training here in Jackson County. Keep up with the news in the the Baptist Herald to see how you can sign up for this training where we can be ready to go and help on the field.

# Discipleship

Gracella and I had the pleasure to teach in two separate Vacation Bible Schools. First we taught the 3rd and 4th graders at Ochre Hill. It was a blessing to share the Gospel with these wonderful children and more so when one young man was saved from our class.

We were also blessed with the opportunity to teach the Bible lesson to each of the classes at Cashiers. It was such a tremendous joy to share the Gospel and have one young lady respond to the call of Jesus on her life. It is always a joy to help any church in any way needed for their Vacation Bible Schools. Let us know how we can help you next year.

As with the worship rallies, we took a year off to begin a two year rotation of the Spring Church Leadership training.

#### Miscellaneous

Here I want to share several bits of news that do not necessarily fit in the above categories.

The finances of the Association are looking up. Once again, the churches of the Association came together through their regular offering and the Alton Hooper Memorial offering to fully support the Association's expenses for the entire year. It is wonderful to see how far we have come together to fund the work of the Association.

One other bit of financial news is that the buyers of the property inherited from the Wall estate paid off the loan early. With this we are able to end the year with a surplus in income. This is great feeling because it gives us freedom to do some things that we have not been able to do in the past because of the lack of funds.

I have been able to attend a few different training opportunities this year and plan to implement and share many of the ideas that I heard in the near future with the churches. In the Upside Down Church training I heard how Graffiti church in New York City is reaching those in need with the Gospel through meeting their physical needs in innovative ways. I believe they are onto something about changing the way we do social ministry.

In August, Gracella and I attended the GO Conference in Marietta, Georgia. It offered two days of training with hundreds of breakout sessions. It offered a wide variety of subjects. We hope to take others in the Association with us next year.

This week (September 26), I attended a Church Revitalization Conference hosted by NAMB and Blackaby Ministries. NAMB aims to help small struggling churches become revived and serving Jesus once again. I will be working on getting this conference here so that the churches in our area can benefit from this training.

This year we saw a great outpouring of support for each other when the churches of the Association came together to help La Primera Iglesia Bautista de Amor build their first building. Many churches gave money and Cashiers even lent a hand. What a blessing to see churches come together in such a way.

I have had the honor to preach and teach in several churches for various reasons (vacation, sickness and during times without a pastors).

I have had the opportunity to counsel with several churches, pastors and church members in good times and bad. It is an honor when I can help you in any way minister to the community and share the Gospel.

There are many other ways that God is working that I would love to share but do not have the space. It is wonderful to see how the churches of the Tuckaseigee Baptist Association have continued to come together to do much more than we ever could apart. Let's keep up the good work of serving our Lord.

### BY-LAWS OF THE TUCKASEIGEE BAPTIST ASSOCIATION, INC.

### ARTICLE I. NAME

The name of the body shall be the Tuckaseigee Baptist Association, Incorporated.

### ARTICLE II. OBJECTIVES

The purpose of the Association is to be a fellowship of churches on mission in our setting. The specific objectives of the Association are as follows:

1. To promote harmony, understanding and spiritual power between the churches.

2. To afford and promote a larger fellowship of Christians in the work of Christ.

3. To provide such programs, projects and organizations as will strengthen the churches and assist them in achieving their goals and objectives.

4. To discover needs which cannot be met effectively by churches individually and to coordinate the use of resources in meeting these needs.

5. To encourage support by every church for the mission causes of the Association, the North Carolina Baptist Convention, and the Southern Baptist Convention.

### ARTICLE III. AUTHORITY

SECTION 1. The Association shall have the power to elect and install its officers in whatever manner the body may deem expedient.

SECTION 2. The Association shall have power to recommend measures of usefulness and guidance to our churches in matters of organization, ordinations and questions of doctrines and discipline,

SECTION 3. The Association shall have no power to infringe upon the right of local churches as autonomous bodies.

### ARTICLE IV. MEMBERSHIP

SECTION 1. The Association shall be composed of regularly constituted Baptist churches in cooperating fellowship with the Southern Baptist Convention and following the teachings of the Bible.

SECTION 2. The Association shall be the sole judge of its membership and may receive or reject churches applying for membership therein at its pleasure. Churches applying for membership shall agree to come under the watchcare of the Association for one year. It is understood that during this period of watchcare the church shall be entitled to all rights and privileges of the Association except those of voting.

Applications for membership shall be presented to the Doctrine Committee of the Association. The applications will consist of a letter from a constituted church stating their desire to affiliate with the Tuckaseigee Baptist Association. The Doctrine Committee as a part of the review process may invite the requesting church to a conference to discuss its history, its mission strategy, and any other information that may be pertinent to the application. The Doctrine Committee may then approve the application and recommend them to the Executive Committee. The Executive Committee may by a simple majority vote accept the requesting church to come under the watchcare of the Association for one year. Any church under watchcare is expected to participate in and financially support the Association. At the end of the year, the church may be voted in as a member of the Association with full privileges by a two-thirds vote of the messengers present and voting at the annual meeting of the Association, at the recommendation of the Doctrine and Executive Committees and at least one messenger be present at the meeting.

SECTION 3. Any church may withdraw from the Association at its pleasure and should notify the Association of this action in writing. Such action will be recognized by the Association at the next annual meeting.

SECTION 4. It shall be the duty of each church to furnish the Associational Clerk, before each annual session, a Church Profile, the forms provided by the Associational Clerk, giving the information requested as is applicable to each church situation.

SECTION 5. The Association may withdraw from any church which has become unscriptural in its doctrine or practices by a two-thirds majority vote of the messengers present and voting at the annual meeting. Such vote is to be taken by written ballot.

#### ARTICLE V. MEETINGS

SECTION 1. The Association shall hold its annual meeting on Tuesday and Thursday following the second Sunday in October. Special meetings of the Association may be called by the Executive Committee provided two weeks written notice is given to the member churches.

SECTION 2. Each church shall be entitled to be represented at the annual meeting by the pastor and one additional messenger. Churches which give to the association more than .5% of their undesignated receipts shall be entitled to an additional 2 messengers for every .5% of giving up to a total of 10 messengers for churches which give 2% of their undesignated giving."

SECTION 3. Churches are requested to elect their messengers and alternatives in conference to attend the annual meeting. SECTION 4. In case of internal dissension in a church and two parties coming to the Association, each claiming to represent the church, neither party shall be seated until the Doctrine Committee determines which party is in union with the Association. The decision is to be affirmed by a majority of the messengers present and voting.

### ARTICLE VI. OFFICERS

SECTION 1. General officers of the Association shall be: Moderator, Vice Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer, Parliamentarian, Assistant Parliamentarian, Director of Missions, Trustees and team leaders. Team leaders shall be chosen by the Nominating Committee as needed to serve the purposes of the Association (eg. Sunday School leader, Youth/Children leader). Team leaders will work with the Moderator and/or the Director of Missions to form a team to carry out assigned duties.

Associational representatives will be elected as may be deemed appropriate and elected in the Association. Associational representatives shall be a conduit of information between outside agencies and the Association. They may also represent the Association as the outside agency's policies specify.

SECTION 2. With the exception of the Director of Missions and Trustees, the terms of office for all officers of the Association shall be for one year with the privilege of continuing re-election. The Moderator and Vice Moderator shall not be eligible for re-election but one year in succession. (1) The number of Trustees shall be three. (2) The term of service should be for three years, with the term of only one expiring each year. In the first election of Trustees, the term of service for one should be three years, another two years, and the other one year. (3) Upon the expiration of term of service, the Trustee may or may not be re-elected for another term of three years.

Each term of office shall begin with the close of the annual session. The Associational financial year will run from October 1 through September 30.

### ARTICLE VII. DUTIES OF OFFICERS

SECTION 1. The Moderator shall preside and maintain the order of all meetings of the Association and Executive Committee. He shall serve as ex officio member of all committees of the Association.

SECTION 2. The Vice Moderator shall assist the Moderator and preside in the absence of, or at the pleasure of the Moderator.

SECTION 3. The Clerk shall keep a complete and accurate record of all meetings; shall prepare a "Book of Reports" to be distributed to messengers at the beginning of the annual meeting; and prepare minutes of the annual meeting (Annual Minutes) to be distributed to each church.

The Clerk shall distribute to the clerk of each church in the Association a congregational church profile as soon as they are received from the State Convention. This form is to be returned to the Clerk of the Association as soon as possible or by the deadline set by the Clerk and Director of Missions. All program reports should be returned by the same date.

An Assistant Clerk shall work with the Clerk in preparing the "Book of Reports," the annual minutes and the registration of messengers at the annual meeting.

SECTION 4. The Treasurer shall oversee the receipts and disbursements, by order of the Executive Committee of the Association, of the money of the treasury and ensure that a complete report is presented at the Annual meeting and a current report at each Executive Committee meeting.

An Assistant Treasurer shall be elected to assist the Treasurer by request and to serve in the event the Treasurer resigns or is ill or unable to function.

SECTION 5. The Parliamentarian shall upon the request of the presiding officer of the body, advise and assist the Association with respect to all matters involving Parliamentary Procedure.

An Assistant Parliamentarian shall be elected. The Parliamentarian and Assistant should always communicate with each other to ensure that this office is filled at each Associational Annual or Executive Committee meeting.

SECTION 6. Trustees have no authority except by direction of the Association and are not personally bound by signatures but are to be the legal signees for the Association. Trustees represent the Association in legal matters. Trustees act on behalf of the Association in acquisition and disposal of Associational property.

They sign all deeds of conveyance, execute all notes, bonds or mortgages, intervene in all suits, by authority of the Association.

All persons dealing with the Trustees, as Associational officers, may rely upon any written resolution duly adopted by the Association or Executive Committee, directing and authorizing the Trustees to act in its behalf and certified by the Association Moderator and Clerk.

### ARTICLE VIII. RULES OF ORDER

The business meetings of the Association shall be conducted according to Robert's Parliamentary Practice or in a manner not contrary thereto.

### ARTICLE IX. QUORUM

The quorum for the Annual Associational meeting or any special called meeting of the Association shall not be less than 25 percent of the member churches.

### ARTICLE X. THE EXECUTIVE COMMITTEE

SECTION 1. The Executive Committee shall be composed of the General Officers and Team Leaders elected by the Association and the Pastor and one member from each church in the Association. No Pastor, by virtue of his being an Associational Officer or Program Leader shall be disqualified as a member of the Executive Committee, from representing the church or churches he may be serving in the Association. Twelve of these members shall constitute a quorum.

SECTION 2. It shall be the duty of the Executive Committee to act for the Association on matters arising when the Association is not in session and to make a report of all work to the next session of the Association. This body shall meet at a time and place designated by the Moderator on Monday following the second Sunday of each quarter except for the October quarter which shall be replaced by the Annual Meeting. Special meetings of the Executive Committee may be called by the Moderator with a one week notice to the churches.

SECTION 3. All vacancies occurring on committees or among elected officers shall be filled by the Executive Committee.

### ARTICLE XI. ASSOCIATIONAL STANDING COMMITTEES

SECTION 1. The Association shall have such standing committees as may be deemed necessary to promote efficiently the work of the Master in our midst. The terms of office for all committee members shall be for three years except where specifically stated otherwise.

SECTION 3. THE NOMINATING COMMITTEE shall be composed of seven members It shall be the duty of this committee to nominate the Officers, Committees members, Team Leaders (as needed) and Institutional Agency Representatives. These nominees shall be notified prior to presenting of their names at annual session.

SECTION 4. THE STEWARDSHIP COMMITTEE shall be composed of six members including the Treasurer of the Association. This committee shall: (a) present a Budget to the Association for the following year; (b) devise plans for raising the funds for the Associational Budget; (c) audit the finances and financial records of the Association annually and anytime there is a change of Treasurer or at the direction of the Association or the Executive Committee; (d) report all audits to the Annual Association Meeting.

SECTION 5. THE BUILDING AND GROUNDS COMMITTEE shall be comprised of three members. The committee shall be responsible for and in charge of the upkeep and repairs of the Associational building, grounds, and equipment. SECTION 6. THE PERSONNEL COMMITTEE

A. The Committee shall be composed of 7 members of which 3 are pastors.

B. They shall recommend policies and procedures for the selection, supervision and termination of Associational staff personnel. Those policies and procedures shall be approved by the Association.

C. Prepare and maintain an organizational manual relation to the Association's staff personnel.

D. Develop and recommend to the association policies and procedures for paid and volunteer staff personnel.

E. When a staff vacancy occurs, other than the DOM, they shall serve as the search committee. When a DOM

vacancy occurs, they shall nominate a search committee and present it to the Executive Committee. F. The Personnel Committee shall handle grievances as outlined in the grievance policy.

SECTION 7 THE ANNUAL MEETING COMMITTEE shall be composed of seven members. The duties of this committee shall be to

- A. recommend the church(es) to host the annual meeting and the preacher(s) and alternate preacher(s) to deliver the annual sermon for the following year,
- B. present suitable resolutions at the annual Associational meeting,

- C. bring a report to the annual meeting of those listed by the member churches as deceased since the last annual meeting,
- D. keep the historical records of the Association up-to-date,
- E. plan the program for the Annual Meeting(s) and present it to the Executive Committee at its October meeting,
- F. shall be responsible for registering messengers at the Annual Meeting(s),
- G. and shall perform all duties specified in Article XIII (amendments to by-laws).

SECTION 7 THE DOCTRINE COMMITTEE shall be composed of five pastors and two laymen.

- A. It shall examine applications of churches seeking admission into the Association in keeping with Article IV and make recommendation to the Association. It shall counsel with churches that are out of harmony of fellowship with the Association.
- B. It shall also advise churches about candidates for ordination with the following guidelines: it serves on an advisory capacity only, serves at the request of the church from which the member is seeking ordination, is to examine such candidates as to their call and fitness for the gospel ministry and make such recommendations to the church as they feel led. It should regularly inform the Executive Committee of its work.

### ARTICLE XII. JOB DESCRIPTION, DIRECTOR OF MISSIONS

### SECTION 1. Title and Functions.

A. Position Title. This position shall be known as the Director of Missions for the Tuckaseigee Baptist Association.
 B. Basic Functions. The Director of Missions shall serve as a minister to the church leaders of the Tuckaseigee

Baptist Association, as mission strategist, as chief administrative officer, and as a general leader of the Association.

C. The Personnel Committee shall be responsible to maintain, update and revise a job description as required, making recommendations to the Association for approval as they are needed.

### ARTICLE XIII. AMENDMENTS

The constitution may be amended at any annual meeting of the Association by a two-thirds majority of the messengers present and voting, provided the amendment has been presented to the Annual Meeting Committee at least 10 days prior to the annual meeting and presented to the Association in printed form on the first day of the annual meeting to be voted on the second day.

### ARTICLE XIV. NON-PROFIT STATUS

The Tuckaseigee Baptist Association, Inc. is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the Tuckaseigee Baptist Association, Inc. shall inure to the benefit of its' members, directs, officers, or other persons except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes of the organization.

In the event of dissolution, the residual assets of the Tuckaseigee Baptist Association, Inc. will be turned over to one or more organizations with similar purposes which are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986.

# NC BAPTIST FOUNDATION 2017 Annual Report

The mission of the North Carolina Baptist Foundation after almost 100 years remains the same, to impact lostness by "generating an increased awareness of Christian stewardship principles as a means of financially undergirding Baptist churches, institutions and mission endeavors on a permanent basis." In 2016, the Foundation was blessed in its efforts to accomplish this mission as:

- 50 new accounts were established, the majority of which will permanently support Kingdom work in North Carolina and around the world
- Gifts to all accounts totaled \$4,206,225.58
- A total of \$9,365,842.26 was distributed (\$7,610,978.97 to mission endeavors and \$1,754,863.29 to individuals through charitable trusts)
- Assets under management at the end of 2016 totaled \$146.3 million
- 42 grants were made to special ministry endeavors totaling \$128,075.00
- 177 presentations were made to NC Baptist churches, associations, and other denominational entities by Foundation staff
- NC Baptist Financial Services had 73 church loans totaling \$41.35 million at the end of 2016
- The outstanding Certificates of Participation balance stood at \$35.8 million

Today the Foundation manages 2,279 accounts, 1,421 of which are permanent endowments benefitting 547 different ministries on a permanent basis. In its 96 year history, the NC Baptist Foundation has distributed \$129.6 million to ministry and \$51.7 million to individuals through charitable trusts for a total distribution of \$181.3 million.

In 2015, the Foundation joined with the Baptist State Convention in a new scholarship ministry offering awards to NC Baptist students attending a NC Baptist college or university. Based on both need and academic achievement, 123 scholarships were awarded for the 2017-18 academic year totaling \$252,500.00. Including other scholarships, a total of \$280,500.00 was awarded. Applications for scholarships are available online each year from January 1 to February 15.

The Foundation staff is always available to assist NC Baptist individuals and churches who want to make a lasting impact for the Kingdom.

### GuideStone / Compensation and Benefits Services (CABS)

The GuideStone Team of the Baptist State Convention of North Carolina has a new name: the Compensation and Benefits Services (CABS) Office. Changes in fiduciary laws make it necessary to cease using the "GuideStone" name for our office, since convention employees in this office are not actually GuideStone employees. It does not change anything related to individual retirement accounts of pastors and staff members, and our office will still be able to provide answers to general questions regarding retirement, insurance and other financial needs of our churches. Our goal continues to be keeping our North Carolina Baptist association offices and churches up-to-date on changes that affect them. The following information is a summary of those efforts:

### Retirement

The CABS Office works with church staff and lay leaders in an effort to assist them in the restructuring of pastor and staff compensation packages to include retirement benefits. Many pastors and staff members do not see the benefits of participating in the Church Retirement Plan, and they will opt out of the plan if given an opportunity. Therefore, a continued effort is being made to challenge churches to assist their pastors and staff by contributing to their retirement plans in addition to their salaries and other benefits. Sadly, nearly half of N.C. Baptist churches make no contributions to the retirement plans of their staff members. We continue to educate and encourage our churches to be responsible employers by providing for their staff members' retirements in a Christ-honoring manner.

### **Convention Protection Benefits**

We were pleased to be able to continue offering life and disability benefits to all staff members of N.C. Baptist churches participating in the Church Plan through GuideStone. North Carolina continues to lead all state conventions in the number of participants, but we are still far short of the goal of having every church providing for their staff members through a GuideStone Retirement Plan.

### Tax and Health Insurance Laws Health care reform law:

GuideStone remains a leader in providing detailed information regarding the impact that new tax and health care laws have on our churches and their staff. Timely and thorough updates of changes in the tax law are available on the GuideStone website. We are certain that there will be many more changes in the coming months related to health care laws, and your CABS Office will work diligently to stay on top of these changes.

### **Church Staff Compensation**

The results of the 2016 Southern Baptist Compensation Study are available online by visiting *compstudy.lifeway.com*. Churches and their staff will be able to participate in the 2018 Compensation Study beginning January 1, 2018. Please participate in the 2018 survey. Much of the year has been spent educating churches on the tax implications of the "lump sum pay packages" for pastors and churches. The taxability of such pay packages continues to be a concern.

### **Mission Dignity**

GuideStone Financial Resources continues to provide financial assistance to elderly ministers and widows of ministers who live under financial duress and need ongoing and/or one-time assistance through Mission Dignity. 2017 Report: July 2016 - June 2017

## A Message from BCH President Michael C. Blackwell

In the summer of 2016, I received a stunning message that depicted the desperate journey — both figurative and physical — of three siblings who had just come into Baptist Children's Homes' care.

A nine-year-old boy packed a small bag, took his three-year-old and five-year-old sisters by their hands and led them out of their family home and away from a world filled with abuse. The boy didn't know where to go. All he knew was he had to save his sisters.

Not long afterward, a deputy spotted the siblings walking along the highway. The boy, dressed appropriately in his Superman shirt, told the stunned officer, "Please take me and my sisters to foster care. We can't live with our mom and stepdad anymore."

Within a matter of hours, these precious children were given a compassionate refuge at Baptist Children's Homes. This nine-year-old big brother succeeded in his mission to rescue his little sisters. And at Baptist Children's Homes, he met his own Savior when his cottage parents introduced him to Jesus. (In 2016, 147 of the children and families BCH served made decisions for Christ.)

It has been 34 years since I accepted the invitation to be President of Baptist Children's Homes. After more than three decades, I am even more inspired by these courageous young people (if that's possible) as well as our ministry's amazing friends.

Your generous support, your prayers, your gifts of time and talents are the reason why we can rescue children, bring hope to families, empower the dreams of developmentally disabled adults, and guide aging adults along their journeys.

Please come alongside us as we continue to fulfill the vision of *sharing hope...changing lives* in the name of Christ. Together we have accomplished much, but the mission continues.

### **Greater Vision Outreach Ministry Launched**

BCH has expanded its community outreach to children and families through *The Bob and Carolyn Tucker Greater Vision Outreach Ministry*, a new statewide endeavor to meet the physical and spiritual needs of working families struggling with poverty. ### New College Ministry Supports Former Foster Care Children

**HOMEBASE** launched in Fall 2016 at Western Carolina University in Cullowhee. Located at the campus's former Baptist Student Union building, the new ministry grew out of a need to aid students who have been wards of the state, orphaned, aged out of foster care or even homeless. Many of these students drop out of college because they do not have families they can depend upon for even basic necessities. **HOMEBASE** helps students develop life skills, creates social opportunities, meets physical needs and provides emotional and spiritual support throughout their college experience. ### NC Baptists Share Faith, Raise Support through "Ride to Clyde"

For the second straight year, motorcyclists roared across the state for "Ride to Clyde" a North Carolina Baptist charity ride supporting Baptist Children's Homes. ### NCBAM's AAIM Events Encourage, Inspire, and Educate

North Carolina Baptist Aging Ministry's (NCBAM) **AAIM** program continues to grow and inspire leaders of aging adult groups across the state. **Aging Adults Innovating Ministry** is an outreach of NCBAM that holds an annual roundup each spring as well as regional gatherings each fall.

The 2016 Fall Gatherings were held in Thomasville, Greenville and Asheville. Leaders of aging adults were encouraged in their service to their church's aging members as well as informed about the many ministry opportunities available with aging adults in their communities.

Titled "The Family of God," the May 2017 AAIM Roundup focused on the special needs of caregivers and the role of the church in supporting them. More than 150 senior adult ministers, lay leaders, and church members were in attendance. Alan Blume, editor/president of the *Biblical Recorder*, provided the keynote address. Beth Harris, a minister's wife who has walked the caregivers' journey, provided the closing address. Following four early-bird sessions, the agenda also included special music as well as opportunities to visit with select vendors and a "parade of churches." Exhibiting churches shared innovative ways they are helping frail aging adults and their caregivers.

As a result of the AAIM outreach, ministries and outreaches of churches and Associations to aging adults are being strengthened. Following last fall's regional gathering in Asheville, the *Buncombe Baptist Association (BBA)* partnered with NCBAM to form the *BBA's Senior Adult Leaders Group*.

Norma Melton, church and community missions director for the BBA is enthusiastic about the new Leaders Group. "This partnership will be a blessing to the churches in the Buncombe Association and their senior adult ministries. There is great strength in partnering together."

### Serving Developmentally Disabled Adults – Stephen

Stephen was one of the first four men to call Davis House "home" on March 10, 2003. For the forty three year old, it was the first time to ever live apart from his family.

"My husband Dean and I knew that we would not always be able to care for Stephen," says Martha Trivette, Stephen's 89-year-old mother. "Davis House has been the way we prepared Stephen for the future."

The Trivettes live in Winston-Salem not far from where Stephen lives now. He visits with his mom, dad and sister Nancy on weekends and holidays. Baptist Children's Homes' (BCH) Developmental Disabilities Ministry operates nine group homes for adults with special needs helping them to achieve goals and their highest level of independence. "I have two homes," Stephen says. "I live with my friends here, but I see my family a lot, too."

Living at Davis House he actively participates at The Enrichment Center – a Forsyth County day program that aids in independent living – goes on trips with his housemates to restaurants and the occasional shopping outing – the dollar store is a favorite stop.

"I'm thankful for my friends and family," Stephen shares. "I'm thankful that I am able to live here."

Trivette agrees with her son. She says that as a North Carolina Baptist, she knew BCH could be trusted. "I have had peace of mind since day one. Anytime I feel the need to visit, I am always welcomed."

In 1919, God inspired leaders of the Baptist State Convention of North Carolina with a vision to build a hospital that would extend the healing ministry of Jesus Christ. Expert medical care and compassion for patients and families were core values for the 88 bed hospital that opened in 1923 in Winston-Salem.

In 2017, the legacy of these founders continues to unfold through <u>Wake Forest Baptist Medical Center</u> a fully integrated academic medical center. <u>Wake Forest Baptist Health</u> includes <u>North Carolina Baptist</u> <u>Hospital, Brenner Children's Hospital</u>, <u>Wake Forest Innovations</u>, and <u>Wake Forest Innovation Quarter</u>, an urban research and technology park. A network of affiliated community based hospitals, physician practices, outpatient services and other medical facilities are also included. Wake Forest School of Medicine is ranked among the nation's best medical schools.

Today the system has 1004 acute care and rehabilitation beds and includes <u>Wake Forest Baptist Health-Lexington Medical Center, Wake Forest Baptist Health-Davie Medical Center, and Wake Forest Baptist</u> <u>Health – Wilkes Medical Center,</u> as well as clinics, diagnostic centers, and other primary and specialty care facilities serving 22 counties in northwest North Carolina and southwest Virginia.

### Dr. Julie Ann Freischlag, M.D., Named New Chief Executive Officer

On February 14, 2017, Dr. Julie Ann Freischlag, was named as the new Chief Executive Officer of the Medical Center beginning May 1, succeeding Dr. John McConnell, CEO since 2008. He transitioned to a new position in the Medical Center in May. Dr. Freischlag will oversee the full scope of the academic health system, the School of Medicine, Wake Forest Baptist Health, Wake forest Innovations, Wake Forest Innovation Quarter, the network of hospitals, physician practices and medical/surgical services.

Dr. Freischlag, in her words, "a wife, mother, vascular surgeon, researcher, and administrative leader", came to the Medical Center from Sacramento, California where she was Vice Chancellor for Human Health Sciences and Dean of the School of Medicine at the University of California Davis. She previously served as the chair of the department of surgery/surgeon-in-chief at Johns Hopkins Medical Institutions.

But their hope was restored with their bill was paid by the Mother's Day Offering. "It was like the biggest burden was lifted from our heads. It was unbelievable. I cried for two days", she said. "My

husband didn't have to work so much. My girls and I see him again. It was like God was saying, you've been through so much, here. We feel so blessed."

FaithHealthNC helps ease the journey to health and healing for people and the communities in which they live. It does this by connecting the caring strengths of congregations, the expertise of medical providers, and a network of community resources. A major component of our "ground game" in FaithHealthNC is the work of our Connectors – local, trusted individuals who have earned respect and credibility in their local areas. They find ways to "open doors" of contact with congregations to identify and enlist volunteers to become FaithHealth partners and Connectors identify community resources to improve health. Connectors work with volunteers from congregations to take neighbors to medical appointments, help them run errands, help them find food, offer prayer and encouragement and all kinds of simple acts that make a giant difference.

Our work with Baptist Associations will expand in 2017-2018 as we identify target Associations where we will place Connectors. We will work with Directors of Missions to look at the future integration of FaithHealthNC across NC, much like we did as we launched FaithHealthNC in 2012 in western NC. The support we receive from the Baptist State Convention of NC Cooperative Program Missions Giving Budget provides the funds to make this expansion possible. For this we are profoundly grateful.

### CareNet, Inc. – Lifting Spirits. Holding Hope.

For over forty years the Baptist State Convention has pioneered a unique one of a kind partnership with a mental health ministry that reaches across 70 North Carolina counties. In that span of time it is estimated that over a 250,000 North Carolinians have been touched by this ministry of hope, healing and growth. The care of the mind, body, spirit and community is a hallmark of the Division of Faith and Health Ministries of which CareNet is a part and a witness to the extraordinary vision of the BSCNC to attend to the whole life of the disciples of Jesus. The following is a snapshot of this past fiscal year and the unique work being done by CareNet counselors enabled by the generosity of the Convention. It highlights how this shared ministry of the Convention continues to innovate and go where we think healthcare is going.

**Wilkes Region**- The town where our newest Wake Forest Baptist hospital is located this center is ground zero for trauma associated with substance use in North Carolina. We have a counselor in a homeless center and have plans to locate counselors in local primary care offices along with a closer alignment with the local hospital that is now part of our family.

**Marion Region**- Our newest center in the network (2016) enables us to reach further west in rural NC communities where access to mental health and substance use services are sparse.

In a turbulent policy environment where behavioral health is already reimbursed well below its cost the partnership with the Baptist Sate Convention is a beacon of hope and a welcome respite for tired and weary souls who cannot incur the full cost of services. We are confident our mission of mental health which impacts one out of five Americans will continue to thrive as we develop new and innovative forms of care that touch the mind, body, spirit and community. Thank you North Carolina Baptist for standing with and for the broken, despondent, tired and

hopeless who are given the opportunity through sensitive and compassionate care in 35 CareNet locations to reclaim life, love and hope.

### **Chaplaincy and Clinical Ministries**

The Clinical Pastoral Education program allows Wake Forest Baptist Medical Center chaplains to provide spiritual and supportive care to patients, their loved ones and staff of the Medical Center. Chaplains serve in several capacities, including a 24-hour, on-call ministry within the hospital, and helping people with a range of medical, emotional, and spiritual needs. The CPE educational program is one of the oldest and largest in the nation, and offers a variety of programs, including some in community-based settings.

One of our newest Chaplains spent over 25 years with the Forsyth County Sheriff's Department as their Chaplain. He is now our Chaplain to First Responders. Other new Chaplains are the Manager of Spiritual Care Services at the Wake Forest Innovation Quarter, Wake Forest Baptist Health – Davie Medical Center, and Wake Forest Baptist Health – Wilkes Medical Center.

### Center for Congregational Health – Opening Doors to Hope and Wholeness

Congregations are experiencing unprecedented changes and with these changes strategic opportunities. Since its inception, the Center for Congregational Health (CCH) has sought to assist churches. However, just as congregations have experienced great change so has the CCH. As a self-supporting ministry of the Hospital, CCH has refined and refocused its role in the FaithHealth strategy. The CCH plays a key role in supporting, encouraging and strengthening congregations and thus extends the Medical Center's mission of health and healing beyond the hospital's walls. During the past fiscal year, the Center has provided a variety of consulting, coaching, and training ministries supporting clergy, lay leaders, congregations, and the FaithHealth movement itself. Faith communities and the volunteers from those communities form the backbone of the FaithHealth movement. CCH staff and professional coaches in the Center's coaching network provided coaching for approximately 30 ongoing clients. Consultants work with congregations in the areas of re-visioning/strategic planning, conflict management, pastoral and staff transitions, church mergers, and the challenges of financial sustainability.

CCH staff work directly with the FaithHealth congregations and clergy in the 22 county service area and beyond. As part of the FaithHealth Ministries Division, we provide service and training to the Clinical Pastoral Education residents and interns. The CCH staff often refers clients to CareNet or other Medical Center services.

**Wake Forest Baptist Medical Center** was ranked in 2016 by U.S. News & World Report among the nation's best hospitals in five adult medicine areas: Cancer (19<sup>th</sup>), Nephrology (25<sup>th</sup>), Ear, Nose, and Throat (35<sup>th</sup>), and Neurology & Neurosurgery (46<sup>th</sup>).

**Wake Forest Baptist Medical Center** also holds the "Gold Seal of Approval" from <u>The Joint Commission</u>, the nation's independent esteemed standards-setting and accrediting body for health care quality.

**The Comprehensive Cancer Center** has had its designation by the National Cancer Institute (NCI) renewed for five years. It is 1 of 3 NCI centers in North Carolina and one of 46 in the country.

**Brenner Children's Hospital**, the pediatric arm of the Medical Center, received verification as a Level 1 pediatric trauma center by the American College of Surgeons (ACS). It is one of only 51 Level 1 pediatric trauma centers in the country and the only one in our region and 1 of three in North Carolina.

**The School of Medicine, the Bowman Gray Center for Medical Education**, relocated to its new facility in the fall of 2016. The building, located in the Wake Forest Innovation Quarter, is a former R.J. Reynolds Tobacco Company Manufacturing Plant.

## **Cooperative Program Office Report, 2017**

A pastor in Garner reported his church was increasing Cooperative Program giving by 6 percent for 2018.

The church he leads is not a megachurch, but averages 200 or so in attendance on Sunday — a strong church that is growing. But, he said his members like the idea of partnering with other Baptists so they can accomplish more kingdom-focused missions and ministry than they could ever do alone.

Similar opinions have begun shaping up across North Carolina and also across the United States. The result has been that Cooperative Program giving percentages have been more positive over the last year or two.

A 6 percent increase in Cooperative Program giving is wonderful, of course, but even a 1 percent increase helps more than one might think — if enough churches join in.

Note that if all 4,300 or so churches affiliated with the Baptist State Convention of North Carolina (BSCNC) increased their Cooperative Program giving by just 1 percent of their incomes, it would produce about \$6 million in additional funds for missions. Under the 2017 Cooperative Program budget, an additional \$1.2 million would be used to send and support missionaries in North Carolina, North America and overseas.

Such an increase would also help Southern Baptists start even more new churches across North America — beyond the average of two new churches a day we already start. Ministries across North Carolina would also be multiplied.

These "what if" totals refer just to North Carolina. If all 46,000 Southern Baptist churches across the country similarly increased their Cooperative Program giving by just 1 percent of their undesignated receipts, it would produce an astounding \$100 million in additional funds each year.

Imagine what could happen: Missionaries could be assigned to most of the unreached people groups — those who have not heard the gospel and have no missionaries assigned to them — around the world.

These days, many of those unreached people now live in North Carolina. An increase in funds would enable more training, materials, planning and all the other support that is

helping equip North Carolina Baptists to engage with this new missions challenge so close to home.

Some interesting efforts are underway to help Baptists understand the close relationship that exists between stewardship, giving to the local church and accomplishing the missions task assigned to the church.

One of the most successful new tools for missions education is called 52 Sundays, a guide that presents an international missionary, North American missionary or North Carolina church planter to pray for each Sunday throughout the year. Colorful photos can be projected and brief information provided on these brave missionaries who serve far and wide before the congregation joins in prayer. Over a year, a church can get acquainted with "their" missionaries they support through the Cooperative Program and additional missions offerings.

52 Sundays started here in North Carolina, but has been adopted by the Executive Committee of the Southern Baptist Convention (SBC) for nationwide distribution. Churches across the country now use the prayer guide each Sunday.

Starting with the 2018 edition, the national office of Woman's Missionary Union will support 52 Sundays through its many print and digital outlets — and will even provide translation into other languages. In North Carolina, the 2018 edition of 52 Sundays will be sent to the churches in mid-December of 2017.

North Carolina is one of the state conventions partnering with the SBC Executive Committee on a new computer-assisted effort to keep pastors informed on the Cooperative Program through regular letters or emails.

Another approach in North Carolina will feature pastors talking to pastors and others on videos, explaining why they agree that the Cooperative Program is absolutely the best method for churches to multiply their missions dollars.

Finally, consider this. Each year, usually in April, Southern Baptists set aside a Sunday as Cooperative Program Sunday as a day to think about this missions funding mechanism that started in 1925. It may seem strange to designate a day to how we multiply missions by putting funds into a major missions fund, then spend that money for missions and ministries as approved by messengers from the churches.

But this simple idea that is the Cooperative Program has been one of the major factors in Baptist growth across our country and about our world. With enough churches behind it, the Cooperative Program will enable Baptists to even more kingdom work in the years ahead.
