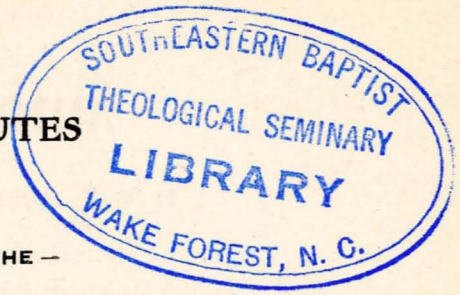

MINUTES.

11 A. M., September 16th, 1910.

1st. The introductory sermon was delivered by Elder J. H. Smith of Rutherford Church, Washington County, Ga.

2nd. After one hour's intermission the messengers assembled in the house. Prayer by Elder J. P. Barrs of Reedy Springs Church, Laurens County, Ga.

3rd. Received and read letters from the churches and enrolled the names of messengers.

4th. Re-elected Elder J. W. Herrin, Moderator and G. E. King, Clerk.

5th. Appointed Committee on Preaching: Brethren J. P. Stalnaker, A. M. Garvin, M. J. Ray, J. H. Colquit and G. E. King.

6th. Called for correspondence and received none.

7th. On motion received, Reedy Springs Church of Laurens County, Ga., into the membership of this body. Elder J. P. Barrs and Bro. J. T. Lyles delegates with letter.

8th. Appointed next session of this body with Reedy Springs Church, Laurens County, Ga., half mile of Cadwell on Dublin & Southwestern R. R., our usual time the third Sunday, Friday and Saturday before in September 1911.

9th. Appointed next session of Union Meeting with Fellowship Church, Houston County, Ga., four miles Southeast of Byron on C. of Ga. Ry., commenc-

ing Friday before and embracing the Fifth Sunday in April 1911.

10th. Called for visiting brethren and received Brethren Geo. Windham and Frank Glover, of New Hope Church, Taylor County, Ga., and Elder J. H. Smith of Rutherford Church, Washington County, Ga.

11th. Called for contributions and received \$8.50 for Minutes. Agreed to have 500 printed.

12th. Adjourned in order to time and place above mentioned.
