3. Approved a seven-year community services partnership plan whereby the Seminary will purchase a 1000 G.P.M. Pumper for fire safety in the Town of Wake Forest.
4. Approved the naming of Lea Lab, upon completion of renovation, Broyhill Hall.
5. Approved naming the relocated Student Center, when constructed adjacent to Gore Gymnasium, the Ledford Student Center.
6. Approved plans for a Trustee/Administration/Faculty Retreat in October, 1980.
7. Employed G. Paul Fletcher, Judson College, as Business Manager Elect to succeed O. L. Cross upon his retirement in July, 1980.
8. Approved a Resolution of Appreciation for John G. Mills, Jr. who served as seminary attorney.
9. Approved a plan for systems study throughout the Seminary.
10. Approved sabbatical study leaves for Professor George Braswell, Professor Archie Nations, and Professor Robert Poerschke.

11. Approved a Statement of Purpose for the Seminary.
12. Approved construction of the Seminary Subdivision on Juniper Street.
13. Approved plans to convert one of the Seminary's major boilers to natural gas as well as fuel oil capability.
14. Accepted the 100 Townhouses from the Fortis Corporation and the long-term financing provided by the Integon Corporation.
15. Voted to renovate Lea Lab.
16. Established the Clyde W. and Elizabeth M. Eby Scholarship Endowment.
17. Established the Associate of Divinity Class Scholarship Endowment Fund.
18. Adopted a "Program of Planned Giving for Southeastern Baptist Theological Seminary."
