



# **Proceedings**

### FRIDAY, SEPTEMBER 8, 1939

The Association met pursuant to adjournment of last year. The introductory sermon was delivered by Elder W. W. Davis, Messenger of Senter Association, Text: St. Matthew, 5-6.

After a short intermission the messengers assembled in the church house and were called to order by praise and prayer, by Elder L. S. Saylor, a visitor from Powers Valley Association.

Wagoner; Abbot's Creek—Elder D. P. Broadway and Bro. C. B. Owens; Indian Creek—Elder E. O. Lilly; Fisher's River—Brother G. T. Jones and W. R. Morefield; Powers Valley-Elder L. S. Saylor; North District-Elder W. H. Cave and Brother C. L. Davis; Upper Mayo-Elder W. J. Brown.

6th. On motion, for moderator to make all temporary appointments during this session. He appointed to stand today,

Elder W. H. Cave and W. J. Brown.

7th. On motion, appointed a committee on ministry composed of one messenger from each church.

8th. On motion, appointed a committee on finance as follows: J. F. Hartsog, Felix Bare and J. M. Weaver.

9th. On motion, appointed a committee on arrangements as follows: Elders G. D. Roten, W. W. Davis, Ed Ham, with moderator and clerk to sit with them-also transient and visiting brethren.

10th. On motion, appointed a committee to appoint correspondents to sister associations as follows: G. E. Kilby, T. E.

Hartzog and Geo. Caudill.

11th. On motion, for committee on arrangements to sit at Brother Bob Blevins'.

12th. On motion, that we adjourn until temorrow morning at 9 o'clock.

# SATURDAY, SEPTEMBER 9, 1939

The association met pursuant to adjournment of yesterdey and was called to order by praise and prayer by Elder H. M. Blevins.

1st. On motion, called on committee on arrangements to report. Report received and brethren discharged.

2nd. On motion, called roll, and erased absentees.

3rd. On motion, that we omit reading constitution and rules

of decorum.

4th. On motion, called on committee who appointed correspondents to report. The report was as follows; St. Clair's Bottom—Elders Ed Davis, Ed Ham, Blair Kilby, Brothers G. E. Kilby and Hamp Davis; Mountain—Elder Ed Davis, Elder G. D. Roten, and Brother Hamp Davis; Fisher's Creek—Elders Ed Davis, W. W. Davis and G. D. Roten; Upper Mayo—Elder Ed Davis, Elder W. W. Davis, Elder G. D. Roten and Brother T. E. Hartzog; Roaring River—Elder Ed Ham and Brother F. T. Miller; Abbots Creek—Elder G. D. Roten and Brother F. T. Miller; Indian Creek—Elders Ed Davis and W. W. Davis.

5th. On motion, called on correspondents that were to go to sister associations to report. Reports received and brethren

discharged.

6th. On motion, that we correspond with New River, Fisher's River, Washington, Ebenezer, Tenn., Nola Chucky consolidated, Kehuke, Ketockton, and Powers Valley by Minutes.

7th. On motion, that we correspond with Fisher's River, Upper Mayo, and Abbots Creek associations by messengers.

8th. On motion, that we omit having the Constitution and

Rules of Decorum printed in these Minutes.

9th. On motion, called on committee on preaching to report, who reported for Saturday: 1st., Elder S. P. Roberts; 2nd., Elder C. B. Kilby; 3rd., Elder L. S. Saylor, and 4th., Elder H. M. Blevins. For Sunday—1st., Elder E. O. Lilly; 2nd., U. G. Nichols, 3rd., Elder F. P. Stone; 4th., Elder D. P. Broedway.

10th. On motion, that the next session of this association be held with Horse Creek church, beginning on Friday before the second Sunday in September, 1940—about 16 miles west

of Jefferson, N. C.

11th. On motion, that we have the Obituaries of Brother Jonathan Perry and Sister Elizabath Ham printed in these Minutes.

12th. On motion, that we bear with the churches that failed to represent another year and that the preaching brethren visit them if possible.

13th. On motion, called on Finance committee to report who

# Obituaries

### JONATHAN PERRY

Jonathan Perry was born in Ashe county July 6, 1856, and departed this life March 30, 1938, making his stay on earth seventy-nine years, eight months and twenty-four days.

He was married to Alvok Sheets March 9, 1878. To this union was born fourteen children four of which preceded him to the Great Beyond. He is also survived by thirty-seven grand-

children, twenty great grandchildren and one sister.

He professed a hope in Christ and joined the Horse Creek Primitive Baptist church in the year 1884, later moving his membership to Big Helton Primitive Baptist church where he remained a faithful member till death. He never allowed the business affairs of life to interfere with his Seturday church meetings. Not only did he attend his local church services but, prior to his failing health he traveled hundreds of miles yearly to attend services of other churches. He took special interest in the young ministers of the church advising them, pointing out and overlooking their mistakes and always urging them on.

He was versed in the Bible and his chief interest seemed to center in the church; nevertheless he was very active in civic life outside the church. He served several years as clerk of the church. He was very patient during his affliction, always approving anything done for his comfort, and never complaining

about his condition.

The church has lost a faithful member, his wife a faithful husband, and the children a devoted father, but heaven has gained their loss.


