

PROCEEDINGS OF THE

UPPER COUNTRY LINE ASSOCIATION

Wednesday Morning, August 14th, at 10 O'clock

1. The introductory sermon was preached by Elder J. W. Gilliam from 1st Cor. 22nd, and was followed by Elder C. A. Davis, who preached from Matthew 13th, 33. 34th verses.

2. After an intermission, the Association convened, and after praise and prayer by Elder L. H. Hardy, proceeded to business. On motion Bro. E. R. Harris was chosen Moderator. The clerk called to his assistance brother T. A. Stanfield.

8. The Circular Letter appointed to be written by Brother R. L. Snead was called for, but not written. He was excused by the association.

9. On motion the Association adjourned to meet Friday morning, August 16th, 1918, at 9 o'clock.
