**Ninety-second Annual Session of the Oconee Primitive Baptist**  
**Association, Held With Mount Paron Church,**  
**October 9, 10, 11, 1929**

Elected Elder W. L. Allen Moderator Pro Tem.

Appointed Elder W. J. Green, R. L. Cook and Bro. J. W. Green to read letters from sister associations.

Item 1. Elected J. H. Stewart Moderator, W. H. Robison Clerk.

Item 2. Adopted order of business of last session for this session.

Item 3. Invited visiting ministers and Brethren to seats with us and welcomed them.

Item 4. Appointed the following committee to arrange preaching: Brethren J. B. Moon, C. R. Garrett, G. E. Ivy, A. G. Adair, R. P. Cheek, together with messengers from this church.

## ARTICLES OF FAITH

---

I. We believe in one only true and living God, and that there is a Trinity of persons in the God-head, the Father, the Son, and the Holy Ghost; and yet there are not three Gods, but one God.

II. We believe that the Scriptures of the Old and New Testaments are the word of God, and the only rule of faith and practice.

III. In the fall of Adam, and the imputation of his sin to his posterity; in the corruption of human nature, and the impotency of man to recover himself by his own free will or ability.

IV. In the everlasting love of God to his people, and the eternal election of a definite number of the human race to grace and glory; and that there was a covenant of grace or redemption made between the Father and the Son before the world began, in which their salvation is secure, and that they in particular are redeemed.

V. That sinners are justified in the sight of God only by the righteousness of Christ imputed to them.

VI. That all those who were chosen in Christ will be effectually called, regenerated, converted, sanctified and supported by the Spirit and power of God, so that they shall persevere in grace, and not one of them be finally lost.

VII. That good works are the fruits of faith, and follow after justification; and that they only justify us in the sight of men and angels, and are evidences of our gracious state.

VIII. That there will be a resurrection of the dead and a general judgment; and that the happiness of the righteous and the punishment of the wicked will be eternal.

## THE PLAN OR FORM OF OUR GOVERNMENT

Article 1. Those members who are regularly chosen by the church in our union shall compose Association.

2. The members so chosen shall produce letters from their respective churches, certifying their appointment, together with their number in fellowship, those baptized, received by letter, restored, dismissed, excommunicated, and dead since the last Association.

3. The members thus chosen and convened shall be denominated "The Oconee Baptist Association."

4. The Association shall have no power to lord it over God's heritage; nor to infringe upon any of the interval rights of the churches.

5. The Association shall have a Moderator and Clerk, who shall be annually chosen by the members present, and who shall continue in office until the next election.

6. If a new church should desire to be admitted into this union, she shall petition by letter and messengers; and upon examination, if found orthodox and orderly, shall be received by the Association, and manifested by the Moderator's giving the messengers the right hand of fellowship.

7. No church in the union shall have a right to more than two messengers, till she shall exceed one hundred members, and then she shall have a right to an additional messenger for every fifty after the first hundred.

8. Every query sent to the Association by any church in the union shall be read and put to vote by the Moderator, whether it shall be debated? And if there be a majority for it, it shall be taken up and investigated; but if not, it shall be withdrawn; provided always that those be first considered which affect the union



of churches.

9. Every motion made and seconded shall come under the observation of the Association, except it be withdrawn by the member who made it.

10. Every person who speaks in debate shall rise from his seat and address the Moderator, and shall not be interrupted while speaking, except he depart from the subject.

11. No person shall speak more than three times on the same subject, without leave of the Association.

12. There shall be no talking nor whispering in time of a public speech, nor reflections cast upon the speaker.

13. No member shall absent himself from the Association, without leave from the Moderator.

14. If any member shall break the rules of this decorum, he shall be immediately reprov'd by the Moderator.

15. It is the business of the Association,

1. To provide for the general union of the churches.

2. To keep up a correspondence with those Associations of the same faith and order, that a chain of communion may be preserved amongst the churches.

3. To give churches the best advice they can in matters of difficulty; and if the communion should be broken between any of the sister churches in the union, to enquire into the cause of the break, and use their best endeavors to remove the difficulty; but if the breach cannot be healed, to withdraw from any church or churches, where they shall look upon to be unsound in principle or immoral in practice, till they be reclaimed.

4. To admit any of the brethren in the ministry, or assistants, if they shall judge it to be necessary.

5. To see that the Clerk keeps a regular record of the transactions of the body, and that he be satisfied for his trouble.

6. To have the Minutes of the Association read and corrected if need be and signed by the Moderator and Clerk, before the Association rise; and have them printed if they think proper.

7. To amend this Plan or Form of Government, at any time when a majority of the union shall deem it necessary.

8. To adjourn to any time or place which they may think to be most proper.
