At the earlier date the matter of the eventual disposition of the property was discussed. The house is not in a place conducive to an increase in members or congregation.

At that time, an offer made by a black Christian to purchase the property. We understood that to be able to give a deed to the place it would be necessary to adhere to a public legality, As, according to the deed, the site had been contributed, but if and when it ceased to be used in the worship of God, it should revert to the donars. Inclosed is a copy of the deed. It seemed to us that the property could be legally transferred. Because we would not consider selling it, except for worshipservices. Since no denomination is named in the deed, why could a clear deed not be given without any further problem?
