# ELK RIVER ASSOCIATION

The introductory sermon was preached by Elder J. G. Woodfin from 2 Tim. iv. 2: "Preach the Word." Then the churches met and were called to order by the clerk

On motion, Elder J. G. Woodfin was called to the chair as temporary moderator.

Prayer by Elder P. G. Byars.

The letters from the churches called for and read. Messengers invited to seats. The letters show in table the state of the churches.

Appointed the clerks as committee on correspondence.

On motion, the association adjourned to meet Saturday morning at 9 o'clock.

The report of the memorial committee was received and the committee discharged, and report ordered printed in the minutes.

Committee on finance, W. R. Cashion and J. C. Shofner, report \$20.36 received from the churches to pay for the printing and distributing of the minutes of this association. Report accepted and committee discharged.
