Of the Forty-Seventh Annual Session of the Harmony Primi-TIVE BAPTIST ASSOCIATION, held with Mars Hill Church, Calhoun county, Ga., Commencing on Saturday before the 2d Sunday in October. 1885.

2d. We believe the Scriptures of the Old and New Testament are the word of God, and the only rule of faith and practice. 3rd. We believe in the doctrine of eternal and particular

4th. We believe in the doctrine of original sin.

5th. We believe in the doctrine of man's impotency to recover himself from the fallen state, he is in by nature. of his own free will and ability.

6th We believe that sinners are justified in the sight of

God, only by the imputed righteousness of Christ.

7th. We believe that God's elect shall be called, converted and sanctified by the Holy Spirit.

8th. We believe that the saints shall persevere in grace, and

shall never finally fall.


